SUMMARY—Makes various changes regarding education and educational personnel.  
(BDR 34-2)

AN ACT relating to education; revising provisions relating to the achievement and proficiency examinations administered in public schools; revising provisions governing the increase of salary for a teacher who is certified by the National Board for Professional Teaching Standards; requiring the boards of trustees of school districts to pay the increase of salary retroactively under certain circumstances; authorizing under certain circumstances the employment of licensed teachers who do not hold endorsements in a particular subject area; requiring certain school districts to create and operate regional training programs for the professional development of teachers and administrators; creating the statewide council for the coordination of the regional training programs; authorizing under certain circumstances the licensure and employment of teachers who are not citizens of the United States; prohibiting persons from making certain threats to pupils and employees of school districts, charter schools and private schools; providing for the reimbursement of certain costs of teachers who acquire certification by the National Board for Professional Teaching Standards if money is made available; providing a penalty; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     **Section 1.** NRS 387.303 is hereby amended to read as follows:  
2     387.303 1. Not later than November 10 of each year, the board of  
3     trustees of each school district shall submit to the superintendent of public  
4     instruction and the department of taxation a report which includes the  
5     following information:  
6     (a) For each fund within the school district, including, without  
7     limitation, the school district's general fund and any special revenue fund  
8     which receives state money, the total number and salaries of licensed and  
9     nonlicensed persons whose salaries are paid from the fund and who are  
10    employed by the school district in full-time positions or in part-time



1 positions added together to represent full-time positions. Information must  
2 be provided for the current school year based upon the school district's  
3 final budget, including any amendments and augmentations thereto, and for  
4 the preceding school year. An employee must be categorized as filling an  
5 instructional, administrative, instructional support or other position.  
6 (b) The count of pupils computed pursuant to paragraph (a) of  
7 subsection 1 of NRS 387.1233.  
8 (c) The school district's actual expenditures in the fiscal year  
9 immediately preceding the report.  
10 (d) The school district's proposed expenditures for the current fiscal  
11 year.  
12 (e) The schedule of salaries for licensed employees in the current school  
13 year and a statement of whether the negotiations regarding salaries for the  
14 current school year have been completed. If the negotiations have not been  
15 completed at the time the schedule of salaries is submitted, the board of  
16 trustees shall submit a supplemental report to the superintendent of public  
17 instruction upon completion of negotiations or the determination of an  
18 arbitrator concerning the negotiations that includes the schedule of salaries  
19 agreed to or required by the arbitrator.  
20 (f) The number of teachers who received an increase in salary pursuant  
21 to subsection 2 of NRS 391.160 for the current and preceding fiscal years.  
22 *If the board of trustees is required to pay an increase in salary*  
23 *retroactively pursuant to subsection 2 of NRS 391.160, the board of*  
24 *trustees shall submit a supplemental report to the superintendent of*  
25 *public instruction not later than February 15 of the year in which the*  
26 *retroactive payment was made that includes the number of teachers to*  
27 *whom an increase in salary was paid retroactively.*  
28 (g) The number of employees eligible for health insurance within the  
29 school district for the current and preceding fiscal years and the amount  
30 paid for health insurance for each such employee during those years.  
31 (h) The rates for fringe benefits, excluding health insurance, paid by the  
32 school district for its licensed employees in the preceding and current fiscal  
33 years.  
34 (i) The amount paid for extra duties, supervision of extracurricular  
35 activities and supplemental pay and the number of employees receiving  
36 that pay in the preceding and current fiscal years.  
37 2. On or before November 25 of each year, the superintendent of  
38 public instruction shall submit to the department of administration and the  
39 fiscal analysis division of the legislative counsel bureau, in a format  
40 approved by the director of the department of administration, a compilation  
41 of the reports made by each school district pursuant to subsection 1.  
42 3. The superintendent of public instruction shall, in the compilation  
43 required by subsection 2, reconcile the revenues and expenditures of the  
44 school districts with the apportionment received by those districts from the  
45 state distributive school account for the preceding year.  
46 **Sec. 2.** NRS 389.015 is hereby amended to read as follows:  
47 389.015 1. The board of trustees of each school district shall  
48 administer examinations in all public schools of the school district. The  
49 governing body of a charter school shall administer the same examinations



- 1 in the charter school. The examinations administered by the board of  
2 trustees and governing body must determine the achievement and  
3 proficiency of pupils in:
- 4 (a) Reading;
  - 5 (b) Writing;
  - 6 (c) Mathematics; and
  - 7 (d) Science.
- 8 2. The examinations required by subsection 1 must be:
- 9 (a) Administered before the completion of grades 4, 8, 10 and 11.
  - 10 (b) Administered in each school district and each charter school at the  
11 same time. The time for the administration of the examinations must be  
12 prescribed by the state board.
  - 13 (c) Administered in each school in accordance with uniform procedures  
14 adopted by the state board. The department shall monitor the compliance of  
15 school districts and individual schools with the uniform procedures.
  - 16 (d) Administered in each school in accordance with the plan adopted  
17 pursuant to section 2 of ~~this act~~ *Assembly Bill No. 214 of the 71st session*  
18 *of the Nevada Legislature* by the department and with the plan adopted  
19 pursuant to section 4 of ~~this act~~ *Assembly Bill No. 214 of the 71st session*  
20 *of the Nevada Legislature* by the board of trustees of the school district in  
21 which the examinations are administered. The department shall monitor the  
22 compliance of school districts and individual schools with:
    - 23 (1) The plan adopted by the department; and
    - 24 (2) The plan adopted by the board of trustees of the applicable school  
25 district, to the extent that the plan adopted by the board of trustees of the  
26 school district is consistent with the plan adopted by the department.
  - 27 (e) Scored by the department or a single private entity that has  
28 contracted with the state board to score the examinations. If a private entity  
29 scores the examinations, it shall report the results of the examinations in  
30 the form and by the date required by the department.
- 31 3. Not more than 14 working days after the results of the examinations  
32 are reported to the department by a private entity that scored the  
33 examinations or the department completes the scoring of the examinations,  
34 the superintendent of public instruction shall certify that the results of the  
35 examinations have been transmitted to each school district and each charter  
36 school. Not more than 10 working days after a school district receives the  
37 results of the examinations, the superintendent of schools of each school  
38 district shall certify that the results of the examinations have been  
39 transmitted to each school within the school district. Except as otherwise  
40 provided in this subsection, not more than 15 working days after each  
41 school receives the results of the examinations, the principal of each school  
42 and the governing body of each charter school shall certify that the results  
43 for each pupil have been provided to the parent or legal guardian of the  
44 pupil:
- 45 (a) During a conference between the teacher of the pupil or  
46 administrator of the school and the parent or legal guardian of the pupil; or
  - 47 (b) By mailing the results of the examinations to the last known address  
48 of the parent or legal guardian of the pupil.



1 If a pupil fails the high school proficiency examination, the school shall  
2 notify the pupil and the parents or legal guardian of the pupil as soon as  
3 practicable but not later than 15 working days after the school receives the  
4 results of the examination.

5 4. Different standards of proficiency may be adopted for pupils with  
6 diagnosed learning disabilities. If a pupil with a disability is unable to take  
7 an examination created by a private entity under regular testing conditions  
8 or with modifications and accommodations that are approved by the private  
9 entity, the pupil may take the examination with modifications and  
10 accommodations that are approved by the state board pursuant to  
11 subsection 8. If a pupil with a disability is unable to take an examination  
12 created by the department under regular testing conditions or with  
13 modifications and accommodations that are approved by the department,  
14 the pupil may take the examination with modifications and  
15 accommodations that are approved by the state board pursuant to  
16 subsection 8. The results of an examination that is taken under conditions  
17 that are not approved by a private entity or the department, as applicable,  
18 must not be reported pursuant to subsection 2 of NRS 389.017. If different  
19 standards of proficiency are adopted or other modifications or  
20 accommodations are made in the administration of the examinations for a  
21 pupil who is enrolled in a program of special education pursuant to NRS  
22 388.440 to 388.520, inclusive, other than a gifted and talented pupil, the  
23 different standards adopted or other modifications or accommodations  
24 must be set forth in the pupil's program of special education developed in  
25 accordance with the Individuals with Disabilities Education Act, 20 U.S.C.  
26 §§ 1400 et seq., and the standards prescribed by the state board. During the  
27 administration of the high school proficiency examination, a pupil with a  
28 disability may be given additional time to complete the examination if the  
29 additional time is a modification or accommodation that is approved in the  
30 pupil's program of special education developed in accordance with the  
31 Individuals with Disabilities Education Act, 20 U.S.C. §§ 1400 et seq.

32 5. If a pupil fails to demonstrate at least adequate achievement on the  
33 examination administered before the completion of grade 4, 8 or 10, he  
34 may be promoted to the next higher grade, but the results of his  
35 examination must be evaluated to determine what remedial study is  
36 appropriate. If such a pupil is enrolled at a school that has been designated  
37 as demonstrating need for improvement pursuant to subsection 1 of NRS  
38 385.367, the pupil must, in accordance with the requirements set forth in  
39 this subsection, complete remedial study that is determined to be  
40 appropriate for the pupil.

41 6. If a pupil fails to pass the proficiency examination administered  
42 before the completion of grade 11, he must not be graduated until he is  
43 able, through remedial study, to pass the proficiency examination, but he  
44 may be given a certificate of attendance, in place of a diploma, if he has  
45 reached the age of 17 years.

46 7. The state board shall prescribe standard examinations of  
47 achievement and proficiency to be administered pursuant to subsection 1.

48 *The high school proficiency examination must be developed, printed and*  
49 *scored by a nationally recognized testing company in accordance with*



1 *the process established by the testing company.* The examinations on  
2 reading, mathematics and science prescribed for grades 4, 8 and 10 must be  
3 selected from examinations created by private entities and administered to  
4 a national reference group, and must allow for a comparison of the  
5 achievement and proficiency of pupils in grades 4, 8 and 10 in this state to  
6 that of a national reference group of pupils in grades 4, 8 and 10. The  
7 questions contained in the examinations and the approved answers used for  
8 grading them are confidential, and disclosure is unlawful except:

9 (a) To the extent necessary for administering and evaluating the  
10 examinations.

11 (b) That a disclosure may be made to a:

12 (1) State officer who is a member of the executive or legislative  
13 branch to the extent that it is necessary for the performance of his duties;

14 (2) Superintendent of schools of a school district to the extent that it  
15 is necessary for the performance of his duties;

16 (3) Director of curriculum of a school district to the extent that it is  
17 necessary for the performance of his duties; and

18 (4) Director of testing of a school district to the extent that it is  
19 necessary for the performance of his duties.

20 (c) That specific questions and answers may be disclosed if the  
21 superintendent of public instruction determines that the content of the  
22 questions and answers is not being used in a current examination and  
23 making the content available to the public poses no threat to the security of  
24 the current examination process.

25 8. The state board shall prescribe, in accordance with the Individuals  
26 with Disabilities Education Act, 20 U.S.C. §§ 1400 et seq., the  
27 modifications and accommodations that may be used in the administration  
28 of an examination to a pupil with a disability who is unable to take the  
29 examination under regular testing conditions or with modifications and  
30 accommodations that are approved by the private entity that created the  
31 examination or, if the department created the examination, by the  
32 department. These regulations may include, without limitation, authorizing  
33 a pupil to complete an examination with additional time.

34 **Sec. 3.** Chapter 391 of NRS is hereby amended by adding thereto the  
35 provisions set forth as sections 4 to 19, inclusive, of this act.

36 **Sec. 4. 1.** *If the board of trustees of a school district determines*  
37 *that a shortage of teachers exists within the school district in a particular*  
38 *subject area, the board of trustees may submit a written request to the*  
39 *superintendent of public instruction to employ persons who are licensed*  
40 *teachers but who do not hold an endorsement to teach in the subject area*  
41 *for which there is a shortage of teachers. The superintendent of public*  
42 *instruction may grant such a request if the superintendent determines*  
43 *that a shortage of teachers exists in the subject area. If the*  
44 *superintendent of public instruction grants a request pursuant to this*  
45 *subsection, a person who holds a license to teach but not an endorsement*  
46 *in the subject area for which the request was granted may be employed*  
47 *by the school district for not more than 2 school years to teach in that*  
48 *subject area.*



- 1     2. *If the superintendent of public instruction grants a request*  
2 *pursuant to subsection 1, the superintendent shall submit a written report*  
3 *to the commission that includes the name of the school district for which*  
4 *the request was granted and the subject area for which the request was*  
5 *granted. Upon receipt of such a report, the commission shall consider*  
6 *whether to adopt revisions to the requirements for an endorsement in*  
7 *that subject area to address the shortage of teachers.*  
8     Sec. 5. *As used in sections 5 to 19, inclusive, of this act, unless the*  
9 *context otherwise requires, the words and terms defined in sections 6 and*  
10 *7 of this act have the meanings ascribed to them in those sections.*  
11     Sec. 6. *“Regional training program” means a regional training*  
12 *program for the professional development of teachers and administrators*  
13 *created pursuant to section 8 of this act.*  
14     Sec. 7. *“Statewide council” means the statewide council for the*  
15 *coordination of the regional training programs created by section 9 of*  
16 *this act.*  
17     Sec. 8. 1. *The Clark County school district, Douglas County school*  
18 *district, Elko County school district and Washoe County school district*  
19 *shall each establish and operate a regional training program for the*  
20 *professional development of teachers and administrators.*  
21     2. *Except as otherwise provided in subsection 6, the regional training*  
22 *program established by the Clark County school district must primarily*  
23 *provide services to teachers and administrators who are employed by*  
24 *school districts in:*  
25     (a) *Clark County;*  
26     (b) *Esmeralda County;*  
27     (c) *Lincoln County; and*  
28     (d) *Nye County.*  
29     3. *Except as otherwise provided in subsection 6, the regional training*  
30 *program established by the Douglas County school district must*  
31 *primarily provide services to teachers and administrators who are*  
32 *employed by school districts in:*  
33     (a) *Carson City;*  
34     (b) *Churchill County;*  
35     (c) *Douglas County;*  
36     (d) *Lyon County; and*  
37     (e) *Mineral County.*  
38     4. *Except as otherwise provided in subsection 6, the regional training*  
39 *program established by the Elko County school district must primarily*  
40 *provide services to teachers and administrators who are employed by*  
41 *school districts in:*  
42     (a) *Elko County;*  
43     (b) *Eureka County;*  
44     (c) *Lander County;*  
45     (d) *Humboldt County; and*  
46     (e) *White Pine County.*  
47     5. *Except as otherwise provided in subsection 6, the regional training*  
48 *program established by the Washoe County school district must primarily*



1 *provide services to teachers and administrators who are employed by*  
2 *school districts in:*

- 3 *(a) Pershing County;*
- 4 *(b) Storey County; and*
- 5 *(c) Washoe County.*

6 *6. Each regional training program shall, when practicable, make*  
7 *reasonable accommodations for the attendance of teachers and*  
8 *administrators who are employed by school districts outside the primary*  
9 *jurisdiction of the regional training program.*

10 **Sec. 9.** *1. The statewide council for the coordination of the*  
11 *regional training programs, consisting of eight members, is hereby*  
12 *created. The membership of the council consists of:*

13 *(a) Each coordinator appointed by the governing body of each*  
14 *regional training program pursuant to section 13 of this act; and*

15 *(b) One member of the governing body of each regional training*  
16 *program, appointed by the governing body. The member appointed*  
17 *pursuant to this paragraph may appoint a designee to serve in his place.*

18 *2. Each coordinator who serves on the statewide council is a member*  
19 *of the statewide council only for the period of his service as coordinator*  
20 *of the regional training program pursuant to section 13 of this act.*

21 *3. Each member appointed by the governing body pursuant to*  
22 *paragraph (b) of subsection 1 serves a term of 2 years.*

23 *4. Members of the statewide council serve without salary or*  
24 *compensation for their travel or per diem expenses.*

25 *5. The governing bodies of the regional training programs may*  
26 *mutually agree to expend a portion of their respective budgets to pay for*  
27 *the administrative support of the statewide council.*

28 **Sec. 10.** *1. The statewide council shall meet not less than four*  
29 *times per year.*

30 *2. The statewide council shall:*

31 *(a) Adopt uniform standards for use by the governing body of each*  
32 *regional training program in the review and approval by the governing*  
33 *body of the training to be provided by the regional training program*  
34 *pursuant to sections 15 and 16 of this act. The standards must ensure*  
35 *that the training provided by the regional training programs is of high*  
36 *quality and is effective in addressing the training programs specified in*  
37 *subsection 1 of section 16 of this act.*

38 *(b) Coordinate the dissemination of information to school districts,*  
39 *administrators and teachers concerning the training, programs and*  
40 *services provided by the regional training programs.*

41 *(c) Disseminate information to the regional training programs*  
42 *concerning innovative and effective methods to provide professional*  
43 *development.*

44 *(d) Conduct long-range planning concerning the professional*  
45 *development needs of teachers and administrators employed in this state.*

46 *(e) Adopt uniform procedures for use by the governing body of each*  
47 *regional training program to report the evaluation conducted pursuant to*  
48 *section 18 of this act.*





- 1     **Sec. 11. 1.** *Each regional training program must have a governing*  
2 *body consisting of:*  
3     (a) *The superintendent of schools, or his designee, for each school*  
4 *district that is included within the primary jurisdiction of the regional*  
5 *training program. The superintendent of schools serves ex officio.*  
6     (b) *Teachers who are considered masters, appointed by the*  
7 *superintendents of schools of the school districts that are included within*  
8 *the primary jurisdiction of the regional training program and the*  
9 *representatives of higher education appointed to the governing body.*  
10 *Each teacher who wishes to be considered for appointment to the*  
11 *governing body must submit an application explaining his qualifications*  
12 *as a master teacher. At least one teacher must be appointed from each*  
13 *school district within the primary jurisdiction of the regional training*  
14 *program.*  
15     (c) *Representatives of the University and Community College System*  
16 *of Nevada, appointed by the board of regents, and representatives of*  
17 *other institutions of higher education, as determined by the*  
18 *superintendents of school districts included within the primary*  
19 *jurisdiction of the regional training program.*  
20     (d) *A nonvoting member who is an employee of the department.*  
21     **2.** *After the appointments are made, the governing body shall select a*  
22 *chairman from among its membership.*  
23     **3.** *Each member of the governing body shall serve a term of 2 years.*  
24 *A person must not be appointed to serve more than three consecutive*  
25 *terms.*  
26     **4.** *A vacancy in the governing body must be filled in the same*  
27 *manner as the original appointment.*  
28     **Sec. 12. 1.** *Each governing body shall meet not less than two times*  
29 *per year and at the call of the chairman.*  
30     **2.** *Members of the governing body serve without salary or*  
31 *compensation for their travel or per diem expenses.*  
32     **Sec. 13. 1.** *The governing body of each regional training program*  
33 *shall appoint a coordinator of the program, who serves at the pleasure of*  
34 *the governing body.*  
35     **2.** *The coordinator of each regional training program shall:*  
36     (a) *Serve on the statewide council;*  
37     (b) *Assist in the evaluation of the regional training program, as*  
38 *directed by the governing body; and*  
39     (c) *Perform such other duties as directed by the governing body.*  
40     **Sec. 14.** *On an annual basis, the governing body of each regional*  
41 *training program shall review the budget for the program and submit a*  
42 *proposed budget to the legislative committee on education. The proposed*  
43 *budget must include, without limitation, the amount of money requested*  
44 *by the governing body to pay for the services of the coordinator of the*  
45 *program appointed pursuant to section 13 of this act. In even-numbered*  
46 *years, the proposed budget must be submitted to the legislative committee*  
47 *on education at least 4 months before the commencement of the next*  
48 *regular session of the legislature.*





1     **Sec. 15.** *The governing body of each regional training program*  
2 *shall:*

3     1. *Adopt a training model, taking into consideration other model*  
4 *programs, including, without limitation, the program used by the*  
5 *Geographic Alliance in Nevada.*

6     2. *Assess the training needs of teachers and administrators who are*  
7 *employed by the school districts within the primary jurisdiction of the*  
8 *regional training program and adopt priorities of training for the*  
9 *program based upon the assessment of needs. The board of trustees of*  
10 *each such school district may submit recommendations to the*  
11 *appropriate governing body for the types of training that should be*  
12 *offered by the regional training program.*

13     3. *Prepare a 5-year plan for the regional training program, which*  
14 *includes, without limitation:*

15       (a) *An assessment of the training needs of teachers and*  
16 *administrators who are employed by the school districts within the*  
17 *primary jurisdiction of the regional training program; and*

18       (b) *Specific details of the training that will be offered by the regional*  
19 *training program for the first 2 years covered by the plan.*

20     4. *Review the 5-year plan on an annual basis and make revisions to*  
21 *the plan as are necessary to serve the training needs of teachers and*  
22 *administrators employed by the school districts within the primary*  
23 *jurisdiction of the regional training program.*

24     **Sec. 16.** 1. *Based upon the assessment of needs for training within*  
25 *the region and priorities of training adopted by the governing body*  
26 *pursuant to section 15 of this act, each regional training program must*  
27 *provide:*

28       (a) *Training for teachers in the standards established by the council to*  
29 *establish academic standards for public schools pursuant to NRS*  
30 *389.520; and*

31       (b) *At least one of the following types of training:*

32           (1) *Training for teachers and school administrators in the*  
33 *assessment and measurement of pupil achievement and the effective*  
34 *methods to analyze the test results and scores of pupils to improve the*  
35 *achievement and proficiency of pupils.*

36           (2) *Training for teachers in specific content areas to enable the*  
37 *teachers to provide a higher level of instruction in their respective fields*  
38 *of teaching. Such training must include instruction in effective methods*  
39 *to teach in a content area provided by teachers who are considered*  
40 *masters in that content area.*

41           (3) *Training for teachers in the methods to teach basic skills to*  
42 *pupils, such as providing instruction in reading with the use of phonics*  
43 *and providing instruction in basic skills of mathematics computation.*

44     2. *The training required pursuant to subsection 1 must:*

45       (a) *Include appropriate procedures to ensure follow-up training for*  
46 *teachers and administrators who have received training through the*  
47 *program.*

48       (b) *Incorporate training that addresses the educational needs of:*



1       (1) Pupils with disabilities who participate in programs of special  
2       education; and

3       (2) Pupils whose primary language is not English.

4       3. The governing body of each regional training program shall  
5       prepare and maintain a list that identifies programs for the professional  
6       development of teachers and administrators that successfully incorporate  
7       the standards of content and performance established by the council to  
8       establish academic standards for public schools pursuant to NRS  
9       389.520 and other training listed in subsection 1. The governing body  
10      shall provide a copy of the list on an annual basis to school districts for  
11      dissemination to teachers and administrators.

12      4. A regional training program may include model classrooms that  
13      demonstrate the use of educational technology for teaching and learning.

14      **Sec. 17.** 1. To the extent that money is available from legislative  
15      appropriation or otherwise, a regional training program must pay:

16      (a) The salaries and travel expenses of staff and other personnel  
17      necessary to the operation of the program;

18      (b) Related administrative expenses; and

19      (c) The costs incurred to acquire equipment and space to operate the  
20      program.

21      2. To the extent that money is available from legislative  
22      appropriation or otherwise, a regional training program may provide  
23      incentives for teachers to attend the regional training program,  
24      including, without limitation:

25      (a) Arrangement for credit toward renewal of a license or an  
26      endorsement for a license;

27      (b) Provision of books, supplies or instructional materials for the  
28      classrooms; and

29      (c) Provision of stipends.

30      **Sec. 18.** The governing body of each regional training program  
31      shall:

32      1. Establish a method for the evaluation of the success of the  
33      regional training program. The method must be consistent with the  
34      uniform procedures adopted by the statewide council pursuant to section  
35      10 of this act.

36      2. On or before July 1 of each year, submit an annual report to the  
37      state board, the commission, the legislative committee on education and  
38      the legislative bureau of educational accountability and program  
39      evaluation that includes:

40      (a) The priorities for training adopted by the governing body pursuant  
41      to section 15 of this act;

42      (b) The type of training offered through the program in the  
43      immediately preceding year;

44      (c) The number of teachers and administrators who received training  
45      through the program in the immediately preceding year;

46      (d) An evaluation of the success of the program in accordance with  
47      the method adopted pursuant to subsection 1; and

42 **Sec. 33.** The legislature hereby finds and declares that a general law  
43 cannot be made applicable for the provisions of sections 5 to 19, inclusive,  
44 of this act because of the geographic diversity of the areas served by the  
45 school districts in this state which creates a need for the training of teachers  
46 and administrators that is specific to the region in which those teachers and  
47 administrators are employed. The legislature believes that the creation of  
48 regional training programs for the professional development of teachers  
49 and administrators is the most effective way to provide high quality and



1 effective professional development training for the teachers and  
2 administrators employed in this state.

3 **Sec. 34.** On or before July 1, 2001, appointments must be made to the  
4 governing body of each regional training program for the professional  
5 development of teachers and administrators pursuant to section 11 of this  
6 act to terms commencing on that date. A person who serves on a governing  
7 body before July 1, 2001, may be reappointed pursuant to this section. If a  
8 person who serves on a governing body before July 1, 2001, is reappointed  
9 pursuant to this section, his appointment shall be deemed his first term for  
10 purposes of subsection 3 of section 11 of this act.

11 **Sec. 35.** On or before September 1, 2001, the governing body of each  
12 regional training program shall appoint a coordinator of the program  
13 pursuant to section 13 of this act.

14 **Sec. 36.** On or before September 1, 2001, appointments must be made  
15 to the statewide council for the coordination of the regional training  
16 programs created pursuant to section 9 of this act.

17 **Sec. 37.** For purposes of the 2001-2002 school year and the 2002-  
18 2003 school year, the governing body of each regional training program for  
19 the professional development of teachers and administrators may expend a  
20 reasonable amount from the budget of the program to pay for the services  
21 of the coordinator of the program appointed pursuant to section 13 of this  
22 act. The amount expended pursuant to this section must comply with the  
23 budget submitted by the governing body to the legislative bureau of  
24 educational accountability and program evaluation for the 2001-2003  
25 biennium.

26 **Sec. 38.** Commencing in the 2003-2004 school year, the high school  
27 proficiency examination that, pursuant to NRS 389.015, pupils must pass  
28 to receive a standard high school diploma must measure the performance  
29 of pupils on the standards of content and performance in science  
30 established by the council to establish academic standards for public  
31 schools pursuant to NRS 389.520 and adopted by the state board of  
32 education. The high school proficiency examination that measures the  
33 performance of pupils in the standards of content and performance in  
34 science established by the council to establish academic standards for  
35 public schools must first be administered to pupils enrolled in grade 11 in  
36 the 2003-2004 school year, who must pass the examination before the  
37 completion of grade 12 to graduate with a standard high school diploma in  
38 the 2004-2005 school year. Pupils who graduate in the 2003-2004 school  
39 year are not required to pass the examination that measures the  
40 performance of pupils on the standards in science established by the  
41 council to establish academic standards for public schools, but must pass  
42 the examination that is administered to pupils in the immediately preceding  
43 school year.

44 **Sec. 39.** Notwithstanding the provisions of NRS 389.015 to the  
45 contrary, the board of trustees of a school district and the governing body  
46 of a charter school shall, for the 2002-2003 school year, administer the  
47 norm-referenced examinations on reading, mathematics and science that  
48 are otherwise required to be administered to pupils who are enrolled in  
49 grade 8 to pupils who are enrolled in grade 7, rather than to pupils who are

1 enrolled in grade 8. In addition, the results of the examinations  
2 administered to pupils enrolled in grade 7 must be reported as the results of  
3 the examinations are otherwise reported pursuant to NRS 385.347 and  
4 389.017.

5 **Sec. 40.** 1. If money is appropriated by the legislature for the 2001-  
6 2003 biennium for the development of a new criterion-referenced  
7 examination for pupils who are enrolled in grade 8, the state board of  
8 education shall, on or before December 1, 2002, pursuant to the  
9 recommendations of the council to establish academic standards for public  
10 schools, develop or purchase examinations that measure the achievement  
11 and proficiency of pupils who are enrolled in grade 8 on the standards of  
12 content and performance established by the council. The examinations  
13 must be scored by a single entity, the department of education, or a school  
14 district on behalf of the other school districts.

15 2. The department of education shall conduct a pilot program of the  
16 examinations or the questions included on the examinations in the spring  
17 semester of 2002.

18 3. The examinations must be administered to all pupils, as required by  
19 NRS 389.550, commencing in the spring semester of 2003. The results of  
20 those examinations must be used solely to gather information and data  
21 concerning the examinations.

22 **Sec. 41.** 1. The department of education shall allow the legislative  
23 counsel bureau to participate, to the extent practicable, in the process for  
24 the review and selection of contractors for the development, printing,  
25 administration and scoring of examinations that are required pursuant to  
26 NRS 389.015 and 389.550. The department shall provide to the legislative  
27 counsel bureau a copy of any solicitation for bids for such contractors.

28 2. The department of education shall not enter into a contract with a  
29 testing vendor unless the contract includes a provision to allow the testing  
30 vendor to respond to requests by the legislative counsel bureau for  
31 information at no additional cost to the department, to the extent that the  
32 information that is requested will not compromise any proprietary or  
33 confidentiality agreements.

34 **Sec. 42.** The provisions of this act do not apply to offenses committed  
35 before July 1, 2001.

36 **Sec. 43.** 1. This section and sections 3, 5 to 19, inclusive, and 33 to  
37 37, inclusive, of this act become effective upon passage and approval.

38 2. Sections 4, 20, 21, 22, 24 to 28, inclusive, 30, 31, 32 and 38 to 42,  
39 inclusive, of this act become effective on July 1, 2001.

40 3. Sections 1 and 23 of this act become effective at 12:01 a.m. on  
41 July 1, 2001.

42 4. Sections 2 and 29 of this act become effective at 12:02 a.m. on  
43 July 1, 2001.
