ASSEMBLY RESOLUTION—Adopting the Rules of the Assembly for the 18th Special
Session of the Nevada Legislature.

1 RESOLVED BY THE ASSEMBLY OF THE STATE OF NEVADA, That the
2 following Rules of the Assembly for the 18th Special Session of the
3 Legislature are hereby adopted:

5 **I. APPLICABILITY**
6

7 **Rule No. 1. Generally.**

8 ***The Rules of the Assembly for the 18th Special Session of the***
9 ***Legislature are applicable only during the 18th Special Session of the***
10 ***Legislature.***

11
12 **II. OFFICERS AND EMPLOYEES**
13

14 **Rule No. 2. Speaker of the Assembly.**

15 ***1. All officers of the Assembly are subordinate to the Speaker in all***
16 ***that relates to the prompt, efficient and correct discharge of their official***
17 ***duties under the Speaker's supervision.***

18 ***2. Possessing the powers and performing the duties described in this***
19 ***rule, the Speaker shall:***

20 ***(a) Take the chair at the hour to which the Assembly will be meeting,***
21 ***call the members to order, and upon the appearance of a quorum,***
22 ***proceed to business.***

23 ***(b) Preserve order and decorum and have general direction of the***
24 ***chamber of the Assembly and the approaches thereto. In the event of any***
25 ***disturbance or disorderly conduct therein, order the same to be cleared.***

26 ***(c) Decide all questions of order, subject to a member's right to appeal***
27 ***to the Assembly. On appeal from such decisions, the Speaker has the***
28 ***right, in the Speaker's place, to assign the reason for the decision.***

- 1 (d) Have the right to name any member to perform the duties of the
2 chair, but such substitution must not extend beyond one legislative day.
3 (e) If the Assembly resolves itself into a Committee of the Whole,
4 name a chairman to preside thereover and call him to the chair.
5 (f) Have the power to accredit the persons who act as representatives
6 of the news media and assign them seats.
7 (g) Sign all bills and resolutions passed by the Legislature as provided
8 by law.
9 (h) Sign all subpoenas issued by the Assembly.
10 (i) Receive all messages and communications from other departments
11 of the government and announce them to the Assembly.
12 (j) Represent the Assembly, declare its will and in all things obey its
13 commands.
14 (k) Vote on final passage of a bill or resolution, but the Speaker shall
15 not be required to vote in ordinary legislative proceedings except where
16 the Speaker's vote would be decisive. In all yea and nay votes, the
17 Speaker's name must be called last.
18 3. If a vacancy occurs in the office of Speaker, through death,
19 resignation or disability of the Speaker, the Speaker pro Tempore shall
20 temporarily and for the period of vacancy or disability conduct the
21 necessary business of the Assembly.
22 4. If a permanent vacancy occurs in the office of Speaker, the
23 Assembly shall select a new Speaker.

IV. DECORUM AND DEBATE

Rule No. 20. Points of Order.

If any member, in speaking or otherwise, transgresses the rules of the Assembly, the Speaker shall, or any member may, call to order, in which case the member so called to order shall immediately sit down, unless permitted to explain; and if called to order by a member, such member shall immediately state the point of order. If the point of order be sustained by the presiding officer, the member shall not be allowed to proceed; but if it be not sustained, then he shall be permitted to go on. Every such decision from the presiding officer shall be subject to an appeal to the House; but no discussion of the question of order shall be allowed unless an appeal be taken from the decision of the presiding officer.

Rule No. 21. Portable electronic communication devices.

1. A person who is within the Assembly Chambers shall not engage in a telephone conversation via the use of a portable telephone.

2. Before entering the Assembly Chambers, any person who possesses a portable electronic communication device, such as a pager or telephone, that emits an audible alert, such as a ringing or beeping sound, to signal an incoming message or call shall turn the audible alert off. A device that contains a nonaudible alert, such as a silent vibration, may be operated in a nonaudible manner within the Assembly Chambers.

V. QUORUM, VOTING, ELECTIONS

Rule No. 30. Manner of Voting.

1. The presiding officer shall declare all votes, but the yeas and nays must be taken when called for by three members present, and the names of those calling for the yeas and nays must be entered in the Journal by the Chief Clerk.

2. The presiding officer shall call for yeas and nays by a division or by a roll call, either electronic or oral.

3. When taking the yeas and nays on any question, the electronic roll call system may be used, and when so used shall have the force and effect of any roll call under these rules.

4. When taking the yeas and nays by oral roll call, the Chief Clerk shall take the names of members alphabetically, except that the Speaker's name must be called last.

5. The electronic roll call system may be used to determine the presence of a quorum.

1 6. The yeas and nays must not be taken with the electronic roll call
2 system until all members present are at their desks. The presiding officer
3 may vote at the rostrum.

4 7. Only a member who is physically present within the Assembly
5 Chambers may cast a vote in the Assembly.

6 8. A member shall not vote for another member on any roll call,
7 either electronic or oral. Any member who votes for another member
8 may be punished in any manner deemed appropriate by the Assembly.

12 Rule No. 32. Announcement of the Vote.

13 1. A member may change his vote at any time before the
14 announcement of the vote if the voting is by voice, or at any time before
15 the votes are electronically recorded if the voting is conducted
16 electronically.

17 2. The announcement of the result of any vote shall not be
18 postponed.

19
20 Rule No. 33. Voting by Division.

21 Upon a division and count of the Assembly on any question, no person
22 without the bar shall be counted.

23

26 VI. LEGISLATIVE BODIES

27
28 Rule No. 40. Standing Committees.

29 The standing committees of the Assembly are as follows:

30 1. Elections, Procedures, and Ethics.

31 2. Medical Malpractice Issues.

32 3. Ways and Means.

33
34 Rule No. 41. Appointment of Committees.

35 All committees must be appointed by the Speaker, unless otherwise
36 directed by the Assembly. The Speaker shall determine the appropriate
37 number of members for each committee and shall designate the
38 chairman and vice chairman of each committee.

39
40 Rule No. 42. Committee Action.

41 1. The committee shall have meetings in accordance with the
42 direction of the Assembly leadership. A quorum of the committee is a
43 majority of its appointed members and may transact business except as
44 limited by this rule.

45 2. Except as limited by this rule, a simple majority of those present
46 may move, second and pass a motion by voice vote.

47 3. Definite action on a bill or resolution will require a majority of the
48 entire committee.



1 4. A two-thirds majority of the entire committee is required to
2 reconsider action on a bill or resolution.

3 5. Committee introduction of legislative measures requires
4 concurrence of a majority of the members of the entire committee and
5 requires a commitment from each such concurring member to support
6 final passage. A decision by a committee to request the drafting of an
7 amendment for a bill requires concurrence of a majority of the members
8 of the entire committee and requires a commitment from each such
9 concurring member to support the amendment when it is considered on
10 the floor of the Assembly.

11 6. The chairman shall vote on all final action regarding bills or
12 resolutions.

13 7. No member of the committee may vote by proxy under any
14 circumstances.

15 8. A committee shall not take a vote on the question of whether to
16 exercise its statutory authority to issue a legislative subpoena unless the
17 chairman has informed the Speaker of the intention of the committee to
18 consider such a question.

19
20 **Rule No. 43. Subcommittees.**

21 Subcommittees made up of committee members may be appointed by
22 the chairman to consider and report back on specific subjects or bills.

23
24 **Rule No. 44. Committee on Elections, Procedures, and Ethics.**

25 The Committee on Elections, Procedures, and Ethics has jurisdiction
26 over matters relating to personnel. It shall recommend by resolution the
27 appointment of all attachés and employees of the Assembly not otherwise
28 provided for by law. It may suspend or remove any such attaché or
29 employee for incompetency or dereliction of duty. It shall function as the
30 Committee on Credentials of the Assembly.

31
32 **Rule No. 45. Approval of Committee on Medical Malpractice Issues**
33 **Required Before Submission to Legislative Counsel of Request for**
34 **Drafting of Bill, Resolution or Amendment.**

35 Except as otherwise provided in this rule and in Joint Rule No. 2 for
36 requests by a conference committee, a majority of the members appointed
37 to the Committee on Medical Malpractice Issues must approve any
38 request for the drafting of a bill, resolution or amendment during the
39 18th Special Session before it is submitted to the Legislative Counsel.
40 The Speaker may request the drafting of one bill for the 18th Special
41 Session without seeking the approval of the Committee on Medical
42 Malpractice Issues. The Legislative Counsel shall not honor a request for
43 the drafting of a bill, resolution or amendment to be introduced in the
44 Assembly, unless it is submitted by the Committee on Medical
45 Malpractice Issues or a Conference Committee.

46
47 **Rule No. 46. Committee Action on Reports.**

48 Committee reports must be adopted at a committee session actually
49 assembled and meeting as a committee with a quorum present. Every



1 *committee vote on a matter pertaining to a bill or resolution must be*
2 *recorded. The vote may be taken by roll call at the discretion of the*
3 *chairman.*

4
5 **Rule No. 47. Committee Records.**

6 *The chairman of each committee shall keep, or cause to be kept, a*
7 *complete record of the committee proceedings in which there must be*
8 *entered:*

- 9 1. *The time and place of each meeting;*
10 2. *The attendance and absence of members;*
11 3. *The names of all persons appearing before the committee, with the*
12 *names of persons, firms, corporations or associations in whose behalf*
13 *such appearance is made; and*
14 4. *The subjects or measures considered and action taken.*

15
16 **Rule No. 48. Disposition of Committee Records.**

17 *All minutes, records and documents in the possession of committees*
18 *and their chairmen must be filed in the offices of the Legislative Counsel*
19 *Bureau upon adjournment sine die.*

20
21 **Rule No. 49. Committee Hearings.**

- 22 1. *The presence of a quorum of the committee is desirable but not*
23 *required to conduct a public hearing. At the discretion of the chairman,*
24 *members of the committee may attend, participate in and, if applicable,*
25 *vote during the hearing via simultaneous telephone or video conference.*
26 2. *Public hearings are opened by the chairman who announces the*
27 *subject under consideration and provides for those wishing to address the*
28 *committee to be heard. These persons shall rise in an order determined*
29 *by the chairman, address the chair and furnish their names, addresses*
30 *and firms or other organizations represented. Committee members may*
31 *address the chairman for permission to question the witness.*

37 **Rule No. 52. Concurrent Referrals.**

38 *When a bill or resolution is referred to two committees, the bill or*
39 *resolution must go to the first committee named. If the first committee*
40 *votes to amend the bill or resolution, it must be reprinted with*
41 *amendments and then returned to the first committee or sent immediately*
42 *to the next committee. If there is no amendment proposed by the first*
43 *committee, or if the first committee acts upon the bill or resolution after*
44 *amendment, the bill or resolution must be sent with the committee*
45 *recommendation immediately to the second committee.*

46

VII. RULES GOVERNING MOTIONS

A. PROCEDURE

Rule No. 60. Entertaining.

No motion may be debated until it is distinctly announced by the presiding officer. If desired by the presiding officer or any member, the motion must be reduced to writing and be read by the Chief Clerk before the motion is debated. A motion may be withdrawn by the maker at any time before amendment or before the motion is put to vote.

Rule No. 61. Reserved.

B. PARTICULAR MOTIONS

Rule No. 65. Indefinite Postponement.

When a question is postponed indefinitely, the same question must not be considered again during the 18th Special Session of the Legislature and the question is not subject to a motion for reconsideration.

Rule No. 66. To Strike Enacting Clause.

A motion to strike out the enacting clause of a bill or resolution does not take precedence over any other subsidiary motion. If the motion is carried, it shall be considered equivalent to the rejection of such bill or resolution.

Rule No. 67. Division of Question.

Any member may call for a division of the question, which shall be divided, if it comprehends propositions in substance so distinct that, one being taken away, a substantive proposition shall remain for the decision of the Assembly. A motion to strike out being lost shall preclude neither amendment nor a motion to strike out and insert. A motion to strike out and insert shall be deemed indivisible.

Rule No. 68. To Reconsider.

No motion to reconsider a vote is in order.

VIII. DEBATE

Rule No. 80. Speaking on Question.

No member shall speak more than twice during the consideration of any one question, on the same day, and at the same stage of proceedings, without leave. Members who have once spoken shall not again be entitled to the floor (except for explanation) to the exclusion of others who have not spoken.

Rule No. 81. Previous Question.

The previous question shall be put only when demanded by three members. The previous question shall not be moved by the member last speaking on the question.

Rule No. 82. Privilege of Closing Debate.

The author of a bill, a resolution or a main question shall have the privilege of closing the debate, unless the previous question has been sustained.

IX. CONDUCT OF BUSINESS

A. RULES AND PROCEDURE

Rule No. 90. Mason's Manual.

The rules of parliamentary practice contained in Mason's Manual of Legislative Procedure shall govern the Assembly in all cases in which they are applicable and in which they are not inconsistent with the Rules and orders of the Assembly for the 18th Special Session of the Legislature, and the Joint Rules of the Senate and Assembly for the 18th Special Session of the Legislature.

Rule No. 91. Rescission, Change or Suspension of Rule.

No rule or order of the Assembly for the 18th Special Session of the Legislature may be rescinded or changed without a vote of two-thirds of the members elected, and one day's notice being given of the motion therefor; but a rule or order may be suspended temporarily by a vote of two-thirds of the members present.

Rule No. 92. Notices of Bills, Topics and Public Hearings.

1. Except as otherwise provided in subsection 3, all committees shall provide adequate notice of public hearings on bills, resolutions or other topics which are to come before the committees. The notice must include the date, time, place and agenda to be covered. The notice must be posted conspicuously in the legislative building, appear in the daily history and be made available to the news media. The daily history must include the most current version of the notice that is available at the time the daily history is created and an informational statement informing the public

1 where more current information, if any, regarding such notices may be
2 found.

3 2. The noticing requirements of this rule may be suspended for
4 emergency situations but only after approval by a two-thirds vote of a
5 committee.

6 3. Subsection 1 does not apply to:

7 (a) Committee meetings held on the floor of the Assembly during a
8 recess; or

9 (b) Conference committee meetings.

10

11 Rule No. 93. Reserved.

12

13 Rule No. 94. Privilege of the Floor and Lobbying.

14 No person, except Senators, former Assemblymen and state officers,
15 may be admitted at the bar of the Assembly, except by special invitation
16 on the part of some member; but a majority may authorize the Speaker to
17 have the Assembly cleared of all such persons. No person may do any
18 lobbying upon the floor of the Assembly at any time, and it is the duty of
19 the Sergeant at Arms to remove any person violating any of the
20 provisions of this rule.

21

22 Rule No. 95. Material Placed on Legislators' Desks.

23 All papers, letters, notes, pamphlets and other written material placed
24 upon an Assemblyman's desk shall contain the signature of the
25 Legislator requesting the placement of such material on the desk or shall
26 contain a designation of the origin of such material. This rule does not
27 apply to books containing the legislative bills and resolutions, the
28 legislative daily histories, the legislative daily journals or Legislative
29 Counsel Bureau material.

30

31 Rule No. 96. Peddling, Begging and Soliciting.

32 1. Peddling, begging and soliciting are strictly forbidden in the
33 Assembly Chamber, and in the lobby, gallery and halls adjacent thereto.

34 2. No part of the Assembly Chamber may be used for, or occupied by
35 signs or other devices for any kind of advertising.

36 3. No part of the hallways adjacent to the Assembly Chambers may
37 be used for or occupied by signs or other devices for any kind of
38 advertising for commercial or personal gain. Notices for nonprofit,
39 nonpartisan, civic or special legislative events may be posted in a
40 designated area of the hallways adjacent to the Assembly Chambers with
41 the approval of the Chief Clerk.

42

43 Rule No. 97. Petitions and Memorials.

44 Petitions, memorials and other papers addressed to the Assembly, shall
45 be presented by the Speaker, or by a member in the Speaker's place. A
46 brief statement of the contents thereof shall be made by the introducer.
47 They shall not be debated on the day of their being presented, but shall
48 be on the table, or be referred, as the Assembly shall determine.



1 **Rule No. 98. Request of Purpose.**
2 *A member may request the purpose of a bill or joint resolution upon its*
3 *introduction.*

4
5 **Rule No. 99. Remarks.**
6 *It shall be in order for members to make remarks and to have such*
7 *remarks entered in the Journal.*

8
9 **Rule No. 100. Precedence of Parliamentary Authority.**
10 *The precedence of parliamentary authority in the Assembly is:*
11 *1. The Constitution of the State of Nevada.*
12 *2. The Statutes of the State of Nevada.*
13 *3. The Rules of the Assembly for the 18th Special Session of the*
14 *Legislature and the Joint Rules of the Senate and Assembly for the 18th*
15 *Special Session of the Legislature.*
16 *4. Mason's Manual of Legislative Procedure.*

17
18 **Rule No. 101. Reserved.**

19
20 **Rule No. 102. Privileged Questions.**
21 *Privileged questions have precedence of all others in the following*
22 *order:*
23 *1. Motions to fix the time to which the Assembly shall adjourn.*
24 *2. Motions to adjourn.*
25 *3. Questions relating to the rights and privileges of the Assembly or*
26 *any of its members.*
27 *4. A call of the House.*
28 *5. Motions for special orders.*

29
30 **Rule No. 103. Reserved.**

31
32 **B. BILLS**

33
34 **Rule No. 104. Reserved.**

35
36 **Rule No. 105. Substitute Bills.**
37 *A substitute bill shall be deemed and held to be an amendment, and*
38 *treated in all respects as such. However, a substitute bill may be amended*
39 *after its adoption, in the same manner as if it were an original bill.*

40
41 **Rule No. 106. Skeleton Bills.**
42 *The introduction of skeleton bills is not authorized.*

43
44 **Rule No. 107. Reserved.**

45
46 **Rule No. 108. Reserved.**



1 **Rule No. 109. Reading of Bills.**

2 *The presiding officer shall announce at each reading of a bill whether*
3 *it be the first, second or third reading. The first reading of a bill shall be*
4 *for information. If there is objection, the question shall be, "Shall the bill*
5 *be rejected?" If the question to reject fails to receive a majority vote by*
6 *the members present, or if there is no objection, the bill shall take the*
7 *proper course. No bill shall be referred to a committee until after the first*
8 *reading, nor amended until after the second reading.*

9
10 **Rule No. 110. Second Reading and Amendment of Bills.**

11 *1. All bills must be read the second time after which they are*
12 *reported by committee. Upon second reading, Assembly bills reported*
13 *without amendments shall be placed on the General File and Senate bills*
14 *reported without amendments shall be placed on the General File.*
15 *Committee amendments reported with bills shall be considered upon*
16 *their second reading, and such amendments may be adopted by a*
17 *majority vote of the members present. Any amendment which is*
18 *numbered, copied and made available to all members must be moved and*
19 *voted upon by number unless any member moves that it be read in full.*
20 *Assembly bills so amended must be reprinted, engrossed, and placed on*
21 *the General File. Senate bills so amended must be reprinted, then*
22 *engrossed or reengrossed, as applicable, and placed on the General File.*

23 *2. Only amendments proposed by the Committee on Medical*
24 *Malpractice Issues or a conference committee may be considered on the*
25 *floor of the Assembly. Such a motion to amend may be adopted on the*
26 *floor of the Assembly by a majority vote of the members present. Bills so*
27 *amended on second reading must be treated the same as bills with*
28 *amendments proposed by a committee. Any bill so amended upon the*
29 *General File must be reprinted and then engrossed or reengrossed, as*
30 *applicable.*

31 *3. The reprinting of amended bills may be dispensed with only in*
32 *accordance with the provisions of law.*

33
34 **Rule No. 111. Consent Calendar.**

35 *1. A committee may by unanimous vote of the members present*
36 *report a bill with the recommendation that it be placed on the consent*
37 *calendar. The question of recommending a bill for the consent calendar*
38 *may be voted upon in committee only after the bill has been*
39 *recommended for passage and only if no amendment is recommended.*

40 *2. The Chief Clerk shall maintain a list of bills recommended for the*
41 *consent calendar. The list must be printed in the daily history and must*
42 *include the summary of each bill, and the date the bill is scheduled for*
43 *consideration on final passage.*

44 *3. At any time before the presiding officer calls for a vote on the*
45 *passage of the consent calendar, a member may give written notice to the*
46 *Chief Clerk or state orally from the floor of the Assembly in session that*
47 *he requests the removal of a particular bill from the consent calendar. If*
48 *a member so requests, the Chief Clerk shall remove the bill from the*



1 consent calendar and transfer it to the second reading file. A bill
2 removed from the consent calendar may not be restored to that calendar.

3 4. During floor consideration of the consent calendar, members may
4 ask questions and offer explanations relating to the respective bills.

5 5. When the consent calendar is brought to a vote, the bills
6 remaining on the consent calendar must be read by number and
7 summary and the vote must be taken on their final passage as a group.
8

9 Rule No. 112. Reserved.

10
11 Rule No. 113. General File.

12 All bills reported to the Assembly, after receiving their second readings
13 must be placed upon a General File, to be kept by the Chief Clerk. Bills
14 must be taken from the General File and acted upon in the order in
15 which they were reported, unless otherwise specially ordered by the
16 Assembly. But engrossed bills shall be placed at the head of the file, in
17 the order in which they are received. The Chief Clerk shall post a daily
18 statement of the bills on the General File, setting forth the order in which
19 they are filed, and specifying the alterations arising from the disposal of
20 business each day. The Chief Clerk shall likewise post notices of special
21 orders as made.

25 Rule No. 115. Reserved.

26
27 Rule No. 116. Vetoed Bills.

28 Bills that have passed both Houses of the Legislature and are
29 transmitted to the Assembly accompanied by a message or statement of
30 the Governor's disapproval or veto of the same must be taken up and
31 considered immediately upon the coming in of the message transmitting
32 the same, or become the subject of a special order. When the message is
33 received, or (if made a special order) when the special order is called, the
34 said message or statement must be read together with the bill or bills so
35 disapproved or vetoed. The message and bill must be read by the Chief
36 Clerk without interruption, consecutively, one following the other, and
37 not upon separate occasions. No such bill or message may be referred to
38 any committee, or otherwise acted upon save as provided by law and
39 custom; that is to say, that immediately following such reading the only
40 question (except as hereinafter stated) which may be put by the Speaker
41 is, "Shall the bill pass, notwithstanding the objections of the Governor?"
42 It shall not be in order, at any time, to vote upon such a vetoed bill unless
43 the same shall first have been read, from the first word of its title to and
44 including the last word of its final section. No motion may be entertained
45 after the Speaker has stated the question, save a motion to adjourn or a
46 motion for the previous question, but the merits of the bill itself may be
47 debated. The message or statement containing the objections of the
48 Governor to the bill must be entered in the Journal of the Assembly. The



1 *consideration of a vetoed bill, and the objections of the Governor thereto,*
2 *shall be a privileged question, and shall take precedence over all others.*

8 *Rule No. 118. Treated as Bills—Joint Resolutions.*

9 *The procedure of enacting joint resolutions must be identical to that of*
10 *enacting bills. However, joint resolutions proposing amendments to the*
11 *Constitution must be entered in the Journal in their entirety.*

13 *Rule No. 119. Reserved.*

15 D. ORDER OF BUSINESS

16
17 *Rule No. 120. Order of Business.*

18 *The Order of Business must be as follows:*

- 19 1. *Call to Order.*
