Declared an Emergency Measure

SUMMARY—Makes conditional appropriations to National Judicial College and Louis W. McHardy National College of Juvenile and Family Justice. (BDR S-52)

AN ACT making conditional appropriations to the National Judicial College and the Louis W. McHardy National College of Juvenile and Family Justice; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. Notwithstanding the provisions of
2 NRS 353.235:
3 (a) Upon receipt of the projections and estimates of the
4 Economic Forum required by paragraph (d) of subsection 1 of NRS
5 353.228 to be reported on or before December 1, 2004, the Interim
6 Finance Committee shall project:
7 (1) The ending balance of the State General Fund for Fiscal
8 Year 2004-2005, using all relevant information known to it; and
9 (2) The amount, if any, by which the projection required by
10 subparagraph (1) exceeds the sum of:
11 (I) The amount of the ending balance of the State General
12 Fund for Fiscal Year 2004-2005 as estimated by the Nevada
13 Legislature; and
14 (II) The amount of money necessary to fulfill any
15 contingent appropriation required by the Nevada Legislature to the



1 Fund to Stabilize the Operation of the State Government created by
2 NRS 353.288.

3 (b) If the amount projected by the Interim Finance Committee
4 pursuant to subparagraph (2) of paragraph (a) is \$350,000 or more,
5 there is hereby contingently appropriated from the State General
6 Fund to:

7 (1) The National Judicial College the sum of \$225,000 to
8 assist in securing public and private grants and other funding for
9 support; and

10 (2) The Louis W. McHardy National College of Juvenile and
11 Family Justice the sum of \$125,000 to assist in securing public and
12 private grants and other funding for support.

13 (c) If the amount projected by the Interim Finance Committee
14 pursuant to subparagraph (2) of paragraph (a) is more than \$0 but
15 less than \$350,000, there is hereby contingently appropriated from
16 the State General Fund to the National Judicial College and the
17 Louis W. McHardy National College of Juvenile and Family Justice
18 the sum projected by the Interim Finance Committee pursuant to
19 subparagraph (2) of paragraph (a), divided between the National
20 Judicial College and the Louis W. McHardy National College of
21 Juvenile and Family Justice in a manner proportional to the amounts
22 of the contingent appropriations set forth in paragraph (b). The sums
23 appropriated pursuant to this paragraph are for the purposes set forth
24 in paragraph (b).

25 2. Any remaining balance of any contingent appropriation
26 made pursuant to this section must not be committed for expenditure
27 after June 30, 2005, and reverts to the State General Fund as soon as
28 all payments of money committed have been made.

29 **Sec. 2.** This act becomes effective on July 1, 2004.
