SENATE RESOLUTION—Expressing appreciation to Washoe County Chief Deputy District Attorney Daniel Greco for serving as Special Prosecutor in the impeachment proceedings for State Controller Kathy Augustine.

1        WHEREAS, On November 12, 2004, Washoe County Chief  
2        Deputy District Attorney Daniel Greco was appointed to serve as  
3        Special Prosecutor for the impeachment trial of State Controller  
4        Kathy Augustine; and

5        WHEREAS, The appointment of Dan Greco was based upon his  
6        extensive experience as a prosecutor for the Washoe County District  
7        Attorney's Office and his excellent reputation in the legal  
8        community for being dedicated, fair-minded and efficient in the  
9        pursuit of justice; and

10      WHEREAS, With only a short time to prepare for this trial,  
11      Special Prosecutor Greco undertook the enormous responsibility of  
12      ensuring that the State Controller and the people of Nevada received  
13      a fair trial; and

14      WHEREAS, In preparing for the impeachment trial, many  
15      demands were placed upon Special Prosecutor Greco causing him to  
16      work overtime through evenings, weekends and the Thanksgiving  
17      holiday for which, as a professional employee of Washoe County,  
18      he will not be compensated; and



1        WHEREAS, The Special Prosecutor has performed his role  
2 admirably while commuting daily to a “courtroom” that is not a  
3 courtroom to prosecute a unique case that he and his staff neither  
4 investigated nor developed; and

5        WHEREAS, Throughout his tenure as Special Prosecutor, Dan  
6 Greco has demonstrated amazing personal fortitude and strength of  
7 character in carrying out his appointment in unfamiliar  
8 surroundings, with evolving rules of procedure and an impossibly  
9 short time to prepare; now, therefore, be it

10      RESOLVED BY THE SENATE OF THE STATE OF NEVADA, That the  
11 members of the Senate of the 21st Special Session of the Nevada  
12 Legislature do hereby express their sincere appreciation to Dan  
13 Greco for serving as Special Prosecutor for these historic  
14 impeachment proceedings; and be it further

16 Dan Greco for a job well done; and be it further

17      RESOLVED, That the Secretary of the Senate prepare and
