

ASSEMBLY BILL NO. 4—COMMITTEE OF THE WHOLE

Declared an Emergency Measure

AN ACT relating to education; making an appropriation for certain schools to provide full-day kindergarten; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
2 General Fund to the Department of Education for the Fiscal Year
3 2006-2007 the sum of \$22,000,000 for school districts to provide
4 full-day kindergarten at certain schools. The sum must be included
5 in the Account for Programs for Innovation and the Prevention of
6 Remediation.
7 2. The Department of Education shall distribute the allocation
8 made by subsection 1 to school districts that elect to provide full-
9 day kindergarten during the 2006-2007 school year at certain
10 schools within the school district. In no event is a school district
11 required to submit an application for an allocation of money or
12 otherwise required to provide full-day kindergarten.
13 3. Except as otherwise provided in subsection 4, a school
14 district that elects to receive an allocation of money pursuant to this
15 section shall use the money to provide full-day kindergarten in each
16 school within the school district that is prioritized for full-day
17 kindergarten based upon the percentage of pupils enrolled in the
18 school who are eligible for free or reduced price lunches pursuant to



1 42 U.S.C. §§ 1751 et seq. A school district shall allocate the money
2 by assigning first priority to those schools within the school district
3 that have the highest percentage of pupils who are eligible for free
4 or reduced price lunches. If a school within a school district that is
5 required to provide full-day kindergarten pursuant to this section
6 currently provides full-day kindergarten with money that it receives
7 from the Federal Government or other funding allocations, the
8 school may redirect that money, to the extent authorized by
9 applicable federal law, for other programs of remediation at the
10 school and use the money provided by the Department of Education
11 from the allocation to provide full-day kindergarten during the
12 2006-2007 school year.

13 4. A school that is otherwise required to provide full-day
14 kindergarten pursuant to subsection 3 may opt out of providing full-
15 day kindergarten.

16 5. A parent or legal guardian of a pupil who is otherwise zoned
17 to attend a public school that provides full-day kindergarten
18 pursuant to this section may request that the pupil not be enrolled in
19 full-day kindergarten. The school district in which the pupil is
20 enrolled shall grant the request and ensure that the pupil is allowed
21 to attend kindergarten, whether at the zoned school or another
22 school, for less than a full day.

23 **Sec. 2.** This act becomes effective on July 1, 2005.
