
ASSEMBLY BILL NO. 7—COMMITTEE OF THE WHOLE

JUNE 7, 2005

Declared an Emergency Measure

SUMMARY—Makes appropriations to Nevada Commission on Sports to fund operational expenses and to Big Brothers Big Sisters of Northern Nevada, Inc., for costs relating to purchase of facility. (BDR S-21)

AN ACT making appropriations to the Nevada Commission on Sports to fund operational expenses and to Big Brothers Big Sisters of Northern Nevada, Inc., for costs relating to the purchase of a facility; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
2 General Fund to the Nevada Commission on Sports the sum of
3 \$100,000 to fund the operational expenses of the Nevada
4 Commission on Sports.
5 2. Upon acceptance of the money appropriated by subsection
6 1, the Nevada Commission on Sports shall:
7 (a) Prepare and transmit a report to the Interim Finance
8 Committee on or before December 15, 2006, that describes each
9 expenditure made from the money appropriated by subsection 1
10 from the date on which the money was received by the Nevada
11 Commission on Sports through December 1, 2006; and
12 (b) Upon request of the Legislative Commission, make
13 available to the Legislative Auditor any of the books, accounts,
14 claims, reports, vouchers or other records of information,



1 confidential or otherwise, of the Nevada Commission on Sports,
2 regardless of their form or location, that the Legislative Auditor
3 deems necessary to conduct an audit of the use of the money
4 appropriated pursuant to subsection 1.

5 3. Any remaining balance of the appropriation made by
6 subsection 1 must not be committed for expenditure after June 30,
7 2007, and must be reverted to the State General Fund on or before
8 September 21, 2007.

9 **Sec. 2.** 1. There is hereby appropriated from the State
10 General Fund to Big Brothers Big Sisters of Northern Nevada, Inc.,
11 the sum of \$25,000 to be used toward the payment of the cost of a
12 facility for use by the organization.

13 2. Upon acceptance of the money appropriated by subsection
14 1, the Big Brothers Big Sisters of Northern Nevada, Inc., shall:

15 (a) Prepare and transmit a report to the Interim Finance
16 Committee on or before December 15, 2006, that describes each
17 expenditure made from the money appropriated by subsection 1
18 from the date on which the money was received by the Big Brothers
19 Big Sisters of Northern Nevada, Inc., through December 1, 2006;
20 and

21 (b) Upon request of the Legislative Commission, make
22 available to the Legislative Auditor any of the books, accounts,
23 claims, reports, vouchers or other records of information,
24 confidential or otherwise, of the Big Brothers Big Sisters of
25 Northern Nevada, Inc., regardless of their form or location, that the
26 Legislative Auditor deems necessary to conduct an audit of the use
27 of the money appropriated pursuant to subsection 1.

28 3. Any remaining balance of the appropriation made by
29 subsection 1 must not be committed for expenditure after June 30,
30 2007, and must be reverted to the State General Fund on or before
31 September 21, 2007.

32 **Sec. 3.** This act becomes effective on July 1, 2005.
