AN ACT relating to state financial administration; authorizing allocation of the proceeds of certain general obligation bonds to the Department of Transportation for the construction, reconstruction, improvement and maintenance of highways; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 347, Statutes of Nevada 2007, at page
2 1636, is hereby amended by adding thereto a new section to be
3 designated sec. 3.5, immediately following sec. 3, to read as
4 follows:

5 ***Sec. 3.5. 1. Any balance of the allocated amounts***
6 ***authorized in section 3 of this act resulting from revisions or***
7 ***deferrals to the scope of projects set forth in that section or***
8 ***from the reduction of money allocated for such projects that***
9 ***are approved by the Interim Finance Committee is hereby***
10 ***authorized to be allocated, upon approval of the Interim***
11 ***Finance Committee, to the Department of Transportation in***
12 ***a total amount not to exceed \$20,000,000 for the purpose of***
13 ***the construction, reconstruction, improvement and***
14 ***maintenance of highways.***

15 ***2. To request an allocation of money pursuant to this***
16 ***section, the Department of Transportation must submit a***

1 *detailed plan for expenditure of the money to the State*
2 *Board of Examiners. Upon review, the State Board of*
3 *Examiners shall transmit the plan with its recommendation*
4 *to the Interim Finance Committee. The Interim Finance*
5 *Committee is not bound to follow the recommendation of*
6 *the State Board of Examiners.*

7 *3. Any money allocated to the Department of*
8 *Transportation pursuant to this section must be deposited in*
9 *the State Highway Fund and expended for the purposes*
10 *described in this section.*

11 **Sec. 2.** Section 42 of chapter 347, Statutes of Nevada 2007, at
12 page 1656, is hereby amended to read as follows:

13 Sec. 42. 1. This section, subsections 1 and 3 of section
14 1 of this act, and sections 2 , **3 and 4** to 41, inclusive, of this
15 act become effective upon passage and approval.

16 2. Subsections 2 and 4 of section 1 of this act become
17 effective on July 1, 2007.

18 **3. Section 3.5 of this act becomes effective on June 30,**
19 **2008.**

20 **Sec. 3.** This act becomes effective upon passage and approval.
