

SENATE BILL NO. 1—SELECT COMMITTEE ON
REDISTRICTING AND ELECTIONS

NOVEMBER 12, 2021

Referred to Select Committee on Redistricting and Elections

SUMMARY—Revises the election districts for members of the Legislature, members of the State Board of Education and Representatives in Congress and the petition districts for certain statewide initiatives or referendums. (BDR 17-9)

AN ACT relating to elections; revising the districts from which members of the Legislature, members of the State Board of Education and Representatives in Congress are elected; revising the petition districts for certain initiatives or referendums proposing statewide ballot measures; authorizing the Chair of the Legislative Commission to direct the Legislative Counsel Bureau to contract for professional and other services for certain actions or proceedings relating to election or petition districts; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Section 5 of Article 4 of the Nevada Constitution provides that it is the
2 mandatory duty of the Legislature after the taking of the decennial census to: (1) fix
3 by law the number of Senators and the number of members of the Assembly; (2)
4 determine the boundaries of the legislative districts; and (3) apportion the number
5 of the members of the Senate and Assembly in each district. Section 13 of Article 1
6 of the Nevada Constitution provides that representation must be apportioned
7 according to population. Finally, Section 13 of Article 15 of the Nevada
8 Constitution requires that the decennial census serve as the basis of representation
9 in both Houses of the Legislature.

10 **Section 2** of this bill revises the boundaries of the 42 Assembly Districts by
11 adopting a shapefile that indicates the areas that comprise each of those districts
12 based upon the data from the Twenty-fourth United States Census, known as the
13 2020 Census. **Section 3** of this bill similarly revises the boundaries of the 21 Senate



14 Districts. **Section 15** of this bill sets forth a graphical representation of the contents
15 of the shapefile for each legislative district and directs the Legislative Counsel to
16 include the graphical representation with the Nevada Revised Statutes. **Sections 1-7**
17 **and 22** of this bill make conforming changes relating to the revised boundaries of
18 the Assembly and Senate Districts. **Section 24** of this bill provides that the
19 provisions of **sections 1-7 and 22** relating to the revised Assembly and Senate
20 Districts become effective on January 1, 2022, for the purpose of filing for office
21 and for nominating and electing the members of the Legislature, and for all other
22 purposes on November 9, 2022, the day after the 2022 General Election and the
23 first day of the new legislative terms. (Nev. Const. Art. 4, §§ 3, 4)

24 Under existing law, the terms of Senators must be allotted by the Legislature so
25 that one-half of their number, as nearly as is possible, must be elected every two
26 years. (Nev. Const. Art. 17, § 10) **Section 16** of this bill provides that the 10
27 Senators who were elected on November 3, 2020, shall serve out the term of office
28 for which they were elected by representing the district to which they were elected
29 through November 8, 2022, and representing the corresponding new Senate District
30 established by the shapefile adopted by **section 3** from November 9, 2022, until the
31 expiration of their current term of office.

32 Under existing law, a person is prohibited from using the term “reelect” in any
33 material, statement or publication supporting the election of a candidate unless the
34 candidate: (1) was elected to the identical office with the same district number in
35 the most recent election to fill that office; and (2) is serving and has served
36 continuously in that office from the beginning of the term to which the candidate
37 was elected. (NRS 294A.330) **Section 17** of this bill, notwithstanding this
38 prohibition on the use of the term “reelect,” authorizes each Senator who was
39 elected on November 6, 2018, and serves continuously in that office to use the term
40 “reelect” in the 2022 election when running for the Senate from the same new
41 corresponding Senate District if he or she is otherwise qualified for election to that
42 office. **Section 17** similarly authorizes each member of the Assembly who was
43 elected on November 3, 2020, and serves continuously in that office to use the term
44 “reelect” in the 2022 election when running for the same new corresponding
45 Assembly District if he or she is otherwise qualified for election to that office.

46 Section 2 of Article I of the United States Constitution requires that
47 congressional representatives must be apportioned among the several states
48 according to population. The apportionment of the number of congressional
49 representatives is based upon the decennial census. Currently, Nevada is
50 apportioned four congressional representatives and, based upon the results of the
51 2020 Census, remains apportioned four congressional representatives.

52 **Section 9** of this bill revises the boundaries of the existing congressional
53 districts by adopting a shapefile that indicates the areas that comprise each of those
54 congressional districts. **Section 15** sets forth a graphical representation of the
55 contents of the shapefile for each congressional district and directs the Legislative
56 Counsel to include the graphical representation with the Nevada Revised Statutes.
57 **Sections 9-13 and 23** of this bill make conforming changes relating to the revised
58 boundaries of the congressional districts. **Section 24** provides that the provisions of
59 **sections 9-13 and 23** relating to the revised congressional districts become
60 effective on January 1, 2022, for the purposes of filing for office and for
61 nominating and electing the congressional representatives, and for all other
62 purposes on January 3, 2023, when the congressional representatives begin their
63 terms. (U.S. Const. Amend. XX)

64 Under existing law, the State Board of Education consists of four elected
65 members and several appointed members, and the four elected members must be
66 elected by the registered voters of each existing congressional district. (NRS
67 385.021) Each of the four elected members were last elected in 2020 for four-year
68 terms beginning in January 2021 and ending in January 2025. Because **section 9**



69 revises the boundaries of the existing congressional districts, **section 14** of this bill
70 makes those revised boundaries applicable to the election of the four elected
71 members of the Board. **Section 18** of this bill provides that the four elected
72 members of the Board who were elected to office in 2020: (1) shall be deemed,
73 until the expiration of their current term of office, to be elected from and represent
74 the same new corresponding congressional district; and (2) may use the term
75 “reelect” in campaign materials, statements or publications if they are seeking
76 election in 2024 to the same new corresponding congressional district and are
77 otherwise qualified for election to that office.

78 Under existing law, persons who want to circulate petitions for initiative or
79 referendum proposing state constitutional amendments or other statewide ballot
80 measures cannot begin such circulation before certain dates set forth in the Nevada
81 Constitution. (Nev. Const. Art. 19, §§ 1, 2) In addition, such persons must file the
82 petitions with the Secretary of State before presenting the petitions to the registered
83 voters for their signatures, and if they amend the petitions, they must file the
84 revised petitions with the Secretary of State before presenting the revised petitions
85 to the registered voters for their signatures. (NRS 295.015) When circulating the
86 petitions, they must gather a certain number of signatures from the registered voters
87 within each of the petition districts which have boundaries that are coterminous
88 with each of the existing congressional districts. (NRS 293.069, 293.127563)

89 Because **section 9** revises the boundaries of the existing congressional districts,
90 **section 8** of this bill makes those revised boundaries applicable to the petition
91 districts. **Section 24** provides the provisions of **sections 8-13 and 23** relating to the
92 revised petition districts apply to each petition that is filed with the Secretary of
93 State: (1) on or after passage and approval of this bill; or (2) on or after August 1,
94 2021, and before passage and approval of this bill, if the petition is amended and
95 the revised petition is filed with the Secretary of State on or after passage and
96 approval of this bill.

97 Existing law authorizes the Legislative Commission or, in certain
98 circumstances, the Chair of the Legislative Commission to direct the Legal
99 Division of the Legislative Counsel Bureau to appear in, commence, prosecute,
100 defend or intervene on behalf of the Legislature in any action or proceeding before
101 any court, agency or officer of the United States, this State or any other jurisdiction,
102 or any political subdivision thereof, when deemed necessary or advisable to protect
103 the official interests of the Legislature in the action or proceeding. (NRS 218F.720)
104 **Section 20** of this bill authorizes the Chair of the Legislative Commission to direct
105 the Legislative Counsel Bureau to contract for such professional and other services
106 as the Director of the Legislative Counsel Bureau determines are necessary or
107 advisable for the Legislature to appear in, commence, prosecute, defend or
108 intervene in any action or proceeding relating to any election or petition district.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 218B of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 2 and 3 of this act.

3 **Sec. 2.** *The shapefile identified as*
4 *“2021Assembly_Final_SBI_Amd2,” filed with the Secretary of*
5 *State pursuant to NRS 218B.180, is hereby adopted to describe the*
6 *assembly districts in this State.*



1 **Sec. 3.** *The shapefile identified as*
2 *“2021Senate_Final_SBI_Amd2,” filed with the Secretary of State*
3 *pursuant to NRS 218B.180, is hereby adopted to describe the*
4 *senate districts in this State.*

5 **Sec. 4.** NRS 218B.100 is hereby amended to read as follows:

6 218B.100 1. The assembly districts described in ~~[NRS~~
7 ~~218B.600 to 218B.805, inclusive,]~~ *the shapefile adopted by section*
8 *2 of this act* are hereby created.

9 2. The ~~[senatorial]~~ *senate* districts described in ~~[NRS 218B.300~~
10 ~~to 218B.390, inclusive,]~~ *the shapefile adopted by section 3 of this*
11 *act* are hereby created . ~~[, and the numbers of Senators designated~~
12 ~~therein are apportioned to each respectively.]~~

13 3. Each Legislator must be elected from within the district
14 wherein the Legislator resides by the registered voters residing in
15 that district.

16 **Sec. 5.** NRS 218B.150 is hereby amended to read as follows:

17 218B.150 1. If any area of this State is omitted from the
18 ~~[provisions of this chapter]~~ *shapefiles adopted by sections 2 and 3*
19 *of this act* inadvertently or by virtue of the complexities of the
20 information supplied to the Legislature, the county clerk, the Carson
21 City Clerk or the Director, upon discovery of the omission, shall
22 notify the Secretary of State of the omission. The Secretary of State
23 shall attach that area to the appropriate assembly district or
24 ~~[senatorial]~~ *senate* district as follows:

25 (a) If the area is surrounded by an assembly district or
26 ~~[senatorial]~~ *senate* district, the area must be attached to that district.

27 (b) If the area is contiguous to two or more assembly districts or
28 ~~[senatorial]~~ *senate* districts, the area must be attached to the district
29 that has the least population.

30 2. Any attachments made pursuant to the provisions of this
31 section must be certified in writing and filed with the Director and
32 with the Secretary of State. No change may be made in any
33 attachments until the Legislature is again reapportioned.

34 **Sec. 6.** NRS 218B.180 is hereby amended to read as follows:

35 218B.180 The Director shall:

36 1. *File a copy of the shapefiles adopted by sections 2 and 3 of*
37 *this act with the Secretary of State.*

38 2. Retain in an office of the Legislative Counsel Bureau, copies
39 of maps of the legislative districts described in ~~[this chapter,]~~ *the*
40 *shapefiles adopted by sections 2 and 3 of this act.*

41 ~~[2.]~~ 3. Make available copies of the maps to any interested
42 person for a reasonable fee, not to exceed the actual costs of
43 producing copies of the maps.



~~[3.]~~ 4. File a copy of the maps with the Secretary of State.

Sec. 7. NRS 218B.190 is hereby amended to read as follows:

218B.190 The Secretary of State shall:

1. Provide to the clerk of each county and the Clerk of Carson City, copies of the *shapefiles filed pursuant to subsection 1 of NRS 218B.180 and* maps filed pursuant to subsection ~~[3]~~ 4 of NRS 218B.180.

2. Make available copies of the *shapefiles and* maps to any interested person for a reasonable fee, not to exceed the actual costs of producing copies of the *shapefiles or* maps.

Sec. 8. NRS 293.069 is hereby amended to read as follows:

293.069 "Petition district" means a district ~~[created pursuant to the provisions of NRS 304.060 to 304.120, inclusive,]~~ *described in the shapefile adopted by section 9 of this act* for the election of Representatives in Congress.

Sec. 9. Chapter 304 of NRS is hereby amended by adding thereto a new section to read as follows:

1. *The shapefile identified as "2021 Congressional Final SB1 Amd2," filed with the Secretary of State pursuant to NRS 304.070, is hereby adopted to describe the congressional districts in this State.*

2. *The congressional districts described in the shapefile adopted by subsection 1 are hereby created.*

Sec. 10. NRS 304.060 is hereby amended to read as follows:

304.060 As used in NRS 304.060 to ~~[304.120,]~~ 304.090, inclusive, *and section 9 of this act*, unless the context otherwise requires:

1. "Block" means the smallest geographical unit whose boundaries were designated by the Bureau of the Census of the United States Department of Commerce in its topographically integrated geographic encoding and referencing system.

2. "Block group" means a combination of blocks whose numbers begin with the same digit.

3. "Census tract" means a combination of block groups.

4. ~~["Census voting district" means the voting district:~~

~~—(a) Based on the geographic and population databases compiled by the Bureau of the Census of the United States Department of Commerce as revised by the State Demographer pursuant to NRS 360.288 and validated and incorporated into the geographic information system by the Legislative Counsel Bureau for use by the Nevada Legislature; and~~

~~—(b) Designated in the maps filed with the Office of the Secretary of State pursuant to subsection 3 of NRS 304.070.~~



1 ~~—5.]~~ “State Demographer” means the demographer employed by
2 the Department of Taxation pursuant to NRS 360.283.

3 **Sec. 11.** NRS 304.070 is hereby amended to read as follows:

4 304.070 The Director of the Legislative Counsel Bureau shall:

5 1. *File a copy of the shapefile adopted by section 9 of this act*
6 *with the Secretary of State.*

7 2. Retain in an office of the Legislative Counsel Bureau, copies
8 of maps of the congressional districts described in ~~[NRS 304.100,~~
9 ~~304.110 and 304.120.]~~ *the shapefile adopted by section 9 of this*
10 *act.*

11 ~~[2.]~~ 3. Make available copies of the maps to any interested
12 person for a reasonable fee, not to exceed the actual costs of
13 producing copies of the maps.

14 ~~[3.]~~ 4. File a copy of the maps with the Secretary of State.

15 **Sec. 12.** NRS 304.080 is hereby amended to read as follows:

16 304.080 The Secretary of State shall:

17 1. Provide to the clerk of each county and the clerk of Carson
18 City, copies of the *shapefile filed pursuant to subsection 1 of NRS*
19 *304.070 and* maps filed pursuant to subsection ~~[3]~~ 4 of
20 NRS 304.070.

21 2. Make available copies of the *shapefile and* maps to any
22 interested person for a reasonable fee, not to exceed the actual costs
23 of producing copies of the *shapefile or* maps.

24 **Sec. 13.** NRS 304.090 is hereby amended to read as follows:

25 304.090 1. If any area of this State is omitted from the
26 ~~[provisions of NRS 304.060 to 304.120, inclusive,]~~ *shapefile*
27 *adopted by section 9 of this act* inadvertently or by virtue of the
28 complexities of the information supplied to the Legislature, the
29 county clerk, the Carson City clerk or the Director of the Legislative
30 Counsel Bureau, upon discovery of the omission, shall notify the
31 Secretary of State of the omission. The Secretary of State shall
32 attach that area to the appropriate congressional district as follows:

33 (a) If the area is surrounded by a congressional district, the area
34 must be attached to that district.

35 (b) If the area is contiguous to two or more congressional
36 districts, the area must be attached to the district that has the least
37 population.

38 2. Any attachments made pursuant to the provisions of this
39 section must be certified in writing and filed with the Director of the
40 Legislative Counsel Bureau and with the Secretary of State. No
41 change may be made in any attachments until the districts are again
42 reapportioned.



1 **Sec. 14.** NRS 385.021 is hereby amended to read as follows:
2 385.021 1. The State Board of Education is hereby created.
3 The State Board consists of the following voting members:

4 (a) One member elected by the registered voters of each
5 congressional district described in ~~NRS 304.060 to 304.120,~~
6 ~~inclusive;]~~ *the shapefile adopted by section 9 of this act;*

7 (b) One member appointed by the Governor;

8 (c) One member appointed by the Governor, nominated by the
9 Majority Leader of the Senate; and

10 (d) One member appointed by the Governor, nominated by the
11 Speaker of the Assembly.

12 2. In addition to the voting members described in subsection 1,
13 the State Board consists of the following four nonvoting members:

14 (a) One member appointed by the Governor who is a member of
15 a board of trustees of a school district, nominated by the Nevada
16 Association of School Boards;

17 (b) One member appointed by the Governor who is the
18 superintendent of schools of a school district, nominated by the
19 Nevada Association of School Superintendents;

20 (c) One member appointed by the Governor who represents the
21 Nevada System of Higher Education, nominated by the Board of
22 Regents of the University of Nevada; and

23 (d) One member appointed by the Governor who is a pupil
24 enrolled in a public school in this State, nominated by the Nevada
25 Association of Student Councils or its successor organization and in
26 consultation with the Nevada Youth Legislature. After the initial
27 term, the term of the member appointed pursuant to this paragraph
28 commences on June 1 and expires on May 31 of the following year.

29 3. Each member of the State Board elected pursuant to
30 paragraph (a) of subsection 1 must be a qualified elector of the
31 district from which that member is elected.

32 4. Each member appointed pursuant to paragraphs (b), (c) and
33 (d) of subsection 1 and each member appointed pursuant to
34 subsection 2 must be a resident of this State.

35 5. Except as otherwise provided in paragraphs (a) and (c) of
36 subsection 2, a person who is elected to serve as an officer of this
37 State or any political subdivision thereof or a person appointed to
38 serve for the unexpired term of such an office may not serve or
39 continue to serve on the State Board.

40 6. The Governor shall ensure that the members appointed
41 pursuant to paragraphs (b), (c) and (d) of subsection 1 represent the
42 geographic diversity of this State and that:



1 (a) One member is a teacher at a public school selected from a
2 list of three candidates provided by the Nevada State Education
3 Association.

4 (b) One member is the parent or legal guardian of a pupil
5 enrolled in a public school.

6 (c) One member is a person active in a private business or
7 industry of this State.

8 7. After the initial terms, each member:

9 (a) Elected pursuant to paragraph (a) of subsection 1 serves a
10 term of 4 years. A member may be elected to serve not more than
11 three terms but may be appointed to serve pursuant to paragraph (b),
12 (c) or (d) of subsection 1 or subsection 2 after service as an elected
13 member, notwithstanding the number of terms the member served as
14 an elected member.

15 (b) Appointed pursuant to paragraphs (b), (c) and (d) of
16 subsection 1 serves a term of 2 years, except that each member
17 continues to serve until a successor is appointed. A member may be
18 reappointed for additional terms of 2 years in the same manner as
19 the original appointment.

20 (c) Appointed pursuant to subsection 2 serves a term of 1 year.
21 A member may be reappointed for additional terms of 1 year in the
22 same manner as the original appointment.

23 8. If a vacancy occurs during the term of:

24 (a) A member who was elected pursuant to paragraph (a) of
25 subsection 1, the Governor shall appoint a member to fill
26 the vacancy until the next general election, at which election a
27 member must be chosen for the balance of the unexpired term. The
28 appointee must be a qualified elector of the district where the
29 vacancy occurs.


30 (b) A voting member appointed pursuant to paragraph (b), (c) or
31 (d) of subsection 1 or a nonvoting member appointed pursuant to
32 subsection 2, the vacancy must be filled in the same manner as the
33 original appointment for the remainder of the unexpired term.

34 **Sec. 15.** 1. The Legislative Counsel shall include with the
35 Nevada Revised Statutes the following graphical representations of
36 the assembly districts contained in the shapefile adopted by section
37 2 of this act, printed here in descriptive form for the convenience of
38 the reader:





31 (2) Challenges, contests or raises as an issue, either in law or
32 in equity, in whole or in part, or facially or as applied, the meaning,
33 intent, purpose, scope, applicability, validity, enforceability or
34 constitutionality of any law, resolution, initiative, referendum
35 or other legislative or constitutional measure relating to any election
36 or petition district.

37 (b) "Agency" means any agency, office, department, division,
38 bureau, unit, board, commission, authority, institution, committee,
39 subcommittee or other similar body or entity, including, without
40 limitation, any body or entity created by an interstate, cooperative,
41 joint or interlocal agreement or compact.

42 (c) "Board of Regents" means the Board of Regents of the
43 University of Nevada, consisting of the members set forth in
44 NRS 396.040.



1 (d) "Director" means the person appointed or serving as the
2 Director of the Legislative Counsel Bureau pursuant to
3 NRS 218F.100.

4 (e) "Election or petition district" means:

5 (1) Any district from which one or more members of the
6 Legislature are elected, members of the Board of Regents are
7 elected, members of the State Board of Education are elected or
8 Representatives in Congress are elected; or

9 (2) Any petition district, as defined in NRS 293.069.

10 (f) "General Counsel" means the person appointed or serving as
11 the General Counsel and a chief of the Legal Division of the
12 Legislative Counsel Bureau pursuant to NRS 218F.100.

13 (g) "Legislative Commission" means the Legislative
14 Commission created by NRS 218E.150.

15 (h) "Legislative Counsel" means the person appointed or serving
16 as the Legislative Counsel and a chief of the Legal Division of the
17 Legislative Counsel Bureau pursuant to NRS 218F.100.

18 (i) "Legislative Counsel Bureau" means the Legislative Counsel
19 Bureau created by NRS 218F.100.

20 (j) "Legislature" means:

21 (1) The Legislature or either House; or

22 (2) Any current or former agency, member, officer or
23 employee of the Legislature, the Legislative Counsel Bureau or the
24 Legislative Department.

25 (k) "Representatives in Congress" means the Representatives in
26 the Congress of the United States to which this State is entitled.

27 (l) "State Board of Education" means the State Board of
28 Education created by NRS 385.021.
