SUMMARY—Makes various changes to provisions governing mobile home parks. (BDR 10-516)

AN ACT relating to mobile home parks; revising the eligibility requirements for receiving assistance from the fund for low-income owners of mobile homes; providing authority for law enforcement agencies of certain cities and counties to patrol the common areas of mobile home parks; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE
AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** NRS 118B.215 is hereby amended to read as follows:
2 118B.215 1. There is hereby created as a special revenue fund in the
3 state treasury the fund for low-income owners of mobile homes, to be
4 administered by the division. All money received for the use of the fund
5 pursuant to NRS 118B.213 or from any other source must be deposited in
6 the fund.
7 2. The interest and income earned on the money in the fund, after
8 deducting any applicable charges, must be credited to the fund. All claims
9 against the fund must be paid as other claims against the state are paid.
10 3. The money in the fund may be used only to pay necessary
11 administrative costs and to assist eligible persons by supplementing their
12 monthly rent for the mobile home lot on which their mobile home is
13 located. To be eligible for assistance from the fund a person must:

1 (a) Except as otherwise provided in this subsection, have been a tenant
2 in the same mobile home park in this state for at least 1 year immediately
3 preceding his application for assistance;

4 (b) Be the registered owner of the mobile home which is subject to the
5 tenancy, as indicated on the certificate of ownership that is issued by the
6 division pursuant to NRS 489.541;

7 (c) Have a monthly household income which is at or below ~~the~~ **an**
8 **amount equal to \$100 more than:**

9 (1) The federally designated level signifying poverty or ~~\$750,~~ **\$850,**
10 whichever is greater, if the person is the sole occupant of the mobile home;
11 or

12 (2) The federally designated level signifying poverty or ~~\$1,125,~~
13 **\$1,225,** whichever is greater, if the person is not the sole occupant of the
14 mobile home;

15 (d) Be a tenant in a mobile home park that is operated for profit and
16 maintain continuous tenancy in that park during the duration of the
17 supplemental assistance; and

18 (e) Not have assets whose value is more than ~~\$10,000,~~ **\$12,000,**
19 excluding the value of ~~the~~ :

20 (1) **The** mobile home which is subject to the tenancy ~~the~~ ;

21 (2) **The** contents of that mobile home ;

22 (3) **Any food stamps the person was eligible to receive or has**
23 **received pursuant to the Food Stamp Act of 1977, as amended, 7 U.S.C.**
24 **§§ 2011 et seq., during the year immediately preceding his application**
25 **for assistance; and ~~one~~**

26 (4) **One** motor vehicle.

27 A person who has been a tenant of a mobile home park in this state for at
28 least 1 year, but has not been a tenant of the mobile home park in which he
29 resides at the time he applies for assistance for at least 1 year, is eligible for
30 assistance from the fund if he moved to the mobile home park in which he
31 resides at the time of his application because he was unable to pay the rent
32 at the mobile home park from which he moved or because that park was
33 closed.

34 4. The administrator shall adopt regulations establishing:

35 (a) The annual reporting requirements for persons receiving assistance
36 pursuant to this section. The regulations must require that each such person
37 provide the division with a written acknowledgment of his continued
38 eligibility for assistance.

39 (b) The maximum amount of assistance which may be distributed to a
40 person to supplement his monthly rent pursuant to this section.

1 5. As used in this section:

2 (a) "Mobile home" includes a travel trailer that is located on a mobile
3 home lot within a mobile home park.

4 (b) "Monthly household income" means the combined monthly
5 incomes of the occupants of a mobile home which is subject to the tenancy
6 for which assistance from the fund is requested.

7 (c) "Travel trailer" has the meaning ascribed to it in NRS 489.150.

8 **Sec. 2.** Chapter 244 of NRS is hereby amended by adding thereto a
9 new section to read as follows:

10 ***1. The board of county commissioners of a county whose population***
11 ***is 400,000 or more shall enact an ordinance authorizing the members of***
12 ***the county law enforcement agency to patrol and provide for the public***
13 ***safety within the common areas of a mobile home park that is located***
14 ***within the unincorporated area of the county and into or upon which the***
15 ***public is admitted by easement, license or otherwise.***

16 ***2. As used in this section, "mobile home park" has the meaning***
17 ***ascribed to it in NRS 118B.017.***

18 **Sec. 3.** Chapter 268 of NRS is hereby amended by adding thereto a
19 new section to read as follows:

20 ***1. The governing body of each city located in a county whose***
21 ***population is 400,000 or more shall enact an ordinance authorizing the***
22 ***members of the law enforcement agency of the city to patrol and provide***
23 ***for the public safety within the common areas of a mobile home park***
24 ***that is located within the city and into or upon which the public is***
25 ***admitted by easement, license or otherwise.***

26 ***2. As used in this section, "mobile home park" has the meaning***
27 ***ascribed to it in NRS 118B.017.***
