AN ACT making an appropriation to the University and Community College System of Nevada for a needs assessment and implementation plan for a 4-year state college in Henderson, Nevada; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** There is hereby appropriated from the state general fund to
- 2 the University and Community College System of Nevada the sum of
- 3 \$1,000,000 for completion of a needs assessment and implementation plan
- 4 for a 4-year state college in Henderson, Nevada.
- 5 **Sec. 2.** On or before September 1, 2000, the Board of Regents shall
- 6 submit a report of its findings and recommendations relating to the needs
- 7 assessment and implementation plan to:

1 1. The Director of the Legislative Counsel Bureau for transmittal to
2 the 71st session of the Nevada Legislature; and

3 2. The Director of the Department of Administration.

4 **Sec. 3.** Any remaining balance of the appropriation made by section 1
5 of this act must not be committed for expenditure after June 30, 2001, and
6 reverts to the state general fund as soon as all payments of money
7 committed have been made.

8 **Sec. 4.** This act becomes effective upon passage and approval.
