AN ACT making an appropriation to the City of North Las Vegas for the completion of the Kiel Ranch Historic Site; and providing other matters properly relating thereto.

- 1 WHEREAS, The City of North Las Vegas is developing the Kiel Ranch
- 2 Historic Site both as a local educational facility and as a tourist site; and
- 3 WHEREAS, Heritage tourism is viewed as a positive benefit to the State
- 4 of Nevada's most significant industries of gaming and tourism; and
- 5 WHEREAS, The Kiel Ranch Historic Site offers a colorful and
- 6 significant glimpse of the culture and society of the bygone eras; and
- 7 WHEREAS, Community members have formed the Friends of Kiel
- 8 Ranch Historic Site to support the ongoing development of programming
- 9 for the site; and
- 10 WHEREAS, The City of North Las Vegas and the Community College of
- 11 Southern Nevada have formed a partnership to foster the Heritage Tourism
- 12 Program at the college; and
- 13 WHEREAS, The Kiel Ranch Historic Site is a significant historic,
- 14 cultural and educational resource for the entire Las Vegas Valley; now,
- 15 therefore,

1 THE PEOPLE OF THE STATE OF NEVADA,
2 REPRESENTED IN SENATE AND ASSEMBLY, DO
3 ENACT AS FOLLOWS:

5 **Section 1.** There is hereby appropriated from the state general fund to
6 the City of North Las Vegas the sum of \$2,000,000 for the completion of
7 the Kiel Ranch Historic Site.

8 **Sec. 2.** Any remaining balance of the appropriation made by section 1
9 of this act must not be committed for expenditure after the project is
10 completed and reverts to the state general fund as soon as all payments of
11 money committed have been made.

12 **Sec. 3.** This act becomes effective upon passage and approval.
