SUMMARY—Authorizes courts to contract for acceptance of credit cards and debit cards for payment of fees, fines and other charges owed to court. (BDR 1-178)

AN ACT relating to courts; authorizing courts to contract for the acceptance of credit cards and debit cards for the payment of fees, fines and other charges owed to the court; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE
AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 1 of NRS is hereby amended by adding thereto a
2 new section to read as follows:
3 ***1. A court in this state may enter into a contract with an issuer of***
4 ***credit cards or debit cards to provide for the acceptance of credit cards or***
5 ***debit cards by the court for the payment of money owed to the court for a***
6 ***fee, fine, administrative assessment, restitution or any other charge owed***
7 ***to the court.***
8 ***2. If the issuer charges the court a fee for each use of a credit card or***
9 ***debit card, the court may require the cardholder to pay a fee. The fee***
10 ***charged by the court must not exceed the amount charged by the issuer***
11 ***for the use of the card.***
12 ***3. As used in this section:***
13 ***(a) “Cardholder” means the person or organization named on the face***
14 ***of a credit card or debit card to whom or for whose benefit the credit card***
15 ***or debit card is issued by an issuer.***

1 (b) "Credit card" means any instrument or device, whether known as a
2 credit card or credit plate, or by any other name, issued with or without a
3 fee by an issuer for the use of the cardholder in obtaining money,
4 property, goods, services or anything else of value on credit.

5 (c) "Debit card" means any instrument or device, whether known as a
6 debit card or by any other name, issued with or without a fee by an issuer
7 for the use of the cardholder in depositing, obtaining or transferring
8 funds.

9 (d) "Issuer" means a business organization, financial institution or
10 authorized agent of a business organization or financial institution that
11 issues a credit card or debit card.

12 **Sec. 2.** NRS 354.770 is hereby amended to read as follows:

13 354.770 1. A local government may enter into contracts with issuers
14 of credit cards or debit cards to provide for the acceptance of credit cards or
15 debit cards by the local government:

16 (a) For the payment of money owed to the local government for taxes,
17 interest, penalties or any other obligation; or

18 (b) In payment for goods or services.

19 2. If the issuer charges the local government a fee for each use of a
20 credit card or debit card, a contract entered into pursuant to subsection 1
21 must include a provision that requires the local government to pay the fee
22 charged by the issuer for the use of the credit card or debit card.

23 3. The payment of fees charged by the issuer for each use of a credit
24 card or debit card must be treated in the same manner as any other
25 administrative cost of the local government.

26 4. As used in this section:

27 (a) "Cardholder" means the person or organization named on the face of
28 a credit card or debit card to whom or for whose benefit the credit card or
29 debit card is issued by an issuer.

30 (b) "Credit card" means any instrument or device, whether known as a
31 credit card or credit plate, or by any other name, issued with or without a
32 fee by an issuer for the use of the cardholder in obtaining money, property,
33 goods, services or anything else of value on credit.

34 (c) "Debit card" means any instrument or device, whether known as a
35 debit card or by any other name, issued with or without a fee by an issuer
36 for the use of the cardholder in depositing, obtaining or transferring funds.

37 (d) "Issuer" means a business organization, financial institution or
38 authorized agent of a business organization or financial institution that
39 issues a credit card or debit card.

40 (e) "Local government" has the meaning ascribed to it in NRS 354.474
41 ~~1~~, except that the term does not include a court that has entered into a
42 contract pursuant to section 1 of this act.

1 **Sec. 3.** This act becomes effective on July 1, 1999.
