
ASSEMBLY BILL NO. 3—COMMITTEE ON EDUCATION

SUMMARY—Requires department of education to prescribe form for developing individualized education programs for pupils with disabilities. (BDR 34-318)

AN ACT relating to education; requiring the department of education to prescribe a form for use by school districts in the development of individualized education programs for pupils with disabilities; requiring the department to provide information to the boards of trustees of school districts concerning the identification and evaluation of pupils with disabilities; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE
AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** NRS 388.520 is hereby amended to read as follows:
2 388.520 1. ***The department shall:***
3 ***(a) Prescribe a form for the uniform development, review and revision of***
4 ***an individualized education program for a pupil with a disability in***
5 ***accordance with 20 U.S.C. § 1414(d); and***
6 ***(b) Make the form available on a computer disk for use by school***
7 ***districts and, upon request, in any other manner deemed reasonable by the***
8 ***department.***
9 ***Each school district shall ensure that the form prescribed by the department***
10 ***is used for the development, review and revision of an individualized***
11 ***education program for each pupil with a disability who receives special***
12 ***education in the school district.***
13 2. The state board shall prescribe minimum standards for the special
14 education of pupils with disabilities and gifted and talented pupils.
15 ~~1-1~~ 3. The minimum standards prescribed by the state board must include
16 standards for programs of instruction or special services maintained for the
17 purpose of serving pupils with:
18 (a) Hearing impairments, including, but not limited to, deafness.

- 1 (b) Visual impairments, including, but not limited to, blindness.
- 2 (c) Orthopedic impairments.
- 3 (d) Speech and language impairments.
- 4 (e) Mental retardation.
- 5 (f) Multiple impairments.
- 6 (g) Serious emotional disturbances.
- 7 (h) Other health impairments.
- 8 (i) Specific learning disabilities.
- 9 (j) Autism.
- 10 (k) Traumatic brain injuries.
- 11 (l) Developmental delays.
- 12 (m) Gifted and talented abilities.

13 ~~13.1~~ 4. No apportionment of state money may be made to any school
14 district or charter school for the instruction of pupils with disabilities and
15 gifted and talented pupils until the program of instruction maintained therein
16 for such pupils is approved by the superintendent of public instruction as
17 meeting the minimum standards prescribed by the state board.

18 *5. The department shall, upon the request of the board of trustees of a*
19 *school district, provide information to the board of trustees concerning the*
20 *identification and evaluation of pupils with disabilities in accordance with*
21 *the standards prescribed by the state board.*

22 *6. As used in this section, "individualized education program" has the*
23 *meaning ascribed to it in 20 U.S.C. § 1414(d)(1)(A).*

24 **Sec. 2.** 1. On or before October 1, 1999, the department of education
25 shall, in accordance with NRS 388.520, prescribe the form for the
26 development, review and revision of individualized education programs for
27 pupils with disabilities.

28 2. The board of trustees of each school district in this state shall ensure
29 that the form prescribed by the department of education is used for pupils
30 who are initially evaluated for placement in a program of special education
31 after November 1, 1999. If an individualized education program is initially
32 developed for a pupil with a disability on or before November 1, 1999, the
33 board of trustees of a school district shall ensure that any review or revision
34 of that program after November 1, 1999, complies with the form prescribed
35 by the department of education.

36 **Sec. 3.** This act becomes effective on July 1, 1999.
