AN ACT relating to crime; including within the crime of involuntary manslaughter the violation of certain laws resulting in the death of another person; providing penalties; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE
AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** NRS 193.190 is hereby amended to read as follows:
- 2 193.190 ~~1. Except as otherwise provided in subsection 2, in~~
- 3 ***1. Except as otherwise provided in subsection 2, in*** every crime or
- 4 public offense there must exist a union, or joint operation of act and
- 5 intention, or criminal negligence.
- 6 ***2. A conviction for involuntary manslaughter pursuant to paragraph***
- 7 ***(c) of subsection 1 of NRS 200.070 may be based upon a finding of***
- 8 ***simple negligence.***
- 9 **Sec. 2.** NRS 200.070 is hereby amended to read as follows:
- 10 200.070 ***1. Except ~~under the circumstances~~ as otherwise*** provided
- 11 in ~~NRS 484.348 and 484.377, 1~~ ***subsection 2,*** involuntary manslaughter is
- 12 the killing of a human being, without any intent to do so ~~in~~ :
- 13 ***(a) In the commission of an unlawful act ~~or~~ ;***
- 14 ***(b) In the commission of*** a lawful act which probably might produce
- 15 such a consequence ***if committed*** in an unlawful manner ~~but where~~ ; ***or***
- 16 ***(c) As a result of violating a provision of chapter 484 or 706 of NRS,***
- 17 ***whether or not the violation constitutes criminal negligence or simple***
- 18 ***negligence.***

1 **2.** *If* the involuntary killing occurs in the commission of an unlawful
2 act, which, in its consequences, naturally tends to destroy the life of a
3 human being, or is committed in the prosecution of a felonious intent, the
4 offense is murder.

5 **Sec. 3.** NRS 200.090 is hereby amended to read as follows:

6 200.090 *Unless a greater penalty is otherwise provided in NRS*
7 *484.348, 484.3595, 484.377 or 484.3795 or another specific statute:*

8 **1.** A person convicted of involuntary manslaughter *pursuant to*
9 *paragraph (a) or (b) of subsection 1 of NRS 200.070* is guilty of a
10 category D felony and shall be punished as provided in NRS 193.130.

11 **2.** *A person convicted of involuntary manslaughter pursuant to*
12 *paragraph (c) of subsection 1 of NRS 200.070 for a violation of chapter*
13 *484 or 706 of NRS constituting criminal negligence is guilty of a*
14 *category D felony and shall be punished as provided in NRS 193.130.*

15 **3.** *A person convicted of involuntary manslaughter pursuant to*
16 *paragraph (c) of subsection 1 of NRS 200.070 for a violation of chapter*
17 *484 or 706 of NRS constituting simple negligence, but not constituting*
18 *criminal negligence, is guilty of a misdemeanor.*

19 **Sec. 4.** The amendatory provisions of this act do not apply to offenses
20 that were committed before October 1, 1999.
