SUMMARY—Reduces and prospectively eliminates certain special motor vehicle privilege tax in Washoe County. (BDR S-1334)

AN ACT relating to taxation; requiring the board of county commissioners of Washoe County to reduce the rate of a certain special motor vehicle privilege tax imposed during a certain period; prospectively prohibiting the board of county commissioners of Washoe County from imposing, levying or continuing the tax after a certain date; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE
AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Section 38 of chapter 491, Statutes of Nevada 1991, as
2 amended by section 4 of chapter 475, Statutes of Nevada 1993, at page
3 1950, is hereby amended to read as follows:
4 Sec. 38. 1. The board of county commissioners of Washoe
5 County shall reduce the rate of the tax ad valorem imposed pursuant
6 to section 33 of this act by 1.5 cents per \$100 of assessed valuation
7 for the fiscal year 1993-1994.
8 2. The board of county commissioners of Washoe County shall
9 reduce the rate of the tax ad valorem imposed pursuant to section 33
10 of this act, in addition to the reduction made pursuant to subsection
11 1, by 4 cents per \$100 of assessed valuation for the fiscal year
12 1994-1995.

1 3. *The board of county commissioners of Washoe County*
2 *shall reduce the rate of the special privilege tax imposed pursuant*
3 *to section 30 of this act to the amounts shown for each \$1 of*
4 *valuation for the respective fiscal years:*

6 2001-2002..... 0.8 cents
7 2002-2003..... 0.6 cents
8 2003-2004..... 0.4 cents
9 2004-2005..... 0.2 cents

11 *The board of county commissioners of Washoe County shall not*
12 *impose or levy that special privilege tax for any fiscal year after*
13 *June 30, 2005.*

14 4. The board of county commissioners of Washoe County or
15 Churchill County shall not, after June 30, 1994:

16 (a) Except as otherwise provided in subsection 2 ~~for 4,~~ 3 or 5,
17 decrease the rate of any of the taxes imposed pursuant to sections
18 29 to 33, inclusive, of this act unless all of the local governments
19 that are entitled to receive a monthly distribution from the tax
20 distribution fund for the county agree to the decrease.

21 (b) Increase the rate of any tax imposed pursuant to sections 29
22 to 33, inclusive, of this act.

23 ~~4.~~ 5. If necessary to avoid violating the provisions of
24 subsection 2 of section 31 of this act, the board of county
25 commissioners of Washoe County shall reduce the amount of the
26 license fee imposed pursuant to that section by the minimum
27 amount necessary to comply with the provisions of subsection 2 of
28 section 31 of this act.
