SUMMARY—Revises provisions governing certificates of registration issued to certain business organizations and associations by state board of architecture, interior design and residential design. (BDR 54-788)

AN ACT relating to the state board of architecture, interior design and residential design; providing for the annual renewal of a certificate of registration issued by the board to certain business organizations and associations; requiring the secretary of the board to keep an official register of such certificates; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE
AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 623 of NRS is hereby amended by adding thereto
2 the provisions set forth as sections 2 and 3 of this act.
- 3 **Sec. 2.** *The secretary of the board shall keep an official register of*
4 *all certificates of registration issued pursuant to NRS 623.349 to a*
5 *partnership, corporation, limited-liability company or other form of*
6 *business organization or association, and the renewals thereof. The*
7 *register must be properly indexed and open for public inspection and*
8 *information.*
- 9 **Sec. 3. 1.** *Each partnership, corporation, limited-liability company*
10 *or other form of business organization or association that holds and*
11 *wishes to renew a certificate of registration issued pursuant to NRS*
12 *623.349 shall, before or during the month of July of each year, submit to*
13 *the board the fee for renewal required by the board pursuant to NRS*

1 *623.310 and proof of continued compliance with the provisions of NRS*
2 *623.349.*

3 *2. Upon receipt of the fee for renewal and the required proof, the*
4 *secretary of the board shall execute and issue to the business*
5 *organization or association a renewal form for the certificate of*
6 *registration, certifying that the certificate is renewed for 1 year. The*
7 *renewal form must bear a serial number, the signature or a facsimile*
8 *thereof of the secretary or executive director of the board, and the seal of*
9 *the board.*

10 *3. The renewal form must be recorded, together with its serial*
11 *number, by the secretary of the board in the official register of the board*
12 *kept pursuant to section 2 of this act.*

13 **Sec. 4.** This act becomes effective on July 1, 1999.
