PROCEDURES, AND ETHICS

SUMMARY—Makes various changes regarding administration of state legislature and legislative counsel bureau. (BDR 17-820)

AN ACT relating to the state legislature; establishing certain limitations on the drafting of requests for legislation; authorizing the appointment of committees to conduct certain activities before the commencement of a regular session; making various changes regarding expenditures from the legislative fund; repealing the provisions requiring the submission of joint resolutions to the governor for approval; clarifying references to certain standing committees; revising the duties of the legislative counsel regarding administrative regulations; revising certain provisions governing fiscal notes concerning legislative measures; making various changes regarding the dissemination of certain budgetary information; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE
AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 218 of NRS is hereby amended by adding thereto
2 the provisions set forth as sections 2 to 8, inclusive, of this act.
3 **Sec. 2. 1. *Except as otherwise provided by specific statute or***
4 *concurrent resolution of the legislature, the legislative counsel shall*
5 *honor:*
6 *(a) The number of requests for the drafting of a bill or resolution for a*
7 *regular session of the legislature only as provided in NRS 218.240 to*
8 *218.255, inclusive, and sections 2 to 6, inclusive, of this act.*
9 *(b) A request for the drafting of a bill or resolution for a regular*
10 *session of the legislature only if the request is received by the legislative*

1 *counsel on or before December 15 preceding the commencement of that*
2 *session.*

3 *(c) A request for the drafting of a bill or resolution for any session of*
4 *the legislature which is submitted by a state agency, board or department,*
5 *a local government, the judiciary or another authorized nonlegislative*
6 *requester only if the request is in a subject related to the function of the*
7 *requester.*

8 *2. The legislative counsel shall not:*

9 *(a) Assign a number to a request for the drafting of a bill or resolution*
10 *for any session of the legislature to establish the priority of the request*
11 *until sufficient detail has been received to allow complete drafting of the*
12 *legislative measure.*

13 *(b) Honor a request to change the subject matter of a request for the*
14 *drafting of a bill or resolution for any session of the legislature after it*
15 *has been submitted for drafting.*

16 *(c) Honor a request for the drafting of a bill or resolution for any*
17 *session of the legislature which has been combined in violation of section*
18 *17 of article 4 of the Nevada constitution.*

19 **Sec. 3. 1. Each:**

20 *(a) Incumbent assemblyman may request the drafting of not more*
21 *than 5 legislative measures submitted to the legislative counsel before*
22 *September 1 preceding the commencement of a regular session of the*
23 *legislature and not more than 5 legislative measures submitted to the*
24 *legislative counsel on or after September 1 but on or before December 15*
25 *preceding the commencement of a regular session of the legislature.*

26 *(b) Incumbent senator may request the drafting of not more than 10*
27 *legislative measures submitted to the legislative counsel before*
28 *September 1 preceding the commencement of a regular session of the*
29 *legislature and not more than 10 legislative measures submitted to the*
30 *legislative counsel on or after September 1 but on or before December 15*
31 *preceding the commencement of a regular session of the legislature.*

32 *(c) Newly elected assemblyman may request the drafting of not more*
33 *than 5 legislative measures submitted to the legislative counsel on or*
34 *before December 15 preceding the commencement of a regular session*
35 *of the legislature.*

36 *(d) Newly elected senator may request the drafting of not more than*
37 *10 legislative measures submitted to the legislative counsel on or before*
38 *December 15 preceding the commencement of a regular session of the*
39 *legislature.*

40 *2. In addition to the number authorized pursuant to subsection 1:*

41 *(a) The chairman of each standing committee of the immediately*
42 *preceding regular legislative session, or a person designated in the place*
43 *of the chairman by the speaker of the assembly or the majority leader of*

1 *the senate, as the case may be, may request before the commencement of*
2 *the next regular legislative session the drafting of not more than 1*
3 *legislative measure for introduction by the committee in a subject within*
4 *the jurisdiction of the committee for every 15 legislative measures that*
5 *were referred to the respective standing committee during the*
6 *immediately preceding regular legislative session.*

7 *(b) A person designated after a general election as a chairman of a*
8 *standing committee for the next regular legislative session, or a person*
9 *designated in the place of a chairman by the person designated as the*
10 *speaker of the assembly or majority leader of the senate for the next*
11 *regular legislative session, may request before the commencement of the*
12 *next regular legislative session the drafting of the remaining number of*
13 *the legislative measures allowed for the respective standing committee*
14 *that were not requested by the previous chairman or designee.*

15 **Sec. 4. 1.** *In addition to the number authorized pursuant to section*
16 *3 of this act:*

17 *(a) The speaker of the assembly and the majority leader of the senate*
18 *may each request before or during a regular legislative session, without*
19 *limitation, the drafting of not more than 15 legislative measures for that*
20 *session.*

21 *(b) The minority leader of the assembly and the minority leader of the*
22 *senate may each request before or during a regular legislative session,*
23 *without limitation, the drafting of not more than 10 legislative measures*
24 *for that session.*

25 *(c) A person designated after a general election as the speaker of the*
26 *assembly, the majority leader of the senate, the minority leader of the*
27 *assembly or the minority leader of the senate for the next regular*
28 *legislative session may request the drafting of the remaining number of*
29 *the legislative measures allowed for the respective officer that were not*
30 *requested by the previous officer.*

31 **2.** *The secretary of the senate and the chief clerk of the assembly*
32 *may request before or during a regular legislative session, without*
33 *limitation, the drafting of as many legislative measures as are necessary*
34 *or convenient for the proper exercise of their duties.*

35 **Sec. 5. 1.** *The chairman of the legislative commission may request*
36 *the drafting of not more than 15 legislative measures before the*
37 *commencement of a regular legislative session, with the approval of the*
38 *commission, which relate to the affairs of the legislature or its employees,*
39 *including measures requested by the legislative staff.*

40 **2.** *The chairman of the interim finance committee may request the*
41 *drafting of not more than 10 legislative measures before the*
42 *commencement of a regular legislative session, with the approval of the*
43 *committee, which relate to matters within the scope of the committee.*

1 3. Except as otherwise provided by specific statute or concurrent
2 resolution of the legislature:

3 (a) Any other legislative committee created by statute may request the
4 drafting of not more than 10 legislative measures before the
5 commencement of a regular legislative session, which relate to matters
6 within the scope of the committee.

7 (b) An interim committee which conducts a study or investigation
8 pursuant to subsection 5 of NRS 218.682 may request the drafting of not
9 more than 10 legislative measures before the commencement of a
10 regular legislative session, which relate to matters within the scope of the
11 study or investigation, except that such a committee may request the
12 drafting of additional legislative measures before the commencement of
13 a regular legislative session if the legislative commission approves each
14 additional request by a majority vote.

15 (c) Any other committee established by the legislature which conducts
16 an interim legislative study may request the drafting of not more than 10
17 legislative measures before the commencement of a regular legislative
18 session, which relate to matters within the scope of the study.

19 **Sec. 6. 1.** The governor or his designated representative may
20 transmit to the legislative counsel before September 1 preceding a
21 regular legislative session not more than 125 requests for the drafting of
22 legislative measures approved on behalf of state agencies, boards and
23 departments of the executive branch of state government pursuant to
24 subsection 1 of NRS 218.245.

25 2. The department of administration may request on or before the
26 19th day of the legislative session, without limitation, the drafting of as
27 many legislative measures as are necessary to implement the budget
28 proposed by the governor and to provide for the fiscal management of
29 the state.

30 3. The following constitutional officers may request the drafting of
31 not more than the following numbers of legislative measures before
32 September 1 preceding a regular legislative session:

35 Secretary of state.....8
36 State treasurer.....5
37 State controller.....5
38 Attorney general25
39

40 4. The board of regents of the University of Nevada may request the
41 drafting of not more than 5 legislative measures on behalf of the
42 University and Community College System of Nevada before September
43 1 preceding a regular legislative session.

1 **Sec. 7.** *If the governor elects to communicate the message required*
2 *pursuant to section 10 of article 5 of the Nevada constitution before the*
3 *commencement of a regular session of the legislature, the chairman of*
4 *the legislative commission may, on behalf of the legislative commission*
5 *pursuant to subsection 5 of NRS 218.682, appoint a special committee to*
6 *receive that message. A special committee appointed pursuant to this*
7 *section:*

8 1. *Must consist of all persons elected or appointed to serve as a*
9 *senator or assemblyman during the next ensuing regular session of the*
10 *legislature.*

11 2. *Must be chaired by the speaker designate of the assembly.*

12 3. *Shall receive the governor's message and conclude its activities*
13 *upon the completion of that message.*

14 **Sec. 8.** *The legislative commission may, pursuant to subsection 5 of*
15 *NRS 218.682, appoint one or more special committees before the*
16 *commencement of a regular session of the legislature. Each special*
17 *committee appointed pursuant to this section:*

18 1. *Must consist of all persons designated by the:*

19 (a) *Speaker designate of the assembly to serve as members of an*
20 *assembly standing committee, other than the assembly standing*
21 *committee on ways and means, for the next ensuing regular session of*
22 *the legislature; or*

23 (b) *Majority leader designate of the senate to serve as members of a*
24 *senate standing committee, other than the senate standing committee on*
25 *finance, for the next ensuing regular session of the legislature.*

26 2. *May meet to consider issues that may require consideration during*
27 *the next ensuing session by the standing committee upon which the*
28 *members of the special committee have been designated to serve.*

29 3. *Shall conclude its activities before the commencement of the next*
30 *ensuing session.*

31 **Sec. 9.** NRS 218.085 is hereby amended to read as follows:

32 218.085 1. The legislative fund is hereby created as a special revenue
33 fund for the use of the legislature, and where specifically authorized by law,
34 for the use of the legislative counsel bureau.

35 2. Support for the legislative fund must be provided by legislative
36 appropriation from the state general fund.

37 3. Expenditures from the legislative fund may be made for:

38 (a) The payment of necessary ~~operating~~ expenses of the senate;

39 (b) The payment of necessary ~~operating~~ expenses of the assembly;

40 (c) The payment of ~~the~~ necessary improvements to the legislative
41 building and its grounds;

42 (d) The payment of expenses for the interim operation of the legislature;
43 and

(e) The payment of necessary ~~operating~~ expenses of, but not limited to:

- (1) The legislative commission;
- (2) The legal division;
- (3) The research division;
- (4) The audit division;
- (5) The fiscal analysis division; and
- (6) The administrative division,

of the legislative counsel bureau.

4. Expenditures from the legislative fund for purposes other than those specified in subsection 3 or authorized specifically by another statute may be made only upon the authority of a concurrent resolution regularly adopted by the senate and assembly.

5. ~~Except as otherwise provided in NRS 218.644, all~~ All money in the legislative fund must be paid out on claims approved by the director of the legislative counsel bureau or his designee. ~~as other claims against the state are paid.~~

Sec. 10. NRS 218.130 is hereby amended to read as follows:

218.130 The number of officers and employees of the senate ~~shall~~ must be determined by each session of the senate as recommended by the senate committee ~~on~~ which has jurisdiction of issues relating to legislative functions.

Sec. 11. NRS 218.160 is hereby amended to read as follows:

218.160 The number of officers and employees of the assembly ~~shall~~ must be determined by each session of the assembly as recommended by the assembly committee ~~on~~ which has jurisdiction of issues relating to legislative functions.

Sec. 12. NRS 218.210 is hereby amended to read as follows:

218.210 ~~1.—Each senator elected before November 4, 1986, or appointed to succeed a senator elected before November 4, 1986, is entitled to receive as compensation \$104 per day for each day of service:~~

~~—(a) During any regular session, for the number of days the legislature is in session, or in adjournment for not more than 3 days, or the maximum number of days for which compensation for a regular session is permitted by the constitution, whichever is smaller; and~~

~~—(b) During any special session, for the number of days the legislature is in session or the maximum number of days for which compensation for a special session is permitted by the constitution, whichever is smaller.~~

~~2.] Each senator and assemblyman [elected on or after November 4, 1986, or appointed to succeed a senator or assemblyman elected on or after November 4, 1986,]~~ is entitled to receive as compensation \$130 per day for

each day of service:

~~1~~ ~~(a)~~ **1.** During any regular session, for the number of days the
2 legislature is in session, or in adjournment for not more than 3 days, or the
3 maximum number of days for which compensation for a regular session is
4 permitted by the constitution, whichever is smaller; and

~~5~~ ~~(b)~~ **2.** During any special session, for the number of days the
6 legislature is in session or the maximum number of days for which
7 compensation for a special session is permitted by the constitution,
8 whichever is smaller.

Sec. 13. NRS 218.220 is hereby amended to read as follows:

218.220 1. The per diem expense allowance and the travel and
11 telephone expenses of senators and assemblymen elected or appointed and
12 in attendance at any session or pre-session orientation conference of the
13 legislature must be allowed in the manner set forth in this section.

2. For initial travel from his home to Carson City, Nevada, to attend a
15 session or pre-session orientation conference of the legislature, and for
16 return travel from Carson City, Nevada, to his home upon adjournment sine
17 die of a session or termination of a pre-session orientation conference of the
18 legislature, each senator and assemblyman is entitled to receive:

(a) A per diem expense allowance, not to exceed the ~~greater of:~~
20 ~~—(1) The rate of \$44; or~~
21 ~~—(2) The~~ maximum rate established by the Federal Government for the
22 ~~locality in which the travel is performed,~~ **Carson City area**, for one day's
23 travel to and one day's travel from the session or conference.

(b) Travel expenses.

3. In addition to the per diem and travel expenses authorized by
26 subsection 2, each senator and assemblyman is entitled to receive a
27 supplemental allowance which must not exceed:

(a) A total of \$6,800 during each regular session of the legislature for:

29 (1) His actual expenses in moving to and from Carson City for the
30 session;

31 (2) Travel to and from his home or temporary residence or for
32 traveling to and from legislative committee and subcommittee meetings or
33 hearings or for individual travel within the state which relates to legislative
34 business; and

35 (3) If he rents furniture for his temporary residence rather than
36 moving similar furniture from his home, the cost of renting that furniture
37 not to exceed the amount that it would have cost to move the furniture to
38 and from his home; and

39 (b) A total of \$1,000 during each special session of the legislature for
40 travel to and from his home or temporary residence or for traveling to and
41 from legislative committee and subcommittee meetings or hearings or for
42 individual travel within the state which relates to legislative business.

1 4. Each senator and assemblyman is entitled to receive a per diem
2 expense allowance , not to exceed the ~~{greater of:~~
3 ~~—(a) The rate of \$44; or~~
4 ~~—(b) The~~ maximum rate established by the Federal Government for the
5 ~~locality in which the travel is performed,}~~ **Carson City area**, for each day
6 that the legislature is in session or in a pre-session orientation conference
7 and for each day that he attends a meeting of a standing committee of
8 which he is a member when the legislature has adjourned for more than 4
9 days.

10 5. Each senator and assemblyman who maintains temporary quarters in
11 or near Carson City for which he has entered into a lease or other
12 agreement for continuous occupancy for the duration of a legislative
13 session is entitled to receive a lodging allowance equal to that portion of
14 the expense allowance which the legislative commission designates by rule
15 as being allocated to lodging, for not more than 14 days in each period in
16 which:

17 (a) The legislature has adjourned until a time certain; and

18 (b) The senator or assemblyman is not entitled to a per diem expense
19 allowance pursuant to subsection 4.

20 6. In addition to the per diem expense allowance authorized by
21 subsection 4 and the lodging allowance authorized by subsection 5, each
22 senator and assemblyman who maintains temporary quarters in or near
23 Carson City for which he has entered into a lease or other agreement for
24 continuous occupancy for the duration of a legislative session is entitled to
25 receive a lodging allowance equal to that portion of the expense allowance
26 which the legislative commission designates by rule as being allocated to
27 lodging, for not more than 17 days in each period in which:

28 (a) The legislature has adjourned for more than 4 days; and

29 (b) The senator or assemblyman must obtain temporary lodging in a
30 location that a standing committee of which he is a member is meeting.

31 7. Each senator and assemblyman is entitled to receive a lodging
32 allowance equal to that portion of the expense allowance which the
33 legislative commission designates by rule as being allocated to lodging, for
34 not more than 6 days in each period in which:

35 (a) The legislature has adjourned for more than 4 days; and

36 (b) The senator or assemblyman must obtain temporary lodging in a
37 location that a standing committee of which he is a member is meeting,
38 if the senator or assemblyman is not entitled to the per diem expense
39 allowance authorized by subsection 4 or the lodging allowances authorized
40 by subsections 5 and 6.

41 8. Each senator and assemblyman is entitled to receive a telephone
42 allowance of not more than \$2,800 for the payment of tolls and charges
43 incurred by him in the performance of official business during each regular

1 session of the legislature and not more than \$300 during each special
2 session of the legislature.

3 9. An employee of the legislature assigned to serve a standing
4 committee is entitled to receive the travel expenses and per diem expense
5 allowance provided by law for state employees generally if he is required to
6 attend a hearing of the committee outside Carson City.

7 10. ~~{Except as otherwise provided in NRS 218.644, claims}~~ **Claims** for
8 expenses made under the provisions of this section must be ~~{made as other~~
9 ~~claims are made against the state, and must be}~~ paid from the legislative
10 fund. Claims for per diem expense allowances authorized by subsection 4
11 and lodging allowances authorized by subsections 5, 6 and 7 must be paid
12 once each week during a legislative session and upon completion of a
13 presession orientation conference.

14 11. A claim for travel expenses authorized by subsection 2 or 3 must
15 not be paid unless the senator or assemblyman submits a signed statement
16 affirming:

17 (a) The date of the travel; and

18 (b) The places of departure and arrival and, if the travel is by private
19 conveyance, the actual miles traveled. If the travel is not by private
20 conveyance, the claim must include a receipt or other evidence of the
21 expenditure.

22 12. Travel expenses authorized by subsections 2 and 3 are limited to:

23 (a) If the travel is by private conveyance, a rate equal to the standard
24 mileage reimbursement rate for which a deduction is allowed for the
25 purposes of federal income tax. If two or more legislators travel in the same
26 private conveyance, the legislator who provided or arranged for providing
27 the transportation is presumed entitled to reimbursement.

28 (b) If the travel is not by private conveyance, the actual amount
29 expended.

30 Transportation must be by the most economical means, considering total
31 cost, time spent in transit and the availability of state-owned automobiles.

32 **Sec. 14.** NRS 218.225 is hereby amended to read as follows:

33 218.225 1. At each regular session of the legislature, each legislator
34 is entitled to receive at the expense of the legislative fund from the state
35 printing division of the department of administration the following:

36 (a) Not to exceed 2,000 letterheads, ~~{8 1/2 inches x 11 inches}~~, ~~{~~
37 and 2,000 half size, or 4,000 of either variety;

38 (b) Not to exceed 2,000 No. 10 envelopes and 2,000 No. 6 3/4
39 envelopes, or 4,000 of either variety; and

40 (c) Not to exceed 2,000 business cards and 1,000 memorandum sheets,
41 ~~{500 each of the small and large type or 1,000 of either type}~~. ~~{~~

42 Selections must be made from samples submitted by the superintendent of
43 the state printing division of the department of administration, and all

1 printing must be done in the state printing division of the department of
2 administration.

3 2. Each female member of the assembly is entitled to have the word
4 “Assemblywoman” precede the inscription of her name on her official
5 stationery and business cards.

6 3. All orders for the printing specified in subsection 1 must be placed
7 by legislators with the director of the legislative counsel bureau, who shall
8 approve those claims which comply with the provisions of this section and
9 shall pay the claims from the legislative fund . ~~{in the same manner as other~~
10 ~~claims against the state are paid.}~~

11 4. A legislator may purchase from the state printing division of the
12 department of administration official stationery, cards and other material
13 appropriate to his official duties in excess of that specified in subsection 1
14 at his own expense.

15 **Sec. 15.** NRS 218.230 is hereby amended to read as follows:

16 218.230 1. ~~{There}~~ **Except as otherwise provided in this section,**
17 **there** must be paid to the ~~{several}~~ employees of the senate and assembly,
18 for all services rendered by them under the provisions of this chapter, the
19 following sums of money for each day’s employment and no more:

27 legislature whose service is required shall perform duties as assigned and
28 are entitled to be paid the amount specified in ~~this section~~ **subsection 1**
29 for each day of service.

30 **3. During periods before the commencement of a session and after**
31 **the adjournment of a session sine die, employees of the legislature whose**
32 **service is required shall perform duties as assigned and are entitled to be**
33 **paid at an hourly rate commensurate with the daily rate specified in**
34 **subsection 1.**

35 **Sec. 16.** NRS 218.240 is hereby amended to read as follows:

36 218.240 1. The legislative counsel and the legal division of the
37 legislative counsel bureau shall prepare and assist in the preparation and
38 amendment of legislative measures when requested or upon suggestion as
39 provided in NRS 218.240 to 218.255, inclusive ~~1~~, **and sections 2 to 6,**
40 **inclusive, of this act.** Except as otherwise provided in those provisions, the
41 legislative counsel and the legal division of the legislative counsel bureau
42 shall not prepare or assist in the preparation and amendment of legislative
43 measures directly submitted or requested by a natural person, corporation,

1 firm, association or other entity, including an organization that represents
2 governmental agencies, unless the requester, or if the requester is a natural
3 person the office or other position held by the person, is created by the
4 constitution or laws of this state.

15 state printing division of the department of administration and request that
16 he print or preset the type for printing a legislative measure before its
17 introduction upon the consent of the person or persons requesting the

19 superintendent shall promptly comply with this request.

20 **Sec. 17.** NRS 218.241 is hereby amended to read as follows:

21 218.241 1. Upon request made within the time allowed and ~~[within]~~
22 limits established ~~[by the legislature by concurrent resolution,]~~ *pursuant to*
23 *NRS 218.240 to 218.255, inclusive, and sections 2 to 6, inclusive, of this*
24 *act*, the legislative counsel shall advise any agency or officer of the
25 executive branch of the state government, and ~~[shall advise]~~ any county,
26 school district or city, as to the preparation of measures to be submitted to
27 the legislature.

28 2. To ensure the greatest possible equity in the handling of requests,
29 drafting must proceed as follows:
