AN ACT relating to public employees; making appropriations from the state general fund and the state highway fund to the State Board of Examiners for increases in the salaries of certain employees of the State of Nevada; and providing other matters properly relating thereto.**THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE
AND ASSEMBLY, DO ENACT AS FOLLOWS:**

1 **Section 1.** 1. Except as otherwise provided in this act, to effect
2 increases in salaries of approximately 2 percent, there is hereby
3 appropriated from the state general fund to the State Board of Examiners
4 for the fiscal period beginning July 1, 2000, and ending June 30, 2001, the
5 sum of \$6,812,012 for the purpose of meeting any deficiencies which may
6 be created between the appropriated money of the respective departments,
7 commissions and agencies of the State of Nevada, as fixed by the 70th
8 session of the legislature and the requirements for salaries of the classified
9 and unclassified personnel of those departments, commissions and
10 agencies, including the judicial branch, necessary under an adjusted pay
11 plan, except those employees whose salaries have been retained, to become
12 effective on July 1, 2000.

13 2. The State Board of Examiners, upon the recommendation of the
14 Director of the Department of Administration, may allocate and disburse to
15 the various departments, commissions and agencies of the State of Nevada,
16 out of the money appropriated by this section such sums of money as may
17 from time to time be required, which when added to the money otherwise
18 appropriated or available equals the amount of money required to pay the

1 salaries of the classified and unclassified employees of the respective
2 departments, commissions and agencies under the adjusted pay plan.

3 **Sec. 2.** 1. To effect increases in salaries of approximately 2 percent,
4 there is hereby appropriated from the state highway fund to the State Board
5 of Examiners for the fiscal period beginning July 1, 2000, and ending June
6 30, 2001, the sum of \$681,914 for the purpose of meeting any deficiencies
7 which may exist between the appropriated money of the Department of
8 Motor Vehicles and Public Safety, the Transportation Services Authority
9 and the Attorney General's Office as fixed by the 70th session of the
10 legislature and the requirements for salaries of classified and unclassified
11 personnel of the Department of Motor Vehicles and Public Safety, the
12 Transportation Services Authority and the Attorney General's Office
13 necessary under an adjusted pay plan, except those employees whose
14 salaries have been retained, to become effective July 1, 2000.

15 2. The State Board of Examiners, upon the recommendation of the
16 Director of the Department of Administration, may allocate and disburse to
17 the Department of Motor Vehicles and Public Safety, the Transportation
18 Services Authority and the Attorney General's Office out of the money
19 appropriated by this section such sums of money as may from time to time
20 be required, which when added to the money otherwise appropriated or
21 available equals the amount of money required to meet and pay the salaries
22 of the classified and unclassified employees of the Department of Motor
23 Vehicles and Public Safety, the Transportation Services Authority and the
24 Attorney General's Office under the adjusted pay plan.

25 **Sec. 3.** 1. To effect increases in salaries of approximately 2 percent,
26 there is hereby appropriated from the state general fund to the State Board
27 of Examiners for the fiscal period beginning July 1, 2000, and ending June
28 30, 2001, the sum of \$1,434,488 for the purpose of meeting any
29 deficiencies which may be created between the appropriated money of the
30 University and Community College System of Nevada as fixed by the 70th
31 session of the legislature and the requirements for salaries of the classified
32 personnel of the University and Community College System of Nevada
33 necessary under the adjusted pay plan, except those employees whose
34 salaries have been retained, to become effective July 1, 2000.

35 2. The State Board of Examiners, upon the recommendation of the
36 Director of the Department of Administration, may allocate and disburse to
37 the University and Community College System of Nevada out of the money
38 appropriated by this section such sums of money as may from time to time
39 be required, which when added to the money otherwise appropriated or
40 available equals the amount of money required to pay the salaries of the
41 classified employees of the University and Community College System of
42 Nevada under the adjusted pay plan.

1 **Sec. 4.** To effect increases in salaries of approximately 2 percent, there
2 is hereby appropriated from the state general fund to the legislative fund for
3 the fiscal year beginning July 1, 2000, and ending June 30, 2001, the sum
4 of \$260,575 for the purpose of meeting any deficiencies which may be
5 created between the appropriated money as fixed by the 70th session of the
6 legislature and the requirements for salaries of the employees of the
7 Legislative Counsel Bureau and of interim legislative operations, except
8 those employees whose salaries have been retained, to become effective
9 July 1, 2000.

10 **Sec. 5.** The State Board of Examiners shall allocate from the amounts
11 appropriated by section 1 of this act to the Tahoe Regional Planning
12 Agency to provide for Nevada's share of a salary increase, the same
13 percentage granted to classified employees of the State of Nevada which
14 take effect on July 1, 2000. The amounts transferred must not be utilized to
15 increase an employee's base salary unless the State of California provides
16 the required 2 for 1 matching money. Any amounts provided to the Tahoe
17 Regional Planning Agency should California not provide matching money
18 must be utilized as a one-time salary bonus.

19 **Sec. 6.** The approximate maximum salaries for the state officers and
20 employees in the unclassified service of the state as provided in Senate Bill
21 No. 554 of this session must be increased by 2 percent on July 1, 2000.

22 **Sec. 7.** Any balance of the money appropriated by sections 1, 2 and 3
23 of this act must not be committed for expenditure after June 30, 2001, and
24 reverts to the fund from which it was appropriated as soon as all payments
25 of money committed have been made.

26 **Sec. 8.** This act becomes effective on July 1, 2000.
