
ASSEMBLY BILL NO. 76—COMMITTEE ON TRANSPORTATION

SUMMARY—Revises provisions relating to transfer of ownership of motor vehicle and color of license plates. (BDR 43-1304)

AN ACT relating to motor vehicles; requiring the director of the department of motor vehicles and public safety to order the redesign and preparation of motor vehicle license plates with colors that are predominately blue and silver; authorizing the transferee and transferor of a motor vehicle to write their signatures upon the certificate of ownership for the vehicle by any method that is approved by the department of motor vehicles and public safety; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE
AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** NRS 482.270 is hereby amended to read as follows:
2 482.270 1. Except as otherwise provided by specific statute, the
3 director shall order the redesign and preparation of motor vehicle license
4 plates with ~~no other colors than~~ ***colors that are predominately*** blue and
5 silver. The director may substitute white in place of silver when no suitable
6 material is available.
7 2. Except as otherwise provided in subsection 3, the department shall,
8 upon the payment of all applicable fees, issue redesigned motor vehicle
9 license plates pursuant to this section to persons who apply for the
10 registration or renewal of the registration of a motor vehicle on or after
11 January 1, 2001.

3. The department shall not issue redesigned motor vehicle license plates pursuant to this section to a person who was issued motor vehicle license plates before January 1, 1982, or pursuant to NRS 482.3747, 482.3763, 482.3775, 482.378 or 482.379, without the approval of the person.

4. The director may determine and vary the size, shape and form and the material of which license plates are made, but each license plate must be of sufficient size to be plainly readable from a distance of 100 feet during daylight. All license plates must be treated to reflect light and to be at least 100 times brighter than conventional painted number plates. When properly mounted on an unlighted vehicle, the license plates, when viewed from a vehicle equipped with standard headlights, must be visible for a distance of not less than 1,500 feet and readable for a distance of not less than 110 feet.

5. Every license plate must have displayed upon it:

(a) The registration number, or combination of letters and numbers, assigned to the vehicle and to the owner thereof;

(b) The name of this state, which may be abbreviated;

(c) If issued for a calendar year, the year; and

(d) If issued for a registration period other than a calendar year, the month and year the registration expires.

6. The letters I and Q must not be used in the designation.

7. Except as otherwise provided in NRS 482.379, all letters and numbers must be of the same size.

Sec. 2. NRS 482.400 is hereby amended to read as follows:

482.400 1. Except as otherwise provided in subsections 2, 5 and 6, upon a transfer of the title to, or the interest of an owner in, a vehicle registered or issued a certificate of ownership under the provisions of this chapter, the person or persons whose title or interest is to be transferred and the transferee shall write their signatures with pen and ink, *or by any other method authorized by the department*, upon the certificate of ownership issued for the vehicle, together with the residence address of the transferee, in the appropriate spaces provided upon the reverse side of the certificate.

2. The department shall provide a form for use by a dealer for the transfer of ownership of a vehicle when the spaces provided upon the reverse side of the certificate of ownership issued for the vehicle have been filled. The form must be produced in a manner which ensures that the form may not be easily counterfeited. Upon the attachment of the form to a certificate of ownership issued for a vehicle, the form becomes a part of that certificate of ownership. The department may charge a fee not to exceed \$5 for each form it provides.

1 3. Except as otherwise provided in subsections 4, 5 and 6, the
2 transferee shall immediately apply for registration as provided in NRS
3 482.215, and shall pay the privilege taxes due.

4 4. If the transferee is a dealer who intends to resell the vehicle, he shall
5 deliver immediately to the department or its agent the certificate of
6 registration and the license plate or plates for the vehicle. When the vehicle
7 is resold, the purchaser shall apply for registration as provided in NRS
8 482.215, and shall pay the privilege taxes due. The dealer is not required to
9 register, pay a transfer or registration fee for, or pay a privilege tax on ~~any~~
10 ~~such~~ *the* vehicle.

11 5. If the transferee consigns the vehicle to a wholesale vehicle
12 auctioneer:

13 (a) The transferee shall, within 30 days after that consignment, provide
14 the wholesale vehicle auctioneer with the certificate of ownership for the
15 vehicle, executed as required by subsection 1, and any other documents
16 necessary to obtain another certificate of ownership for the vehicle.

17 (b) The wholesale vehicle auctioneer shall be deemed a transferee of the
18 vehicle for the purposes of subsection 4. The wholesale vehicle auctioneer
19 is not required to comply with subsection 1 if he:

20 (1) Does not take an ownership interest in the vehicle;

21 (2) Auctions the vehicle to a vehicle dealer or automobile wrecker
22 *who is* licensed as such in this or any other state; and

23 (3) Stamps his name, his identification number as a vehicle dealer
24 and the date of the auction on the certificate of ownership and the bill of
25 sale and any other documents of transfer for the vehicle.

26 6. A charitable organization which intends to sell a vehicle which has
27 been donated to the organization must deliver immediately to the
28 department or its agent the certificate of registration and the license plate
29 or plates for the vehicle. The charitable organization must not be required
30 to register, pay a transfer or registration fee for, or pay a privilege tax on
31 the vehicle. When the vehicle is sold by the charitable organization, the
32 purchaser shall apply for registration as provided in NRS 482.215 and pay
33 the privilege taxes due.

34 7. ~~For the purposes of~~ *As used in* this section, "wholesale vehicle
35 auctioneer" means a dealer who:

36 (a) Is engaged in the business of auctioning consigned motor vehicles to
37 vehicle dealers or automobile wreckers, or both, who are licensed as such
38 in this or any other state; and

39 (b) Does not in the ordinary course of his business buy, sell or own *the*
40 vehicles he auctions.

41 **Sec. 3.** This act becomes effective on July 1, 1999.
