THE SYSTEM OF JUVENILE JUSTICE IN NEVADA)

ASSEMBLY CONCURRENT RESOLUTION—Directing the Legislative Commission to continue the study of the system of juvenile justice in Nevada.

- 1 WHEREAS, The Legislative Commission was directed by Assembly
- 2 Concurrent Resolution No. 57 of the 69th session of the Nevada Legislature
- 3 to study specific issues relating to the system of juvenile justice in this
- 4 state; and
- 5 WHEREAS, The study was conducted during the 1997-98 legislative
- 6 interim and it facilitated a wide-ranging discussion by national, state and
- 7 local experts that resulted in the development of a comprehensive long-
- 8 range plan to improve the system of juvenile justice in this state; and
- 9 WHEREAS, The study concluded that a second phase of discussion,
- 10 oversight and consideration of this issue was necessary to ensure a
- 11 comprehensive approach that will result in meaningful improvements in the
- 12 system of juvenile justice in Nevada; now, therefore, be it
- 13 RESOLVED BY THE ASSEMBLY OF THE STATE OF NEVADA, THE SENATE
- 14 CONCURRING, That the Legislative Commission is hereby directed to
- 15 appoint a subcommittee, consisting of four members of the Assembly and
- 16 four members of the Senate, to continue the study of the system of juvenile
- 17 justice in the State of Nevada; and be it further
- 18 RESOLVED, That the subcommittee may appoint an advisory committee,
- 19 consisting of persons who are knowledgeable in the areas of the study, to
- 20 consult with and to assist in conducting the study; and be it further

- 1 RESOLVED, That the study may include, but is not limited to:
- 2 1. A review and evaluation of the recent efforts made by state and local
- 3 juvenile authorities to adopt and use uniform criteria, methodology and
- 4 instruments when detaining a juvenile, placing a juvenile in a correctional
- 5 facility or placing a juvenile on probation or otherwise in the community;
- 6 2. A review and evaluation of the system of intermediate sanctions and
- 7 corresponding interventions for delinquent youth;
- 8 3. A review of the results of an updated report on the assessment of the
- 9 need for juvenile correctional facilities and related programs in this state
- 10 that was originally completed in August 1992;
- 11 4. A review of the evaluation of the Standardized Juvenile Justice Data
- 12 Collection System of the Division of Child and Family Services of the
- 13 Department of Human Resources;
- 14 5. A review of the use in the juvenile justice system of this state of
- 15 programs intended to prevent and treat substance abuse, including, without
- 16 limitation, educational programs and aftercare efforts;
- 17 6. An assessment of the desirability of restructuring the relationship
- 18 between state and local juvenile justice agencies, including the potential to
- 19 produce a seamless continuum of care;
- 20 7. An assessment of gang activity and a review of prevention and
- 21 intervention efforts;
- 22 8. An assessment of school violence in this state;
- 23 9. A review of the survey of the availability of nontraditional
- 24 alternative education programs;
- 25 10. An assessment of the uniformity of standards of operation for
- 26 juvenile detention and juvenile correctional facilities;
- 27 11. An evaluation of the results of an assessment of the need for mental
- 28 health services for the juvenile justice population at the state and local
- 29 level;
- 30 12. A review and evaluation of a proposed integrated data system to
- 31 track the various interactions that individual youths have with the various
- 32 state and local service agencies;
- 33 13. A review and evaluation of the programs and efforts to reduce
- 34 truancy in public schools; and
- 35 14. A discussion of the desirability of implementing restorative justice
- 36 programs in this state, including programs involving interaction between
- 37 the delinquent juvenile and the victim; and be it further
- 38 RESOLVED, That no action may be taken by the subcommittee on
- 39 recommended legislation unless it receives a majority vote of the Senators
- 40 on the subcommittee and a majority vote of the Assemblymen on the
- 41 subcommittee; and be it further

- 1 RESOLVED, That the Legislative Commission submit a report of the
- 2 study and any recommendations for legislation to the 71st session of the
- 3 Nevada Legislature.
