ASSEMBLY CONCURRENT RESOLUTION—Directing the Legislative Commission to conduct an interim study concerning the evaluation of sex offenders by panels.

WHEREAS. The nend that certifies prisoners who are say offenders for

- WHEREAS, The panel that certifies prisoners who are sex offenders for
- 2 release on parole has been given an enormous responsibility with few
- 3 guidelines or information on which to base its decisions; and
- WHEREAS, The panel, consisting of the Administrator of the Mental
- 5 Hygiene and Mental Retardation Division of the Department of Human
- 6 Resources, the Director of the Department of Prisons and a psychologist or
- 7 psychiatrist licensed in the State of Nevada, does not interact with the
- 8 offenders in question before a hearing and does not require reports from
- 9 staff members who do have daily interaction with the offenders; and
- 10 WHEREAS, The members of the panel do not administer any
- standardized or psychosexual tests to the sex offender before making a
- 12 decision: and
- WHEREAS. The panel hearing is currently structured in an interview
- format with most of the information given orally by the offender in
- response to questions asked; and
- WHEREAS, Although NRS 213.1214 requires that the panel certify that
- the prisoner was "under observation while confined in an institution of the
- department of prisons," no guidelines are given regarding who makes such
- 19 observations: and
- 20 WHEREAS, The prison's psychologist and the prisoner's caseworker see
- 21 the prisoner on a frequent basis, and could better certify the sex offender's

- readiness for continuing rehabilitation in a community environment; now, therefore, be it
- 3 RESOLVED BY THE ASSEMBLY OF THE STATE OF NEVADA, THE SENATE
- 4 CONCURRING, That the Legislative Commission is hereby directed to
- 5 conduct an interim study concerning the evaluation of sex offenders for
- 6 certification for release on parole pursuant to NRS 213.1214; and be it 7 further
- RESOLVED, That the study must include, without limitation, an analysis of:
- 1. The procedures followed by the panel in making its determinations regarding the certification of sex offenders for release on parole;
- 12 2. The criteria used by the panel to arrive at decisions regarding the certification of sex offenders for such release;
- 3. The qualifications that are necessary for panel members to possess to determine fairly whether a sex offender is "a menace to the health, safety or morals of others" pursuant to NRS 213.1214;
- 4. The advantages of hiring a specialist in the rehabilitation of sex offenders to develop and carry out a treatment program for incarcerated sex offenders that would include assessments in behavior which could be used in deliberations by the panel;
- 5. The composition and effectiveness of similar panels in other states, if any; and
- 6. Any other matters deemed pertinent to the evaluation of sex offenders for certification for release on parole; and be it further
- 25 RESOLVED, That no action may be taken by the study committee on
- 26 recommended legislation unless it receives a majority vote of the Senators
- on the committee and a majority vote of the Assemblymen on the
- 28 committee; and be it further
- 29 RESOLVED, That the Legislative Commission shall submit a report of the
- results of the study and any recommendations for legislation to the 71st
- session of the Nevada Legislature.
