2 and Jesse Waite, were selected from a list of distinguished nominees; and

3 WHEREAS, Jamie McAdoo, 18 years, of Elko High School in Elko was  
4 chosen for her commitment to tutoring a young autistic boy for the past 6  
5 years and due in part to her work with this boy, she aspires to be a special  
6 education teacher; and

7 WHEREAS, Jesse Waite, 15 years, of W. Mack Lyon Middle School in  
8 Overton was chosen for designing and organizing a landscaping project to  
9 beautify an empty lot at a local elementary school; and

10 WHEREAS, He organized volunteers, solicited donations and,  
11 overcoming some weighty obstacles, his patience and determination  
12 enabled him to see the project to completion; and

13 WHEREAS, These young people exemplify the spirit of the community  
14 that is so important to the future of our cities, towns and neighborhoods;
