AN ACT relating to professions; creating the board of examiners for alcohol and drug abuse counselors; prescribing the powers and duties of the board; requiring persons who counsel alcohol and drug abusers to be licensed or certified by the board; prescribing the requirements for licensure and certification; providing a penalty; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY. DO ENACT AS FOLLOWS:

- **Section 1.** Title 54 of NRS is hereby amended by adding thereto a
- new chapter to consist of the provisions set forth as sections 2 to 44,
- 3 inclusive, of this act.
- 4 Sec. 2. As used in this chapter, unless the context otherwise requires,
- 5 the words and terms defined in sections 3 to 10, inclusive, of this act,
- 6 have the meanings ascribed to them in those sections.
- 7 Sec. 3. "Board" means the board of examiners for alcohol and drug 8 abuse counselors.
- 9 Sec. 4. "Certificate" means a certificate issued to a person who is
- 10 certified as an alcohol and drug abuse counselor or an alcohol and drug
- 11 abuse counselor intern.
- 12 Sec. 5. "Certified counselor" means a person who is certified as an
- 13 alcohol and drug abuse counselor pursuant to the provisions of this
- 14 *chapter*.
- 15 Sec. 6. "Certified intern" means a person who is certified as an
- 16 alcohol and drug abuse counselor intern pursuant to the provisions of
- 17 this chapter.

- "Habitual use" means the use of alcohol and drugs that endangers the health, safety or welfare of the user or any other person.
- Sec. 8. "License" means a license issued to a person who is licensed as an alcohol and drug abuse counselor pursuant to the provisions of this chapter.
- Sec. 9. "Licensed counselor" means a person who is licensed as an alcohol and drug abuse counselor pursuant to the provisions of this chapter.
- Sec. 10. "Practice of counseling alcohol and drug abusers" means the application of counseling to reduce or eliminate the habitual use of alcohol or other drugs, other than any maintenance dosage of a narcotic or habit-forming drug administered pursuant to chapter 453 of NRS. 12
- **Sec. 11.** The practice of counseling alcohol and drug abusers is 13 hereby declared to be a learned profession, affecting public health, safety and welfare and is subject to regulation to protect the public from the 15 practice of counseling alcohol and drug abusers by unqualified persons and from unprofessional conduct by persons who are licensed or certified to engage in the practice of counseling alcohol and drug abusers. 18
 - **Sec. 12.** A license or certificate issued pursuant to the provisions of this chapter is a privilege that may be revoked in accordance with the disciplinary procedures set forth in this chapter and in regulations adopted by the board pursuant thereto, and no holder of such a license or certificate acquires thereby any vested right.
 - Sec. 13. The provisions of this chapter do not apply to:

- A physician who is licensed pursuant to the provisions of chapter 630 of NRS;
- 2. A nurse who is licensed pursuant to the provisions of chapter 632 of NRS and is authorized by the state board of nursing to engage in the 28 practice of counseling alcohol and drug abusers;
- A psychologist who is licensed pursuant to the provisions of 30 chapter 641 of NRS; 31
- 4. A marriage and family therapist who is licensed pursuant to the 32 provisions of chapter 641A of NRS and is authorized by the board of 34 examiners for marriage and family therapists to engage in the practice of counseling alcohol and drug abusers; or 35
- A person who is licensed as a clinical social worker pursuant to 36 the provisions of chapter 641B of NRS and is authorized by the board of examiners for social workers to engage in the practice of counseling alcohol and drug abusers.
- Sec. 14. 1. The board of examiners for alcohol and drug abuse 40 counselors, consisting of five members appointed by the governor, is hereby created.

- The board must consist of:
- (a) Three members who are licensed as alcohol and drug abuse counselors pursuant to the provisions of this chapter;
- (b) One member who is certified as an alcohol and drug abuse counselor pursuant to the provisions of this chapter; and
 - (c) One member who is a representative of the general public.
 - A person may not be appointed to the board unless he is:
- (a) A citizen of the United States or is lawfully entitled to remain and work in the United States; and
 - (b) A resident of this state.

- No member of the board may be held liable in a civil action for 11 12 any act that he performs in good faith in the execution of his duties 13 pursuant to the provisions of this chapter.
- Sec. 15. 1. After the initial terms, the members of the board must 14 15 be appointed to terms of 4 years and may not serve more than two consecutive terms.
- Upon the expiration of his term, a member continues to serve on the board until a qualified person has been appointed as his successor. 18
- The governor may, after notice and hearing, remove any member 19 of the board for misconduct, incompetence, neglect of duty or any other 20 sufficient cause. 21
- The board shall: 22
- (a) Elect annually from its members a president, vice president and 24 secretary-treasurer. If the president, vice president or secretary-treasurer is replaced by another person appointed by the governor, the board shall 26 elect from its members a replacement for the president, vice president or secretary-treasurer. 27
- (b) Meet not less than twice a year and may meet at other times at the 28 29 call of the president or a majority of its members.
- (c) Not incur any expenses that exceed the money received from time 30 to time as fees provided by the provisions of this chapter. 31
 - (d) Prepare and maintain a record of its transactions and proceedings.
- (e) Adopt a seal of which each court of this state shall take judicial 33 34 *notice*.
- A majority of the members of the board constitutes a quorum to *5*. 35 transact the business of the board.
 - Sec. 16. 1. Each member of the board is entitled to receive:
- (a) A salary of not more than \$80 per day, as fixed by the board, while 38 engaged in the business of the board; and
- (b) A per diem allowance and travel expenses, at a rate fixed by the 40 board, while engaged in the business of the board. The rate must not exceed the rate provided for officers and employees of this state generally.

- 2. While engaged in the business of the board, each employee of the board is entitled to receive a per diem allowance and travel expenses at a rate fixed by the board. The rate must not exceed the rate provided for officers and employees of this state generally.
- Sec. 17. The secretary-treasurer of the board shall prepare and maintain:
- 1. A separate list of the names and addresses of:
- (a) The applicants for a license;
- 9 (b) The applicants for a certificate;
- 10 (c) The licensed counselors;
- 11 (d) The certified counselors; and
- 12 (e) The certified interns.
- 2. A record of each examination conducted by the board.
- 14 3. An inventory of:

- 15 (a) The property of the board; and
 - (b) The property of this state that is in the possession of the board.
- 17 **Sec. 18.** *The board may:*
- 18 1. Maintain offices in as many locations in this state as it considers 19 necessary to carry out the provisions of this chapter.
- 20 **2.** Employ attorneys, investigators and other persons necessary to carry out its duties.
- Sec. 19. 1. Except as otherwise provided in subsection 4, all expenses incurred by the board in carrying out the provisions of this chapter must be paid from the money which it receives. No part of the salaries or expenses of the board may be paid out of the state general fund.
- 27 2. All money received by the board must be deposited in a bank or other financial institution in this state and paid out on its order for its expenses.
- 3. The board may delegate to a hearing officer or panel its authority to take any disciplinary action pursuant to this chapter, impose and collect fines and penalties therefor and deposit the money therefrom in a bank or other financial institution in this state.

If a hearing officer or panel is not authorized to take disciplinary action pursuant to subsection 3, the board shall deposit the money collected from the imposition of fines with the state treasurer for credit to the state general fund. If money is so deposited, the board may present a claim to the state board of examiners for recommendation to the interim finance committee if money is needed to pay attorney's fees or the costs of an investigation, or both.
- Sec. 20. Each applicant for a license or certificate must submit to the board:

- An application on a form provided by the board; and *1*.
- The application fee prescribed in section 34 of this act.
- Sec. 21. An application for a license or certificate must set forth the 3 social security number of the applicant.
- Sec. 22. 1. An applicant for the issuance, renewal, reinstatement or restoration of a license or certificate shall submit to the board the statement prescribed by the welfare division of the department of human resources pursuant to NRS 425.520. The statement must be completed and signed by the applicant.
- The board shall include the statement required pursuant to 10 subsection 1 in: 11
- (a) The application or any other forms that must be submitted for the 12 issuance, renewal, reinstatement or restoration of the license or 13 certificate; or
 - (b) A separate form prescribed by the board.
- A license or certificate may not be issued, renewed, reinstated or 16 restored by the board if the applicant: 17
 - (a) Fails to submit the statement required pursuant to subsection 1; or
- (b) Indicates on the statement submitted pursuant to subsection 1 that he is subject to a court order for the support of a child and is not in compliance with the order or a plan approved by the district attorney or 22 other public agency enforcing the order for the repayment of the amount owed pursuant to the order.
- 4. If an applicant indicates on the statement submitted pursuant to subsection 1 that he is subject to a court order for the support of a child 26 and is not in compliance with the order or a plan approved by the district 27 attorney or other public agency enforcing the order for the repayment of 28 the amount owed pursuant to the order, the board shall advise the 29 applicant to notify the district attorney or other public agency enforcing 30 the order to determine the actions that the applicant may take to satisfy the arrearage.
- Sec. 23. The board shall issue a license as an alcohol and drug 32 abuse counselor to: 33
- 34 1. A person who:

- (e) Passes the written and oral examinations prescribed by the board pursuant to section 28 of this act;
- 41 (f) Pays the fees required pursuant to section 34 of this act; and

- 2. A certificate as an alcohol and drug abuse counselor is valid for 2 years and may be renewed.

 - (c) Has a high school diploma or a general equivalency diploma;

- Sec. 33. 1. A license or certificate that is not renewed on or before 12 the date on which it expires is delinquent. The board shall, within 30 days after the license or certificate becomes delinquent, send a notice to 14 the licensed or certified counselor or certified intern by certified mail, 15 return receipt requested, to the address of the counselor or intern as indicated in the records of the board.
 - A licensed or certified counselor or certified intern may renew a delinquent license or certificate within 60 days after the license or certificate becomes delinquent by complying with the requirements of section 32 of this act and paying, in addition to the fee for the renewal of the license or certificate, the fee for the renewal of a delinquent license or certificate prescribed in section 34 of this act.
 - 3. A license or certificate expires 60 days after it becomes delinquent if it is not renewed within that period.

- The fees charged and collected pursuant to this section are not refundable.
- Sec. 35. The grounds for initiating disciplinary action pursuant to 15 the provisions of this chapter include: 16
 - **Conviction of:**
- (a) A felony; 18
 - (b) An offense involving moral turpitude; or
- (c) A violation of a federal or state law regulating the possession, 20 21 distribution or use of a controlled substance or dangerous drug as defined in chapter 453 of NRS;
 - Fraud or deception in:
 - (a) Applying for a license or certificate;
 - (b) Taking an examination for a license or certificate;
- (c) Documenting the continuing education required to renew or 26 reinstate a license or certificate;
 - (d) Submitting a claim for payment to an insurer; or
 - (e) The practice of counseling alcohol and drug abusers;

specifying the relevant facts with the board. The complaint must specifically charge one or more of the grounds for initiating disciplinary 3 action.

- 2. As soon as practicable after the filing of the complaint, the board 5 shall set a date for a hearing thereon. The date must not be earlier than 30 days after the complaint is filed, except that the date may be changed upon agreement of the parties. The board shall immediately notify the licensed or certified counselor or certified intern of the complaint and the 9 date and place set for the hearing. A copy of the complaint must be attached to the notice.
- The failure of the licensed or certified counselor or certified intern 11 to appear at the hearing does not delay or void the proceeding. 12 13
- The board may, for good cause, continue a hearing from time to 14 *time*.

- Sec. 39. 1. Any records or information obtained during the course 13 of an investigation by the board and any record of the investigation are 14 confidential until the investigation is completed. Upon completion of the investigation, the information and records are public records if:
 - (a) Disciplinary action is imposed by the board as a result of the investigation; or
- (b) The person regarding whom the investigation was made submits a 18 written request to the board asking that the information and records be made public records. 20
- 2. If the board receives a request or subpoena for records or information obtained during an investigation by the board and the records or information is not made public pursuant to subsection 1, the 24 board shall notify the person regarding whom the investigation was made of the request or subpoena. If that person does not consent in writing to 26 the release of the records or information, the board may release the records or information only upon the order of a court of competent jurisdiction.
 - Sec. 40. 1. The board may issue subpoenas for the attendance of witnesses and the production of books and papers.
 - The district court, in and for the county in which a hearing is held, may compel the attendance of witnesses, the giving of testimony and the production of books and papers as required by a subpoena issued by the board.
- *3*. If a witness refuses to attend or testify or to produce any books or 35 papers required by a subpoena, the board may file a petition ex parte with the district court, setting forth that: 37
- (a) Notice has been given of the time and place for the attendance of 38 the witness or the production of the books or papers; 39
- 40 (b) The witness has been subpoenaed by the board pursuant to this section: 41
- (c) The witness has failed or refused to attend or produce the books or 42 papers required by the subpoena before the board in the cause or

proceeding named in the subpoena, or has refused to answer questions propounded to him in the course of the hearing; and

- (d) The board therefore requests an order of the court compelling the witness to attend and testify or produce the books and papers before the board.
- *4*. The court, upon such a petition, shall enter an order directing the witness to appear before the court at a time and place fixed by the court in the order, and to show cause why he has not attended or testified or produced the books or papers before the board. The time may not be more than 10 days after the date of the order. A certified copy of the order must be served upon the witness.

- If the court determines that the subpoena was regularly issued by 13 the board, the court shall enter an order that the witness appear before the board at the time and place fixed in the order, and testify or produce the required books or papers. The failure to obey the order is a contempt of the court that issued it.

TEXT OF REPEALED SECTION

458.360 Unlawful representation as certified counselor; injunction; penalty. 1. No person may hold himself out to the public as an alcohol and drug abuse counselor, employ or use the title "alcohol and drug abuse counselor," "substance abuse counselor" or any similar title in connection with his work, or in any way imply that he is a certified alcohol and drug abuse counselor without being certified as a counselor by the bureau.

- 2. If the bureau believes from satisfactory evidence presented to it that any person has violated or is about to violate the provisions of subsection 1, it may bring an action in a court of competent jurisdiction to enjoin that person from engaging in or continuing the violation. Such an injunction:
- (a) May be issued without proof of actual damage sustained by any person.
- (b) Does not preclude criminal prosecution and punishment of a violator.
- 3. Any person who violates the provisions of subsection 1 is guilty of a misdemeanor.
