SUMMARY—Authorizes public body and department of transportation to use design-build method of contracting in certain circumstances. (BDR 28-517)

AN ACT relating to public works; authorizing a public body to contract with a design-build team or specialty contractor for the design and construction of a public work in certain circumstances; authorizing the department of transportation to contract with a design-build team with respect to a project for the design and construction, reconstruction or improvement of highways in certain circumstances; setting forth the method in which proposals for a design-build contract must be solicited; setting forth the method in which a design-build team must be selected; authorizing a public body or the department of transportation to employ an architect or engineer to oversee the construction of a public work or project; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE
AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 338 of NRS is hereby amended by adding thereto
- 2 the provisions set forth as sections 2 to 9, inclusive, of this act.
- 3 **Sec. 2. 1. *Except as otherwise provided in this section, a public***
- 4 ***body shall contract with a prime contractor for the construction of a***
- 5 ***public work for which the estimated cost exceeds \$100,000.***
- 6 ***2. A public body may contract with a design-build team for the***
- 7 ***design and construction of a public work that is a discrete project if the***
- 8 ***public body determines that:***
- 9 ***(a) The public work is:***
- 10 ***(1) A plant or facility for the treatment and pumping of water or the***
- 11 ***treatment and disposal of wastewater or sewage, the estimated cost of***
- 12 ***which exceeds \$100,000; or***

1 (2) Any other type of public work, except a stand-alone
2 underground utility project, the estimated cost of which exceeds
3 \$30,000,000; and

4 (b) Contracting with a design-build team will enable the public body
5 to:

6 (1) Design and construct the public work at a cost that is
7 significantly lower than the cost that the public body would incur to
8 design and construct the public work using a different method;

9 (2) Design and construct the public work in a shorter time than
10 would be required to design and construct the public work using a
11 different method, if exigent circumstances require that the public work
12 be designed and constructed within a short time; or

13 (3) Ensure that the design and construction of the public work is
14 properly coordinated, if the public work is unique, highly technical and
15 complex in nature.

16 3. Notwithstanding the provisions of subsections 1 and 2, a public
17 body may contract with a prime contractor, specialty contractor or
18 design-build team with respect to a public work if the public body
19 determines that the public work is:

20 (a) Not part of a larger public work; and

21 (b) Limited in scope to:

22 (1) Removal of asbestos;

23 (2) Replacement of equipment or systems for heating, ventilation
24 and air-conditioning;

25 (3) Replacement of a roof; or

26 (4) Landscaping.

27 **Sec. 3. 1.** A public body shall not contract with a design-build team
28 with respect to a public work unless the governing body of the public
29 body makes the determinations, at a public hearing, that are required
30 pursuant to subsection 2 or 3 of section 2 of this act, as applicable.

31 2. A public body that is required to hold a public hearing pursuant to
32 this section shall publish notice of the hearing at least once each week
33 for 3 consecutive weeks in:

34 (a) A newspaper of general circulation published in the county in
35 which the public work is proposed to be constructed or, if there is no such
36 newspaper, in a newspaper of general circulation in the county published
37 in this state; and

38 (b) A newspaper of general circulation in this state.

39 **Sec. 4. 1.** A public body that is required to contract with a prime
40 contractor pursuant to subsection 1 of section 2 of this act or elects to
41 contract with a specialty contractor pursuant to subsection 3 of section 2
42 of this act shall select the prime contractor or specialty contractor, as

1 *appropriate, in accordance with the procedures for bidding that are set*
2 *forth in NRS 338.140 to 338.147, inclusive.*

3 *2. A public body that contracts with a design-build team pursuant to*
4 *sections 2 and 3 of this act shall select the design-build team in*
5 *accordance with sections 5 to 8, inclusive, of this act.*

6 **Sec. 5. 1.** *A public body shall advertise for preliminary proposals*
7 *for the design and construction of a public work by a design-build team*
8 *at least twice each week for 3 consecutive weeks in:*

9 *(a) A newspaper of general circulation published in the county in*
10 *which the public work is proposed to be constructed or, if there is no such*
11 *newspaper, in a newspaper of general circulation in the county published*
12 *in this state; and*

13 *(b) A newspaper of general circulation in this state.*

14 *2. A request for preliminary proposals published pursuant to*
15 *subsection 1 must include, without limitation:*

16 *(a) A description of the public work to be designed and constructed;*

17 *(b) Separate estimates of the costs of designing and constructing the*
18 *public work;*

19 *(c) The dates on which it is anticipated that the separate phases of the*
20 *design and construction of the public work will begin and end;*

21 *(d) A statement setting forth the place and time in which a design-*
22 *build team desiring to bid on the public work may obtain specifications*
23 *for bids and other information necessary to bid on the public work;*

24 *(e) A list of the requirements set forth in section 6 of this act;*

25 *(f) A list of the factors that the public body will use to evaluate design-*
26 *build teams who bid on the public work, including, without limitation:*

27 *(1) The relative weight to be assigned to each factor; and*

28 *(2) A disclosure of whether the factors that are not related to cost*
29 *are, when considered as a group, more or less important in the process of*
30 *evaluation than the factor of cost;*

31 *(g) A statement setting forth that a design-build team whose prime*
32 *contractor holds a certificate of eligibility to receive a preference in*
33 *bidding on public works issued pursuant to NRS 338.147 shall be deemed*
34 *to have submitted a better proposal than a competing design-build team*
35 *whose prime contractor does not hold such a certificate of eligibility if*
36 *the amount of the bid of the design-build team is not more than 5 percent*
37 *higher than the amount bid by the competing design-build team;*

38 *(h) Notice that a design-build team desiring to bid on the public work*
39 *must include with its bid the information used by the public body to*
40 *determine finalists among the bidding design-build teams pursuant to*
41 *subsection 2 of section 7 of this act and a description of that information;*

42 *(i) A statement as to whether a bidding design-build team that is*
43 *selected as a finalist pursuant to section 7 of this act but is not awarded*

1 the design-build contract pursuant to section 8 of this act will be partially
2 reimbursed for the cost of preparing a final proposal and, if so, an
3 estimate of the amount of the partial reimbursement; and

4 (j) The date by which preliminary proposals must be submitted to the
5 public body, which must not be less than 30 days or more than 60 days
6 after the date on which the request for preliminary proposals is first
7 published in a newspaper pursuant to subsection 1.

8 **Sec. 6.** To qualify to participate in a project for the design and
9 construction of a public work, a design-build team must:

10 1. Obtain a performance bond and payment bond as required
11 pursuant to NRS 339.025;

12 2. Obtain insurance covering general liability and liability for errors
13 and omissions;

14 3. Not have been found liable for breach of contract with respect to a
15 previous project, other than a breach for legitimate cause;

16 4. Not have been disqualified from being awarded a contract
17 pursuant to NRS 338.017, 338.145 or 408.333; and

18 5. Ensure that the members of the design-build team possess the
19 licenses and certificates required to carry out the functions of their
20 respective professions within this state.

21 **Sec. 7. 1.** Within 30 days after the date by which preliminary
22 proposals must be submitted to the public body, the public body shall
23 select at least three but not more than five finalists from among the
24 design-build teams that submitted preliminary proposals. If the public
25 body does not receive at least three preliminary proposals from design-
26 build teams that the public body determines to be qualified pursuant to
27 this section and section 6 of this act, the public body may not contract
28 with a design-build team for the design and construction of the public
29 work.

30 2. The public body shall select finalists pursuant to subsection 1 by:
31 (a) Verifying that each design-build team which submitted a
32 preliminary proposal satisfies the requirements of section 6 of this act;
33 and

34 (b) Conducting an evaluation of the qualifications of each design-
35 build team that submitted a preliminary proposal, including, without
36 limitation, an evaluation of:

37 (1) The professional qualifications and experience of the members
38 of the design-build team;

39 (2) The performance history of the members of the design-build
40 team concerning other recent, similar projects completed by those
41 members, if any;

42 (3) The safety programs established and the safety records
43 accumulated by the members of the design-build team; and

1 (4) *The proposed plan of the design-build team to manage the*
2 *design and construction of the public work that sets forth in detail the*
3 *ability of the design-build team to design and construct the public work.*

4 **Sec. 8. 1.** *After selecting the finalists pursuant to section 7 of this*
5 *act, the public body shall provide to each finalist a request for final*
6 *proposals for the public work. The request for final proposals must:*

7 (a) *Set forth the factors that the public body will use to select a design-*
8 *build team to design and construct the public work, including the relative*
9 *weight to be assigned to each factor; and*

10 (b) *Set forth the date by which final proposals must be submitted to*
11 *the public body.*

12 2. *A final proposal submitted by a design-build team pursuant to this*
13 *section must be prepared thoroughly, be responsive to the criteria that the*
14 *public body will use to select a design-build team to design and construct*
15 *the public work described in subsection 1 and comply with the provisions*
16 *of NRS 338.144.*

17 3. *Within 30 days after receiving the final proposals for the public*
18 *work, the public body shall:*

19 (a) *Select the most cost-effective and responsive final proposal, using*
20 *the criteria set forth pursuant to subsection 1; or*

21 (b) *Reject all the final proposals.*

22 4. *If a public body selects a final proposal pursuant to paragraph (a)*
23 *of subsection 3, the public body shall, at its next regularly scheduled*
24 *meeting:*

25 (a) *Review and ratify the selection.*

26 (b) *Award the design-build contract to the design-build team whose*
27 *proposal is selected.*

28 (c) *Partially reimburse the unsuccessful finalists if partial*
29 *reimbursement was provided for in the request for preliminary proposals*
30 *pursuant to paragraph (i) of subsection 2 of section 5 of this act. The*
31 *amount of reimbursement must not exceed, for each unsuccessful*
32 *finalist, three percent of the total amount to be paid to the design-build*
33 *team as set forth in the design-build contract.*

34 (d) *Make available to the public a summary setting forth the factors*
35 *used by the public body to select the successful design-build team, the*
36 *relative weight assigned to each factor and the ranking of the design-*
37 *build teams who submitted final proposals. The public body shall not*
38 *release to a third party, or otherwise make public, financial or*
39 *proprietary information submitted by a design-build team.*

40 5. *A design-build team to whom a contract is awarded pursuant to*
41 *this section shall:*

1 (a) Assume overall responsibility for ensuring that the design and
2 construction of the public work is completed in a satisfactory manner;
3 and

4 (b) Use the work force of the prime contractor on the design-build
5 team to construct at least 15 percent of the public work.

6 **Sec. 9.** A public body may employ a registered architect or licensed
7 professional engineer as a consultant to assist the public body in
8 overseeing the construction of a public work. An architect or engineer so
9 employed shall not:

10 1. Design or construct the public work; or

11 2. Assume overall responsibility for ensuring that the design or
12 construction of the public work is completed in a satisfactory manner.

13 **Sec. 10.** NRS 338.010 is hereby amended to read as follows:

14 338.010 As used in this chapter:

15 1. "Day labor" means all cases where public bodies, their officers,
16 agents or employees, hire, supervise and pay the wages thereof directly to a
17 workman or workmen employed by them on public works by the day and
18 not under a contract in writing.

19 2. "Design-build contract" means a contract between a public body
20 and a design-build team in which the design-build team agrees to design
21 and construct a public work.

22 3. "Design-build team" means an entity that consists of:

23 (a) At least one person who is licensed as a general engineering
24 contractor or a general building contractor pursuant to NRS 624.230 to
25 624.320, inclusive; and

26 (b) At least one person who holds a certificate of registration to
27 practice architecture pursuant to chapter 623 of NRS or is licensed as a
28 professional engineer pursuant to chapter 625 of NRS.

29 4. "Design professional" means a person with a professional license
30 or certificate issued pursuant to chapter 623, 623A or 625 of NRS.

31 5. "Eligible bidder" means a person who ~~was~~ is found to be a
32 responsible and responsive contractor or design-build team by a public
33 body which ~~awarded a contract~~ requests bids for a public work.

34 ~~3.~~ 6. "Offense" means failing to:

35 (a) Pay the prevailing wage required pursuant to this chapter;

36 (b) Pay the contributions for unemployment compensation required
37 pursuant to chapter 612 of NRS; or

38 (c) Provide and secure compensation for employees required pursuant to
39 chapters 616A to 617, inclusive, of NRS.

40 ~~4.~~ 7. "Prime contractor" means a person who:

41 (a) Contracts to construct an entire project;

42 (b) Coordinates all work performed on the entire project;

1 *(c) Uses his own workforce to perform all or a part of the*
2 *construction, repair or reconstruction of the project; and*

3 *(d) Contracts for the services of any subcontractor or independent*
4 *contractor or is responsible for payment to any contracted subcontractors*
5 *or independent contractors.*

6 **8.** "Public body" means the state, county, city, town, school district or
7 any public agency of this state or its political subdivisions sponsoring or
8 financing a public work.

9 ~~15.1~~ **9.** "Public work" means any project for the new construction,
10 repair or reconstruction of:

11 (a) A project financed in whole or in part from public money for:

12 (1) Public buildings;

13 (2) Jails and prisons;

14 (3) Public roads;

15 (4) Public highways;

16 (5) Public streets and alleys;

17 (6) Public utilities which are financed in whole or in part by public
18 money;

19 (7) Publicly owned water mains and sewers;

20 (8) Public parks and playgrounds;

21 (9) Public convention facilities which are financed at least in part with
22 public funds; and

23 (10) All other publicly owned works and property whose cost as a
24 whole exceeds \$20,000. Each separate unit which is a part of a project is
25 included in the cost of the project for the purpose of determining whether a
26 project meets this threshold.

27 (b) A building for the University and Community College System of
28 Nevada of which 25 percent or more of the costs of the building as a whole
29 are paid from money appropriated by the state or federal money.

30 ~~16.1~~ **10.** "Specialty contractor" means a contractor whose operations
31 as such are the performance of construction work requiring special skill
32 and whose principal contracting business involves the use of specialized
33 building trades or crafts.

34 **11.** "Stand-alone underground utility project" means an
35 underground utility project that is not integrated into a larger project,
36 including, without limitation:

37 (a) An underground sewer line or an underground pipeline for the
38 conveyance of water, including facilities appurtenant thereto; and

39 (b) A project for the construction or installation of a storm drain,
40 including facilities appurtenant thereto,

41 that is not located at the site of a public work for the design and
42 construction of which a public body is authorized to contract with a
43 design-build team pursuant to subsection 2 of section 2 of this act.

1 **12.** “Wages” means:

2 (a) The basic hourly rate of pay; and

3 (b) The amount of pension, health and welfare, vacation and holiday
4 pay, the cost of apprenticeship training or other similar programs or other
5 bona fide fringe benefits which are a benefit to the workman.

6 ~~17-1~~ **13.** “Workman” means a skilled mechanic, skilled workman,
7 semiskilled mechanic, semiskilled workman or unskilled workman. *The*
8 *term does not include a design professional.*

9 **Sec. 11.** NRS 338.143 is hereby amended to read as follows:

10 338.143 1. Except as otherwise provided in subsection 6 and NRS
11 338.1906 and 338.1907, an agency or political subdivision of the state, or a
12 public officer, public employee or other person responsible for awarding a
13 contract for the construction, alteration or repair of a public work, shall not:

14 (a) Commence such a project, for which the estimated cost exceeds
15 \$100,000, unless it advertises in a newspaper of general circulation in the
16 state for bids for the project; or

17 (b) Divide such a project into separate portions to avoid the
18 requirements of paragraph (a).

19 2. Except as otherwise provided in subsection 6, a public body that
20 maintains a list of properly licensed contractors who are interested in
21 receiving offers to bid on public works projects for which the estimated
22 cost is more than \$25,000 but less than \$100,000 shall solicit bids from not
23 more than three of the contractors on the list for a contract of that value for
24 the construction, alteration or repair of a public work. The public body
25 shall select contractors from the list in such a manner as to afford each
26 contractor an equal opportunity to bid on a public works project. A
27 properly licensed contractor must submit a written request annually to the
28 public body to remain on the list. Offers for bids which are made pursuant
29 to this subsection must be sent by certified mail.

30 3. Approved plans and specifications for the bids must be on file at a
31 place and time stated in the advertisement for the inspection of all persons
32 desiring to bid thereon and for other interested persons. Contracts for the
33 project must be awarded on the basis of bids received.

34 4. Any or all bids received in response to an advertisement for bids
35 may be rejected if the person responsible for awarding the contract
36 determines that:

37 (a) The bidder is not responsive or responsible;

38 (b) The quality of the services, materials, equipment or labor offered
39 does not conform to the approved plan or specifications; or

40 (c) The public interest would be served by such a rejection.

(a) The determination of the qualifications of contractors to bid for contracts for services described in subsection 1.

(b) The bidding and awarding of such contracts, subject to the provisions of subsection 3.

(c) The awarding of construction contracts, subject to the provisions of subsection 4, based on a final cost of the project which the contractor guarantees will not be exceeded.

(d) The scheduling and controlling of projects.

3. Bids on contracts for services which assist the architect in the design of a project of capital improvement must state separately the contractor's cost for:

(a) Assisting the architect in the design of the project.

(b) Obtaining all bids for subcontracts.

(c) Administering the construction contract.

4. A contractor who is:

(a) Qualified under the regulations of the board to bid for a contract for services described in subsection 1; and

(b) Awarded that contract,

is entitled to be awarded the construction contract for the project if his work under the contract for services is satisfactory to the board and he guarantees a final cost for the project which the board is willing to accept.

5. A person who furnishes services under a contract awarded pursuant to subsection 1 is a contractor subject to all provisions pertaining to a contractor in Title 28 of NRS.

341.171 Single contract for design and construction of capital improvement: Legislative approval; regulations.

1. The board may, with the approval of the interim finance committee when the legislature is not in regular or special session, or with the approval of the legislature by concurrent resolution when the legislature is in regular or special session, let to a contractor licensed under chapter 624 of NRS a single contract for both the design and construction of a project of capital improvement. The board shall for the purpose prepare a comprehensive sketch plan and narrative of the scope of the work involved in a project.

2. The board shall adopt regulations establishing procedures for:

(a) The determination of the qualifications of contractors to bid for contracts for the design and construction of such projects. The board shall consult with the American Institute of Architects and the Associated General Contractors, or the successor of either if the named organization ceases to exist, before adopting procedures under this paragraph.

(b) The board's approval of designs and architects employed in a

project.

(c) The bidding and awarding of contracts for the design and construction of projects based on a final cost of the project which the contractor guarantees will not be exceeded.

(d) The scheduling and controlling of projects.
