SUMMARY—Makes appropriations to Department of Motor Vehicles and Public Safety for costs of VHF Highband Radio Project and to Department of Transportation for completion of 800 MHz radio communication system. (BDR S-1464)

AN ACT making appropriations to the Department of Motor Vehicles and Public Safety for the costs of the VHF Highband Radio Project and to the Department of Transportation for completion of 800 MHz radio communication system; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE
AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the state general
2 fund:
3 (a) The sum of \$290,144 to the Division of Parole and Probation; and
4 (b) The sum of \$65,278 to the Investigation Division,
5 of the Department of Motor Vehicles and Public Safety for the Phase II
6 costs of the VHF Highband Radio Project.
7 2. Any remaining balance of the appropriation made by subsection 1
8 must not be committed for expenditure after June 30, 2001, and reverts to
9 the state general fund as soon as all payments of money committed have
10 been made.
11 **Sec. 2.** 1. There is hereby appropriated from the state highway fund:
12 (a) The sum of \$9,823,840 to the Nevada Highway Patrol Division; and
13 (b) The sum of \$40,220 to the Registration Division,

1 of the Department of Motor Vehicles and Public Safety for the Phase II
2 costs of the VHF Highband Radio Project.

3 2. Any remaining balance of the appropriation made by subsection 1
4 must not be committed for expenditure after June 30, 2001, and reverts to
5 the state highway fund as soon as all payments of money committed have
6 been made.

7 **Sec. 3.** 1. There is hereby appropriated from the state highway fund
8 to the Department of Transportation the sum of \$4,332,250 for the costs to
9 complete the development and installation of the 800 MHz radio
10 communication system.

11 2. Any remaining balance of the appropriation made by subsection 1
12 must not be committed for expenditure after June 30, 2003, and reverts to
13 the state highway fund as soon as all payments of money committed have
14 been made.

15 **Sec. 4.** This act becomes effective upon passage and approval.
