## SENATE BILL NO. 519–COMMITTEE ON HUMAN RESOURCES AND FACILITIES

SUMMARY—Authorizes certain persons to possess and administer controlled substances and dangerous drugs. (BDR 40-456)

AN ACT relating to public health; authorizing certain persons to possess and administer controlled substances and dangerous drugs; and providing other matters properly relating thereto.

## THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. (Deleted by amendment.)
- 2 **Sec. 2.** NRS 453.375 is hereby amended to read as follows:
- 3 453.375 A controlled substance may be possessed and administered by
- 4 the following persons:
- 5 1. A practitioner.
  - 2. A registered nurse licensed to practice professional nursing or
- 7 licensed practical nurse, at the direction of a physician, physician's
- 8 assistant, dentist, podiatric physician or advanced practitioner of nursing, or
- 9 pursuant to a chart order, for administration to a patient at another location.
  - 3. An advanced emergency medical technician:
- 11 (a) As authorized by regulation of:
- 12 (1) The state board of health in a county whose population is less than
- 13 100,000; or

- 14 (2) A county or district board of health in a county whose population
- 15 is 100,000 or more; and
- 16 (b) In accordance with any applicable regulations of:

- (1) The state board of health in a county whose population is less than 100,000; 2
- (2) A county board of health in a county whose population is 100,000 3 or more; or
- (3) A district board of health created pursuant to NRS 439.370 in any county.
- 4. A respiratory therapist, at the direction of a physician or physician's assistant.
- A medical student, student in training to become a physician's assistant or student nurse in the course of his studies at an approved college of medicine or school of professional or practical nursing, at the direction of a physician or physician's assistant and:
- (a) In the presence of a physician, physician's assistant or a registered 13 nurse: or 14
- (b) Under the supervision of a physician, physician's assistant or a 15 registered nurse if the student is authorized by the college or school to administer the substance outside the presence of a physician, physician's assistant or nurse.
- A medical student or student nurse may administer a controlled substance in the presence or under the supervision of a registered nurse alone only if the circumstances are such that the registered nurse would be authorized to administer it personally. 22
- An ultimate user or any person whom the ultimate user designates 23 pursuant to a written agreement.
  - Any person designated by the head of a correctional institution.
  - A veterinary technician at the direction of his supervising veterinarian.
- 9. In accordance with applicable regulations of the state board of 28 29 health, an employee of a residential facility for groups, as defined in NRS 449.017, pursuant to a written agreement entered into by the ultimate user. 30
- 10. In accordance with applicable regulations of the state board of 32 pharmacy, an animal control officer, a wildlife biologist or an employee designated by a federal, state or local governmental agency whose duties include the control of domestic, wild and predatory animals.

- **Sec. 4.** NRS 454.213 is hereby amended to read as follows: 36
- 454.213 A drug or medicine referred to in NRS 454.181 to 454.371, 37

- A physician's assistant at the direction of his supervising physician 40

[A] Except as otherwise provided in subsection 4, a registered nurse licensed to practice professional nursing or licensed practical nurse, at the direction of a prescribing physician, dentist, podiatric physician or advanced practitioner of nursing, or pursuant to a chart order, for administration to a patient at another location.
- In accordance with applicable regulations of the board, a registered nurse licensed to practice professional nursing or licensed practical nurse who is:
- (a) Employed by a health care agency or health care facility that is authorized to provide emergency care, or to respond to the immediate needs of a patient, in the residence of the patient; and
- (b) Acting under the direction of the medical director of that agency 13 or facility who works in this state.
  - An intermediate emergency medical technician or an advanced emergency medical technician, as authorized by regulation of the state board of pharmacy and in accordance with any applicable regulations of:
  - (a) The state board of health in a county whose population is less than 100,000;
- (b) A county board of health in a county whose population is 100,000 or 19 more; or 20
  - (c) A district board of health created pursuant to NRS 439.370 in any county.
  - A respiratory therapist employed in a health care facility. The therapist may possess and administer respiratory products only at the direction of a physician.
  - [6.] 7. A dialysis technician, under the direction or supervision of a physician or registered nurse only if the drug or medicine is used for the process of renal dialysis.
  - [7.] 8. A medical student or student nurse in the course of his studies at an approved college of medicine or school of professional or practical nursing, at the direction of a physician and:
    - (a) In the presence of a physician or a registered nurse; or
- (b) Under the supervision of a physician or a registered nurse if the 33 34 student is authorized by the college or school to administer the drug or medicine outside the presence of a physician or nurse.
- A medical student or student nurse may administer a dangerous drug in the presence or under the supervision of a registered nurse alone only if the 37 circumstances are such that the registered nurse would be authorized to
- administer it personally. 39
