AN ACT relating to commercial transactions; revising Article 9 of the Uniform Commercial Code; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. Chapter 104 of NRS is hereby amended by adding thereto
- the provisions set forth as sections 2 to 135, inclusive, of this act.
- Sec. 2. This article may be cited as Uniform Commercial Code-
- 4 Secured Transactions.
- Sec. 3. 1. In this article:
- (a) "Accession" means goods that are physically united with other
- 7 goods in such a manner that the identity of the original goods is not lost.
 - (b) "Account," except as used in "account for," means a right to
- 9 payment of a monetary obligation, whether or not earned by
- 10 performance; for property that has been or is to be sold, leased, licensed,
- assigned, or otherwise disposed of; for services rendered or to be
- 12 rendered; for a policy of insurance issued or to be issued; for a
- 13 secondary obligation incurred or to be incurred; for energy provided or
- 14 to be provided; for the use or hire of a vessel under a charter or other
- 15 contract; arising out of the use of a credit or charge card or information
- 16 contained on or for use with the card; or as winnings in a lottery or other
- 17 game of chance operated or sponsored by a state, governmental unit of a
- 18 state, or person licensed or authorized to operate the game by a state or

- governmental unit of a state. The term includes health-care-insurance receivables. The term does not include rights to payment evidenced by chattel paper or an instrument; commercial tort claims; deposit accounts; investment property; letter-of-credit rights or letters of credit; or rights to payment for money or funds advanced or sold, other than rights arising out of the use of a credit or charge card or information
- 7 contained on or for use with the card.
 8 (c) "Account debtor" means a person obligated on an account, chattel
 9 paper, or general intangible. The term does not include persons obligated
 10 to pay a negotiable instrument, even if the instrument constitutes part of
- chattel paper.
 (d) "Accounting," except as used in "accounting for," means a record:
 - (1) Authenticated by a secured party;

- (2) Indicating the aggregate unpaid secured obligations as of a date not more than 35 days earlier or 35 days later than the date of the record; and
- (3) Identifying the components of the obligations in reasonable detail.
- (e) "Agricultural lien" means an interest, other than a security interest, in farm products:
 - (1) Which secures payment or performance of an obligation for:
- 23 (I) Goods or services furnished in connection with a debtor's 24 farming operation; or
 - (II) Rent on real property leased by a debtor in connection with its farming operation;
 - (2) Which is created by statute in favor of a person that:
 - (I) In the ordinary course of its business furnished goods or services to a debtor in connection with his farming operation; or
 - (II) Leased real property to a debtor in connection with his farming operation; and
 - (3) Whose effectiveness does not depend on the person's possession of the personal property.
 - (f) "As-extracted collateral" means:
 - (1) Oil, gas, or other minerals that are subject to a security interest that:
 - (I) Is created by a debtor having an interest in the minerals before extraction; and
 - (II) Attaches to the minerals as extracted; or
- 40 (2) Accounts arising out of the sale at the wellhead or minehead of 41 oil, gas, or other minerals in which the debtor had an interest before 42 extraction.
 - (g) "Authenticate" means:

(1) To sign; or

- (2) To execute or otherwise adopt a symbol, or encrypt or similarly process a record in whole or in part, with the present intent of the authenticating person to identify himself and adopt or accept a record.
- (h) "Bank" means an organization that is engaged in the business of banking. The term includes savings banks, savings and loan associations, credit unions, and trust companies.
- (i) "Cash proceeds" means proceeds that are money, checks, deposit accounts, or the like.
- (j) "Certificate of title" means a certificate of title with respect to which a statute provides for the security interest in question to be 12 indicated on the certificate as a condition or result of the security interest's obtaining priority over the rights of a lien creditor with respect to the collateral.
 - (k) "Chattel paper" means a record or records that evidence both a monetary obligation and a security interest in or a lease of specific goods or of specific goods and software used in the goods. The term does not include charters or other contracts involving the use or hire of a vessel. If a transaction is evidenced both by a security agreement or lease and by an instrument or series of instruments, the group of records taken together constitutes chattel paper.
- (l) "Collateral" means the property subject to a security interest or 22 agricultural lien. The term includes: 23
 - (1) Proceeds to which a security interest attaches;
 - (2) Accounts, chattel paper, payment intangibles, and promissory notes that have been sold; and
 - (3) Goods that are the subject of a consignment.
 - (m) "Commercial tort claim" means a claim arising in tort with respect to which:
 - (1) The claimant is an organization; or
 - (2) The claimant is a natural person and the claim:
 - (I) Arose in the course of his business or profession; and
 - (II) Does not include damages arising out of personal injury to or the death of a natural person.
 - (n) "Commodity account" means an account maintained by a commodity intermediary in which a commodity contract is carried for a commodity customer.
- (o) "Commodity contract" means a commodity futures contract, an 38 option on a commodity futures contract, a commodity option, or another contract if the contract or option is:
- (1) Traded on or subject to the rules of a board of trade that has 41 42 been designated as a contract market for such a contract pursuant to 43 federal commodities laws; or

- (2) Traded on a foreign commodity board of trade, exchange, or market, and is carried on the books of a commodity intermediary for a commodity customer.
- (p) "Commodity customer" means a person for which a commodity intermediary carries a commodity contract on its books.
 - (q) "Commodity intermediary" means a person that:
- (1) Is registered as a futures commission merchant under federal commodities law; or
- (2) In the ordinary course of its business provides clearance or settlement services for a board of trade that has been designated as a contract market pursuant to federal commodities law.
 - (r) "Communicate" means:

- (1) To send a written or other tangible record;
- (2) To transmit a record by any means agreed upon by the persons sending and receiving the record; or
- (3) In the case of transmission of a record to or by a filing office, to transmit a record by any means prescribed by filing-office rule.
- (s) "Consignee" means a merchant to which goods are delivered in a consignment.
- (t) "Consignment" means a transaction, regardless of its form, in which a person delivers goods to a merchant for the purpose of sale and:
 - (1) The merchant:
- (I) Deals in goods of that kind under a name other than the name of the person making delivery;
 - (II) Is not an auctioneer; and
- (III) Is not generally known by its creditors to be substantially engaged in selling the goods of others;
- (2) With respect to each delivery, the aggregate value of the goods is \$1,000 or more at the time of delivery;
- 30 (3) The goods are not consumer goods immediately before delivery; 31 and
- 32 (4) The transaction does not create a security interest that secures 33 an obligation.
- 34 (u) "Consignor" means a person that delivers goods to a consignee in 35 a consignment.
 - (v) "Consumer debtor" means a debtor in a consumer transaction.
- (w) "Consumer goods" means goods that are used or bought for use primarily for personal, family, or household purposes.
- 39 (x) "Consumer-goods transaction" means a consumer transaction to the extent that:
- 41 (1) A natural person incurs an obligation primarily for personal, 42 family, or household purposes; and

- (2) A security interest in consumer goods or in consumer goods and 2 software that is held or acquired primarily for personal, family, or 3 household purposes secures the obligation.
 - (y) "Consumer obligor" means an obligor who is a natural person and who incurred the obligation as part of a transaction entered into primarily for personal, family, or household purposes.
 - (z) "Consumer transaction" means a transaction to the extent that a natural person incurs an obligation primarily for personal, family, or household purposes; a security interest secures the obligation; and the collateral is held or acquired primarily for personal, family, or household purposes. The term includes consumer-goods transactions.
- (aa) "Continuation statement" means a change of a financing 13 statement which:
 - (1) Identifies, by its file number, the initial financing statement to which it relates; and
 - (2) Indicates that it is a continuation statement for, or that it is filed to continue the effectiveness of, the identified financing statement. (bb) "Debtor" means:
 - (1) A person having an interest, other than a security interest or other lien, in the collateral, whether or not he is an obligor;
 - (2) A seller of accounts, chattel paper, payment intangibles, or promissory notes; or
 - (3) A consignee.

- (cc) "Deposit account" means a demand, time, savings, passbook, or similar account maintained with a bank. The term does not include investment property or accounts evidenced by an instrument.
- (dd) "Document" means a document of title or a receipt of the type described in subsection 2 of NRS 104.7201.
- (ee) "Electronic chattel paper" means chattel paper evidenced by a record or records consisting of information stored in an electronic medium.
- (ff) "Encumbrance" means a right, other than an ownership interest, in real property. The term includes mortgages and other liens on real 34 *property*.
 - (gg) "Equipment" means goods other than inventory, farm products, or consumer goods.
- (hh) "Farm products" means goods, other than standing timber, with 37 respect to which the debtor is engaged in a farming operation and which 38 are: 39
 - (1) Crops grown, growing, or to be grown, including:
 - (I) Crops produced on trees, vines, and bushes; and
 - (II) Aquatic goods produced in aquacultural operations;

- (2) Livestock, born or unborn, including aquatic goods produced in aquacultural operations;
 - (3) Supplies used or produced in a farming operation: or

- (4) Products of crops or livestock in their unmanufactured states.
- (ii) "Farming operation" means raising, cultivating, propagating, fattening, grazing, or any other farming, livestock, or aquacultural operation.
 - (jj) "File number" means the number assigned to an initial financing statement pursuant to subsection 1 of section 91 of this act.
- (kk) "Filing office" means an office designated in section 73 of this 10 act as the place to file a financing statement. 11
- (ll) "Filing-office rule" means a rule adopted pursuant to section 98 12 13 *of this act*.
- (mm) "Financing statement" means a record or records composed of 14 an initial financing statement and any filed record relating to the initial financing statement.
- (nn) "Fixture filing" means the filing of a financing statement covering goods that are or are to become fixtures and satisfying subsections 1 and 2 of section 74 of this act. The term includes the filing of a financing statement covering goods of a transmitting utility which 21 are or are to become fixtures.
- (00) "Fixtures" means goods that have become so related to 22 particular real property that an interest in them arises under real property law.
- (pp) "General intangible" means any personal property, including 26 things in action, other than accounts, chattel paper, commercial tort claims, deposit accounts, documents, goods, instruments, investment property, letter-of-credit rights, letters of credit, money, and oil, gas, or other minerals before extraction. The term includes payment intangibles 30 and software.
- (qq) "Good faith" means honesty in fact and the observance of 31 32 reasonable commercial standards of fair dealing.
- (rr) "Goods" means all things that are movable when a security 33 34 interest attaches. The term includes fixtures; standing timber that is to be cut and removed under a conveyance or contract for sale; the unborn 36 young of animals; crops grown, growing, or to be grown, even if the 37 crops are produced on trees, vines, or bushes; and manufactured homes. 38 The term also includes a computer program embedded in goods and any 39 supporting information provided in connection with a transaction
- 40 relating to the program if the program is associated with the goods in
- 41 such a manner that it customarily is considered part of the goods, or by
- 42 becoming the owner of the goods, a person acquires a right to use the
- 43 program in connection with the goods. The term does not include a

- 1 computer program embedded in goods that consist solely of the medium 2 in which the program is embedded. The term also does not include 3 accounts, chattel paper, commercial tort claims, deposit accounts, documents, general intangibles, instruments, investment property, letter-5 of-credit rights, letters of credit, money, or oil, gas, or other minerals before extraction.
- (ss) "Governmental unit" means a subdivision, agency, department, county, parish, municipality, or other unit of the government of the United States, a state, or a foreign country. The term includes an organization having a separate corporate existence if the organization is eligible to issue debt on which interest is exempt from income taxation 12 under the laws of the United States.
 - (tt) "Health-care-insurance receivable" means an interest in or claim under a policy of insurance which is a right to payment of a monetary obligation for health-care goods or services provided.
- (uu) "Instrument" means a negotiable instrument or any other writing that evidences a right to the payment of a monetary obligation, is not itself a security agreement or lease, and is of a type that in ordinary course of business is transferred by delivery with any necessary endorsement or assignment. The term does not include investment 21 property, letters of credit, or writings that evidence a right to payment arising out of the use of a credit or charge card or information contained on or for use with the card.
 - (vv) "Inventory" means goods, other than farm products, which:
 - (1) Are leased by a person as lessor;

- (2) Are held by a person for sale or lease or to be furnished under a contract of service;
 - (3) Are furnished by a person under a contract of service; or
- (4) Consist of raw materials, work in process, or materials used or consumed in a business.
- (ww) "Investment property" means a security, whether certificated or 31 uncertificated, security entitlement, securities account, commodity 32 contract, or commodity account. 33
- (xx) "Jurisdiction of organization," with respect to a registered 34 organization, means the jurisdiction under whose law the organization is 35 organized. 36
 - (yy) "Letter-of-credit right" means a right to payment or performance under a letter of credit, whether or not the beneficiary has demanded or is at the time entitled to demand payment or performance. The term does not include the right of a beneficiary to demand payment or performance under a letter of credit.
 - (zz) "Lien creditor" means:

- (1) A creditor that has acquired a lien on the property involved by attachment, levy, or the like;
- (2) An assignee for benefit of creditors from the time of assignment;

(3) A trustee in bankruptcy from the date of the filing of the petition; or

(4) A receiver in equity from the time of appointment.

- (aaa) "Manufactured home" means a structure, transportable in one or more sections, which in the traveling mode, is 8 feet or more in body width or 40 feet or more in body length, or, when erected on site, is 320 or more square feet, and which is built on a permanent chassis and 12 designed to be used as a dwelling with or without a permanent 13 foundation when connected to the required utilities, and includes the 14 plumbing, heating, air-conditioning, and electrical systems contained therein. The term includes any structure that meets all of the 16 requirements of this paragraph except the size requirements and with 17 respect to which the manufacturer voluntarily files a certification required by the United States Secretary of Housing and Urban Development and complies with the standards established under Title 42 of the United States Code.
- (bbb) "Manufactured-home transaction" means a secured 22 transaction:
 - (1) That creates a purchase-money security interest in a manufactured home, other than a manufactured home held as inventory; or
 - (2) In which a manufactured home, other than a manufactured home held as inventory, is the primary collateral.
 - (ccc) "Mortgage" means a consensual interest in real property, including fixtures, which is created by a mortgage, deed of trust, or similar transaction.
 - (ddd) "New debtor" means a person that becomes bound as debtor under subsection 4 of section 14 of this act by a security agreement previously entered into by another person.
- 34 (eee) "New value" means money; money's worth in property, services, or new credit; or release by a transferee of an interest in property 35 previously transferred to the transferee. The term does not include an obligation substituted for another obligation. 37
 - (fff) "Noncash proceeds" means proceeds other than cash proceeds.
- (ggg) "Obligor" means a person that, with respect to an obligation 39 secured by a security interest in or an agricultural lien on the collateral,
- owes payment or other performance of the obligation, has provided
- 42 property other than the collateral to secure payment or other
- performance of the obligation, or is otherwise accountable in whole or in

- part for payment or other performance of the obligation. The term does not include an issuer or a nominated person under a letter of credit.
- (hhh) "Original debtor" means a person that, as debtor, entered into a security agreement to which a new debtor has become bound under subsection 4 of section 14 of this act.
- (iii) "Payment intangible" means a general intangible under which the account debtor's principal obligation is a monetary obligation.
 - (jjj) "Person related to," with respect to a natural person, means:
 - (1) His spouse;

- (2) His brother, brother-in-law, sister, or sister-in-law;
- (3) His or his spouse's ancestor or lineal descendant; or

 - (kkk) "Person related to," with respect to an organization, means:
- (1) A person directly or indirectly controlling, controlled by, or under common control with the organization;
- (2) An officer or director of, or a person performing similar functions with respect to, the organization;
- (3) An officer or director of, or a person performing similar functions with respect to, a person described in subparagraph (1);
- (4) The spouse of a natural person described in subparagraph (1), (2), or (3); or
- 23 (5) A person who is related by blood or marriage to a person 24 described in subparagraph (1), (2), (3), or (4) and shares the same home 25 with that person.
 - (lll) "Proceeds" means the following property:
 - (1) Whatever is acquired upon the sale, lease, license, exchange, or other disposition of collateral;
 - (2) Whatever is collected on, or distributed on account of, collateral:
 - (3) Rights arising out of collateral;
 - (4) To the extent of the value of collateral, claims arising out of the loss, nonconformity, or interference with the use of, defects or infringement of rights in, or damage to, the collateral; and
- 35 (5) To the extent of the value of collateral and to the extent payable 36 to the debtor or the secured party, insurance payable by reason of the loss 37 or nonconformity of, defects or infringement of rights in, or damage to, 38 the collateral.
- (mmm) "Promissory note" means an instrument that evidences a
 promise to pay a monetary obligation, does not evidence an order to pay,
 and does not contain an acknowledgment by a bank that the bank has
 received for deposit a sum of money or funds.

- (nnn) "Proposal" means a record authenticated by a secured party which includes the terms on which the secured party is willing to accept 3 collateral in full or partial satisfaction of the obligation it secures pursuant to sections 119, 120 and 121 of this act.
 - (000) "Public-finance transaction" means a secured transaction in connection with which:
 - (1) Debt securities are issued;

- (2) All or a portion of the securities issued have an initial stated maturity of at least 20 years; and
- (3) The debtor, the obligor, the secured party, the account debtor or other person obligated on collateral, the assignor or assignee of a 12 secured obligation, or the assignor or assignee of a security interest is a state or a governmental unit of a state.
- (ppp) "Pursuant to commitment," with respect to an advance made or other value given by a secured party, means pursuant to the secured 16 party's obligation, whether or not a subsequent event of default or other event not within the secured party's control has relieved or may relieve the secured party from its obligation.
- (qqq) "Record," except as used in "for record," "of record," "record or legal title," and "record owner," means information that is inscribed 21 on a tangible medium or which is stored in an electronic or other 22 medium and is retrievable in perceivable form.
- (rrr) "Registered organization" means an organization organized 24 solely under the law of a single state or the United States and as to which the state or the United States must maintain a public record showing the organization to have been organized. 26
 - (sss) "Secondary obligor" means an obligor to the extent that:
 - (1) The obligor's obligation is secondary; or
 - (2) The obligor has a right of recourse with respect to an obligation secured by collateral against the debtor, another obligor, or property of either.
 - (ttt) "Secured party" means:
 - (1) A person in whose favor a security interest is created or provided for under a security agreement, whether or not any obligation to be secured is outstanding;
 - (2) A person that holds an agricultural lien;
 - (3) A consignor;
 - (4) A person to which accounts, chattel paper, payment intangibles, or promissory notes have been sold;
- (5) A trustee, indenture trustee, agent, collateral agent, or other 40 representative in whose favor a security interest or agricultural lien is created or provided for; or

- (6) A person that holds a security interest arising under NRS 104.2401, 104.2505, subsection 3 of NRS 104.2711, NRS 104.4210, 104.5118, or subsection 5 of NRS 104A.2508.
- (uuu) "Security agreement" means an agreement that creates or provides for a security interest.
 - (vvv) "Send," in connection with a record or notification, means:
- (1) To deposit in the mail, deliver for transmission, or transmit by any other usual means of communication, with postage or cost of transmission provided for, addressed to any address reasonable under the circumstances; or 10
- (2) To cause the record or notification to be received within the time 12 that it would have been received if properly sent under subparagraph (1).
- (www) "Software" means a computer program and any supporting information provided in connection with a transaction relating to the 15 program. The term does not include a computer program that is 16 contained in goods unless the goods are a computer or computer 17 *peripheral*.
- (xxx) "State" means a state of the United States, the District of 18 Columbia, Puerto Rico, the United States Virgin Islands, or any territory or insular possession subject to the jurisdiction of the United States. 20
- (yyy) "Supporting obligation" means a letter-of-credit right or secondary obligation that supports the payment or performance of an account, chattel paper, document, general intangible, instrument, or 24 investment property.
- (zzz) "Tangible chattel paper" means chattel paper evidenced by a 26 record or records consisting of information that is inscribed on a tangible medium. 27
 - (aaaa) "Termination statement" means a subsequent filing which:
 - (1) Identifies, by its file number, the initial financing statement to which it relates: and
 - (2) Indicates either that it is a termination statement or that the identified financing statement is no longer effective.
- (bbbb) "Transmitting utility" means a person primarily engaged in 33 34 the business of:
 - (1) Operating a railroad, subway, street railway, or trolley bus;
- 36 (2) Transmitting communications electrically, electromagnetically, or by light; 37
 - (3) Transmitting goods by pipeline;
 - (4) Providing sewerage; or

 - A security interest in software is a purchase-money security interest to the extent that the security interest also secures a purchasemoney obligation incurred with respect to goods in which the secured party holds or held a purchase-money security interest if:
 - (a) The debtor acquired its interest in the software in an integrated transaction in which it acquired an interest in the goods; and
- (b) The debtor acquired its interest in the software for the principal 21 purpose of using the software in the goods.
 - The security interest of a consignor in goods that are the subject of a consignment is a purchase-money security interest in inventory.
 - 5. In a transaction other than a consumer-goods transaction, if the extent to which a security interest is a purchase-money security interest depends on the application of a payment to a particular obligation, the payment must be applied:
 - (a) In accordance with any reasonable method of application to which the parties agree;
- (b) In the absence of the parties' agreement to a reasonable method, in accordance with any intention of the obligor manifested at or before 32 the time of payment; or
 - (c) In the absence of an agreement to a reasonable method and a timely manifestation of the obligor's intention, in the following order:
 - (1) To obligations that are not secured; and
 - (2) If more than one obligation is secured, to obligations secured by purchase-money security interests in the order in which those obligations were incurred.
 - 6. In a transaction other than a consumer-goods transaction, a purchase-money security interest does not lose its status as such, even if:
- (a) The purchase-money collateral also secures an obligation that is 41 42 not a purchase-money obligation;

- (b) Collateral that is not purchase-money collateral also secures the purchase-money obligation; or
- (c) The purchase-money obligation has been renewed, refinanced, consolidated, or restructured.
 - 7. In a transaction other than a consumer-goods transaction, a secured party claiming a purchase-money security interest has the burden of establishing the extent to which the security interest is a purchase-money security interest.
- The limitation of the rules in subsections 5, 6 and 7 to transactions other than consumer-goods transactions leaves to the court the 11 determination of the proper rules in consumer-goods transactions. The 12 court may not infer from that limitation the nature of the proper rule in 13 consumer-goods transactions and may continue to apply established 14 approaches.
- Sec. 5. 1. A secured party has control of a deposit account if: 15
- (a) The secured party is the bank with which the deposit account is 16 maintained: 17
- (b) The debtor, secured party, and bank have agreed in an 18 authenticated record that the bank will comply with instructions originated by the secured party directing disposition of the funds in the 21 account without further consent by the debtor; or
- (c) The secured party becomes the bank's customer with respect to the 22 deposit account. 23
- 2. A secured party that has satisfied subsection 1 has control, even if the debtor retains the right to direct the disposition of funds from the deposit account. 26

- Sec. 6. A secured party has control of electronic chattel paper if the 28 record or records comprising the chattel paper are created, stored, and assigned in such a manner that:
- A single authoritative copy of the record or records exists which is 30 unique, identifiable and, except as otherwise provided in subsections 4, 5, 31 and 6, unalterable; 32
- 2. The authoritative copy identifies the secured party as the assignee 33 of the record or records; 34
- The authoritative copy is communicated to and maintained by the 35 secured party or its designated custodian; 36
- Copies or revisions that add or change an identified assignee of 37 the authoritative copy can be made only with the participation of the secured party; 39
- Each copy of the authoritative copy and any copy of a copy is 40 41 readily identifiable as a copy that is not the authoritative copy; and
- Any revision of the authoritative copy is readily identifiable as an 42 authorized or unauthorized revision.

- Sec. 7. 1. A person has control of a certificated security, uncertificated security, or security entitlement as provided in NRS 104.8106.
 - 2. A secured party has control of a commodity contract if:
- (a) The secured party is the commodity intermediary with which the commodity contract is carried; or
- (b) The commodity customer, secured party, and commodity intermediary have agreed that the commodity intermediary will apply any value distributed on account of the commodity contract as directed by the secured party without further consent by the commodity customer.
- 3. A secured party having control of all security entitlements or commodity contracts carried in a securities account or commodity account has control over the securities account or commodity account.
- Sec. 8. A secured party has control of a letter-of-credit right to the extent of any right to payment or performance by the issuer or any nominated person if the issuer or nominated person has consented to an assignment of proceeds of the letter of credit under subsection 3 of NRS 104.5114 or otherwise applicable law or practice.
- Sec. 9. 1. Except as otherwise provided in subsections 3, 4 and 5, a description of personal or real property is sufficient, whether or not it is specific, if it reasonably identifies what is described.
- 22 2. Except as otherwise provided in subsection 4, a description of collateral reasonably identifies the collateral if it identifies the collateral by:
 - (a) Specific listing;
 - (b) Category;

- 27 (c) Except as otherwise provided in subsection 5, a type of collateral 28 defined in the Uniform Commercial Code;
 - (d) Quantity;
- 30 (e) Computational or allocational formula or procedure; or
- 31 (f) Except as otherwise provided in subsection 3, any other method, if 32 the identity of the collateral is objectively determinable.
- 33. A description of collateral as "all the debtor's assets" or "all the debtor's personal property" or using words of similar import does not reasonably identify the collateral.
- 4. Except as otherwise provided in subsection 5, a description of a

 sufficient if it describes:
 - (a) The collateral by those terms or as investment property; or
- 40 (b) The underlying financial asset or commodity contract.
- 5. A description only by type of collateral defined in the Uniform Commercial Code is an insufficient description of:
 - (a) A commercial tort claim; or

- (b) In a consumer transaction, consumer goods, a security entitlement, a securities account, or a commodity account.
- Sec. 10. 1. Except as otherwise provided in subsections 3 and 4, this article applies to:
- (a) A transaction, regardless of its form, that creates a security interest in personal property or fixtures by contract;
 - (b) An agricultural lien;
- (c) A sale of accounts, chattel paper, payment intangibles, or promissory notes;
- 10 (d) A consignment;

- 35 The rights of the secured party after default by the debtor are 36 governed by Article 2 or 2A; and 37
- The security interest has priority over a conflicting security 38 interest created by the debtor.
- Sec. 12. 1. Except as otherwise provided in the Uniform
- 41 Commercial Code, a security agreement is effective according to its terms
- 42 between the parties, against purchasers of the collateral, and against
- 43 creditors.

nonperfection, and the priority of an agricultural lien on the farm products.

- (d) If neither paragraph (a) nor paragraph (b) nor paragraph (c) 38 applies, the bank's jurisdiction is the jurisdiction in which the office 40 identified in an account statement as the office serving the customer's 41 account is located.

- (e) If none of the preceding paragraphs applies, the bank's jurisdiction is the jurisdiction in which the chief executive office of the bank is located.
- Sec. 26. 1. Except as otherwise provided in subsection 3, the following rules apply:
 - (a) While a security certificate is located in a jurisdiction, the law of that jurisdiction governs perfection, the effect of perfection or nonperfection, and the priority of a security interest in the certificated security represented thereby.

- (d) If neither paragraph (a) nor paragraph (b) nor paragraph (c) 39 applies, the commodity intermediary's jurisdiction is the jurisdiction in 41 which the office identified in an account statement as the office serving 42 the commodity customer's account is located.

- (e) If none of the preceding paragraphs applies, the commodity intermediary's jurisdiction is the jurisdiction in which the chief executive office of the commodity intermediary is located.
 - 3. The law of the jurisdiction in which the debtor is located governs:
- (a) Perfection of a security interest in investment property by filing;
- (b) Automatic perfection of a security interest in investment property granted by a broker or securities intermediary; and
- (c) Automatic perfection of a security interest in a commodity contract or commodity account granted by a commodity intermediary.
- Sec. 27. 1. Subject to subsection 3, the law of the issuer's jurisdiction or a nominated person's jurisdiction governs perfection, the effect of perfection or nonperfection, and the priority of a security interest in a letter-of-credit right if the issuer's jurisdiction or nominated person's jurisdiction is a state.

- 7. A registered organization continues to be located in the jurisdiction specified by subsection 5 or 6 notwithstanding:

- 10. A foreign air carrier under the Federal Aviation Act of 1958, as amended, is located at the designated office of the agent upon which service of process may be made on behalf of the carrier.

11. This section applies only for purposes of this part.

Except as otherwise provided in this section and section 30 of this act, a security interest is perfected if it has attached and all of the applicable requirements for perfection in sections 31 to 37, inclusive, of this act have been satisfied. A security interest is perfected when it attaches if the applicable requirements are satisfied before the security interest attaches.
- 2. An agricultural lien is perfected if it has become effective and all of the applicable requirements for perfection in section 31 of this act have been satisfied. - (d) Before the filing of a financing statement covering the goods.
- To the extent that it affects the priority of a security interest over a 35 buyer of goods under subsection 2, the period of effectiveness of a filing made in the jurisdiction in which the seller is located is governed by 37 subsections 1 and 2 of section 37 of this act. 38
- 4. A buyer in the ordinary course of business buying oil, gas, or 39 other minerals at the wellhead or minehead or after extraction takes free 40 of an interest arising out of an encumbrance. 41
- Subsections 1 and 2 do not affect a security interest in goods in the 42 possession of the secured party under section 34 of this act.

- Sec. 42. 1. In this section, "licensee in ordinary course of business" means a person that becomes a licensee of a general intangible 3 in good faith, without knowledge that the license violates the rights of another person in the general intangible, and in the ordinary course from a person in the business of licensing general intangibles of that 6 kind. A person becomes a licensee in the ordinary course if the license to him comports with the usual or customary practices in the kind of business in which the licensor is engaged or with the licensor's own usual or customary practices.
 - 2. A licensee in the ordinary course of business takes his rights under a nonexclusive license free of a security interest in the general intangible created by the licensor, even if the security interest is perfected and he knows of its existence.
 - A lessee in the ordinary course of business takes his leasehold interest free of a security interest in the goods created by the lessor, even if the security interest is perfected and he knows of its existence.
- Sec. 43. 1. Except as otherwise provided in this section, priority among conflicting security interests and agricultural liens in the same 18 collateral is determined according to the following rules:
- (a) Conflicting perfected security interests and agricultural liens rank according to priority in time of filing or perfection. Priority dates from 21 the earlier of the time a filing covering the collateral is first made or the security interest or agricultural lien is first perfected, if there is no period thereafter when there is neither filing nor perfection.
 - (b) A perfected security interest or agricultural lien has priority over a conflicting unperfected security interest or agricultural lien.
- (c) The first security interest or agricultural lien to attach or become effective has priority if conflicting security interests and agricultural 28 29 liens are unperfected.
 - For the purposes of paragraph (a) of subsection 1:
- (a) The time of filing or perfection as to a security interest in 31 collateral is also the time of filing or perfection as to a security interest in 32 proceeds; and 33
 - (b) The time of filing or perfection as to a security interest in collateral supported by a supporting obligation is also the time of filing or perfection as to a security interest in the supporting obligation.
- Except as otherwise provided in subsection 6, a security interest in 37 collateral which qualifies for priority over a conflicting security interest 38 under section 48, 49, 50, 51 or 52 of this act also has priority over a conflicting security interest in: 40
 - (a) Any supporting obligation for the collateral; and
- 42 (b) Proceeds of the collateral if:

(1) The security interest in proceeds is perfected;

- (2) The proceeds are cash proceeds or of the same type as the collateral; and

- Subject to subsection 5 and except as otherwise provided in subsection 6, if a security interest in chattel paper, deposit accounts, negotiable documents, instruments, investment property, or letter-ofcredit rights is perfected by a method other than filing, conflicting perfected security interests in proceeds of the collateral rank according to priority in time of filing.
- Subsection 4 applies only if the proceeds of the collateral are not 12 cash proceeds, chattel paper, negotiable documents, instruments, 13 investment property, or letter-of-credit rights.
 - Subsections 1 to 5, inclusive, are subject to:

 - A perfected agricultural lien on collateral has priority over a conflicting security interest in or agricultural lien on the same collateral if the statute creating the agricultural lien so provides.
 - Sec. 44. 1. Except as otherwise provided in subsection 3, for purposes of determining the priority of a perfected security interest under subsection 1 of section 43 of this act, perfection of the security interest dates from the time an advance is made to the extent that the security interest secures an advance that:
 - (a) Is made while the security interest is perfected only:
 - (1) Under section 30 of this act when it attaches; or
 - (2) Temporarily under subsection 5, 6, or 7 of section 33 of this act; and

 - (b) If the purchase-money security interest is temporarily perfected without filing or possession under subsection 6 of section 33 of this act, before the beginning of the 20-day period thereunder.
- 36 Except as otherwise provided in subsection 7, a perfected purchase-money security interest in goods other than inventory or 37 livestock has priority over a conflicting security interest in the same goods, and, except as otherwise provided in section 48 of this act, a perfected security interest in its identifiable proceeds also has priority, if 41 the purchase-money security interest is perfected when the debtor 42 receives possession of the collateral or within 20 days thereafter.

- Except as otherwise provided in subsection 7, a perfected purchase-money security interest in software has priority over a conflicting security interest in the same collateral, and, except as otherwise provided in section 48 of this act, a perfected security interest 5 in its identifiable proceeds also has priority, to the extent that the purchase-money security interest in the goods in which the software was acquired for use has priority in the goods and proceeds of the goods under this section.
- If more than one security interest qualifies for priority in the same collateral under subsection 1, 3, 5 or 6: 10

- (a) A security interest securing an obligation incurred as all or part of the price of the collateral has priority over a security interest securing an obligation incurred for value given to enable the debtor to acquire rights in or the use of collateral; and

- Sec. 46. 1. Except as otherwise provided in subsection 2, a security interest created by a debtor is subordinate to a security interest in the same collateral created by another person if:

Sec. 48. The following rules govern priority among conflicting security interests in the same deposit account:

 - (1) The secured party's becoming the person for which the securities account is maintained, if the secured party obtained control under paragraph (a) of subsection 4 of NRS 104.8106;
 - (2) The securities intermediary's agreement to comply with the secured party's entitlement orders with respect to security entitlements carried or to be carried in the securities account, if the secured party obtained control under paragraph (b) of that subsection; or
- 40 (3) If the secured party obtained control through another person 41 under paragraph (c) of that subsection, the time on which priority would 42 be based under this paragraph if the other person were the secured party; 43 or

- (b) The proceeds consist of the specific goods covered by the chattel paper or cash proceeds of the specific goods, even if the purchaser's security interest in the proceeds is unperfected.

Except as otherwise provided in subsection 1 of section 52 of this act, a purchaser of an instrument has priority over a security interest in the instrument perfected by a method other than possession if the purchaser gives value and takes possession of the instrument in good 12 faith and without knowledge that the purchase violates the rights of the 13 secured party.
- For purposes of subsections 1 and 2, the holder of a purchase-14 money security interest in inventory gives new value for chattel paper 15 constituting proceeds of the inventory.

This article does not limit the rights of a holder in due course of a negotiable instrument, a holder to which a negotiable 24 document of title has been duly negotiated, or a protected purchaser of a security.  - (1) Is perfected by a fixture filing before the interest of the encumbrancer or owner is of record; and
 - (2) Has priority over any conflicting interest of a predecessor in title of the encumbrancer or owner;
- 35 (b) Before the goods become fixtures, the security interest is perfected 36 by any method permitted by this article and the fixtures are readily 37 removable: 38
 - (1) Factory or office machines;

- 6. A security interest in fixtures, whether or not perfected, has priority over a conflicting interest of an encumbrancer or owner of the real property if:
- (a) The encumbrancer or owner has, in an authenticated record, 12 13 consented to the security interest or disclaimed an interest in the goods as fixtures; or
- (b) The debtor has a right to remove the goods as against the 15 encumbrancer or owner. 16
- The priority of the security interest under subsection 6 continues 17 for a reasonable time if the debtor's right to remove the goods as against the encumbrancer or owner terminates.
- A mortgage is a construction mortgage to the extent that it secures 21 an obligation incurred for the construction of an improvement on land, including the acquisition cost of the land, if the recorded record so indicates. Except as otherwise provided in subsections 5 and 6, a security 24 interest in fixtures is subordinate to a construction mortgage recorded before the goods become fixtures if the goods become fixtures before the 26 completion of the construction. A mortgage has this priority to the same extent as a construction mortgage to the extent that it is given to refinance a construction mortgage.
 - A perfected security interest in crops growing on real property has priority over a conflicting interest of an encumbrancer or owner of the real property if the debtor has an interest of record in or is in possession of the real property.
- Sec. 56. 1. A security interest may be created in an accession and 33 34 continues in collateral that becomes an accession.
 - If a security interest is perfected when the collateral becomes an accession, the security interest remains perfected in the collateral.

- Sec. 60. This article does not preclude subordination by agreement by a person entitled to priority.
 - Sec. 61. 1. Except as otherwise provided in subsection 3, a bank with which a deposit account is maintained may exercise any right of recoupment or set-off against a secured party that holds a security interest in the deposit account.

 - Sec. 62. Except as otherwise provided in subsection 3 of section 61 of this act, and unless the bank otherwise agrees in an authenticated record, a bank's rights and duties with respect to a deposit account maintained with the bank are not terminated, suspended, or modified by:

- (a) Purports to delete all debtors and fails to provide the name of a debtor to be covered by the financing statement; or
- (b) Purports to delete all secured parties of record and fails to provide the name of a new secured party of record.

- (c) The financing statement covers goods that were the subject of a consignment to the debtor but are not in the debtor's possession; or
- 36 (d) The debtor did not authorize the filing of the initial financing statement.
- 4. Except as otherwise provided in section 82 of this act, upon the filing of a termination statement with the filing office, the financing statement to which the termination statement relates ceases to be effective.

- Except as otherwise provided in subsection 3, an initial Sec. 86. 1. financing statement may reflect an assignment of all of the secured party's power to authorize an amendment to the financing statement by providing the name and mailing address of the assignee as the name and address of the secured party.
- 2. Except as otherwise provided in subsection 3, a secured party of record may assign of record all or part of its power to authorize an amendment to a financing statement by filing in the filing office an amendment of the financing statement which:

 - A continuation statement may be filed only within 6 months before the expiration of the 5-year period specified in subsection 1 or the 30year period specified in subsection 2, whichever is applicable.
- 5. Except as otherwise provided in section 82 of this act, upon timely 39 filing of a continuation statement, the effectiveness of the initial 41 financing statement continues for a period of 5 years commencing on the

 - (b) The date and time of filing of each financing statement; and
 - (c) The information provided in each financing statement.

- In complying with its duty under subsection 3, the filing office may communicate information in any medium. However, if requested, the filing office shall communicate information by issuing its written certificate.

- 8. Subsection 6 of section 114 of this act, which deals with calculation of a deficiency or surplus when a disposition is made to the secured party, a person related to the secured party, or a secondary obligor;
- 23 9. Section 115 of this act, which deals with explanation of the calculation of a surplus or deficiency;
- 25 10. Sections 119, 120, and 121 of this act, which deal with acceptance of collateral in satisfaction of obligation;

- 11. Section 122 of this act, which deals with redemption of collateral;
- 12. Section 123 of this act, which deals with permissible waivers; and
- 29 13. Sections 124 and 125 of this act, which deal with the secured 30 party's liability for failure to comply with this article.
- Sec. 102. 1. The parties may determine by agreement the standards measuring the fulfillment of the rights of a debtor or obligor
- and the duties of a secured party under a rule stated in section 101 of this act if the standards are not manifestly unreasonable.

- 2. If necessary to enable a secured party to exercise under paragraph 13 (c) of subsection 1 the right of a debtor to enforce a mortgage nonjudicially, the secured party may record in the office in which the mortgage is recorded:
 - (a) A copy of the security agreement that creates or provides for a security interest in the obligation secured by the mortgage; and
 - (b) The secured party's sworn affidavit in recordable form stating that:
 - (1) A default has occurred; and

- If the underlying transaction is a sale of accounts, chattel paper, 20 payment intangibles, or promissory notes, the debtor is not entitled to any 21 surplus, and the obligor is not liable for any deficiency.
 - Sec. 108. 1. After default, a secured party:
 - (a) May take possession of the collateral;
- (b) If a debtor so agrees, may require the debtor to assemble the 25 collateral and make it available to the secured party at a place to be 26 designated by the secured party which is reasonably convenient to both 27 parties; and 28 29
 - (c) Without removal may render equipment unusable and dispose of collateral on a debtor's premises under section 109 of this act.

 - (b) The amount of proceeds of the disposition is significantly below the range of proceeds that a complying disposition to a person other than the secured party, a person related to the secured party, or a secondary obligor would have brought.
- A secured party that receives cash proceeds of a disposition in 26 good faith and without knowledge that the receipt violates the rights of the holder of a security interest or other lien that is not subordinate to the security interest or agricultural lien under which the disposition is made:
 - (a) Takes the cash proceeds free of the security interest or other lien;
- (b) Is not obligated to apply the proceeds of the disposition to the 30 satisfaction of obligations secured by the security interest or other lien; 31 32 *and*
- (c) Is not obligated to account to or pay the holder of the security 33 34 interest or other lien for any surplus.
 - Sec. 115. 1. In this section:
 - (a) "Explanation" means a writing that:
 - (1) States the amount of the surplus or deficiency;
- (2) Provides an explanation in accordance with subsection 3 of how 38 the secured party calculated the surplus or deficiency; 39
- (3) States, if applicable, that future debits, credits, charges, 40 including additional credit service charges or interest rebates, and 41 expenses may affect the amount of the surplus or deficiency; and

- (4) Provides a telephone number or mailing address from which additional information concerning the transaction is available.

 - In a consumer-goods transaction in which the debtor is entitled to a surplus or a consumer obligor is liable for a deficiency under section 114 of this act, the secured party shall:
 - (a) Send an explanation to the debtor or consumer obligor, as applicable, after the disposition and:
 - (1) Before or when the secured party accounts to the debtor and pays any surplus or first makes written demand on the consumer obligor after the disposition for payment of the deficiency; and
 - (2) Within 14 days after receipt of a request; or

A debtor or consumer obligor is entitled without charge to one response to a request under this section during any 6-month period in which the secured party did not send to the debtor or consumer obligor an explanation pursuant to paragraph (a) of subsection 2. The secured party may require payment of a charge not exceeding \$25 for each additional response.
- 14 **Sec. 116.** 1. A secured party's disposition of collateral after 15 default:
- (a) Transfers to a transferee for value all of the debtor's rights in the collateral;
- 18 (b) Discharges the security interest under which the disposition is 19 made; and
- 20 (c) Discharges any subordinate security interest or other subordinate 21 lien.

- Sec. 125. 1. In an action arising from a transaction, other than a consumer transaction, in which the amount of a deficiency or surplus is in issue, the following rules apply:
- (a) A secured party need not prove compliance with the provisions of this part relating to collection, enforcement, disposition, or acceptance unless the debtor or a secondary obligor places the secured party's compliance in issue.
- (b) If the secured party's compliance is placed in issue, the secured 26 party has the burden of establishing that the collection, enforcement, disposition, or acceptance was conducted in accordance with this part.

- (a) A debtor's representation concerning the purpose for which 18 collateral was to be used, acquired, or held; or

A transfer of "the lease" or of "all my rights under the lease," or a transfer in similar general terms, is a transfer of rights, and, unless the language or the circumstances, as in a transfer for security, indicate the contrary, the transfer is a delegation of duties by the transferor to the transferee. Acceptance by the transferee constitutes a promise by him to perform those duties. The promise is enforceable by either the transferor or the other party to the lease contract.
- Unless otherwise agreed by the lessor and the lessee, a delegation of performance does not relieve the transferor as against the other party of any duty to perform or of any liability for default.
- [8.] 7. In a consumer lease, to prohibit the transfer of an interest of a party under the lease contract or to make a transfer an event of default, the language must be specific, by a writing, and conspicuous.

- 12 (c) Insurance which protects his interest in the collateral pledged for the loan:
 - (d) Single interest nonfiling insurance; or
- 15 (e) Any other credit-related insurance approved by the commissioner, 16 if the insurance complies with the applicable provisions of chapter 690A of 17 NRS.
- 4. In accepting any insurance provided by this section as security for a 18 loan, the licensee may include the premiums or identifiable charge as part of the principal or may deduct the premiums or identifiable charge therefor 20 from the proceeds of the loan, which premium or identifiable charge must 21 not exceed those filed with and approved by the commissioner of 22 insurance, and remit those premiums to the insurance company writing the insurance, and any gain or advantage to the licensee, any employee, officer, director, agent, affiliate or associate from the insurance or its sale may not be considered as additional or further charge in connection with any loan 26 made under this chapter. Not more than one policy of life insurance and 27 one policy providing accident and health coverage may be written by a licensee in connection with any loan transaction under this chapter, and a licensee shall not require the borrower to be insured as a condition of any 30 loan. If the unpaid balance of the loan is prepaid in full by cash or other 31 thing of value, refinancing, renewal, a new loan or otherwise, the charge for 32 any credit life insurance and any credit accident and health insurance must 33 34 be refunded or credited as prescribed in chapter 690A of NRS. The insurance must be written by a company authorized to conduct business in 35 this state, and the licensee shall not require the purchase of the insurance 36 from any agent or broker designated by the licensee. 37
 - 5. The amount charged to a debtor by a licensee for any type of coverage under a policy of insurance provided by this section as security for a loan must not exceed the amount of the premium. In the case of a single interest nonfiling policy of insurance, the amount charged to a debtor by a licensee must not exceed the amount charged by a county recorder for

filing and releasing documents pursuant to [NRS 104.9403 and 104.9406.] section 97 of this act.

As used in this section, "single interest nonfiling insurance" means a contract of insurance for which a lender pays a predetermined fee, which affords coverage to a lender in connection with a specific loan, and which is obtained by the lender in lieu of perfecting a security interest pursuant to chapter 104 of NRS.
