AN ACT relating to commercial transactions; revising Article 9 of the Uniform Commercial Code;
and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND
ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Chapter 104 of NRS is hereby amended by adding thereto
the provisions set forth as sections 2 to 135, inclusive, of this act.

Sec. 2. *This article may be cited as Uniform Commercial Code–
Secured Transactions.*

Sec. 3. 1. *In this article:*

*(a) “Accession” means goods that are physically united with other
goods in such a manner that the identity of the original goods is not lost.*

*(b) “Account,” except as used in “account for,” means a right to
payment of a monetary obligation, whether or not earned by
performance; for property that has been or is to be sold, leased, licensed,
assigned, or otherwise disposed of; for services rendered or to be
rendered; for a policy of insurance issued or to be issued; for a
secondary obligation incurred or to be incurred; for energy provided or
to be provided; for the use or hire of a vessel under a charter or other
contract; arising out of the use of a credit or charge card or information
contained on or for use with the card; or as winnings in a lottery or other
game of chance operated or sponsored by a state, governmental unit of a
state, or person licensed or authorized to operate the game by a state or*

1 *governmental unit of a state. The term includes health-care-insurance*
2 *receivables. The term does not include rights to payment evidenced by*
3 *chattel paper or an instrument; commercial tort claims; deposit*
4 *accounts; investment property; letter-of-credit rights or letters of credit;*
5 *or rights to payment for money or funds advanced or sold, other than*
6 *rights arising out of the use of a credit or charge card or information*
7 *contained on or for use with the card.*

8 (c) *“Account debtor” means a person obligated on an account, chattel*
9 *paper, or general intangible. The term does not include persons obligated*
10 *to pay a negotiable instrument, even if the instrument constitutes part of*
11 *chattel paper.*

12 (d) *“Accounting,” except as used in “accounting for,” means a*
13 *record:*

14 (1) *Authenticated by a secured party;*

15 (2) *Indicating the aggregate unpaid secured obligations as of a date*
16 *not more than 35 days earlier or 35 days later than the date of the*
17 *record; and*

18 (3) *Identifying the components of the obligations in reasonable*
19 *detail.*

20 (e) *“Agricultural lien” means an interest, other than a security*
21 *interest, in farm products:*

22 (1) *Which secures payment or performance of an obligation for:*

23 (I) *Goods or services furnished in connection with a debtor’s*
24 *farming operation; or*

25 (II) *Rent on real property leased by a debtor in connection with*
26 *its farming operation;*

27 (2) *Which is created by statute in favor of a person that:*

28 (I) *In the ordinary course of its business furnished goods or*
29 *services to a debtor in connection with his farming operation; or*

30 (II) *Leased real property to a debtor in connection with his*
31 *farming operation; and*

32 (3) *Whose effectiveness does not depend on the person’s possession*
33 *of the personal property.*

34 (f) *“As-extracted collateral” means:*

35 (1) *Oil, gas, or other minerals that are subject to a security interest*
36 *that:*

37 (I) *Is created by a debtor having an interest in the minerals*
38 *before extraction; and*

39 (II) *Attaches to the minerals as extracted; or*

40 (2) *Accounts arising out of the sale at the wellhead or minehead of*
41 *oil, gas, or other minerals in which the debtor had an interest before*
42 *extraction.*

43 (g) *“Authenticate” means:*

- 1 (1) *To sign; or*
- 2 (2) *To execute or otherwise adopt a symbol, or encrypt or similarly*
- 3 *process a record in whole or in part, with the present intent of the*
- 4 *authenticating person to identify himself and adopt or accept a record.*
- 5 (h) *“Bank” means an organization that is engaged in the business of*
- 6 *banking. The term includes savings banks, savings and loan*
- 7 *associations, credit unions, and trust companies.*
- 8 (i) *“Cash proceeds” means proceeds that are money, checks, deposit*
- 9 *accounts, or the like.*
- 10 (j) *“Certificate of title” means a certificate of title with respect to*
- 11 *which a statute provides for the security interest in question to be*
- 12 *indicated on the certificate as a condition or result of the security*
- 13 *interest’s obtaining priority over the rights of a lien creditor with respect*
- 14 *to the collateral.*
- 15 (k) *“Chattel paper” means a record or records that evidence both a*
- 16 *monetary obligation and a security interest in or a lease of specific goods*
- 17 *or of specific goods and software used in the goods. The term does not*
- 18 *include charters or other contracts involving the use or hire of a vessel. If*
- 19 *a transaction is evidenced both by a security agreement or lease and by*
- 20 *an instrument or series of instruments, the group of records taken*
- 21 *together constitutes chattel paper.*
- 22 (l) *“Collateral” means the property subject to a security interest or*
- 23 *agricultural lien. The term includes:*
- 24 (1) *Proceeds to which a security interest attaches;*
- 25 (2) *Accounts, chattel paper, payment intangibles, and promissory*
- 26 *notes that have been sold; and*
- 27 (3) *Goods that are the subject of a consignment.*
- 28 (m) *“Commercial tort claim” means a claim arising in tort with*
- 29 *respect to which:*
- 30 (1) *The claimant is an organization; or*
- 31 (2) *The claimant is a natural person and the claim:*
- 32 (I) *Arose in the course of his business or profession; and*
- 33 (II) *Does not include damages arising out of personal injury to*
- 34 *or the death of a natural person.*
- 35 (n) *“Commodity account” means an account maintained by a*
- 36 *commodity intermediary in which a commodity contract is carried for a*
- 37 *commodity customer.*
- 38 (o) *“Commodity contract” means a commodity futures contract, an*
- 39 *option on a commodity futures contract, a commodity option, or another*
- 40 *contract if the contract or option is:*
- 41 (1) *Traded on or subject to the rules of a board of trade that has*
- 42 *been designated as a contract market for such a contract pursuant to*
- 43 *federal commodities laws; or*

1 (2) *Traded on a foreign commodity board of trade, exchange, or*
2 *market, and is carried on the books of a commodity intermediary for a*
3 *commodity customer.*

4 (p) *“Commodity customer” means a person for which a commodity*
5 *intermediary carries a commodity contract on its books.*

6 (q) *“Commodity intermediary” means a person that:*

7 (1) *Is registered as a futures commission merchant under federal*
8 *commodities law; or*

9 (2) *In the ordinary course of its business provides clearance or*
10 *settlement services for a board of trade that has been designated as a*
11 *contract market pursuant to federal commodities law.*

12 (r) *“Communicate” means:*

13 (1) *To send a written or other tangible record;*

14 (2) *To transmit a record by any means agreed upon by the persons*
15 *sending and receiving the record; or*

16 (3) *In the case of transmission of a record to or by a filing office, to*
17 *transmit a record by any means prescribed by filing-office rule.*

18 (s) *“Consignee” means a merchant to which goods are delivered in a*
19 *consignment.*

20 (t) *“Consignment” means a transaction, regardless of its form, in*
21 *which a person delivers goods to a merchant for the purpose of sale and:*

22 (1) *The merchant:*

23 (I) *Deals in goods of that kind under a name other than the name*
24 *of the person making delivery;*

25 (II) *Is not an auctioneer; and*

26 (III) *Is not generally known by its creditors to be substantially*
27 *engaged in selling the goods of others;*

28 (2) *With respect to each delivery, the aggregate value of the goods is*
29 *\$1,000 or more at the time of delivery;*

30 (3) *The goods are not consumer goods immediately before delivery;*
31 *and*

32 (4) *The transaction does not create a security interest that secures*
33 *an obligation.*

34 (u) *“Consignor” means a person that delivers goods to a consignee in*
35 *a consignment.*

36 (v) *“Consumer debtor” means a debtor in a consumer transaction.*

37 (w) *“Consumer goods” means goods that are used or bought for use*
38 *primarily for personal, family, or household purposes.*

39 (x) *“Consumer-goods transaction” means a consumer transaction to*
40 *the extent that:*

41 (1) *A natural person incurs an obligation primarily for personal,*
42 *family, or household purposes; and*

1 (2) A security interest in consumer goods or in consumer goods and
2 software that is held or acquired primarily for personal, family, or
3 household purposes secures the obligation.

4 (y) "Consumer obligor" means an obligor who is a natural person
5 and who incurred the obligation as part of a transaction entered into
6 primarily for personal, family, or household purposes.

7 (z) "Consumer transaction" means a transaction to the extent that a
8 natural person incurs an obligation primarily for personal, family, or
9 household purposes; a security interest secures the obligation; and the
10 collateral is held or acquired primarily for personal, family, or household
11 purposes. The term includes consumer-goods transactions.

12 (aa) "Continuation statement" means a change of a financing
13 statement which:

14 (1) Identifies, by its file number, the initial financing statement to
15 which it relates; and

16 (2) Indicates that it is a continuation statement for, or that it is filed
17 to continue the effectiveness of, the identified financing statement.

18 (bb) "Debtor" means:

19 (1) A person having an interest, other than a security interest or
20 other lien, in the collateral, whether or not he is an obligor;

21 (2) A seller of accounts, chattel paper, payment intangibles, or
22 promissory notes; or

23 (3) A consignee.

24 (cc) "Deposit account" means a demand, time, savings, passbook, or
25 similar account maintained with a bank. The term does not include
26 investment property or accounts evidenced by an instrument.

27 (dd) "Document" means a document of title or a receipt of the type
28 described in subsection 2 of NRS 104.7201.

29 (ee) "Electronic chattel paper" means chattel paper evidenced by a
30 record or records consisting of information stored in an electronic
31 medium.

32 (ff) "Encumbrance" means a right, other than an ownership interest,
33 in real property. The term includes mortgages and other liens on real
34 property.

35 (gg) "Equipment" means goods other than inventory, farm products,
36 or consumer goods.

37 (hh) "Farm products" means goods, other than standing timber, with
38 respect to which the debtor is engaged in a farming operation and which
39 are:

40 (1) Crops grown, growing, or to be grown, including:

41 (I) Crops produced on trees, vines, and bushes; and

42 (II) Aquatic goods produced in aquacultural operations;

1 (2) *Livestock, born or unborn, including aquatic goods produced in*
2 *aquacultural operations;*

3 (3) *Supplies used or produced in a farming operation; or*

4 (4) *Products of crops or livestock in their unmanufactured states.*

5 (ii) *“Farming operation” means raising, cultivating, propagating,*
6 *fattening, grazing, or any other farming, livestock, or aquacultural*
7 *operation.*

8 (jj) *“File number” means the number assigned to an initial financing*
9 *statement pursuant to subsection 1 of section 91 of this act.*

10 (kk) *“Filing office” means an office designated in section 73 of this*
11 *act as the place to file a financing statement.*

12 (ll) *“Filing-office rule” means a rule adopted pursuant to section 98*
13 *of this act.*

14 (mm) *“Financing statement” means a record or records composed of*
15 *an initial financing statement and any filed record relating to the initial*
16 *financing statement.*

17 (nn) *“Fixture filing” means the filing of a financing statement*
18 *covering goods that are or are to become fixtures and satisfying*
19 *subsections 1 and 2 of section 74 of this act. The term includes the filing*
20 *of a financing statement covering goods of a transmitting utility which*
21 *are or are to become fixtures.*

22 (oo) *“Fixtures” means goods that have become so related to*
23 *particular real property that an interest in them arises under real*
24 *property law.*

25 (pp) *“General intangible” means any personal property, including*
26 *things in action, other than accounts, chattel paper, commercial tort*
27 *claims, deposit accounts, documents, goods, instruments, investment*
28 *property, letter-of-credit rights, letters of credit, money, and oil, gas, or*
29 *other minerals before extraction. The term includes payment intangibles*
30 *and software.*

31 (qq) *“Good faith” means honesty in fact and the observance of*
32 *reasonable commercial standards of fair dealing.*

33 (rr) *“Goods” means all things that are movable when a security*
34 *interest attaches. The term includes fixtures; standing timber that is to be*
35 *cut and removed under a conveyance or contract for sale; the unborn*
36 *young of animals; crops grown, growing, or to be grown, even if the*
37 *crops are produced on trees, vines, or bushes; and manufactured homes.*
38 *The term also includes a computer program embedded in goods and any*
39 *supporting information provided in connection with a transaction*
40 *relating to the program if the program is associated with the goods in*
41 *such a manner that it customarily is considered part of the goods, or by*
42 *becoming the owner of the goods, a person acquires a right to use the*
43 *program in connection with the goods. The term does not include a*

1 computer program embedded in goods that consist solely of the medium
2 in which the program is embedded. The term also does not include
3 accounts, chattel paper, commercial tort claims, deposit accounts,
4 documents, general intangibles, instruments, investment property, letter-
5 of-credit rights, letters of credit, money, or oil, gas, or other minerals
6 before extraction.

7 (ss) "Governmental unit" means a subdivision, agency, department,
8 county, parish, municipality, or other unit of the government of the
9 United States, a state, or a foreign country. The term includes an
10 organization having a separate corporate existence if the organization is
11 eligible to issue debt on which interest is exempt from income taxation
12 under the laws of the United States.

13 (tt) "Health-care-insurance receivable" means an interest in or claim
14 under a policy of insurance which is a right to payment of a monetary
15 obligation for health-care goods or services provided.

16 (uu) "Instrument" means a negotiable instrument or any other
17 writing that evidences a right to the payment of a monetary obligation, is
18 not itself a security agreement or lease, and is of a type that in ordinary
19 course of business is transferred by delivery with any necessary
20 endorsement or assignment. The term does not include investment
21 property, letters of credit, or writings that evidence a right to payment
22 arising out of the use of a credit or charge card or information contained
23 on or for use with the card.

24 (vv) "Inventory" means goods, other than farm products, which:

- 25 (1) Are leased by a person as lessor;
26 (2) Are held by a person for sale or lease or to be furnished under a
27 contract of service;
28 (3) Are furnished by a person under a contract of service; or
29 (4) Consist of raw materials, work in process, or materials used or
30 consumed in a business.

31 (ww) "Investment property" means a security, whether certificated or
32 uncertificated, security entitlement, securities account, commodity
33 contract, or commodity account.

34 (xx) "Jurisdiction of organization," with respect to a registered
35 organization, means the jurisdiction under whose law the organization is
36 organized.

37 (yy) "Letter-of-credit right" means a right to payment or performance
38 under a letter of credit, whether or not the beneficiary has demanded or
39 is at the time entitled to demand payment or performance. The term does
40 not include the right of a beneficiary to demand payment or performance
41 under a letter of credit.

42 (zz) "Lien creditor" means:

1 (1) A creditor that has acquired a lien on the property involved by
2 attachment, levy, or the like;

3 (2) An assignee for benefit of creditors from the time of
4 assignment;

5 (3) A trustee in bankruptcy from the date of the filing of the
6 petition; or

7 (4) A receiver in equity from the time of appointment.

8 (aaa) "Manufactured home" means a structure, transportable in one
9 or more sections, which in the traveling mode, is 8 feet or more in body
10 width or 40 feet or more in body length, or, when erected on site, is 320
11 or more square feet, and which is built on a permanent chassis and
12 designed to be used as a dwelling with or without a permanent
13 foundation when connected to the required utilities, and includes the
14 plumbing, heating, air-conditioning, and electrical systems contained
15 therein. The term includes any structure that meets all of the
16 requirements of this paragraph except the size requirements and with
17 respect to which the manufacturer voluntarily files a certification
18 required by the United States Secretary of Housing and Urban
19 Development and complies with the standards established under Title 42
20 of the United States Code.

21 (bbb) "Manufactured-home transaction" means a secured
22 transaction:

23 (1) That creates a purchase-money security interest in a
24 manufactured home, other than a manufactured home held as inventory;
25 or

26 (2) In which a manufactured home, other than a manufactured
27 home held as inventory, is the primary collateral.

28 (ccc) "Mortgage" means a consensual interest in real property,
29 including fixtures, which is created by a mortgage, deed of trust, or
30 similar transaction.

31 (ddd) "New debtor" means a person that becomes bound as debtor
32 under subsection 4 of section 14 of this act by a security agreement
33 previously entered into by another person.

34 (eee) "New value" means money; money's worth in property, services,
35 or new credit; or release by a transferee of an interest in property
36 previously transferred to the transferee. The term does not include an
37 obligation substituted for another obligation.

38 (fff) "Noncash proceeds" means proceeds other than cash proceeds.

39 (ggg) "Obligor" means a person that, with respect to an obligation
40 secured by a security interest in or an agricultural lien on the collateral,
41 owes payment or other performance of the obligation, has provided
42 property other than the collateral to secure payment or other
43 performance of the obligation, or is otherwise accountable in whole or in

1 *part for payment or other performance of the obligation. The term does*
2 *not include an issuer or a nominated person under a letter of credit.*

3 *(hhh) "Original debtor" means a person that, as debtor, entered into a*
4 *security agreement to which a new debtor has become bound under*
5 *subsection 4 of section 14 of this act.*

6 *(iii) "Payment intangible" means a general intangible under which*
7 *the account debtor's principal obligation is a monetary obligation.*

8 *(jjj) "Person related to," with respect to a natural person, means:*

9 *(1) His spouse;*

10 *(2) His brother, brother-in-law, sister, or sister-in-law;*

11 *(3) His or his spouse's ancestor or lineal descendant; or*

12 *(4) Any other relative, by blood or marriage, of the person or his*
13 *spouse who shares the same home with him.*

14 *(kkk) "Person related to," with respect to an organization, means:*

15 *(1) A person directly or indirectly controlling, controlled by, or*
16 *under common control with the organization;*

17 *(2) An officer or director of, or a person performing similar*
18 *functions with respect to, the organization;*

19 *(3) An officer or director of, or a person performing similar*
20 *functions with respect to, a person described in subparagraph (1);*

21 *(4) The spouse of a natural person described in subparagraph (1),*
22 *(2), or (3); or*

23 *(5) A person who is related by blood or marriage to a person*
24 *described in subparagraph (1), (2), (3), or (4) and shares the same home*
25 *with that person.*

26 *(lll) "Proceeds" means the following property:*

27 *(1) Whatever is acquired upon the sale, lease, license, exchange, or*
28 *other disposition of collateral;*

29 *(2) Whatever is collected on, or distributed on account of,*
30 *collateral;*

31 *(3) Rights arising out of collateral;*

32 *(4) To the extent of the value of collateral, claims arising out of the*
33 *loss, nonconformity, or interference with the use of, defects or*
34 *infringement of rights in, or damage to, the collateral; and*

35 *(5) To the extent of the value of collateral and to the extent payable*
36 *to the debtor or the secured party, insurance payable by reason of the loss*
37 *or nonconformity of, defects or infringement of rights in, or damage to,*
38 *the collateral.*

39 *(mmm) "Promissory note" means an instrument that evidences a*
40 *promise to pay a monetary obligation, does not evidence an order to pay,*
41 *and does not contain an acknowledgment by a bank that the bank has*
42 *received for deposit a sum of money or funds.*

1 (nnn) “Proposal” means a record authenticated by a secured party
2 which includes the terms on which the secured party is willing to accept
3 collateral in full or partial satisfaction of the obligation it secures
4 pursuant to sections 119, 120 and 121 of this act.

5 (ooo) “Public-finance transaction” means a secured transaction in
6 connection with which:

7 (1) Debt securities are issued;

8 (2) All or a portion of the securities issued have an initial stated
9 maturity of at least 20 years; and

10 (3) The debtor, the obligor, the secured party, the account debtor or
11 other person obligated on collateral, the assignor or assignee of a
12 secured obligation, or the assignor or assignee of a security interest is a
13 state or a governmental unit of a state.

14 (ppp) “Pursuant to commitment,” with respect to an advance made or
15 other value given by a secured party, means pursuant to the secured
16 party’s obligation, whether or not a subsequent event of default or other
17 event not within the secured party’s control has relieved or may relieve
18 the secured party from its obligation.

19 (qqq) “Record,” except as used in “for record,” “of record,” “record
20 or legal title,” and “record owner,” means information that is inscribed
21 on a tangible medium or which is stored in an electronic or other
22 medium and is retrievable in perceivable form.

23 (rrr) “Registered organization” means an organization organized
24 solely under the law of a single state or the United States and as to which
25 the state or the United States must maintain a public record showing the
26 organization to have been organized.

27 (sss) “Secondary obligor” means an obligor to the extent that:

28 (1) The obligor’s obligation is secondary; or

29 (2) The obligor has a right of recourse with respect to an obligation
30 secured by collateral against the debtor, another obligor, or property of
31 either.

32 (ttt) “Secured party” means:

33 (1) A person in whose favor a security interest is created or
34 provided for under a security agreement, whether or not any obligation
35 to be secured is outstanding;

36 (2) A person that holds an agricultural lien;

37 (3) A consignor;

38 (4) A person to which accounts, chattel paper, payment intangibles,
39 or promissory notes have been sold;

40 (5) A trustee, indenture trustee, agent, collateral agent, or other
41 representative in whose favor a security interest or agricultural lien is
42 created or provided for; or

1 (6) A person that holds a security interest arising under NRS
2 104.2401, 104.2505, subsection 3 of NRS 104.2711, NRS 104.4210,
3 104.5118, or subsection 5 of NRS 104A.2508.

4 (uuu) "Security agreement" means an agreement that creates or
5 provides for a security interest.

6 (vvv) "Send," in connection with a record or notification, means:

7 (1) To deposit in the mail, deliver for transmission, or transmit by
8 any other usual means of communication, with postage or cost of
9 transmission provided for, addressed to any address reasonable under the
10 circumstances; or

11 (2) To cause the record or notification to be received within the time
12 that it would have been received if properly sent under subparagraph (1).

13 (www) "Software" means a computer program and any supporting
14 information provided in connection with a transaction relating to the
15 program. The term does not include a computer program that is
16 contained in goods unless the goods are a computer or computer
17 peripheral.

18 (xxx) "State" means a state of the United States, the District of
19 Columbia, Puerto Rico, the United States Virgin Islands, or any territory
20 or insular possession subject to the jurisdiction of the United States.

21 (yyy) "Supporting obligation" means a letter-of-credit right or
22 secondary obligation that supports the payment or performance of an
23 account, chattel paper, document, general intangible, instrument, or
24 investment property.

25 (zzz) "Tangible chattel paper" means chattel paper evidenced by a
26 record or records consisting of information that is inscribed on a tangible
27 medium.

28 (aaaa) "Termination statement" means a subsequent filing which:

29 (1) Identifies, by its file number, the initial financing statement to
30 which it relates; and

31 (2) Indicates either that it is a termination statement or that the
32 identified financing statement is no longer effective.

33 (bbbb) "Transmitting utility" means a person primarily engaged in
34 the business of:

35 (1) Operating a railroad, subway, street railway, or trolley bus;

36 (2) Transmitting communications electrically, electromagnetically,
37 or by light;

38 (3) Transmitting goods by pipeline;

39 (4) Providing sewerage; or

40 (5) Transmitting or producing and transmitting electricity, steam,
41 gas, or water.

- “Proceeds of a letter of credit.” NRS 104.5114.*
- “Prove.” NRS 104.3103.*
- “Sale.” NRS 104.2106.*
- “Securities account.” NRS 104.8501.*
- “Securities intermediary.” NRS 104.8102.*
- “Security.” NRS 104.8102.*
- “Security certificate.” NRS 104.8102.*
- “Security entitlement.” NRS 104.8102.*
- “Uncertificated security.” NRS 104.8102.*

3. *Article 1 contains general definitions and principles of construction and interpretation applicable throughout this article.*

Sec. 4. 1. In this section:

- (a) “Purchase-money collateral” means goods or software that secures a purchase-money obligation incurred with respect to that collateral; and*
- (b) “Purchase-money obligation” means an obligation of an obligor incurred as all or part of the price of the collateral or for value given to*

1 *enable the debtor to acquire rights in or the use of the collateral if the*
2 *value is in fact so used.*

3 *2. A security interest in goods is a purchase-money security interest:*

4 *(a) To the extent that the goods are purchase-money collateral with*
5 *respect to that security interest;*

6 *(b) If the security interest is in inventory that is or was purchase-*
7 *money collateral, also to the extent that the security interest secures a*
8 *purchase-money obligation incurred with respect to other inventory in*
9 *which the secured party holds or held a purchase-money security*
10 *interest; and*

11 *(c) Also to the extent that the security interest secures a purchase-*
12 *money obligation incurred with respect to software in which the secured*
13 *party holds or held a purchase-money security interest.*

14 *3. A security interest in software is a purchase-money security*
15 *interest to the extent that the security interest also secures a purchase-*
16 *money obligation incurred with respect to goods in which the secured*
17 *party holds or held a purchase-money security interest if:*

18 *(a) The debtor acquired its interest in the software in an integrated*
19 *transaction in which it acquired an interest in the goods; and*

20 *(b) The debtor acquired its interest in the software for the principal*
21 *purpose of using the software in the goods.*

22 *4. The security interest of a consignor in goods that are the subject of*
23 *a consignment is a purchase-money security interest in inventory.*

24 *5. In a transaction other than a consumer-goods transaction, if the*
25 *extent to which a security interest is a purchase-money security interest*
26 *depends on the application of a payment to a particular obligation, the*
27 *payment must be applied:*

28 *(a) In accordance with any reasonable method of application to which*
29 *the parties agree;*

30 *(b) In the absence of the parties' agreement to a reasonable method,*
31 *in accordance with any intention of the obligor manifested at or before*
32 *the time of payment; or*

33 *(c) In the absence of an agreement to a reasonable method and a*
34 *timely manifestation of the obligor's intention, in the following order:*

35 *(1) To obligations that are not secured; and*

36 *(2) If more than one obligation is secured, to obligations secured by*
37 *purchase-money security interests in the order in which those obligations*
38 *were incurred.*

39 *6. In a transaction other than a consumer-goods transaction, a*
40 *purchase-money security interest does not lose its status as such, even if:*

41 *(a) The purchase-money collateral also secures an obligation that is*
42 *not a purchase-money obligation;*

1 **(b) Collateral that is not purchase-money collateral also secures the**
2 **purchase-money obligation; or**

3 **(c) The purchase-money obligation has been renewed, refinanced,**
4 **consolidated, or restructured.**

5 **7. In a transaction other than a consumer-goods transaction, a**
6 **secured party claiming a purchase-money security interest has the**
7 **burden of establishing the extent to which the security interest is a**
8 **purchase-money security interest.**

9 **8. The limitation of the rules in subsections 5, 6 and 7 to transactions**
10 **other than consumer-goods transactions leaves to the court the**
11 **determination of the proper rules in consumer-goods transactions. The**
12 **court may not infer from that limitation the nature of the proper rule in**
13 **consumer-goods transactions and may continue to apply established**
14 **approaches.**

15 **Sec. 5. 1. A secured party has control of a deposit account if:**

16 **(a) The secured party is the bank with which the deposit account is**
17 **maintained;**

18 **(b) The debtor, secured party, and bank have agreed in an**
19 **authenticated record that the bank will comply with instructions**
20 **originated by the secured party directing disposition of the funds in the**
21 **account without further consent by the debtor; or**

22 **(c) The secured party becomes the bank's customer with respect to the**
23 **deposit account.**

24 **2. A secured party that has satisfied subsection 1 has control, even if**
25 **the debtor retains the right to direct the disposition of funds from the**
26 **deposit account.**

27 **Sec. 6. A secured party has control of electronic chattel paper if the**
28 **record or records comprising the chattel paper are created, stored, and**
29 **assigned in such a manner that:**

30 **1. A single authoritative copy of the record or records exists which is**
31 **unique, identifiable and, except as otherwise provided in subsections 4, 5,**
32 **and 6, unalterable;**

33 **2. The authoritative copy identifies the secured party as the assignee**
34 **of the record or records;**

35 **3. The authoritative copy is communicated to and maintained by the**
36 **secured party or its designated custodian;**

37 **4. Copies or revisions that add or change an identified assignee of**
38 **the authoritative copy can be made only with the participation of the**
39 **secured party;**

40 **5. Each copy of the authoritative copy and any copy of a copy is**
41 **readily identifiable as a copy that is not the authoritative copy; and**

42 **6. Any revision of the authoritative copy is readily identifiable as an**
43 **authorized or unauthorized revision.**

1 **Sec. 7. 1. A person has control of a certificated security,**
2 **uncertificated security, or security entitlement as provided in NRS**
3 **104.8106.**

4 **2. A secured party has control of a commodity contract if:**

5 **(a) The secured party is the commodity intermediary with which the**
6 **commodity contract is carried; or**

7 **(b) The commodity customer, secured party, and commodity**
8 **intermediary have agreed that the commodity intermediary will apply any**
9 **value distributed on account of the commodity contract as directed by the**
10 **secured party without further consent by the commodity customer.**

11 **3. A secured party having control of all security entitlements or**
12 **commodity contracts carried in a securities account or commodity**
13 **account has control over the securities account or commodity account.**

14 **Sec. 8. A secured party has control of a letter-of-credit right to the**
15 **extent of any right to payment or performance by the issuer or any**
16 **nominated person if the issuer or nominated person has consented to an**
17 **assignment of proceeds of the letter of credit under subsection 3 of NRS**
18 **104.5114 or otherwise applicable law or practice.**

19 **Sec. 9. 1. Except as otherwise provided in subsections 3, 4 and 5, a**
20 **description of personal or real property is sufficient, whether or not it is**
21 **specific, if it reasonably identifies what is described.**

22 **2. Except as otherwise provided in subsection 4, a description of**
23 **collateral reasonably identifies the collateral if it identifies the collateral**
24 **by:**

25 **(a) Specific listing;**

26 **(b) Category;**

27 **(c) Except as otherwise provided in subsection 5, a type of collateral**
28 **defined in the Uniform Commercial Code;**

29 **(d) Quantity;**

30 **(e) Computational or allocational formula or procedure; or**

31 **(f) Except as otherwise provided in subsection 3, any other method, if**
32 **the identity of the collateral is objectively determinable.**

33 **3. A description of collateral as “all the debtor’s assets” or “all the**
34 **debtor’s personal property” or using words of similar import does not**
35 **reasonably identify the collateral.**

36 **4. Except as otherwise provided in subsection 5, a description of a**
37 **security entitlement, securities account, or commodity account is**
38 **sufficient if it describes:**

39 **(a) The collateral by those terms or as investment property; or**

40 **(b) The underlying financial asset or commodity contract.**

41 **5. A description only by type of collateral defined in the Uniform**
42 **Commercial Code is an insufficient description of:**

43 **(a) A commercial tort claim; or**

1 **(b) In a consumer transaction, consumer goods, a security**
2 **entitlement, a securities account, or a commodity account.**

3 **Sec. 10. 1. Except as otherwise provided in subsections 3 and 4,**
4 **this article applies to:**

5 **(a) A transaction, regardless of its form, that creates a security interest**
6 **in personal property or fixtures by contract;**

7 **(b) An agricultural lien;**

8 **(c) A sale of accounts, chattel paper, payment intangibles, or**
9 **promissory notes;**

10 **(d) A consignment;**

11 **(e) A security interest arising under NRS 104.2401, 104.2505,**
12 **subsection 3 of NRS 104.2711, or subsection 5 of NRS 104A.2508, as**
13 **provided in section 11 of this act; and**

14 **(f) A security interest arising under NRS 104.4210 or 104.5118.**

15 **2. The application of this article to a security interest in a secured**
16 **obligation is not affected by the fact that the obligation is itself secured**
17 **by a transaction or interest to which this article does not apply.**

18 **3. This article does not apply to the extent that:**

19 **(a) A statute, regulation, or treaty of the United States preempts this**
20 **article;**

21 **(b) Another statute of this state expressly governs the creation,**
22 **perfection, priority, or enforcement of a security interest created by this**
23 **state or a governmental unit of this state;**

24 **(c) A statute of another state, a foreign country, or a governmental**
25 **unit of another state or a foreign country, other than a statute generally**
26 **applicable to security interests, expressly governs creation, perfection,**
27 **priority, or enforcement of a security interest created by the state,**
28 **country, or governmental unit; or**

29 **(d) The rights of a transferee beneficiary or nominated person under**
30 **a letter of credit are independent and superior under NRS 104.5114.**

31 **4. This article does not apply to:**

32 **(a) A landlord's lien, other than an agricultural lien;**

33 **(b) A lien, other than an agricultural lien, given by statute or other**
34 **rule of law for services or materials, but section 54 of this act applies**
35 **with respect to priority of the lien;**

36 **(c) An assignment of a claim for wages, salary, or other compensation**
37 **of an employee;**

38 **(d) A sale of accounts, chattel paper, payment intangibles, or**
39 **promissory notes as part of a sale of the business out of which they arose;**

40 **(e) An assignment of accounts, chattel paper, payment intangibles, or**
41 **promissory notes which is for the purpose of collection only;**

42 **(f) An assignment of a right to payment under a contract to an**
43 **assignee that is also obligated to perform under the contract;**

1 (g) An assignment of a single account, payment intangible, or
2 promissory note to an assignee in full or partial satisfaction of a
3 preexisting indebtedness;

4 (h) A transfer of an interest in or an assignment of a claim under a
5 policy of insurance, other than an assignment by or to a health-care
6 provider of a health-care-insurance receivable and any subsequent
7 assignment of the right to payment, but sections 36 and 43 of this act
8 apply with respect to proceeds and priorities in proceeds;

9 (i) An assignment of a right represented by a judgment, other than a
10 judgment taken on a right to payment that was collateral;

11 (j) A right of recoupment or set-off, but:

12 (1) Section 61 of this act applies with respect to the effectiveness of
13 rights of recoupment or set-off against deposit accounts; and

14 (2) Section 67 of this act applies with respect to defenses or claims
15 of an account debtor;

16 (k) The creation or transfer of an interest in or lien on real property,
17 including a lease or rents thereunder, except to the extent that provision
18 is made for:

19 (1) Liens on real property in sections 14 and 29 of this act;

20 (2) Fixtures in section 55 of this act;

21 (3) Fixture filings in sections 73, 74, 84, 88 and 91 of this act; and

22 (4) Security agreements covering personal and real property in
23 section 103 of this act;

24 (l) An assignment of a claim arising in tort, other than a commercial
25 tort claim, but sections 36 and 43 of this act apply with respect to
26 proceeds and priorities in proceeds; or

27 (m) An assignment of a deposit account in a consumer transaction,
28 but sections 36 and 43 of this act apply with respect to proceeds and
29 priorities in proceeds.

30 **Sec. 11.** A security interest arising under NRS 104.2401, 104.2505,
31 subsection 3 of 104.2711, or subsection 5 of NRS 104A.2508 is subject to
32 this article. However, until the debtor obtains possession of the goods:

33 1. The security interest is enforceable, even if paragraph (c) of
34 subsection 2 of section 14 of this act has not been satisfied;

35 2. Filing is not required to perfect the security interest;

36 3. The rights of the secured party after default by the debtor are
37 governed by Article 2 or 2A; and

38 4. The security interest has priority over a conflicting security
39 interest created by the debtor.

40 **Sec. 12.** 1. Except as otherwise provided in the Uniform
41 Commercial Code, a security agreement is effective according to its terms
42 between the parties, against purchasers of the collateral, and against
43 creditors.

1 2. A transaction subject to this article is subject to any applicable
2 rule of law which establishes a different rule for consumers and to
3 chapters 97 and 97A of NRS.

4 3. In case of conflict between this article and a rule of law, statute, or
5 regulation described in subsection 2, the rule of law, statute, or
6 regulation controls. Failure to comply with a statute or regulation
7 described in subsection 2 has only the effect the statute or regulation
8 specifies.

9 4. This article does not:

10 (a) Validate any rate, charge, agreement, or practice that violates a
11 rule of law, statute, or regulation described in subsection 2; or

12 (b) Extend the application of the rule of law, statute, or regulation to a
13 transaction not otherwise subject to it.

14 **Sec. 13.** Except as otherwise provided with respect to consignments
15 or sales of accounts, chattel paper, payment intangibles, or promissory
16 notes, the provisions of this article with regard to rights and obligations
17 apply whether or not title to collateral is in the secured party or the
18 debtor.

19 **Sec. 14.** 1. A security interest attaches to collateral when it
20 becomes enforceable against the debtor with respect to the collateral,
21 unless an agreement expressly postpones the time of attachment.

22 2. Except as otherwise provided in subsections 3 to 9, inclusive, a
23 security interest is enforceable against the debtor and third parties with
24 respect to the collateral only if:

25 (a) Value has been given;

26 (b) The debtor has rights in the collateral or the power to transfer
27 rights in the collateral to a secured party; and

28 (c) One of the following conditions is met:

29 (1) The debtor has authenticated a security agreement that provides
30 a description of the collateral and, if the security interest covers timber to
31 be cut, a description of the land concerned;

32 (2) The collateral is not a certificated security and is in the
33 possession of the secured party under section 34 of this act pursuant to
34 the debtor's security agreement;

35 (3) The collateral is a certificated security in registered form and
36 the security certificate has been delivered to the secured party under NRS
37 104.8301 pursuant to the debtor's security agreement; or

38 (4) The collateral is deposit accounts, electronic chattel paper,
39 investment property, or letter-of-credit rights, and the secured party has
40 control under section 5, 6, 7 or 8 of this act pursuant to the debtor's
41 security agreement.

42 3. Subsection 2 is subject to NRS 104.4210 on the security interest of
43 a collecting bank, NRS 104.5118 on the security interest of a letter-of

1 *credit issuer or nominated person, section 11 of this act on a security*
2 *interest arising under Article 2 or 2A, and section 17 of this act on*
3 *security interests in investment property.*

4 *4. A person becomes bound as debtor by a security agreement*
5 *entered into by another person if, by operation of law other than this*
6 *article or by contract:*

7 *(a) The security agreement becomes effective to create a security*
8 *interest in his property; or*

9 *(b) He becomes generally obligated for the obligations of the other*
10 *person, including the obligation secured under the security agreement,*
11 *and acquires or succeeds to all or substantially all of the assets of the*
12 *other person.*

13 *5. If a new debtor becomes bound as debtor by a security agreement*
14 *entered into by another person:*

15 *(a) The agreement satisfies paragraph (c) of subsection 2 with respect*
16 *to existing or after-acquired property of the new debtor to the extent the*
17 *property is described in the agreement; and*

18 *(b) Another agreement is not necessary to make a security interest in*
19 *the property enforceable.*

20 *6. The attachment of a security interest in collateral gives the*
21 *secured party the rights to proceeds provided by section 36 of this act and*
22 *is also attachment of a security interest in a supporting obligation for the*
23 *collateral.*

24 *7. The attachment of a security interest in a right to payment or*
25 *performance secured by a security interest or other lien on personal or*
26 *real property is also attachment of a security interest in the security*
27 *interest, mortgage, or other lien.*

28 *8. The attachment of a security interest in a securities account is also*
29 *attachment of a security interest in the security entitlements carried in*
30 *the securities account.*

31 *9. The attachment of a security interest in a commodity account is*
32 *also attachment of a security interest in the commodity contracts carried*
33 *in the commodity account.*

34 **Sec. 15. 1.** *Except as otherwise provided in subsection 2, a security*
35 *agreement may create or provide for a security interest in after-acquired*
36 *collateral.*

37 *2. A security interest does not attach under a term constituting an*
38 *after-acquired property clause to:*

39 *(a) Consumer goods, other than an accession when given as*
40 *additional security, unless the debtor acquires rights in them within 10*
41 *days after the secured party gives value; or*

42 *(b) A commercial tort claim.*

1 **3.** A security agreement may provide that collateral secures, or that
2 accounts, chattel paper, payment intangibles, or promissory notes are
3 sold in connection with, future advances or other value, whether or not
4 the advances or value are given pursuant to commitment.

5 **Sec. 16. 1.** A security interest is not invalid or fraudulent against
6 creditors solely because:

7 **(a)** The debtor has the right or ability to:

8 **(1)** Use, commingle, or dispose of all or part of the collateral,
9 including returned or repossessed goods;

10 **(2)** Collect, compromise, enforce, or otherwise deal with collateral;

11 **(3)** Accept the return of collateral or make repossessions; or

12 **(4)** Use, commingle, or dispose of proceeds; or

13 **(b)** The secured party fails to require the debtor to account for
14 proceeds or replace collateral.

15 **2.** This section does not relax the requirements of possession if
16 attachment, perfection, or enforcement of a security interest depends
17 upon possession of the collateral by the secured party.

18 **Sec. 17. 1.** A security interest in favor of a securities intermediary
19 attaches to a person's security entitlement if:

20 **(a)** He buys a financial asset through the securities intermediary in a
21 transaction in which he is obligated to pay the purchase price to the
22 securities intermediary at the time of the purchase; and

23 **(b)** The securities intermediary credits the financial asset to his
24 securities account before he pays the securities intermediary.

25 **2.** The security interest described in subsection 1 secures the buyer's
26 obligation to pay for the financial asset.

27 **3.** A security interest in favor of a person that delivers a certificated
28 security or other financial asset represented by a writing attaches to the
29 security or other financial asset if:

30 **(a)** The security or other financial asset:

31 **(1)** In the ordinary course of business is transferred by delivery with
32 any necessary endorsement or assignment; and

33 **(2)** Is delivered under an agreement between persons in the
34 business of dealing with such securities or financial assets; and

35 **(b)** The agreement calls for delivery against payment.

36 **4.** The security interest described in subsection 3 secures the
37 obligation to make payment for the delivery.

38 **Sec. 18. 1.** Except as otherwise provided in subsection 4, a secured
39 party shall use reasonable care in the custody and preservation of
40 collateral in the secured party's possession. In the case of chattel paper
41 or an instrument, reasonable care includes taking necessary steps to
42 preserve rights against prior parties unless otherwise agreed.

1 2. Except as otherwise provided in subsection 4, if a secured party
2 has possession of collateral:

3 (a) Reasonable expenses, including the cost of insurance and payment
4 of taxes or other charges, incurred in the custody, preservation, use, or
5 operation of the collateral are chargeable to the debtor and are secured
6 by the collateral;

7 (b) The risk of accidental loss or damage is on the debtor to the extent
8 of a deficiency in any effective insurance coverage;

9 (c) The secured party shall keep the collateral identifiable, but
10 fungible collateral may be commingled; and

11 (d) The secured party may use or operate the collateral:

12 (1) For the purpose of preserving the collateral or its value;

13 (2) As permitted by an order of a court having competent
14 jurisdiction; or

15 (3) Except in the case of consumer goods, in the manner and to the
16 extent agreed by the debtor.

17 3. Except as otherwise provided in subsection 4, a secured party
18 having possession of collateral or control of collateral under section 5, 6,
19 7 or 8 of this act:

20 (a) May hold as additional security any proceeds, except money or
21 funds, received from the collateral;

22 (b) Shall apply money or funds received from the collateral to reduce
23 the secured obligation, unless remitted to the debtor; and

24 (c) May create a security interest in the collateral.

25 4. If the secured party is a buyer of accounts, chattel paper, payment
26 intangibles, or promissory notes or a consignor:

27 (a) Subsection 1 does not apply unless the secured party is entitled
28 under an agreement:

29 (1) To charge back uncollected collateral; or

30 (2) Otherwise to full or limited recourse against the debtor or a
31 secondary obligor based on the nonpayment or other default of an
32 account debtor or other obligor on the collateral; and

33 (b) Subsections 2 and 3 do not apply.

34 **Sec. 19.** If there is no outstanding secured obligation and the
35 secured party is not committed to make advances, incur obligations, or
36 otherwise give value, within 10 days after receiving an authenticated
37 demand by the debtor:

38 1. A secured party having control of a deposit account under
39 paragraph (b) of subsection 1 of section 5 of this act shall send to the
40 bank with which the deposit account is maintained an authenticated
41 statement that releases the bank from any further obligation to comply
42 with instructions originated by the secured party;

1 2. A secured party having control of a deposit account under
2 paragraph (c) of subsection 1 of section 5 of this act shall:

3 (a) Pay the debtor the balance on deposit in the deposit account; or

4 (b) Transfer the balance on deposit into a deposit account in the
5 debtor's name;

6 3. A secured party, other than a buyer, having control of electronic
7 chattel paper under section 6 of this act shall:

8 (a) Communicate the authoritative copy of the electronic chattel paper
9 to the debtor or its designated custodian;

10 (b) If the debtor designates a custodian that is the designated
11 custodian with which the authoritative copy of the electronic chattel
12 paper is maintained for the secured party, communicate to the custodian
13 an authenticated record releasing the designated custodian from any
14 further obligation to comply with instructions originated by the secured
15 party and instructing the custodian to comply with instructions originated
16 by the debtor; and

17 (c) Take appropriate action to enable the debtor or its designated
18 custodian to make copies of or revisions to the authoritative copy which
19 add or change an identified assignee of the authoritative copy without the
20 consent of the secured party;

21 4. A secured party having control of investment property under
22 paragraph (b) of subsection 4 of NRS 104.8106 or under subsection 2 of
23 section 7 of this act shall send to the securities intermediary or
24 commodity intermediary with which the security entitlement or
25 commodity contract is maintained an authenticated record that releases
26 the securities intermediary or commodity intermediary from any further
27 obligation to comply with entitlement orders or directions originated by
28 the secured party; and

29 5. A secured party having control of a letter-of-credit right under
30 section 8 of this act shall send to each person having an unfulfilled
31 obligation to pay or deliver proceeds of the letter of credit to the secured
32 party an authenticated release from any further obligation to pay or
33 deliver proceeds of the letter of credit to the secured party.

34 **Sec. 20. 1.** Except as otherwise provided in subsection 3, this
35 section applies if:

36 (a) There is no outstanding secured obligation; and

37 (b) The secured party is not committed to make advances, incur
38 obligations, or otherwise give value.

39 2. Within 10 days after receiving an authenticated demand by the
40 debtor, a secured party shall send to an account debtor that has received
41 notification of an assignment to the secured party as assignee under
42 subsection 1 of section 69 of this act an authenticated record that

1 releases the account debtor from any further obligation to the secured
2 party.

3 3. This section does not apply to an assignment constituting the sale
4 of an account, chattel paper, or payment intangible.

5 **Sec. 21. 1. In this section:**

6 (a) “Request” means a record of a type described in paragraph (b),
7 (c), or (d).

8 (b) “Request for an accounting” means a record authenticated by a
9 debtor requesting that the recipient provide an accounting of the unpaid
10 obligations secured by collateral and reasonably identifying the
11 transaction or relationship that is the subject of the request.

12 (c) “Request regarding a list of collateral” means a record
13 authenticated by a debtor requesting that the recipient approve or correct
14 a list of what the debtor believes to be the collateral securing an
15 obligation and reasonably identifying the transaction or relationship that
16 is the subject of the request.

17 (d) “Request regarding a statement of account” means a record
18 authenticated by a debtor requesting that the recipient approve or correct
19 a statement indicating what the debtor believes to be the aggregate
20 amount of unpaid obligations secured by collateral as of a specified date
21 and reasonably identifying the transaction or relationship that is the
22 subject of the request.

23 2. Subject to subsections 3, 4, 5 and 6, a secured party, other than a
24 buyer of accounts, chattel paper, payment intangibles, or promissory
25 notes or a consignor, shall comply with a request within 14 days after
26 receipt:

27 (a) In the case of a request for an accounting, by authenticating and
28 sending to the debtor an accounting; and

29 (b) In the case of a request regarding a list of collateral or a request
30 regarding a statement of account, by authenticating and sending to the
31 debtor an approval or correction.

32 3. A secured party that claims a security interest in all of a particular
33 type of collateral owned by the debtor may comply with a request
34 regarding a list of collateral by sending to the debtor an authenticated
35 record including a statement to that effect within 14 days after receipt.

36 4. A person that receives a request regarding a list of collateral,
37 claims no interest in the collateral when it receives the request, and
38 claimed an interest in the collateral at an earlier time shall comply with
39 the request within 14 days after receipt by sending to the debtor an
40 authenticated record:

41 (a) Disclaiming any interest in the collateral; and

1 ***(b) If known to the recipient, providing the name and mailing address***
2 ***of any assignee of or successor to the recipient's security interest in the***
3 ***collateral.***

4 ***5. A person that receives a request for an accounting or a request***
5 ***regarding a statement of account, claims no interest in the obligations***
6 ***when it receives the request, and claimed an interest in the obligations at***
7 ***an earlier time shall comply with the request within 14 days after receipt***
8 ***by sending to the debtor an authenticated record:***

9 ***(a) Disclaiming any interest in the obligations; and***

10 ***(b) If known to the recipient, providing the name and mailing address***
11 ***of any assignee of or successor to the recipient's interest in the***
12 ***obligations.***

13 ***6. A debtor is entitled without charge to one response to a request***
14 ***under this section during any 6-month period. The secured party may***
15 ***require payment of a charge not exceeding \$25 for each additional***
16 ***response.***

17
18 ***Sec. 22. Except as otherwise provided in sections 24 to 27, inclusive,***
19 ***of this act, the following rules determine the law governing perfection,***
20 ***the effect of perfection or nonperfection, and the priority of a security***
21 ***interest in collateral:***

22 ***1. Except as otherwise provided in this section, while a debtor is***
23 ***located in a jurisdiction, the law of that jurisdiction governs perfection,***
24 ***the effect of perfection or nonperfection, and the priority of a security***
25 ***interest in collateral.***

26 ***2. While collateral is located in a jurisdiction, the law of that***
27 ***jurisdiction governs perfection, the effect of perfection or nonperfection,***
28 ***and the priority of a possessory security interest in that collateral.***

29 ***3. Except as otherwise provided in subsections 4, 5 and 6, while***
30 ***negotiable documents, goods, instruments, money, or tangible chattel***
31 ***paper is located in a jurisdiction, the law of that jurisdiction governs the***
32 ***effect of perfection or nonperfection and the priority of a nonpossessory***
33 ***security interest.***

34 ***4. While goods are located in a jurisdiction, the law of that***
35 ***jurisdiction governs perfection of a security interest in the goods by a***
36 ***fixture filing.***

37 ***5. The law of the jurisdiction in which timber to be cut is located***
38 ***governs perfection of a security interest in the timber.***

39 ***6. The law of the jurisdiction in which the wellhead or minehead is***
40 ***located governs perfection, the effect of perfection or nonperfection, and***
41 ***the priority of a security interest in as-extracted collateral.***

42 ***Sec. 23. While farm products are located in a jurisdiction, the law of***
43 ***that jurisdiction governs perfection, the effect of perfection or***

1 *nonperfection, and the priority of an agricultural lien on the farm*
2 *products.*

3 **Sec. 24. 1.** *This section applies to goods covered by a certificate of*
4 *title, even if there is no other relationship between the jurisdiction under*
5 *whose certificate of title the goods are covered and the goods or the*
6 *debtor.*

7 **2.** *Goods become covered by a certificate of title when a valid*
8 *application for the certificate of title and the applicable fee are delivered*
9 *to the appropriate authority. Goods cease to be covered by a certificate of*
10 *title at the earlier of the time the certificate of title ceases to be effective*
11 *under the law of the issuing jurisdiction or the time the goods become*
12 *covered subsequently by a certificate of title issued by another*
13 *jurisdiction.*

14 **3.** *The law of the jurisdiction under whose certificate of title the*
15 *goods are covered governs perfection, the effect of perfection or*
16 *nonperfection, and the priority of a security interest in goods covered by*
17 *a certificate of title from the time the goods become covered by the*
18 *certificate of title until the goods cease to be covered by the certificate of*
19 *title.*

20 **Sec. 25. 1.** *The law of a bank's jurisdiction governs perfection, the*
21 *effect of perfection or nonperfection, and the priority of a security*
22 *interest in a deposit account maintained with that bank.*

23 **2.** *The following rules determine a bank's jurisdiction for purposes*
24 *of this part:*

25 *(a) If an agreement between the bank and the debtor governing the*
26 *deposit account expressly provides that a particular jurisdiction is the*
27 *bank's jurisdiction for purposes of this part, this article, or the Uniform*
28 *Commercial Code, that jurisdiction is the bank's jurisdiction.*

29 *(b) If paragraph (a) does not apply and an agreement between the*
30 *bank and its customer governing the deposit account expressly provides*
31 *that the agreement is governed by the law of a particular jurisdiction,*
32 *that jurisdiction is the bank's jurisdiction.*

33 *(c) If neither paragraph (a) nor paragraph (b) applies and an*
34 *agreement between the bank and its customer governing the deposit*
35 *account expressly provides that the deposit account is maintained at an*
36 *office in a particular jurisdiction, that jurisdiction is the bank's*
37 *jurisdiction.*

38 *(d) If neither paragraph (a) nor paragraph (b) nor paragraph (c)*
39 *applies, the bank's jurisdiction is the jurisdiction in which the office*
40 *identified in an account statement as the office serving the customer's*
41 *account is located.*

1 (e) *If none of the preceding paragraphs applies, the bank's*
2 *jurisdiction is the jurisdiction in which the chief executive office of the*
3 *bank is located.*

4 **Sec. 26. 1.** *Except as otherwise provided in subsection 3, the*
5 *following rules apply:*

6 (a) *While a security certificate is located in a jurisdiction, the law of*
7 *that jurisdiction governs perfection, the effect of perfection or*
8 *nonperfection, and the priority of a security interest in the certificated*
9 *security represented thereby.*

10 (b) *The law of the issuer's jurisdiction as specified in subsection 4 of*
11 *NRS 104.8110 governs perfection, the effect of perfection or*
12 *nonperfection, and the priority of a security interest in an uncertificated*
13 *security.*

14 (c) *The law of the securities intermediary's jurisdiction as specified in*
15 *subsection 5 of NRS 104.8110 governs perfection, the effect of perfection*
16 *or nonperfection, and the priority of a security interest in a security*
17 *entitlement or securities account.*

18 (d) *The law of the commodity intermediary's jurisdiction governs*
19 *perfection, the effect of perfection or nonperfection, and the priority of a*
20 *security interest in a commodity contract or commodity account.*

21 **2.** *The following rules determine a commodity intermediary's*
22 *jurisdiction for purposes of this part:*

23 (a) *If an agreement between the commodity intermediary and*
24 *commodity customer governing the commodity account expressly*
25 *provides that a particular jurisdiction is the commodity intermediary's*
26 *jurisdiction for purposes of this part, this article, or the Uniform*
27 *Commercial Code, that jurisdiction is the commodity intermediary's*
28 *jurisdiction.*

29 (b) *If paragraph (a) does not apply and an agreement between the*
30 *commodity intermediary and commodity customer governing the*
31 *commodity account expressly provides that the agreement is governed by*
32 *the law of a particular jurisdiction, that jurisdiction is the commodity*
33 *intermediary's jurisdiction.*

34 (c) *If neither paragraph (a) nor paragraph (b) applies and an*
35 *agreement between the commodity intermediary and commodity*
36 *customer governing the commodity account expressly provides that the*
37 *commodity account is maintained at an office in a particular jurisdiction,*
38 *that jurisdiction is the commodity intermediary's jurisdiction.*

39 (d) *If neither paragraph (a) nor paragraph (b) nor paragraph (c)*
40 *applies, the commodity intermediary's jurisdiction is the jurisdiction in*
41 *which the office identified in an account statement as the office serving*
42 *the commodity customer's account is located.*

1 (e) If none of the preceding paragraphs applies, the commodity
2 intermediary's jurisdiction is the jurisdiction in which the chief executive
3 office of the commodity intermediary is located.

4 3. The law of the jurisdiction in which the debtor is located governs:

5 (a) Perfection of a security interest in investment property by filing;

6 (b) Automatic perfection of a security interest in investment property
7 granted by a broker or securities intermediary; and

8 (c) Automatic perfection of a security interest in a commodity contract
9 or commodity account granted by a commodity intermediary.

10 **Sec. 27. 1.** Subject to subsection 3, the law of the issuer's
11 jurisdiction or a nominated person's jurisdiction governs perfection, the
12 effect of perfection or nonperfection, and the priority of a security
13 interest in a letter-of-credit right if the issuer's jurisdiction or nominated
14 person's jurisdiction is a state.

15 2. For purposes of this part, an issuer's jurisdiction or nominated
16 person's jurisdiction is the jurisdiction whose law governs the liability of
17 the issuer or nominated person with respect to the letter-of-credit right as
18 provided in NRS 104.5116.

19 3. This section does not apply to a security interest that is perfected
20 only under subsection 4 of section 29 of this act.

21 **Sec. 28. 1.** In this section, "place of business" means a place
22 where a debtor conducts its affairs.

23 2. Except as otherwise provided in this section, the following rules
24 determine a debtor's location:

25 (a) A natural person is located at his residence.

26 (b) Any other debtor having only one place of business is located at its
27 place of business.

28 (c) Any other debtor having more than one place of business is located
29 at its chief executive office.

30 3. Subsection 2 applies only if a debtor's residence, place of business,
31 or chief executive office, as applicable, is located in a jurisdiction whose
32 law requires information concerning the existence of a nonpossessory
33 security interest to be made generally available in a filing, recording, or
34 registration system as a condition or result of the security interest's
35 obtaining priority over the rights of a lien creditor with respect to the
36 collateral. If subsection 2 does not apply, the debtor is deemed to be
37 located in the District of Columbia.

38 4. A person that ceases to exist, have a residence, or have a place of
39 business continues to be located in the jurisdiction specified by
40 subsections 2 and 3.

41 5. A registered organization that is organized under the law of a state
42 is located in that state.

1 6. Except as otherwise provided in subsection 9, a registered
2 organization that is organized under the law of the United States and a
3 branch or agency of a bank that is not organized under the law of the
4 United States or a state are located or deemed to be located:

5 (a) In the state that the law of the United States designates, if the law
6 designates a state of location;

7 (b) In the state that the registered organization, branch, or agency
8 designates, if the law of the United States authorizes the registered
9 organization, branch, or agency to designate its state of location; or

10 (c) In the District of Columbia, if neither paragraph (a) nor
11 paragraph (b) applies.

12 7. A registered organization continues to be located in the
13 jurisdiction specified by subsection 5 or 6 notwithstanding:

14 (a) The suspension, revocation, forfeiture, or lapse of the registered
15 organization's status as such in its jurisdiction of organization; or

16 (b) The dissolution, winding up, or cancellation of the existence of the
17 registered organization.

18 8. The United States is deemed to be located in the District of
19 Columbia.

20 9. A branch or agency of a bank that is not organized under the law
21 of the United States or a state is located in the state in which the branch
22 or agency is licensed, if all branches and agencies of the bank are
23 licensed in only one state.

24 10. A foreign air carrier under the Federal Aviation Act of 1958, as
25 amended, is located at the designated office of the agent upon which
26 service of process may be made on behalf of the carrier.

27 11. This section applies only for purposes of this part.

28 **Sec. 29.** 1. Except as otherwise provided in this section and section
29 30 of this act, a security interest is perfected if it has attached and all of
30 the applicable requirements for perfection in sections 31 to 37, inclusive,
31 of this act have been satisfied. A security interest is perfected when it
32 attaches if the applicable requirements are satisfied before the security
33 interest attaches.

34 2. An agricultural lien is perfected if it has become effective and all
35 of the applicable requirements for perfection in section 31 of this act
36 have been satisfied. An agricultural lien is perfected when it becomes
37 effective if the applicable requirements are satisfied before the
38 agricultural lien becomes effective.

39 3. A security interest or agricultural lien is perfected continuously if
40 it is originally perfected in one manner under this article and is later
41 perfected in another manner under this article, without an intermediate
42 period when it was unperfected.

1 4. *Perfection of a security interest in collateral also perfects a*
2 *security interest in a supporting obligation for the collateral.*

3 5. *Perfection of a security interest in a right to payment or*
4 *performance also perfects a security interest in a security interest,*
5 *mortgage, or other lien on personal or real property securing the right.*

6 6. *Perfection of a security interest in a securities account also*
7 *perfects a security interest in the security entitlements carried in the*
8 *securities account.*

9 7. *Perfection of a security interest in a commodity account also*
10 *perfects a security interest in the commodity contracts carried in the*
11 *commodity account.*

12 **Sec. 30.** *The following security interests are perfected when they*
13 *attach:*

14 1. *A purchase-money security interest in consumer goods, except as*
15 *otherwise provided in subsection 2 of section 32 of this act with respect to*
16 *consumer goods that are subject to a statute or treaty described in*
17 *subsection 1 of that section;*

18 2. *An assignment of accounts or payment intangibles which does not*
19 *by itself or in conjunction with other assignments to the same assignee*
20 *transfer a significant part of the assignor's outstanding accounts or*
21 *payment intangibles;*

22 3. *A sale of a payment intangible;*

23 4. *A sale of a promissory note;*

24 5. *A security interest created by the assignment of a health-care-*
25 *insurance receivable to the provider of the health-care goods or services;*

26 6. *A security interest arising under NRS 104.2401, 104.2505,*
27 *subsection 3 of NRS 104.2711, or subsection 5 of NRS 104A.2508, until*
28 *the debtor obtains possession of the collateral;*

29 7. *A security interest of a collecting bank arising under NRS*
30 *104.4210;*

31 8. *A security interest of an issuer or nominated person arising under*
32 *NRS 104.5118;*

33 9. *A security interest arising in the purchase or delivery of a*
34 *financial asset under section 17 of this act;*

35 10. *A security interest in investment property created by a broker or*
36 *securities intermediary;*

37 11. *A security interest in a commodity contract or a commodity*
38 *account created by a commodity intermediary;*

39 12. *An assignment for the benefit of all creditors of the transferor*
40 *and subsequent transfers by the assignee thereunder; and*

41 13. *A security interest created by an assignment of a beneficial*
42 *interest in a decedent's estate.*

1 **Sec. 31. 1.** *Except as otherwise provided in subsection 2 or*
2 *subsection 2 of section 33 of this act, a financing statement must be filed*
3 *to perfect all security interests and agricultural liens.*

4 **2.** *The filing of a financing statement is not necessary to perfect a*
5 *security interest:*

6 *(a) That is perfected under subsection 4, 5, 6 or 7 of section 29 of this*
7 *act;*

8 *(b) That is perfected under section 30 of this act when it attaches;*

9 *(c) In property subject to a statute, regulation, or treaty described in*
10 *subsection 1 of section 32 of this act;*

11 *(d) In goods in possession of a bailee which is perfected under*
12 *paragraph (a) or (b) of subsection 4 of section 33 of this act;*

13 *(e) In certificated securities, documents, goods, or instruments which*
14 *is perfected without filing or possession under subsection 5, 6 or 7 of*
15 *section 33 of this act;*

16 *(f) In collateral in the secured party's possession under section 34 of*
17 *this act;*

18 *(g) In a certificated security which is perfected by delivery of the*
19 *security certificate to the secured party under section 34 of this act;*

20 *(h) In deposit accounts, electronic chattel paper, investment property,*
21 *or letter-of-credit rights which is perfected by control under section 35 of*
22 *this act;*

23 *(i) In proceeds which is perfected under section 36 of this act; or*

24 *(j) That is perfected under section 37 of this act.*

25 **3.** *If a secured party assigns a perfected security interest or*
26 *agricultural lien, a filing under this article is not required to reconfirm*
27 *the perfected status of the security interest against creditors of and*
28 *transferees from the original debtor.*

29 **Sec. 32. 1.** *Except as otherwise provided in subsection 4, the filing*
30 *of a financing statement is not necessary or effective to perfect a security*
31 *interest in property subject to:*

32 *(a) A statute, regulation, or treaty of the United States whose*
33 *requirements for a security interest's obtaining priority over the rights of*
34 *a lien creditor with respect to the property preempt subsection 1 of*
35 *section 31 of this act;*

36 *(b) Chapter 105 of NRS, NRS 482.423 to 482.431, inclusive, 488.1793*
37 *to 488. 1827, inclusive, and 489.501 to 489.581, inclusive; or*

38 *(c) A certificate-of-title statute of another jurisdiction which provides*
39 *for a security interest to be indicated on the certificate as a condition or*
40 *result of the security interest's obtaining priority over the rights of a lien*
41 *creditor with respect to the property.*

42 **2.** *Compliance with the requirements of a statute, regulation, or*
43 *treaty described in subsection 1 for obtaining priority over the rights of a*

1 *lien creditor is equivalent to the filing of a financing statement under this*
2 *article. Except as otherwise provided in subsection 4, section 34 of this*
3 *act and subsections 4 and 5 of section 37 of this act for goods covered by*
4 *a certificate of title, a security interest in property subject to a statute,*
5 *regulation, or treaty described in subsection 1 may be perfected only by*
6 *compliance with those requirements, and a security interest so perfected*
7 *remains perfected notwithstanding a change in the use or transfer of*
8 *possession of the collateral.*

9 3. *Except as otherwise provided in subsection 4 and subsections 4*
10 *and 5 of section 37 of this act, duration and renewal of perfection of a*
11 *security interest perfected by compliance with the requirements*
12 *prescribed by a statute, regulation, or treaty described in subsection 1 are*
13 *governed by the statute, regulation, or treaty. In other respects, the*
14 *security interest is subject to this article.*

15 4. *During any period in which collateral is inventory held for sale or*
16 *lease by a person or leased by that person as lessor and that person is in*
17 *the business of selling or leasing goods of that kind, this section does not*
18 *apply to a security interest in that collateral created by that person as*
19 *debtor.*

20 **Sec. 33. 1.** *A security interest in chattel paper, negotiable*
21 *documents, instruments, or investment property may be perfected by*
22 *filing.*

23 2. *Except as otherwise provided in subsections 3 and 4 of section 36*
24 *of this act for proceeds:*

25 (a) *A security interest in a deposit account may be perfected only by*
26 *control under section 35 of this act;*

27 (b) *A security interest in a letter-of-credit right may be perfected only*
28 *by control under section 35 of this act, except as otherwise provided in*
29 *subsection 4 of section 29 of this act; and*

30 (c) *A security interest in money may be perfected only by the secured*
31 *party's taking possession under section 34 of this act.*

32 3. *While goods are in the possession of a bailee that has issued a*
33 *negotiable document covering the goods:*

34 (a) *A security interest in the goods may be perfected by perfecting a*
35 *security interest in the document; and*

36 (b) *A security interest perfected in the document has priority over any*
37 *security interest that becomes perfected in the goods by another method*
38 *during that time.*

39 4. *While goods are in the possession of a bailee that has issued a*
40 *nonnegotiable document covering the goods, a security interest in the*
41 *goods may be perfected by:*

42 (a) *Issuance of a document in the name of the secured party;*

1 **(b) The bailee’s receipt of notification of the secured party’s interest;**
2 **or**

3 **(c) Filing as to the goods.**

4 **5. A security interest in certificated securities, negotiable documents,**
5 **or instruments is perfected without filing or the taking of possession for a**
6 **period of 20 days after the time it attaches to the extent that it arises for**
7 **new value given under an authenticated security agreement.**

8 **6. A perfected security interest in a negotiable document or goods in**
9 **possession of a bailee, other than one that has issued a negotiable**
10 **document for the goods, remains perfected for 20 days without filing if**
11 **the secured party makes available to the debtor the goods or documents**
12 **representing the goods for the purpose of:**

13 **(a) Ultimate sale or exchange; or**

14 **(b) Loading, unloading, storing, shipping, transshipping,**
15 **manufacturing, processing, or otherwise dealing with them in a manner**
16 **preliminary to their sale or exchange.**

17 **7. A perfected security interest in a certificated security or instrument**
18 **remains perfected for 20 days without filing if the secured party delivers**
19 **the security certificate or instrument to the debtor for the purpose of:**

20 **(a) Ultimate sale or exchange; or**

21 **(b) Presentation, collection, enforcement, renewal, or registration of**
22 **transfer.**

23 **8. After the 20-day period specified in subsection 5, 6 or 7 expires,**
24 **perfection depends upon compliance with this article.**

25 **Sec. 34. 1. Except as otherwise provided in subsection 2, a secured**
26 **party may perfect a security interest in negotiable documents, goods,**
27 **instruments, money, or tangible chattel paper by taking possession of the**
28 **collateral. A secured party may perfect a security interest in certificated**
29 **securities by taking delivery of the certificated securities under NRS**
30 **104.8301.**

31 **2. With respect to goods covered by a certificate of title issued by this**
32 **state, a secured party may perfect a security interest in the goods by**
33 **taking possession of the goods only in the circumstances described in**
34 **subsection 5 of section 37 of this act.**

35 **3. With respect to collateral other than certificated securities and**
36 **goods covered by a document, a secured party takes possession of**
37 **collateral in the possession of a person other than the debtor, the secured**
38 **party, or a lessee of the collateral from the debtor in the ordinary course**
39 **of the debtor’s business, when:**

40 **(a) The person in possession authenticates a record acknowledging**
41 **that it holds possession of the collateral for the secured party’s benefit; or**

1 **(b) The person takes possession of the collateral after having**
2 **authenticated a record acknowledging that it will hold possession of**
3 **collateral for the secured party's benefit.**

4 **4. If perfection of a security interest depends upon possession of the**
5 **collateral by a secured party, perfection occurs no earlier than the time**
6 **the secured party takes possession and continues only while he retains**
7 **possession.**

8 **5. A security interest in a certificated security in registered form is**
9 **perfected by delivery when delivery of the certificated security occurs**
10 **under NRS 104.8301 and remains perfected by delivery until the debtor**
11 **obtains possession of the security certificate.**

12 **6. A person in possession of collateral is not required to acknowledge**
13 **that it holds possession for a secured party's benefit.**

14 **7. If a person acknowledges that it holds possession for the secured**
15 **party's benefit:**

16 **(a) The acknowledgment is effective under subsection 3 or subsection**
17 **1 of NRS 104.8301, even if the acknowledgment violates the rights of a**
18 **debtor; and**

19 **(b) Unless the person otherwise agrees or law other than this article**
20 **otherwise provides, he does not owe any duty to the secured party and is**
21 **not required to confirm the acknowledgment to another person.**

22 **8. A secured party having possession of collateral does not relinquish**
23 **possession by delivering the collateral to a person other than the debtor**
24 **or a lessee of the collateral from the debtor in the ordinary course of the**
25 **debtor's business if he was instructed before the delivery or is instructed**
26 **contemporaneously with the delivery:**

27 **(a) To hold possession of the collateral for the secured party's benefit;**
28 **or**

29 **(b) To redeliver the collateral to the secured party.**

30 **9. A secured party does not relinquish possession, even if a delivery**
31 **under subsection 8 violates the rights of a debtor. A person to which**
32 **collateral is delivered under subsection 8 does not owe any duty to the**
33 **secured party and is not required to confirm the delivery to another**
34 **person unless he otherwise agrees or law other than this article otherwise**
35 **provides.**

36 **Sec. 35. 1. A security interest in investment property, deposit**
37 **accounts, letter-of-credit rights, or electronic chattel paper may be**
38 **perfected by control of the collateral under section 5, 6, 7 or 8 of this act.**

39 **2. A security interest in deposit accounts, electronic chattel paper, or**
40 **letter-of-credit rights is perfected by control under section 5, 6, 7 or 8 of**
41 **this act when the secured party obtains control and remains perfected by**
42 **control only while the secured party retains control.**

1 3. A security interest in investment property is perfected by control
2 under section 7 of this act from the time the secured party obtains control
3 and remains perfected by control until:

4 (a) The secured party does not have control; and

5 (b) One of the following occurs:

6 (1) If the collateral is a certificated security, the debtor has or
7 acquires possession of the security certificate;

8 (2) If the collateral is an uncertificated security, the issuer has
9 registered or registers the debtor as the registered owner; or

10 (3) If the collateral is a security entitlement, the debtor is or
11 becomes the entitlement holder.

12 **Sec. 36. 1.** Except as otherwise provided in this article and in
13 subsection 2 of NRS 104.2403:

14 (a) A security interest or agricultural lien continues in collateral
15 notwithstanding sale, lease, license, exchange, or other disposition
16 thereof unless the secured party authorized the disposition free of the
17 security interest or agricultural lien; and

18 (b) A security interest attaches to any identifiable proceeds of
19 collateral.

20 2. Proceeds that are commingled with other property are identifiable
21 proceeds:

22 (a) If the proceeds are goods, to the extent provided by section 57 of
23 this act; and

24 (b) If the proceeds are not goods, to the extent that the secured party
25 identifies the proceeds by a method of tracing, including application of
26 equitable principles, that is permitted under law other than this article
27 with respect to commingled property of the type involved.

28 3. A security interest in proceeds is a perfected security interest if the
29 security interest in the original collateral was perfected.

30 4. A perfected security interest in proceeds becomes unperfected on
31 the 21st day after the security interest attaches to the proceeds unless:

32 (a) The following conditions are satisfied:

33 (1) A filed financing statement covers the original collateral;

34 (2) The proceeds are collateral in which a security interest may be
35 perfected by filing in the office in which the financing statement has
36 been filed; and

37 (3) The proceeds are not acquired with cash proceeds;

38 (b) The proceeds are identifiable cash proceeds; or

39 (c) The security interest in the proceeds is perfected when the security
40 interest attaches to the proceeds or within 20 days thereafter.

41 5. If a filed financing statement covers the original collateral, a
42 security interest in proceeds which remains perfected under paragraph

43 (a) of subsection 4 becomes unperfected at the later of:

1 (a) *When the effectiveness of the filed financing statement lapses*
2 *under section 87 of this act or is terminated under section 85 of this act;*
3 *or*

4 (b) *The 21st day after the security interest attaches to the proceeds.*

5 **Sec. 37. 1.** *A security interest perfected pursuant to the law of the*
6 *jurisdiction designated in subsection 1 of section 22 of this act or*
7 *subsection 3 of section 26 of this act remains perfected until the earliest*
8 *of:*

9 (a) *The time perfection would have ceased under the law of that*
10 *jurisdiction;*

11 (b) *The expiration of 4 months after a change of the debtor's location*
12 *to another jurisdiction; or*

13 (c) *The expiration of 1 year after a transfer of collateral to a person*
14 *that thereby becomes a debtor and is located in another jurisdiction.*

15 **2.** *If a security interest described in subsection 1 becomes perfected*
16 *under the law of the other jurisdiction before the earliest time or event*
17 *described in that subsection, it remains perfected thereafter. If the*
18 *security interest does not become perfected under the law of the other*
19 *jurisdiction before the earliest time or event, it becomes unperfected and*
20 *is deemed never to have been perfected as against a purchaser of the*
21 *collateral for value.*

22 **3.** *A possessory security interest in collateral, other than goods*
23 *covered by a certificate of title and as-extracted collateral consisting of*
24 *goods, remains continuously perfected if:*

25 (a) *The collateral is located in one jurisdiction and subject to a*
26 *security interest perfected under the law of that jurisdiction;*

27 (b) *Thereafter the collateral is brought into another jurisdiction; and*

28 (c) *Upon entry into the other jurisdiction, the security interest is*
29 *perfected under the law of the other jurisdiction.*

30 **4.** *Except as otherwise provided in subsection 5, a security interest in*
31 *goods covered by a certificate of title which is perfected by any method*
32 *under the law of another jurisdiction when the goods become covered by*
33 *a certificate of title from this state remains perfected until the security*
34 *interest would have become unperfected under the law of the other*
35 *jurisdiction had the goods not become so covered.*

36 **5.** *A security interest described in subsection 4 becomes unperfected*
37 *as against a purchaser of the goods for value and is deemed never to*
38 *have been perfected as against a purchaser of the goods for value if the*
39 *applicable requirements for perfection under subsection 2 of section 32*
40 *of this act or under section 34 of this act are not satisfied before the*
41 *earlier of:*

1 (a) *The time the security interest would have become unperfected*
2 *under the law of the other jurisdiction had the goods not become covered*
3 *by a certificate of title from this state; or*

4 (b) *The expiration of 4 months after the goods had become so*
5 *covered.*

6 6. *A security interest in deposit accounts, letter-of-credit rights, or*
7 *investment property which is perfected under the law of the bank's*
8 *jurisdiction, the issuer's jurisdiction, a nominated person's jurisdiction,*
9 *the securities intermediary's jurisdiction, or the commodity*
10 *intermediary's jurisdiction, as applicable, remains perfected until the*
11 *earlier of:*

12 (a) *The time the security interest would have become unperfected*
13 *under the law of that jurisdiction; or*

14 (b) *The expiration of 4 months after a change of the applicable*
15 *jurisdiction to another jurisdiction.*

16 7. *If a security interest described in subsection 6 becomes perfected*
17 *under the law of the other jurisdiction before the earlier of the time or*
18 *the end of the period described in that subsection, it remains perfected*
19 *thereafter. If the security interest does not become perfected under the*
20 *law of the other jurisdiction before the earlier of that time or the end of*
21 *that period, it becomes unperfected and is deemed never to have been*
22 *perfected as against a purchaser of the collateral for value.*

23 **Sec. 38. 1.** *An unperfected security interest or agricultural lien is*
24 *subordinate to the rights of:*

25 (a) *A person entitled to priority under section 43 of this act; and*

26 (b) *A person that becomes a lien creditor before the earlier of the time*
27 *the security interest or agricultural lien is perfected or a financing*
28 *statement covering the collateral is filed.*

29 2. *Except as otherwise provided in subsection 5, a buyer, other than a*
30 *secured party, of chattel paper, documents, goods, instruments, or a*
31 *security certificate takes free of a security interest or agricultural lien if*
32 *the buyer gives value and receives delivery of the collateral without*
33 *knowledge of the security interest or agricultural lien and before it is*
34 *perfected.*

35 3. *Except as otherwise provided in subsection 5, a lessee of goods*
36 *takes free of a security interest or agricultural lien if he gives value and*
37 *receives delivery of the collateral without knowledge of the security*
38 *interest or agricultural lien and before it is perfected.*

39 4. *A licensee of a general intangible or a buyer, other than a secured*
40 *party, of accounts, general intangibles, or investment property other than*
41 *a certificated security takes free of a security interest if he gives value*
42 *without knowledge of the security interest and before it is perfected.*

1 5. Except as otherwise provided in sections 41 and 42 of this act, if a
2 person files a financing statement with respect to a purchase-money
3 security interest before or within 20 days after the debtor receives delivery
4 of the collateral, the security interest takes priority over the rights of a
5 buyer, lessee, or lien creditor which arise between the time the security
6 interest attaches and the time of filing.

7 **Sec. 39.** For purposes of determining the rights of creditors of, and
8 purchasers for value of an account or chattel paper from, a debtor that
9 has sold an account or chattel paper, while the buyer's security interest is
10 unperfected, the debtor has rights and title to the account or chattel
11 paper identical to those the debtor sold.

12 **Sec. 40. 1.** Except as otherwise provided in subsection 2, for
13 purposes of determining the rights of creditors of, and purchasers for
14 value of goods from, a consignee, while the goods are in the possession
15 of the consignee, the consignee is deemed to have rights and title to the
16 goods identical to those the consignor had or had power to transfer.

17 2. For purposes of determining the rights of a creditor of a
18 consignee, law other than this article determines the rights and title of a
19 consignee while goods are in the consignee's possession if, under this
20 part, a perfected security interest held by the consignor would have
21 priority over the rights of the creditor.

22 **Sec. 41. 1.** Except as otherwise provided in subsection 5, a buyer in
23 the ordinary course of business, other than a person buying farm
24 products from a person engaged in farming operations, takes free of a
25 security interest created by the buyer's seller, even if the security interest
26 is perfected and the buyer knows of its existence.

27 2. Except as otherwise provided in subsection 5, a buyer of goods
28 from a person who used or bought the goods for use primarily for
29 personal, family, or household purposes takes free of a security interest,
30 even if perfected, if he buys:

31 (a) Without knowledge of the security interest;

32 (b) For value;

33 (c) Primarily for his personal, family, or household purposes; and

34 (d) Before the filing of a financing statement covering the goods.

35 3. To the extent that it affects the priority of a security interest over a
36 buyer of goods under subsection 2, the period of effectiveness of a filing
37 made in the jurisdiction in which the seller is located is governed by
38 subsections 1 and 2 of section 37 of this act.

39 4. A buyer in the ordinary course of business buying oil, gas, or
40 other minerals at the wellhead or minehead or after extraction takes free
41 of an interest arising out of an encumbrance.

42 5. Subsections 1 and 2 do not affect a security interest in goods in the
43 possession of the secured party under section 34 of this act.

1 **Sec. 42. 1.** *In this section, “licensee in ordinary course of*
2 *business” means a person that becomes a licensee of a general intangible*
3 *in good faith, without knowledge that the license violates the rights of*
4 *another person in the general intangible, and in the ordinary course*
5 *from a person in the business of licensing general intangibles of that*
6 *kind. A person becomes a licensee in the ordinary course if the license to*
7 *him comports with the usual or customary practices in the kind of*
8 *business in which the licensor is engaged or with the licensor’s own*
9 *usual or customary practices.*

10 **2.** *A licensee in the ordinary course of business takes his rights under*
11 *a nonexclusive license free of a security interest in the general intangible*
12 *created by the licensor, even if the security interest is perfected and he*
13 *knows of its existence.*

14 **3.** *A lessee in the ordinary course of business takes his leasehold*
15 *interest free of a security interest in the goods created by the lessor, even*
16 *if the security interest is perfected and he knows of its existence.*

17 **Sec. 43. 1.** *Except as otherwise provided in this section, priority*
18 *among conflicting security interests and agricultural liens in the same*
19 *collateral is determined according to the following rules:*

20 **(a)** *Conflicting perfected security interests and agricultural liens rank*
21 *according to priority in time of filing or perfection. Priority dates from*
22 *the earlier of the time a filing covering the collateral is first made or the*
23 *security interest or agricultural lien is first perfected, if there is no period*
24 *thereafter when there is neither filing nor perfection.*

25 **(b)** *A perfected security interest or agricultural lien has priority over a*
26 *conflicting unperfected security interest or agricultural lien.*

27 **(c)** *The first security interest or agricultural lien to attach or become*
28 *effective has priority if conflicting security interests and agricultural*
29 *liens are unperfected.*

30 **2.** *For the purposes of paragraph (a) of subsection 1:*

31 **(a)** *The time of filing or perfection as to a security interest in*
32 *collateral is also the time of filing or perfection as to a security interest in*
33 *proceeds; and*

34 **(b)** *The time of filing or perfection as to a security interest in*
35 *collateral supported by a supporting obligation is also the time of filing*
36 *or perfection as to a security interest in the supporting obligation.*

37 **3.** *Except as otherwise provided in subsection 6, a security interest in*
38 *collateral which qualifies for priority over a conflicting security interest*
39 *under section 48, 49, 50, 51 or 52 of this act also has priority over a*
40 *conflicting security interest in:*

41 **(a)** *Any supporting obligation for the collateral; and*

42 **(b)** *Proceeds of the collateral if:*

43 **(1)** *The security interest in proceeds is perfected;*

1 (2) The proceeds are cash proceeds or of the same type as the
2 collateral; and

3 (3) In the case of proceeds that are proceeds of proceeds, all
4 intervening proceeds are cash proceeds, proceeds of the same type as the
5 collateral, or an account relating to the collateral.

6 4. Subject to subsection 5 and except as otherwise provided in
7 subsection 6, if a security interest in chattel paper, deposit accounts,
8 negotiable documents, instruments, investment property, or letter-of-
9 credit rights is perfected by a method other than filing, conflicting
10 perfected security interests in proceeds of the collateral rank according to
11 priority in time of filing.

12 5. Subsection 4 applies only if the proceeds of the collateral are not
13 cash proceeds, chattel paper, negotiable documents, instruments,
14 investment property, or letter-of-credit rights.

15 6. Subsections 1 to 5, inclusive, are subject to:

16 (a) Subsection 7 and the other provisions of this part;

17 (b) NRS 104.4210 with respect to a security interest of a collecting
18 bank;

19 (c) NRS 104.5118 with respect to a security interest of an issuer or
20 nominated person; and

21 (d) Section 11 of this act with respect to a security interest arising
22 under Article 2 or 2A.

23 7. A perfected agricultural lien on collateral has priority over a
24 conflicting security interest in or agricultural lien on the same collateral
25 if the statute creating the agricultural lien so provides.

26 **Sec. 44. 1.** Except as otherwise provided in subsection 3, for
27 purposes of determining the priority of a perfected security interest under
28 subsection 1 of section 43 of this act, perfection of the security interest
29 dates from the time an advance is made to the extent that the security
30 interest secures an advance that:

31 (a) Is made while the security interest is perfected only:

32 (1) Under section 30 of this act when it attaches; or

33 (2) Temporarily under subsection 5, 6, or 7 of section 33 of this act;
34 and

35 (b) Is not made pursuant to a commitment entered into before or
36 while the security interest is perfected by a method other than under
37 section 30 of this act or subsection 5, 6 or 7 of section 33 of this act.

38 2. Except as otherwise provided in subsection 3, a security interest is
39 subordinate to the rights of a person that becomes a lien creditor while
40 the security interest is perfected only to the extent that it secures advances
41 made more than 45 days after he becomes a lien creditor unless the
42 advance is made:

43 (a) Without knowledge of the lien; or

1 **(b) Pursuant to a commitment entered into without knowledge of the**
2 **lien.**

3 **3. Subsections 1 and 2 do not apply to a security interest held by a**
4 **secured party that is a buyer of accounts, chattel paper, payment**
5 **intangibles, or promissory notes or a consignor.**

6 **4. Except as otherwise provided in subsection 5, a buyer of goods**
7 **other than a buyer in the ordinary course of business takes free of a**
8 **security interest to the extent that it secures advances made after the**
9 **earlier of:**

10 **(a) The time the secured party acquires knowledge of the buyer's**
11 **purchase; or**

12 **(b) Forty-five days after the purchase.**

13 **5. Subsection 4 does not apply if the advance is made pursuant to a**
14 **commitment entered into without knowledge of the buyer's purchase and**
15 **before the expiration of the 45-day period.**

16 **6. Except as otherwise provided in subsection 7, a lessee of goods,**
17 **other than a lessee in ordinary course of business, takes the leasehold**
18 **free of a security interest to the extent that it secures advances made after**
19 **the earlier of:**

20 **(a) The time the secured party acquires knowledge of the lease; or**

21 **(b) Forty-five days after the lease contract becomes enforceable.**

22 **7. Subsection 6 does not apply if the advance is made pursuant to a**
23 **commitment entered into without knowledge of the lease and before the**
24 **expiration of the 45-day period.**

25 **Sec. 45. 1. Subject to subsection 2 and except as otherwise**
26 **provided in subsection 7, a perfected purchase-money security interest in**
27 **inventory has priority over a conflicting security interest in the same**
28 **inventory, has priority over a conflicting security interest in chattel paper**
29 **or an instrument constituting proceeds of the inventory and in proceeds**
30 **of the chattel paper, if so provided in section 51 of this act, and, except as**
31 **otherwise provided in section 48 of this act, also has priority in**
32 **identifiable cash proceeds of the inventory to the extent the identifiable**
33 **cash proceeds are received on or before the delivery of the inventory to a**
34 **buyer, if:**

35 **(a) The purchase-money security interest is perfected when the debtor**
36 **receives possession of the inventory;**

37 **(b) The purchase-money secured party sends an authenticated**
38 **notification to the holder of the conflicting security interest;**

39 **(c) The holder of the conflicting security interest receives the**
40 **notification within 5 years before the debtor receives possession of the**
41 **inventory; and**

1 (d) *The notification states that the person sending the notification has*
2 *or expects to acquire a purchase-money security interest in inventory of*
3 *the debtor and describes the inventory.*

4 2. *Paragraphs (b), (c) and (d) of subsection 1 apply only if the holder*
5 *of the conflicting security interest had filed a financing statement*
6 *covering the same types of inventory:*

7 (a) *If the purchase-money security interest is perfected by filing,*
8 *before the date of the filing; or*

9 (b) *If the purchase-money security interest is temporarily perfected*
10 *without filing or possession under subsection 6 of section 33 of this act,*
11 *before the beginning of the 20-day period thereunder.*

12 3. *Subject to subsection 5 and except as otherwise provided in*
13 *subsection 7, a perfected purchase-money security interest in livestock*
14 *that are farm products has priority over a conflicting security interest in*
15 *the same livestock, and, except as otherwise provided in section 48 of this*
16 *act, a perfected security interest in their identifiable proceeds and*
17 *identifiable products in their unmanufactured states also has priority, if:*

18 (a) *The purchase-money security interest is perfected when the debtor*
19 *receives possession of the livestock;*

20 (b) *The purchase-money secured party sends an authenticated*
21 *notification to the holder of the conflicting security interest;*

22 (c) *The holder of the conflicting security interest receives the*
23 *notification within 6 months before the debtor receives possession of the*
24 *livestock; and*

25 (d) *The notification states that the person sending the notification has*
26 *or expects to acquire a purchase-money security interest in livestock of*
27 *the debtor and describes the livestock.*

28 4. *Paragraphs (b), (c) and (d) of subsection 3 apply only if the holder*
29 *of the conflicting security interest had filed a financing statement*
30 *covering the same types of livestock:*

31 (a) *If the purchase-money security interest is perfected by filing,*
32 *before the date of the filing; or*

33 (b) *If the purchase-money security interest is temporarily perfected*
34 *without filing or possession under subsection 6 of section 33 of this act,*
35 *before the beginning of the 20-day period thereunder.*

36 5. *Except as otherwise provided in subsection 7, a perfected*
37 *purchase-money security interest in goods other than inventory or*
38 *livestock has priority over a conflicting security interest in the same*
39 *goods, and, except as otherwise provided in section 48 of this act, a*
40 *perfected security interest in its identifiable proceeds also has priority, if*
41 *the purchase-money security interest is perfected when the debtor*
42 *receives possession of the collateral or within 20 days thereafter.*

1 6. Except as otherwise provided in subsection 7, a perfected
2 purchase-money security interest in software has priority over a
3 conflicting security interest in the same collateral, and, except as
4 otherwise provided in section 48 of this act, a perfected security interest
5 in its identifiable proceeds also has priority, to the extent that the
6 purchase-money security interest in the goods in which the software was
7 acquired for use has priority in the goods and proceeds of the goods
8 under this section.

9 7. If more than one security interest qualifies for priority in the same
10 collateral under subsection 1, 3, 5 or 6:

11 (a) A security interest securing an obligation incurred as all or part of
12 the price of the collateral has priority over a security interest securing an
13 obligation incurred for value given to enable the debtor to acquire rights
14 in or the use of collateral; and

15 (b) In all other cases, subsection 1 of section 43 of this act applies to
16 the qualifying security interests.

17 **Sec. 46. 1.** Except as otherwise provided in subsection 2, a security
18 interest created by a debtor is subordinate to a security interest in the
19 same collateral created by another person if:

20 (a) The debtor acquired the collateral subject to the security interest
21 created by the other person;

22 (b) The security interest created by the other person was perfected
23 when the debtor acquired the collateral; and

24 (c) There is no period thereafter when the security interest is
25 unperfected.

26 2. Subsection 1 subordinates a security interest only if the security
27 interest:

28 (a) Otherwise would have priority solely under subsection 1 of section
29 43 of this act or section 45 of this act; or

30 (b) Arose solely under subsection 3 of NRS 104.2711 or subsection 5
31 of NRS 104A.2508.

32 **Sec. 47. 1.** Subject to subsection 2, a security interest created by a
33 new debtor which is perfected by a filed financing statement that is
34 effective solely under section 80 of this act in collateral in which a new
35 debtor has or acquires rights is subordinate to a security interest in the
36 same collateral which is perfected other than by a filed financing
37 statement that is effective solely under that section.

38 2. The other provisions of this part determine the priority among
39 conflicting security interests in the same collateral perfected by filed
40 financing statements that are effective solely under section 80 of this act.
41 However, if the security agreements to which a new debtor became
42 bound as debtor were not entered into by the same original debtor, the

1 *conflicting security interests rank according to priority in time of the new*
2 *debtor's having become bound.*

3 **Sec. 48.** *The following rules govern priority among conflicting*
4 *security interests in the same deposit account:*

5 1. *A security interest held by a secured party having control of the*
6 *deposit account under section 5 of this act has priority over a conflicting*
7 *security interest held by a secured party that does not have control.*

8 2. *Except as otherwise provided in subsections 3 and 4, security*
9 *interests perfected by control under section 35 of this act rank according*
10 *to priority in time of obtaining control.*

11 3. *Except as otherwise provided in subsection 4, a security interest*
12 *held by the bank with which the deposit account is maintained has*
13 *priority over a conflicting security interest held by another secured party.*

14 4. *A security interest perfected by control under paragraph (c) of*
15 *subsection 1 of section 5 of this act has priority over a security interest*
16 *held by the bank with which the deposit account is maintained.*

17 **Sec. 49.** *The following rules govern priority among conflicting*
18 *security interests in the same investment property:*

19 1. *A security interest held by a secured party having control of*
20 *investment property under section 7 of this act has priority over a security*
21 *interest held by a secured party that does not have control of the*
22 *investment property.*

23 2. *A security interest in a certificated security in registered form*
24 *which is perfected by taking delivery under subsection 1 of section 34 of*
25 *this act and not by control under section 35 of this act has priority over a*
26 *conflicting security interest perfected by a method other than control.*

27 3. *Except as otherwise provided in subsections 4 and 5, conflicting*
28 *security interests held by secured parties each of which has control under*
29 *section 7 of this act rank according to priority in time of:*

30 (a) *If the collateral is a security, obtaining control;*

31 (b) *If the collateral is a security entitlement carried in a securities*
32 *account:*

33 (1) *The secured party's becoming the person for which the*
34 *securities account is maintained, if the secured party obtained control*
35 *under paragraph (a) of subsection 4 of NRS 104.8106;*

36 (2) *The securities intermediary's agreement to comply with the*
37 *secured party's entitlement orders with respect to security entitlements*
38 *carried or to be carried in the securities account, if the secured party*
39 *obtained control under paragraph (b) of that subsection; or*

40 (3) *If the secured party obtained control through another person*
41 *under paragraph (c) of that subsection, the time on which priority would*
42 *be based under this paragraph if the other person were the secured party;*
43 *or*

1 (c) *If the collateral is a commodity contract carried with a commodity*
2 *intermediary, the satisfaction of the requirement for control specified in*
3 *paragraph (b) of subsection 2 of section 7 of this act with respect to*
4 *commodity contracts carried or to be carried with the commodity*
5 *intermediary.*

6 4. *A security interest held by a securities intermediary in a security*
7 *entitlement or a securities account maintained with the securities*
8 *intermediary has priority over a conflicting security interest held by*
9 *another secured party.*

10 5. *A security interest held by a commodity intermediary in a*
11 *commodity contract or a commodity account maintained with the*
12 *commodity intermediary has priority over a conflicting security interest*
13 *held by another secured party.*

14 6. *Conflicting security interests granted by a broker, securities*
15 *intermediary, or commodity intermediary which are perfected without*
16 *control under section 7 of this act rank equally.*

17 7. *In all other cases, priority among conflicting security interests in*
18 *investment property is governed by sections 43 and 44 of this act.*

19 **Sec. 50.** *The following rules govern priority among conflicting*
20 *security interests in the same letter-of-credit right:*

21 1. *A security interest held by a secured party having control of the*
22 *letter-of-credit right under section 8 of this act has priority to the extent*
23 *of its control over a conflicting security interest held by a secured party*
24 *that does not have control.*

25 2. *Security interests perfected by control under section 35 of this act*
26 *rank according to priority in time of obtaining control.*

27 **Sec. 51.** 1. *A purchaser of chattel paper has priority over a security*
28 *interest in the chattel paper which is claimed merely as proceeds of*
29 *inventory subject to a security interest if:*

30 (a) *In good faith and in the ordinary course of the purchaser's*
31 *business, the purchaser gives new value and takes possession of the*
32 *chattel paper or obtains control of the chattel paper under section 6 of*
33 *this act; and*

34 (b) *The chattel paper does not indicate that it has been assigned to an*
35 *identified assignee other than the purchaser.*

36 2. *A purchaser of chattel paper has priority over a security interest in*
37 *the chattel paper which is claimed other than merely as proceeds of*
38 *inventory subject to a security interest if the purchaser gives new value*
39 *and takes possession of the chattel paper or obtains control of the chattel*
40 *paper under section 6 of this act in good faith, in the ordinary course of*
41 *the purchaser's business, and without knowledge that the purchase*
42 *violates the rights of the secured party.*

1 3. Except as otherwise provided in section 48 of this act, a purchaser
2 having priority in chattel paper under subsection 1 or 2 also has priority
3 in proceeds of the chattel paper to the extent that:

4 (a) Section 43 of this act provides for priority in the proceeds; or

5 (b) The proceeds consist of the specific goods covered by the chattel
6 paper or cash proceeds of the specific goods, even if the purchaser's
7 security interest in the proceeds is unperfected.

8 4. Except as otherwise provided in subsection 1 of section 52 of this
9 act, a purchaser of an instrument has priority over a security interest in
10 the instrument perfected by a method other than possession if the
11 purchaser gives value and takes possession of the instrument in good
12 faith and without knowledge that the purchase violates the rights of the
13 secured party.

14 5. For purposes of subsections 1 and 2, the holder of a purchase-
15 money security interest in inventory gives new value for chattel paper
16 constituting proceeds of the inventory.

17 6. For purposes of subsections 2 and 4, if chattel paper or an
18 instrument indicates that it has been assigned to an identified secured
19 party other than the purchaser, a purchaser of the chattel paper or
20 instrument has knowledge that the purchase violates the rights of the
21 secured party.

22 **Sec. 52.** 1. This article does not limit the rights of a holder in due
23 course of a negotiable instrument, a holder to which a negotiable
24 document of title has been duly negotiated, or a protected purchaser of a
25 security. These holders or purchasers take priority over an earlier
26 security interest, even if perfected, to the extent provided in Articles 3, 7
27 and 8.

28 2. This article does not limit the rights of or impose liability on a
29 person to the extent that the person is protected against the assertion of
30 an adverse claim under Article 8.

31 3. Filing under this article does not constitute notice of a claim or
32 defense to the holders, or purchasers, or persons described in subsections
33 1 and 2.

34 **Sec. 53.** 1. A transferee of money takes the money free of a
35 security interest unless the transferee acts in collusion with the debtor in
36 violating the rights of the secured party.

37 2. A transferee of funds from a deposit account takes the funds free
38 of a security interest in the deposit account unless the transferee acts in
39 collusion with the debtor in violating the rights of the secured party.

40 **Sec. 54.** 1. In this section, "possessory lien" means an interest,
41 other than a security interest or an agricultural lien:

1 (a) Which secures payment or performance of an obligation for
2 services or materials furnished with respect to goods by a person in the
3 ordinary course of his business;

4 (b) Which is created by statute or rule of law in his favor; and

5 (c) Whose effectiveness depends on his possession of the goods.

6 2. A possessory lien on goods has priority over a security interest in
7 the goods unless the lien is created by a statute that expressly provides
8 otherwise.

9 **Sec. 55. 1.** A security interest under this article may be created in
10 goods that are fixtures or may continue in goods that become fixtures. A
11 security interest does not exist under this article in ordinary building
12 materials incorporated into an improvement on land.

13 2. This article does not prevent creation of an encumbrance upon
14 fixtures under real property law.

15 3. In cases not governed by subsections 4 to 8, inclusive, a security
16 interest in fixtures is subordinate to a conflicting interest of an
17 encumbrancer or owner of the related real property other than the
18 debtor.

19 4. Except as otherwise provided in subsection 8, a perfected security
20 interest in fixtures has priority over a conflicting interest of an
21 encumbrancer or owner of the real property if the debtor has an interest
22 of record in or is in possession of the real property and:

23 (a) The security interest is a purchase-money security interest;

24 (b) The interest of the encumbrancer or owner arises before the goods
25 become fixtures; and

26 (c) The security interest is perfected by a fixture filing before the
27 goods become fixtures or within 20 days thereafter.

28 5. A perfected security interest in fixtures has priority over a
29 conflicting interest of an encumbrancer or owner of the real property if:

30 (a) The debtor has an interest of record in the real property or is in
31 possession of the real property and the security interest:

32 (1) Is perfected by a fixture filing before the interest of the
33 encumbrancer or owner is of record; and

34 (2) Has priority over any conflicting interest of a predecessor in title
35 of the encumbrancer or owner;

36 (b) Before the goods become fixtures, the security interest is perfected
37 by any method permitted by this article and the fixtures are readily
38 removable:

39 (1) Factory or office machines;

40 (2) Equipment that is not primarily used or leased for use in the
41 operation of the real property; or

42 (3) Replacements of domestic appliances that are consumer goods;

1 (c) *The conflicting interest is a lien on the real property obtained by*
2 *legal or equitable proceedings after the security interest was perfected by*
3 *any method permitted by this article; or*

4 (d) *The security interest is:*

5 (1) *Created in a manufactured home in a manufactured-home*
6 *transaction; and*

7 (2) *Perfected pursuant to a statute described in paragraph (b) of*
8 *subsection 1 of section 32 of this act.*

9 6. *A security interest in fixtures, whether or not perfected, has*
10 *priority over a conflicting interest of an encumbrancer or owner of the*
11 *real property if:*

12 (a) *The encumbrancer or owner has, in an authenticated record,*
13 *consented to the security interest or disclaimed an interest in the goods as*
14 *fixtures; or*

15 (b) *The debtor has a right to remove the goods as against the*
16 *encumbrancer or owner.*

17 7. *The priority of the security interest under subsection 6 continues*
18 *for a reasonable time if the debtor's right to remove the goods as against*
19 *the encumbrancer or owner terminates.*

20 8. *A mortgage is a construction mortgage to the extent that it secures*
21 *an obligation incurred for the construction of an improvement on land,*
22 *including the acquisition cost of the land, if the recorded record so*
23 *indicates. Except as otherwise provided in subsections 5 and 6, a security*
24 *interest in fixtures is subordinate to a construction mortgage recorded*
25 *before the goods become fixtures if the goods become fixtures before the*
26 *completion of the construction. A mortgage has this priority to the same*
27 *extent as a construction mortgage to the extent that it is given to*
28 *refinance a construction mortgage.*

29 9. *A perfected security interest in crops growing on real property has*
30 *priority over a conflicting interest of an encumbrancer or owner of the*
31 *real property if the debtor has an interest of record in or is in possession*
32 *of the real property.*

33 **Sec. 56. 1.** *A security interest may be created in an accession and*
34 *continues in collateral that becomes an accession.*

35 2. *If a security interest is perfected when the collateral becomes an*
36 *accession, the security interest remains perfected in the collateral.*

37 3. *Except as otherwise provided in subsection 4, the other provisions*
38 *of this part determine the priority of a security interest in an accession.*

39 4. *A security interest in an accession is subordinate to a security*
40 *interest in the whole which is perfected by compliance with the*
41 *requirements of a certificate-of-title statute under subsection 2 of section*
42 *32 of this act.*

1 5. After default, subject to part 6, a secured party may remove an
2 accession from other goods if the security interest in the accession has
3 priority over the claims of every person having an interest in the whole.

4 6. A secured party that removes an accession from other goods under
5 subsection 5 shall promptly reimburse any holder of a security interest or
6 other lien on, or owner of, the whole or of the other goods, other than the
7 debtor, for the cost of repair of any physical injury to the whole or the
8 other goods. The secured party need not reimburse the holder or owner
9 for any diminution in value of the whole or the other goods caused by the
10 absence of the accession removed or by any necessity for replacing it. A
11 person entitled to reimbursement may refuse permission to remove until
12 the secured party gives adequate assurance for the performance of the
13 obligation to reimburse.

14 Sec. 57. 1. In this section, “commingled goods” means goods that
15 are physically united with other goods in such a manner that their
16 identity is lost in a product or mass.

17 2. A security interest does not exist in commingled goods as such.
18 However, a security interest may attach to a product or mass that results
19 when goods become commingled goods.

20 3. If collateral becomes commingled goods, a security interest
21 attaches to the product or mass.

22 4. If a security interest in collateral is perfected before the collateral
23 becomes commingled goods, the security interest that attaches to the
24 product or mass under subsection 3 is perfected.

25 5. Except as otherwise provided in subsection 6, the other provisions
26 of this part determine the priority of a security interest that attaches to
27 the product or mass under subsection 3.

28 6. If more than one security interest attaches to the product or mass
29 under subsection 3, the following rules determine priority:

30 (a) A security interest that is perfected under subsection 4 has priority
31 over a security interest that is unperfected at the time the collateral
32 becomes commingled goods.

33 (b) If more than one security interest is perfected under subsection 4,
34 the security interests rank equally in proportion to value of the collateral
35 at the time it became commingled goods.

36 Sec. 58. If, while a security interest in goods is perfected by any
37 method under the law of another jurisdiction, this state issues a
38 certificate of title that does not show that the goods are subject to the
39 security interest or contain a statement that they may be subject to
40 security interests not shown on the certificate:

41 1. A buyer of the goods, other than a person in the business of selling
42 goods of that kind, takes free of the security interest if the buyer gives

1 *value and receives delivery of the goods after issuance of the certificate*
2 *and without knowledge of the security interest; and*

3 *2. The security interest is subordinate to a conflicting security*
4 *interest in the goods that attaches, and is perfected under subsection 2 of*
5 *section 32 of this act, after issuance of the certificate and without the*
6 *conflicting secured party's knowledge of the security interest.*

7 **Sec. 59.** *If a security interest or agricultural lien is perfected by a*
8 *filed financing statement providing information described in paragraph*
9 *(e) of subsection 2 of section 88 of this act which is incorrect at the time*
10 *the financing statement is filed:*

11 *1. The security interest or agricultural lien is subordinate to a*
12 *conflicting perfected security interest in the collateral to the extent that*
13 *the holder of the conflicting security interest gives value in reasonable*
14 *reliance upon the incorrect information; and*

15 *2. A purchaser, other than a secured party, of the collateral takes*
16 *free of the security interest or agricultural lien to the extent that, in*
17 *reasonable reliance upon the incorrect information, the purchaser gives*
18 *value and, in the case of chattel paper, documents, goods, instruments, or*
19 *a security certificate, receives delivery of the collateral.*

20 **Sec. 60.** *This article does not preclude subordination by agreement*
21 *by a person entitled to priority.*

22 **Sec. 61.** *1. Except as otherwise provided in subsection 3, a bank*
23 *with which a deposit account is maintained may exercise any right of*
24 *recoupment or set-off against a secured party that holds a security*
25 *interest in the deposit account.*

26 *2. Except as otherwise provided in subsection 3, the application of*
27 *this article to a security interest in a deposit account does not affect a*
28 *right of recoupment or set-off of the secured party as to a deposit account*
29 *maintained with the secured party.*

30 *3. The exercise by a bank of a set-off against a deposit account is*
31 *ineffective against a secured party that holds a security interest in the*
32 *deposit account which is perfected by control under paragraph (c) of*
33 *subsection 1 of section 5 of this act, if the set-off is based on a claim*
34 *against the debtor.*

35 **Sec. 62.** *Except as otherwise provided in subsection 3 of section 61*
36 *of this act, and unless the bank otherwise agrees in an authenticated*
37 *record, a bank's rights and duties with respect to a deposit account*
38 *maintained with the bank are not terminated, suspended, or modified by:*

39 *1. The creation, attachment, or perfection of a security interest in the*
40 *deposit account;*

41 *2. The bank's knowledge of the security interest; or*

42 *3. The bank's receipt of instructions from the secured party.*

1 **Sec. 63.** *This article does not require a bank to enter into an*
2 *agreement of the kind described in paragraph (b) of subsection 1 of*
3 *section 5 of this act, even if its customer so requests or directs. A bank*
4 *that has entered into such an agreement is not required to confirm the*
5 *existence of the agreement to another person unless requested to do so by*
6 *its customer.*

7 **Sec. 64. 1.** *Except as otherwise provided in subsection 2 and*
8 *sections 7, 8, 9 and 10 of this act, whether a debtor's rights in collateral*
9 *may be voluntarily or involuntarily transferred is governed by law other*
10 *than this article.*

11 **2.** *An agreement between the debtor and secured party which*
12 *prohibits a transfer of the debtor's rights in collateral or makes the*
13 *transfer a default does not prevent the transfer from taking effect.*

14 **Sec. 65.** *The existence of a security interest, agricultural lien, or*
15 *authority given to a debtor to dispose of or use collateral, without more,*
16 *does not impose upon a secured party liability in contract or tort for the*
17 *debtor's acts or omissions.*

18 **Sec. 66. 1.** *In this section, "value" has the meaning provided in*
19 *subsection 1 of NRS 104.3303.*

20 **2.** *Except as otherwise provided in this section, an agreement*
21 *between an account debtor and an assignor not to assert against an*
22 *assignee any claim or defense that the account debtor may have against*
23 *the assignor is enforceable by an assignee that takes an assignment:*

24 **(a)** *For value;*

25 **(b)** *In good faith;*

26 **(c)** *Without notice of a claim of a property or possessory right to the*
27 *property assigned; and*

28 **(d)** *Without notice of a defense or claim in recoupment of the type that*
29 *may be asserted against a person entitled to enforce a negotiable*
30 *instrument under subsection 1 of NRS 104.3305.*

31 **3.** *An agreement described in subsection 2 is not enforceable with*
32 *respect to defenses of a type that may be asserted against a holder in due*
33 *course of a negotiable instrument under subsection 2 of NRS 104.3305.*

34 **4.** *In a consumer transaction, if a record evidences the account*
35 *debtor's obligation, law other than this article requires that the record*
36 *include a statement to the effect that the rights of an assignee are subject*
37 *to claims or defenses that the account debtor could assert against the*
38 *original obligee, and the record does not include such a statement:*

39 **(a)** *The record has the same effect as if the record included such a*
40 *statement; and*

41 **(b)** *The account debtor may assert against an assignee those claims*
42 *and defenses that would have been available if the record included such*
43 *a statement.*

1 5. This section is subject to law other than this article which
2 establishes a different rule for an account debtor who is a natural person
3 and who incurred the obligation primarily for personal, family, or
4 household purposes.

5 6. Except as otherwise provided in subsection 4, this section does not
6 displace law other than this article which gives effect to an agreement by
7 an account debtor not to assert a claim or defense against an assignee.

8 **Sec. 67.** 1. Unless an account debtor has made an enforceable
9 agreement not to assert defenses or claims, and subject to subsections 2
10 to 5, inclusive, the rights of an assignee are subject to:

11 (a) All terms of the agreement between the account debtor and
12 assignor and any defense or claim in recoupment arising from the
13 transaction that gave rise to the contract; and

14 (b) Any other defense or claim of the account debtor against the
15 assignor which accrues before the account debtor receives a notification
16 of the assignment authenticated by the assignor or the assignee.

17 2. Subject to subsection 3 and except as otherwise provided in
18 subsection 4, the claim of an account debtor against an assignor may be
19 asserted against an assignee under subsection 1 only to reduce the
20 amount the account debtor owes.

21 3. This section is subject to law other than this article which
22 establishes a different rule for an account debtor who is a natural person
23 and who incurred the obligation primarily for personal, family, or
24 household purposes.

25 4. In a consumer transaction, if a record evidences the account
26 debtor's obligation, law other than this article requires that the record
27 include a statement to the effect that the account debtor's recovery
28 against an assignee with respect to claims and defenses against the
29 assignor may not exceed amounts paid by the account debtor under the
30 record, and the record does not include such a statement, the extent to
31 which a claim of an account debtor against the assignor may be asserted
32 against an assignee is determined as if the record included such a
33 statement.

34 5. This section does not apply to an assignment of a health-care-
35 insurance receivable.

36 **Sec. 68.** 1. A modification of or substitution for an assigned
37 contract is effective against an assignee if made in good faith. The
38 assignee acquires corresponding rights under the modified or substituted
39 contract. The assignment may provide that the modification or
40 substitution is a breach of contract by the assignor. This subsection is
41 subject to subsections 2, 3 and 4.

42 2. Subsection 1 applies to the extent that:

1 (a) *The right to payment or a part thereof under an assigned contract*
2 *has not been fully earned by performance; or*

3 (b) *The right to payment or a part thereof has been fully earned by*
4 *performance and the account debtor has not received notification of the*
5 *assignment under subsection 1 of section 69 of this act.*

6 3. *This section is subject to law other than this article which*
7 *establishes a different rule for an account debtor who is a natural person*
8 *and who incurred the obligation primarily for personal, family, or*
9 *household purposes.*

10 4. *This section does not apply to an assignment of a health-care-*
11 *insurance receivable.*

12 **Sec. 69. 1.** *Subject to subsections 2 to 8, inclusive, an account*
13 *debtor on an account, chattel paper, or a payment intangible may*
14 *discharge its obligation by paying the assignor until, but not after, the*
15 *account debtor receives a notification, authenticated by the assignor or*
16 *the assignee, that the amount due or to become due has been assigned*
17 *and that payment is to be made to the assignee. After receipt of the*
18 *notification, the account debtor may discharge its obligation by paying*
19 *the assignee and may not discharge the obligation by paying the*
20 *assignor.*

21 2. *Subject to subsection 8, notification is ineffective under subsection*
22 1:

23 (a) *If it does not reasonably identify the rights assigned;*

24 (b) *To the extent that an agreement between an account debtor and a*
25 *seller of a payment intangible limits the account debtor's duty to pay a*
26 *person other than the seller and the limitation is effective under law*
27 *other than this article; or*

28 (c) *At the option of an account debtor, if the notification notifies the*
29 *account debtor to make less than the full amount of any installment or*
30 *other periodic payment to the assignee, even if:*

31 (1) *Only a portion of the account, chattel paper, or general*
32 *intangible has been assigned to that assignee;*

33 (2) *A portion has been assigned to another assignee; or*

34 (3) *The account debtor knows that the assignment to that assignee*
35 *is limited.*

36 3. *Subject to subsection 8, if requested by the account debtor, an*
37 *assignee shall seasonably furnish reasonable proof that the assignment*
38 *has been made. Unless the assignee complies, the account debtor may*
39 *discharge its obligation by paying the assignor, even if the account*
40 *debtor has received a notification under subsection 1.*

41 4. *Except as otherwise provided in subsection 5 and NRS 104A.2303*
42 *and section 70 of this act, and subject to subsection 8, a term in an*

1 *agreement between an account debtor and an assignor or in a promissory*
2 *note is ineffective to the extent that it:*

3 *(a) Prohibits, restricts, or requires the consent of the account debtor*
4 *or person obligated on the promissory note to the assignment or transfer*
5 *of, or the creation, attachment, perfection, or enforcement of a security*
6 *interest in, the account, chattel paper, payment intangible, or promissory*
7 *note; or*

8 *(b) Provides that the creation, attachment, perfection, or enforcement*
9 *of the security interest may give rise to a default, breach, right of*
10 *recoupment, claim, defense, termination, right of termination, or remedy*
11 *under the account, chattel paper, payment intangible, or promissory note.*

12 *5. Subsection 4 does not apply to the sale of a payment intangible or*
13 *promissory note.*

14 *6. Subject to subsections 7 and 8, a rule of law, statute, or regulation,*
15 *that prohibits, restricts, or requires the consent of a government,*
16 *governmental body or official, or account debtor to the assignment or*
17 *transfer of, or creation of a security interest in, an account or chattel*
18 *paper is ineffective to the extent that the rule of law, statute, or*
19 *regulation:*

20 *(a) Prohibits, restricts, or requires the consent of the government,*
21 *governmental body or official, or account debtor to the assignment or*
22 *transfer of, or the creation, attachment, perfection, or enforcement of a*
23 *security interest in, the account or chattel paper; or*

24 *(b) Provides that the creation, attachment, perfection, or enforcement*
25 *of the security interest may give rise to a default, breach, right of*
26 *recoupment, claim, defense, termination, right of termination, or remedy*
27 *under the account or chattel paper.*

28 *7. Subject to subsection 8, an account debtor may not waive or vary*
29 *its option under paragraph (c) of subsection 2.*

30 *8. This section is subject to law other than this article which*
31 *establishes a different rule for an account debtor who is an individual*
32 *and who incurred the obligation primarily for personal, family, or*
33 *household purposes.*

34 *9. This section does not apply to an assignment of a health-care-*
35 *insurance receivable.*

36 **Sec. 70. 1.** *Except as otherwise provided in subsection 2, a term in*
37 *a lease agreement is ineffective to the extent that it:*

38 *(a) Prohibits, restricts, or requires the consent of a party to the lease to*
39 *the creation, attachment, perfection, or enforcement of a security interest*
40 *in an interest of a party under the lease contract or in the lessor's*
41 *residual interest in the goods; or*

42 *(b) Provides that the creation, attachment, perfection, or enforcement*
43 *of the security interest may give rise to a default, breach, right of*

1 *recoupment, claim, defense, termination, right of termination, or remedy*
2 *under the lease.*

3 2. *Except as otherwise provided in subsection 7 of NRS 104A.2303, a*
4 *term described in paragraph (b) of subsection 1 is effective to the extent*
5 *that there is:*

6 (a) *A transfer by the lessee of the lessee's right of possession or use of*
7 *the goods in violation of the term; or*

8 (b) *A delegation of a material performance of either party to the lease*
9 *contract in violation of the term.*

10 3. *The creation, attachment, perfection, or enforcement of a security*
11 *interest in the lessor's interest under the lease contract or the lessor's*
12 *residual interest in the goods is not a transfer that materially impairs the*
13 *lessee's prospect of obtaining return performance or materially changes*
14 *the duty of or materially increases the burden or risk imposed on the*
15 *lessee within the purview of subsection 4 of NRS 104A.2303 unless, and*
16 *then only to the extent that, enforcement results in a delegation of a*
17 *material performance of the lessor. Even in that event, the creation,*
18 *attachment, perfection, and enforcement of the security interest remain*
19 *effective.*

20 **Sec. 71.** 1. *Except as otherwise provided in subsection 2, a term in*
21 *a promissory note or in an agreement between an account debtor and a*
22 *debtor which relates to a health-care-insurance receivable or a general*
23 *intangible, including a contract, permit, license, or franchise, and*
24 *prohibits, restricts, or requires the consent of the person obligated on the*
25 *promissory note or the account debtor to, the assignment or transfer of,*
26 *or creation, attachment, or perfection of a security interest in, the*
27 *promissory note, health-care-insurance receivable, or general intangible,*
28 *is ineffective to the extent that the term:*

29 (a) *Would impair the creation, attachment, or perfection of a security*
30 *interest; or*

31 (b) *Provides that the creation, attachment, or perfection of the security*
32 *interest may give rise to a default, breach, right of recoupment, claim,*
33 *defense, termination, right of termination, or remedy under the*
34 *promissory note, health-care-insurance receivable, or general intangible.*

35 2. *Subsection 1 applies to a security interest in a payment intangible*
36 *or promissory note only if the security interest arises out of a sale of the*
37 *payment intangible or promissory note.*

38 3. *A rule of law, statute, or regulation that prohibits, restricts, or*
39 *requires the consent of a government, governmental body or official,*
40 *person obligated on a promissory note, or account debtor to the*
41 *assignment or transfer of, or creation of a security interest in, a*
42 *promissory note, health-care-insurance receivable, or general intangible,*
43 *including a contract, permit, license, or franchise between an account*

1 *debtor and a debtor, is ineffective to the extent that the rule of law,*
2 *statute, or regulation:*

3 *(a) Would impair the creation, attachment, or perfection of a security*
4 *interest; or*

5 *(b) Provides that the creation, attachment, or perfection of the security*
6 *interest may give rise to a default, breach, right of recoupment, claim,*
7 *defense, termination, right of termination, or remedy under the*
8 *promissory note, health-care-insurance receivable, or general intangible.*

9 **4.** *To the extent that a term in a promissory note or in an agreement*
10 *between an account debtor and a debtor which relates to a health-care-*
11 *insurance receivable or general intangible or a rule of law, statute, or*
12 *regulation described in subsection 3 would be effective under law other*
13 *than this article but is ineffective under subsection 1 or 3, the creation,*
14 *attachment, or perfection of a security interest in the promissory note,*
15 *health-care-insurance receivable, or general intangible:*

16 *(a) Is not enforceable against the person obligated on the promissory*
17 *note or the account debtor;*

18 *(b) Does not impose a duty or obligation on the person obligated on*

28 *note, health-care-insurance receivable, or general intangible;*

29 *(e) Does not entitle the secured party to use, assign, possess, or have*
30 *access to any trade secrets or confidential information of the person*
31 *obligated on the promissory note or the account debtor; and*

32 *(f) Does not entitle the secured party to enforce the security interest in*
33 *the promissory note, health-care-insurance receivable, or general*
34 *intangible.*

35 **Sec. 72. 1.** *A term in a letter of credit or a rule of law, statute,*
36 *regulation, custom, or practice applicable to the letter of credit which*
37 *prohibits, restricts, or requires the consent of an applicant, issuer, or*
38 *nominated person to a beneficiary's assignment of or creation of a*
39 *security interest in a letter-of-credit right is ineffective to the extent that*
40 *the term or rule of law, statute, regulation, custom, or practice:*

41 *(a) Would impair the creation, attachment, or perfection of a security*
42 *interest in the letter-of-credit right; or*

1 (b) Provides that the creation, attachment, or perfection of the security
2 interest may give rise to a default, breach, right of recoupment, claim,
3 defense, termination, right of termination, or remedy under the letter-of-
4 credit right.

5 2. To the extent that a term in a letter of credit is ineffective under
6 subsection 1 but would be effective under law other than this article or a
7 custom or practice applicable to the letter of credit, to the transfer of a
8 right to draw or otherwise demand performance under the letter of credit,
9 or to the assignment of a right to proceeds of the letter of credit, the
10 creation, attachment, or perfection of a security interest in the letter-of-
11 credit right:

12 (a) Is not enforceable against the applicant, issuer, nominated person,
13 or transferee beneficiary;

14 (b) Imposes no duties or obligations on the applicant, issuer,
15 nominated person, or transferee beneficiary; and

16 (c) Does not require the applicant, issuer, nominated person, or
17 transferee beneficiary to recognize the security interest, pay or render
18 performance to the secured party, or accept payment or other
19 performance from the secured party.

20 **Sec. 73. 1.** Except as otherwise provided in subsection 2, if the law
21 of this state governs perfection of a security interest or agricultural lien,
22 the office in which to file a financing statement to perfect the security
23 interest or agricultural lien is:

24 (a) The office designated for the filing or recording of a mortgage on
25 the real property, if:

26 (1) The collateral is as-extracted collateral or timber to be cut; or

27 (2) The financing statement is filed as a fixture filing and the
28 collateral is goods that are or are to become fixtures; or

29 (b) The office of the secretary of state in all other cases, including a
30 case in which the collateral is goods that are or are to become fixtures
31 and the financing statement is not filed as a fixture filing.

32 2. The office in which to file a financing statement to perfect a
33 security interest in collateral, including fixtures, of a transmitting utility
34 is the office of the secretary of state or the county recorder of the
35 appropriate county, as determined pursuant to chapter 105 of NRS. The
36 financing statement also constitutes a fixture filing as to the collateral
37 indicated in the financing statement which is or is to become fixtures.

38 **Sec. 74. 1.** Subject to subsection 2, a financing statement is
39 sufficient only if it:

40 (a) Provides the name of the debtor;

41 (b) Provides the name of the secured party or a representative of the
42 secured party; and

43 (c) Indicates the collateral covered by the financing statement.

2. Except as otherwise provided in subsection 2 of section 73 of this act, to be sufficient, a financing statement that covers as-extracted collateral or timber to be cut, or which is filed as a fixture filing and covers goods that are or are to become fixtures, must satisfy subsection 1 and also:

- (a) Indicate that it covers this type of collateral;
- (b) Indicate that it is to be filed for record in the real property records;
- (c) Provide a description of the real property to which the collateral is related sufficient to give constructive notice of the mortgage under the law of this state if the description were contained in a mortgage of the real property; and
- (d) If the debtor does not have an interest of record in the real property, provide the name of a record owner.

3. A record of a mortgage is effective, from the date of recording, as a financing statement filed as a fixture filing or as a financing statement covering as-extracted collateral or timber to be cut only if:

- (a) The record indicates the goods or accounts that it covers;
- (b) The goods are or are to become fixtures related to the real property described in the mortgage or the collateral is related to the real property described in the mortgage and is as-extracted collateral or timber to be cut;
- (c) The record satisfies the requirements for a financing statement in this section other than an indication that it is to be filed in the real property records; and
- (d) The mortgage is recorded.

4. A financing statement may be filed before a security agreement is made or a security interest otherwise attaches.

Sec. 75. 1. A financing statement sufficiently provides the name of the debtor:

- (a) If the debtor is a registered organization, only if the financing statement provides the name of the debtor indicated on the public record of the debtor's jurisdiction of organization which shows the debtor to have been organized;
- (b) If the debtor is a decedent's estate, only if the financing statement provides the name of the decedent and indicates that the debtor is an estate;
- (c) If the debtor is a trust or a trustee acting with respect to property held in trust, only if the financing statement:
 - (1) Provides the name specified for the trust in its organic documents or, if no name is specified, provides the name of the settlor and additional information sufficient to distinguish the debtor from other trusts having one or more of the same settlors; and

1 (2) Indicates, in the debtor's name or otherwise, that the debtor is a
2 trust or is a trustee acting with respect to property held in trust; and

3 (d) In other cases:

4 (1) If the debtor has a name, only if it provides the name of the
5 debtor as a natural person or an organization; and

6 (2) If the debtor does not have a name, only if it provides the names
7 of the partners, members, associates, or other persons comprising the
8 debtor.

9 2. A financing statement that provides the name of the debtor in
10 accordance with subsection 1 is not rendered ineffective by the absence
11 of:

12 (a) A trade name or other name of the debtor; or

13 (b) Unless required under subparagraph (2) of paragraph (d) of
14 subsection 1, names of partners, members, associates, or other persons
15 comprising the debtor.

16 3. A financing statement that provides only the debtor's trade name
17 does not sufficiently provide the name of the debtor.

18 4. Failure to indicate the representative capacity of a secured party
19 or representative of a secured party does not affect the sufficiency of a
20 financing statement.

21 5. A financing statement may provide the name of more than one
22 debtor and the name of more than one secured party.

23 Sec. 76. A financing statement sufficiently indicates the collateral
24 that it covers only if the financing statement provides:

25 1. A description of the collateral pursuant to section 9 of this act; or

26 2. An indication that the financing statement covers all assets or all
27 personal property.

28 Sec. 77. 1. A consignor, lessor, or other bailor of goods, a licensor,
29 or a buyer of a payment intangible or promissory note may file a
30 financing statement, or may comply with a statute or treaty described in
31 subsection 1 of section 32 of this act, using the terms "consignor,"
32 "consignee," "lessor," "lessee," "bailor," "bailee," "licensor,"
33 "licensee," "owner," "registered owner," "buyer," "seller," or words of
34 similar import, instead of the terms "secured party" and "debtor."

35 2. This part applies to the filing of a financing statement under
36 subsection 1 and, as appropriate, to compliance that is equivalent to
37 filing a financing statement under subsection 2 of section 32 of this act,
38 but the filing or compliance is not of itself a factor in determining
39 whether the collateral secures an obligation. If it is determined for
40 another reason that the collateral secures an obligation, a security
41 interest held by the consignor, lessor, bailor, licensor, owner, or buyer
42 which attaches to the collateral is perfected by the filing or compliance.

1 **Sec. 78. 1.** *A financing statement substantially satisfying the*
2 *requirements of this part is effective, even if it has minor errors or*
3 *omissions, unless the errors or omissions make the financing statement*
4 *seriously misleading.*

5 2. *Except as otherwise provided in subsection 3, a financing*
6 *statement that fails sufficiently to provide the name of the debtor in*
7 *accordance with subsection 1 of section 75 of this act is seriously*
8 *misleading.*

9 3. *If a search of the records of the filing office under the debtor's*
10 *correct name, using the filing office's standard search logic, if any,*
11 *would disclose a financing statement that fails sufficiently to provide the*
12 *name of the debtor in accordance with subsection 1 of section 75 of this*
13 *act, the name provided does not make the financing statement seriously*
14 *misleading.*

15 4. *For purposes of subsection 2 of section 80 of this act, the*
16 *"debtor's correct name" in subsection 3 means the correct name of the*
17 *new debtor.*

18 **Sec. 79. 1.** *A filed financing statement remains effective with*
19 *respect to collateral that is sold, exchanged, leased, licensed, or otherwise*
20 *disposed of and in which a security interest or agricultural lien*
21 *continues, even if the secured party knows of or consents to the*
22 *disposition.*

23 2. *Except as otherwise provided in subsection 3 and section 80 of this*
24 *act, a financing statement is not rendered ineffective if, after the*
25 *financing statement is filed, the information provided in the financing*
26 *statement becomes seriously misleading under section 78 of this act.*

27 3. *If a debtor so changes its name that a filed financing statement*
28 *becomes seriously misleading under section 78 of this act:*

29 (a) *The financing statement is effective to perfect a security interest in*
30 *collateral acquired by the debtor before, or within 4 months after, the*
31 *change; and*

32 (b) *The financing statement is not effective to perfect a security*
33 *interest in collateral acquired by the debtor more than 4 months after the*
34 *change, unless an amendment to the financing statement which renders*
35 *the financing statement not seriously misleading is filed within 4 months*
36 *after the change.*

37 **Sec. 80. 1.** *Except as otherwise provided in this section, a filed*
38 *financing statement naming an original debtor is effective to perfect a*
39 *security interest in collateral in which a new debtor has or acquires rights*
40 *to the extent that the financing statement would have been effective had*
41 *the original debtor acquired rights in the collateral.*

42 2. *If the difference between the name of the original debtor and that*
43 *of the new debtor causes a filed financing statement that is effective*

1 under subsection 1 to be seriously misleading under section 78 of this
2 act:

3 (a) The financing statement is effective to perfect a security interest in
4 collateral acquired by the new debtor before, and within 4 months after,
5 the new debtor becomes bound under subsection 4 of section 14 of this
6 act; and

7 (b) The financing statement is not effective to perfect a security
8 interest in collateral acquired by the new debtor more than 4 months
9 after the new debtor becomes bound under subsection 4 of section 14 of
10 this act unless an initial financing statement providing the name of the
11 new debtor is filed before the expiration of that time.

12 3. This section does not apply to collateral as to which a filed
13 financing statement remains effective against the new debtor under
14 subsection 1 of section 79 of this act.

15 **Sec. 81. 1.** A person may file an initial financing statement,
16 amendment that adds collateral covered by a financing statement, or
17 amendment that adds a debtor to a financing statement only if:

18 (a) The debtor authorizes the filing in an authenticated record; or

19 (b) The person holds an agricultural lien that has become effective at
20 the time of filing and the financing statement covers only collateral in
21 which he holds an agricultural lien.

22 2. By authenticating or becoming bound as debtor by a security
23 agreement, a debtor or new debtor authorizes the filing of an initial
24 financing statement, and an amendment, covering:

25 (a) The collateral described in the security agreement; and

26 (b) Property that becomes collateral under paragraph (b) of
27 subsection 1 of section 36 of this act, whether or not the security
28 agreement expressly covers proceeds.

29 3. A person may file an amendment other than an amendment that
30 adds collateral covered by a financing statement or an amendment that
31 adds a debtor to a financing statement only if:

32 (a) The secured party of record authorizes the filing; or

33 (b) The change is a termination statement for a financing statement
34 as to which the secured party of record has failed to file or send a
35 termination statement as required by subsection 1 or 3 of section 85 of
36 this act.

37 4. If there is more than one secured party of record for a financing
38 statement, each secured party of record may authorize the filing of an
39 amendment under subsection 3.

40 **Sec. 82. 1.** Subject to subsection 3, a filed record is effective only
41 to the extent that it was filed by a person that may file it under section 81
42 of this act.

1 2. A record authorized by one secured party of record does not affect
2 the financing statement with respect to another secured party of record.

3 3. If a person may file a termination statement only under paragraph
4 (b) of subsection 3 of section 81 of this act, the filed termination
5 statement is effective only if the debtor authorizes the filing and the
6 termination statement indicates that the debtor authorized it to be filed.

7 4. A continuation statement that is not filed within the 6-month
8 period prescribed by subsection 4 of section 87 of this act is ineffective.

9 **Sec. 83.** 1. A secured party of record with respect to a financing
10 statement is a person whose name is provided as the name of the secured
11 party or a representative of the secured party in an initial financing
12 statement that has been filed. If an initial financing statement is filed
13 under subsection 1 of section 86 of this act, the assignee named in the
14 initial financing statement is the secured party of record with respect to
15 the financing statement.

16 2. If an amendment of a financing statement which provides the
17 name of a person as a secured party or a representative of a secured
18 party is filed, the person named in the amendment is a secured party of
19 record. If an amendment is filed under subsection 2 of section 86 of this
20 act, the assignee named in the amendment is a secured party of record.

21 3. A person remains a secured party of record until the filing of an
22 amendment of the financing statement which deletes him.

23 **Sec. 84.** 1. Subject to section 81 of this act, a person may add or
24 delete collateral covered by, continue or terminate the effectiveness of,
25 or, subject to subsection 5, otherwise amend the information provided in,
26 a financing statement by filing an amendment that:

27 (a) Identifies, by its file number, the initial financing statement to
28 which the amendment relates; and

29 (b) If the amendment relates to an initial financing statement filed or
30 recorded in a filing office described in paragraph (a) of subsection 1 of
31 section 73 of this act, provides the date that the initial financing
32 statement was filed or recorded and the information specified in
33 subsection 2 of section 74 of this act.

34 2. Except as otherwise provided in section 87 of this act, the filing of
35 an amendment does not extend the period of effectiveness of the
36 financing statement.

37 3. A financing statement that is amended by an amendment that adds
38 collateral is effective as to the added collateral only from the date of the
39 filing of the amendment.

40 4. A financing statement that is amended by an amendment that adds
41 a debtor is effective as to the added debtor only from the date of the filing
42 of the amendment.

43 5. An amendment is ineffective to the extent it:

1 (a) Purports to delete all debtors and fails to provide the name of a
2 debtor to be covered by the financing statement; or

3 (b) Purports to delete all secured parties of record and fails to provide
4 the name of a new secured party of record.

5 **Sec. 85. 1.** A secured party shall cause the secured party of record
6 for a financing statement to file a termination statement for the
7 financing statement if the financing statement covers consumer goods
8 and:

9 (a) There is no obligation secured by the collateral covered by the
10 financing statement and no commitment to make an advance, incur an
11 obligation, or otherwise give value; or

12 (b) The debtor did not authorize the filing of the initial financing
13 statement.

14 2. To comply with subsection 1, a secured party shall cause the
15 secured party of record to file the termination statement:

16 (a) Within 1 month after there is no obligation secured by the
17 collateral covered by the financing statement and no commitment to
18 make an advance, incur an obligation, or otherwise give value; or

19 (b) If earlier, within 20 days after the secured party receives an
20 authenticated demand from a debtor.

21 3. In cases not governed by subsection 1, within 20 days after a
22 secured party receives an authenticated demand from a debtor, the
23 secured party shall cause the secured party of record for a financing
24 statement to send to the debtor a termination statement for the financing
25 statement or file the termination statement in the filing office if:

26 (a) Except in the case of a financing statement covering accounts or
27 chattel paper that has been sold or goods that are the subject of a
28 consignment, there is no obligation secured by the collateral covered by
29 the financing statement and no commitment to make an advance, incur
30 an obligation, or otherwise give value;

31 (b) The financing statement covers accounts or chattel paper that has
32 been sold but as to which the account debtor or other person obligated
33 has discharged its obligation;

34 (c) The financing statement covers goods that were the subject of a
35 consignment to the debtor but are not in the debtor's possession; or

36 (d) The debtor did not authorize the filing of the initial financing
37 statement.

38 4. Except as otherwise provided in section 82 of this act, upon the
39 filing of a termination statement with the filing office, the financing
40 statement to which the termination statement relates ceases to be
41 effective.

1 **Sec. 86. 1.** *Except as otherwise provided in subsection 3, an initial*
2 *financing statement may reflect an assignment of all of the secured*
3 *party's power to authorize an amendment to the financing statement by*
4 *providing the name and mailing address of the assignee as the name and*
5 *address of the secured party.*

6 2. *Except as otherwise provided in subsection 3, a secured party of*
7 *record may assign of record all or part of its power to authorize an*
8 *amendment to a financing statement by filing in the filing office an*
9 *amendment of the financing statement which:*

10 (a) *Identifies, by its file number, the initial financing statement to*
11 *which it relates;*

12 (b) *Provides the name of the assignor; and*

13 (c) *Provides the name and mailing address of the assignee.*

14 3. *An assignment of record of a security interest in a fixture covered*
15 *by a mortgage of real property which is effective as a fixture filing under*
16 *section 74 of this act may be made only by an assignment of record of the*
17 *mortgage in the manner provided by law of this state other than the*
18 *Uniform Commercial Code.*

19 **Sec. 87. 1.** *Except as otherwise provided in subsections 2, 5, 6 and*
20 *7, a filed financing statement is effective for a period of 5 years after the*
21 *date of filing.*

22 2. *Except as otherwise provided in subsections 5, 6 and 7, an initial*
23 *financing statement filed in connection with a public-finance transaction*
24 *or manufactured-home transaction is effective for a period of 30 years*
25 *after the date of filing if it indicates that it is filed in connection with a*
26 *public-finance transaction or manufactured-home transaction.*

27 3. *The effectiveness of a filed financing statement lapses on the*
28 *expiration of the period of its effectiveness unless before the lapse a*
29 *continuation statement is filed pursuant to subsection 4. Upon lapse, a*
30 *financing statement ceases to be effective and any security interest or*
31 *agricultural lien that was perfected by the financing statement becomes*
32 *unperfected, unless the security interest is perfected otherwise. If the*
33 *security interest or agricultural lien becomes unperfected upon lapse, it is*
34 *deemed never to have been perfected as against a purchaser of the*
35 *collateral for value.*

36 4. *A continuation statement may be filed only within 6 months before*
37 *the expiration of the 5-year period specified in subsection 1 or the 30-*
38 *year period specified in subsection 2, whichever is applicable.*

39 5. *Except as otherwise provided in section 82 of this act, upon timely*
40 *filing of a continuation statement, the effectiveness of the initial*
41 *financing statement continues for a period of 5 years commencing on the*
42 *day on which the financing statement would have become ineffective in*
43 *the absence of the filing. Upon the expiration of the 5-year period, the*

1 *financing statement lapses in the same manner as provided in subsection*
2 *3, unless, before the lapse, another continuation statement is filed*
3 *pursuant to subsection 4. Succeeding continuation statements may be*
4 *filed in the same manner to continue the effectiveness of the initial*
5 *financing statement.*

6 *6. If a debtor is a transmitting utility and a filed financing statement*
7 *so indicates, the financing statement is effective until a termination*
8 *statement is filed.*

9 *7. A real property mortgage that is effective as a fixture filing under*
10 *subsection 3 of section 74 of this act remains effective as a fixture filing*
11 *until the mortgage is released or satisfied of record or its effectiveness*
12 *otherwise terminates as to the real property.*

13 **Sec. 88. 1.** *Except as otherwise provided in subsection 2,*
14 *communication of a record to a filing office and tender of the filing fee*
15 *or acceptance of the record by the filing office constitutes filing.*

16 *2. Filing does not occur with respect to a record that a filing office*
17 *refuses to accept because:*

18 *(a) The record is not communicated by a method or medium of*
19 *communication authorized by the filing office;*

20 *(b) An amount equal to or greater than the applicable filing fee is not*
21 *tendered;*

22 *(c) The filing office is unable to index the record because:*

23 *(1) In the case of an initial financing statement, the record does not*
24 *provide a name for the debtor;*

25 *(2) In the case of an amendment or correction statement, the*
26 *record:*

27 *(I) Does not identify the initial financing statement as required*
28 *by section 84 or 90 of this act, as applicable; or*

29 *(II) Identifies an initial financing statement whose effectiveness*
30 *has lapsed under section 87 of this act;*

31 *(3) In the case of an initial financing statement that provides the*
32 *name of a debtor identified as a natural person or an amendment that*
33 *provides a name of a debtor identified as a natural person which was not*
34 *previously provided in the financing statement to which the record*
35 *relates, the record does not identify the debtor's last name; or*

36 *(4) In the case of a record filed or recorded in the filing office*
37 *described in paragraph (a) of subsection 1 of section 73 of this act, the*
38 *record does not provide a sufficient description of the real property to*
39 *which it relates;*

40 *(d) In the case of an initial financing statement or an amendment that*
41 *adds a secured party of record, the record does not provide a name and*
42 *mailing address for the secured party of record;*

1 (e) In the case of an initial financing statement or an amendment that
2 provides a name of a debtor which was not previously provided in the
3 financing statement to which the amendment relates, the record does not:

4 (1) Provide a mailing address for the debtor;

5 (2) Indicate whether the debtor is a natural person or an
6 organization; or

7 (3) If the financing statement indicates that the debtor is an
8 organization, provide:

9 (I) A type of organization for the debtor;

10 (II) A jurisdiction of organization for the debtor; or

11 (III) An organizational identification number for the debtor or
12 indicate that the debtor has none;

13 (f) In the case of an assignment reflected in an initial financing
14 statement under subsection 1 of section 86 of this act or an amendment
15 filed under subsection 2 of that section, the record does not provide a
16 name and mailing address for the assignee; or

17 (g) In the case of a continuation statement, the record is not filed
18 within the 6-month period prescribed by subsection 4 of section 87 of this
19 act.

20 3. For purposes of subsection 2:

21 (a) A record does not provide information if the filing office is unable
22 to read or decipher the information; and

23 (b) A record that does not indicate that it is an amendment or identify
24 an initial financing statement to which it relates, as required by section
25 84, 86 or 90 of this act, is an initial financing statement.

26 4. A record that is communicated to the filing office with tender of
27 the filing fee, but which the filing office refuses to accept for a reason
28 other than one set forth in subsection 2, is effective as a filed record
29 except as against a purchaser of the collateral which gives value in
30 reasonable reliance upon the absence of the record from the files.

31 **Sec. 89.** The failure of the filing office to index a record correctly
32 does not affect the effectiveness of the filed record.

33 **Sec. 90. 1.** A person may file in the filing office a correction
34 statement with respect to a record indexed there under his name if he
35 believes that the record is inaccurate or was wrongfully filed.

36 2. A correction statement must:

37 (a) Identify the record to which it relates by:

38 (1) The file number assigned to the initial financing statement to
39 which the record relates; and

40 (2) If the correction statement relates to a record filed or recorded
41 in a filing office described in paragraph (a) of subsection 1 of section 73
42 of this act, the date that the initial financing statement was filed or

1 recorded and the information specified in subsection 2 of section 74 of
2 this act;

3 (b) Indicate that it is a correction statement; and

4 (c) Provide the basis for the person's belief that the record is
5 inaccurate and indicate the manner in which he believes the record
6 should be amended to cure any inaccuracy or provide the basis for his
7 belief that the record was wrongfully filed.

8 3. The filing of a correction statement does not affect the
9 effectiveness of an initial financing statement or other filed record.

10 **Sec. 91. 1.** For each record filed in a filing office, the filing office
11 shall:

12 (a) Assign a unique number to the filed record;

13 (b) Create a record that bears the number assigned to the filed record
14 and the date and time of filing;

15 (c) Maintain the filed record for public inspection; and

16 (d) Index the filed record in accordance with subsections 3, 4 and 5.

17 2. Except as otherwise provided in subsection 9, a file number
18 assigned after January 1, 2002, may include a digit that:

19 (a) Is mathematically derived from or related to the other digits of the
20 file number; and

21 (b) Enables the filing office to detect whether a number
22 communicated as the file number includes a single-digit or
23 transpositional error.

24 3. Except as otherwise provided in subsections 4 and 5, the filing
25 office shall:

26 (a) Index an initial financing statement according to the name of the
27 debtor and index all filed records relating to the initial financing
28 statement in a manner that associates with one another an initial
29 financing statement and all filed records relating to the initial financing
30 statement; and

31 (b) Index a record that provides a name of a debtor which was not
32 previously provided in the financing statement to which the record relates
33 also according to the name that was not previously provided.

34 4. If a financing statement is filed as a fixture filing or covers as-
35 extracted collateral or timber to be cut, it must be filed for record and the
36 filing office shall index it:

37 (a) Under the names of the debtor and of each owner of record shown
38 on the financing statement as if they were the mortgagors under a
39 mortgage of the real property described; and

40 (b) To the extent that the law of this state provides for indexing of
41 mortgages under the name of the mortgagee, under the name of the
42 secured party as if the secured party were the mortgagee thereunder.

1 5. If a financing statement is filed as a fixture filing or covers as-
2 extracted collateral or timber to be cut, the filing office shall index an
3 assignment filed under subsection 1 of section 86 of this act or an
4 amendment filed under subsection 2 of that section:

5 (a) Under the name of the assignor as grantor; and

6 (b) To the extent that the law of this state provides for indexing the
7 assignment of a mortgage of real property under the name of the
8 assignee, under the name of the assignee.

9 6. The filing office shall maintain a capability:

10 (a) To retrieve a record by the name of the debtor and:

11 (1) If the filing office is described in paragraph (a) of subsection 1
12 of section 73 of this act, by the file number assigned to the initial
13 financing statement to which the record relates and the date and time
14 that the record was filed or recorded; or

15 (2) If the filing office is described in paragraph (b) of subsection 1
16 of section 73 of this act, by the file number assigned to the initial
17 financing statement to which the record relates; and

18 (b) To associate and retrieve with one another an initial financing
19 statement and each filed record relating to the initial financing
20 statement.

21 7. The filing office may not remove a debtor's name from the index
22 until 1 year after the effectiveness of a financing statement naming the
23 debtor lapses under section 87 of this act with respect to all secured
24 parties of record.

25 8. The filing office shall perform the acts required by subsections 1
26 to 5, inclusive, within a reasonable time and in the manner prescribed by
27 filing-office rule.

28 9. Subsection 2 does not apply to a filing office described in
29 paragraph (a) of subsection 1 of section 73 of this act.

30 **Sec. 92.** 1. A filing office shall refuse to accept a record for filing
31 for a reason set forth in subsection 2 of section 88 of this act and may
32 refuse to accept a record for filing only for a reason set forth in that
33 subsection.

34 2. If a filing office refuses to accept a record for filing, it shall
35 communicate to the person that presented the record the fact of and
36 reason for the refusal and the date and time the record would have been
37 filed had the filing office accepted it. The communication must be made
38 within a reasonable time and in the manner prescribed by filing-office
39 rule.

40 3. A filed financing statement satisfying subsections 1 and 2 of
41 section 74 of this act is effective, even if the filing office is required to
42 refuse to accept it for filing under subsection 1. However, section 59 of

this act applies to a filed financing statement providing information described in paragraph (e) of subsection 2 of section 88 of this act which is incorrect at the time the financing statement is filed.

4. If a record communicated to a filing office provides information that relates to more than one debtor, this part applies to each debtor separately.

11 (a) *May reduce a claim to judgment, foreclose, or otherwise enforce*
12 *the claim, security interest, or agricultural lien by any available judicial*
13 *procedure; and*

14 (b) *If the collateral is documents, may proceed either as to the*
15 *documents or as to the goods they cover.*

16 2. *A secured party in possession of collateral or control of collateral*
17 *under section 5, 6, 7, or 8 of this act has the rights and duties provided in*
18 *section 18 of this act.*

19 3. *The rights under subsections 1 and 2 are cumulative and may be*
20 *exercised simultaneously.*

21 4. *Except as otherwise provided in subsection 7 and section 104 of*
22 *this act, after default, a debtor and an obligor have the rights provided in*
23 *this part and by agreement of the parties.*

24 5. *If a secured party has reduced its claim to judgment, the lien of*
25 *any levy that may be made upon the collateral by virtue of an execution*
26 *based upon the judgment relates back to the earliest of:*

27 (a) *The date of perfection of the security interest or agricultural lien*
28 *in the collateral;*

29 (b) *The date of filing a financing statement covering the collateral; or*

30 (c) *Any date specified in a statute under which the agricultural lien*
31 *was created.*

32 6. *A sale pursuant to an execution is a foreclosure of the security*
33 *interest or agricultural lien by judicial procedure within the meaning of*
34 *this section. A secured party may purchase at the sale and thereafter hold*
35 *the collateral free of any other requirements of this article.*

36 7. *Except as otherwise provided in subsection 3 of section 106 of this*
37 *act, this part imposes no duties upon a secured party that is a consignor*
38 *or is a buyer of accounts, chattel paper, payment intangibles, or*
39 *promissory notes.*

40 **Sec. 101.** *Except as otherwise provided in section 123 of this act, to*
41 *the extent that they give rights to a debtor or obligor and impose duties*
42 *on a secured party, the debtor or obligor may not waive or vary the rules*
43 *stated in the following listed sections:*

1 1. Subparagraph (3) of paragraph (d) of subsection 2 of section 18 of
2 this act, which deals with use and operation of the collateral by the
3 secured party;

4 2. Section 21 of this act, which deals with requests for an accounting
5 and requests concerning a list of collateral and statement of account;

6 3. Subsection 3 of section 106 of this act, which deals with collection
7 and enforcement of collateral;

8 4. Subsection 1 of section 107 of this act and subsection 3 of section
9 114 of this act to the extent that they deal with application or payment of
10 noncash proceeds of collection, enforcement, or disposition;

11 5. Subsection 1 of section 107 of this act and subsection 4 of section
12 114 of this act to the extent that they require accounting for or payment
13 of surplus proceeds of collateral;

14 6. Section 108 of this act to the extent that it imposes upon a secured
15 party that takes possession of collateral without judicial process the duty
16 to do so without breach of the peace;

17 7. Subsection 2 of section 109, and sections 110, 112, and 113 of this
18 act, which deal with disposition of collateral;

19 8. Subsection 6 of section 114 of this act, which deals with
20 calculation of a deficiency or surplus when a disposition is made to the
21 secured party, a person related to the secured party, or a secondary
22 obligor;

23 9. Section 115 of this act, which deals with explanation of the
24 calculation of a surplus or deficiency;

25 10. Sections 119, 120, and 121 of this act, which deal with
26 acceptance of collateral in satisfaction of obligation;

27 11. Section 122 of this act, which deals with redemption of collateral;

28 12. Section 123 of this act, which deals with permissible waivers; and

29 13. Sections 124 and 125 of this act, which deal with the secured
30 party's liability for failure to comply with this article.

31 **Sec. 102.** 1. The parties may determine by agreement the
32 standards measuring the fulfillment of the rights of a debtor or obligor
33 and the duties of a secured party under a rule stated in section 101 of this
34 act if the standards are not manifestly unreasonable.

35 2. Subsection 1 does not apply to the duty under section 108 of this
36 act to refrain from breaching the peace.

37 **Sec. 103.** 1. If a security agreement covers both personal and real
38 property, a secured party may proceed:

39 (a) Under this part as to the personal property without prejudicing any
40 rights with respect to the real property; or

41 (b) As to both the personal property and the real property in
42 accordance with the rights with respect to the real property, in which case
43 the other provisions of this part do not apply.

1 2. Subject to subsection 3, if a security agreement covers goods that
2 are or become fixtures, a secured party may proceed:

3 (a) Under this part; or

4 (b) In accordance with the rights with respect to real property, in
5 which case the other provisions of this part do not apply.

6 3. Subject to the other provisions of this part, if a secured party
7 holding a security interest in fixtures has priority over all owners and
8 encumbrancers of the real property, the secured party, after default, may
9 remove the collateral from the real property.

10 4. A secured party that removes collateral shall promptly reimburse
11 any encumbrancer or owner of the real property, other than the debtor,
12 for the cost of repair of any physical injury caused by the removal. The
13 secured party need not reimburse the encumbrancer or owner for any
14 diminution in value of the real property caused by the absence of the
15 goods removed or by any necessity of replacing them. A person entitled to
16 reimbursement may refuse permission to remove until the secured party
17 gives adequate assurance for the performance of the obligation to
18 reimburse.

19 **Sec. 104.** A secured party does not owe a duty based on its status as
20 secured party:

21 1. To a person that is a debtor or obligor, unless the secured party
22 knows:

23 (a) That he is a debtor or obligor;

24 (b) His identity; and

25 (c) How to communicate with him; or

26 2. To a secured party or lienholder that has filed a financing
27 statement against a person, unless the secured party knows:

28 (a) That the person is a debtor; and

29 (b) His identity.

30 **Sec. 105.** For purposes of this part, a default occurs in connection
31 with an agricultural lien at the time the secured party becomes entitled to
32 enforce the lien in accordance with the statute under which it was
33 created.

34 **Sec. 106.** 1. If so agreed, and in any event after default, a secured
35 party:

36 (a) May notify an account debtor or other person obligated on
37 collateral to make payment or otherwise render performance to or for the
38 benefit of the secured party;

39 (b) May take any proceeds to which the secured party is entitled under
40 section 36 of this act;

41 (c) May enforce the obligations of an account debtor or other person
42 obligated on collateral and exercise the rights of the debtor with respect
43 to the obligation of the account debtor or other person obligated on

1 collateral to make payment or otherwise render performance to the
2 debtor, and with respect to any property that secures the obligations of
3 the account debtor or other person obligated on the collateral;

4 (d) If it holds a security interest in a deposit account perfected by
5 control under paragraph (a) of subsection 1 of section 5 of this act, may
6 apply the balance of the deposit account to the obligation secured by the
7 deposit account; and

8 (e) If it holds a security interest in a deposit account perfected by
9 control under paragraph (b) or (c) of subsection 1 of section 5 of this act,
10 may instruct the bank to pay the balance of the deposit account to or for
11 the benefit of the secured party.

12 2. If necessary to enable a secured party to exercise under paragraph
13 (c) of subsection 1 the right of a debtor to enforce a mortgage
14 nonjudicially, the secured party may record in the office in which the
15 mortgage is recorded:

16 (a) A copy of the security agreement that creates or provides for a
17 security interest in the obligation secured by the mortgage; and

18 (b) The secured party's sworn affidavit in recordable form stating
19 that:

20 (1) A default has occurred; and

21 (2) The secured party is entitled to enforce the mortgage
22 nonjudicially.

23 3. A secured party shall proceed in a commercially reasonable
24 manner if the secured party:

25 (a) Undertakes to collect from or enforce an obligation of an account
26 debtor or other person obligated on collateral; and

27 (b) Is entitled to charge back uncollected collateral or otherwise to full
28 or limited recourse against the debtor or a secondary obligor.

29 4. A secured party may deduct from the collections made pursuant to
30 subsection 3 reasonable expenses of collection and enforcement,
31 including reasonable attorney's fees and legal expenses incurred by the
32 secured party.

33 5. This section does not determine whether an account debtor, bank,
34 or other person obligated on collateral owes a duty to a secured party.

35 **Sec. 107.** 1. If a security interest or agricultural lien secures
36 payment or performance of an obligation, the following rules apply:

37 (a) A secured party shall apply or pay over for application the cash
38 proceeds of collection or enforcement under this section in the following
39 order to:

40 (1) The reasonable expenses of collection and enforcement and, to
41 the extent provided for by agreement and not prohibited by law,
42 reasonable attorney's fees and legal expenses incurred by the secured
43 party;

1 (2) *The satisfaction of obligations secured by the security interest or*
2 *agricultural lien under which the collection or enforcement is made; and*

3 (3) *The satisfaction of obligations secured by any subordinate*
4 *security interest in or other lien on the collateral subject to the security*
5 *interest or agricultural lien under which the collection or enforcement is*
6 *made if the secured party receives an authenticated demand for proceeds*
7 *before distribution of the proceeds is completed.*

8 (b) *If requested by a secured party, a holder of a subordinate security*
9 *interest or other lien shall furnish reasonable proof of the interest or lien*
10 *within a reasonable time. Unless the holder complies, the secured party*
11 *need not comply with the holder's demand under subparagraph (3) of*
12 *paragraph (a).*

13 (c) *A secured party need not apply or pay over for application noncash*
14 *proceeds of collection and enforcement under this section unless the*
15 *failure to do so would be commercially unreasonable. A secured party*
16 *that applies or pays over for application noncash proceeds shall do so in*
17 *a commercially reasonable manner.*

18 (d) *A secured party shall account to and pay a debtor for any surplus,*
19 *and the obligor is liable for any deficiency.*

20 2. *If the underlying transaction is a sale of accounts, chattel paper,*
21 *payment intangibles, or promissory notes, the debtor is not entitled to any*
22 *surplus, and the obligor is not liable for any deficiency.*

23 **Sec. 108.** 1. *After default, a secured party:*

24 (a) *May take possession of the collateral;*

25 (b) *If a debtor so agrees, may require the debtor to assemble the*
26 *collateral and make it available to the secured party at a place to be*
27 *designated by the secured party which is reasonably convenient to both*
28 *parties; and*

29 (c) *Without removal may render equipment unusable and dispose of*
30 *collateral on a debtor's premises under section 109 of this act.*

31 2. *A secured party may proceed under subsection 1:*

32 (a) *Pursuant to judicial process; or*

33 (b) *Without judicial process, if it proceeds without breach of the*
34 *peace.*

35 **Sec. 109.** 1. *After default, a secured party may sell, lease, license,*
36 *or otherwise dispose of any or all of the collateral in its present condition*
37 *or following any commercially reasonable preparation or processing.*

38 2. *Every aspect of a disposition of collateral, including the method,*
39 *manner, time, place, and other terms, must be commercially reasonable.*
40 *If commercially reasonable, a secured party may dispose of collateral by*
41 *public or private proceedings, by one or more contracts, as a unit or in*
42 *parcels, and at any time and place and on any terms.*

43 3. *A secured party may purchase collateral:*

- 1 (a) At a public sale; or
- 2 (b) At a private sale only if the collateral is of a kind that is
- 3 customarily sold on a recognized market or the subject of widely
- 4 distributed standard price quotations.

5 4. A contract for sale, lease, license, or other disposition includes the

6 warranties relating to title, possession, quiet enjoyment, and the like

7 which by operation of law accompany a voluntary disposition of property

8 of the kind subject to the contract.

9 5. A secured party may disclaim or modify warranties under

10 subsection 4:

11 (a) In a manner that would be effective to disclaim or modify the

12 warranties in a voluntary disposition of property of the kind subject to the

13 contract of disposition; or

14 (b) By communicating to the purchaser a record evidencing the

15 contract for disposition and including an express disclaimer or

16 modification of the warranties.

17 6. A record is sufficient to disclaim warranties under subsection 5 if

18 it indicates “There is no warranty relating to title, possession, quiet

19 enjoyment, or the like in this disposition” or uses words of similar

20 import.

21 **Sec. 110. 1.** In this section, “notification date” means the earlier

22 of the date on which:

23 (a) A secured party sends to the debtor and any secondary obligor an

24 authenticated notification of disposition; or

25 (b) The debtor and any secondary obligor waive the right to

26 notification.

27 2. Except as otherwise provided in subsection 4, a secured party that

28 disposes of collateral under section 109 of this act shall send to the

29 persons specified in subsection 3 a reasonable authenticated notification

30 of disposition.

31 3. To comply with subsection 2, the secured party shall send an

32 authenticated notification of disposition to:

33 (a) The debtor;

34 (b) Any secondary obligor; and

35 (c) If the collateral is other than consumer goods:

36 (1) Any other person from which the secured party has received,

37 before the notification date, an authenticated notification of a claim of

38 an interest in the collateral;

39 (2) Any other secured party or lienholder that, 10 days before the

40 notification date, held a security interest in or other lien on the collateral

41 perfected by the filing of a financing statement that:

42 (I) Identified the collateral;

43 (II) Was indexed under the debtor’s name as of that date; and

1 (III) Was filed in the office in which to file a financing statement
2 against the debtor covering the collateral as of that date; and

3 (3) Any other secured party that, 10 days before the notification
4 date, held a security interest in the collateral perfected by compliance
5 with a statute, regulation, or treaty described in subsection 1 of section 32
6 of this act.

7 4. Subsection 2 does not apply if the collateral is perishable or
8 threatens to decline speedily in value or is of a type customarily sold on a
9 recognized market.

10 5. A secured party complies with the requirement for notification
11 prescribed by subparagraph (2) of paragraph (c) of subsection 3 if:

12 (a) Not later than 20 days or earlier than 30 days before the
13 notification date, the secured party requests, in a commercially
14 reasonable manner, information concerning financing statements
15 indexed under the debtor's name in the office indicated in that
16 subparagraph; and

17 (b) Before the notification date, the secured party:

18 (1) Did not receive a response to the request for information; or

19 (2) Received a response to the request for information and sent an
20 authenticated notification of disposition to each secured party named in
21 that response whose financing statement covered the collateral.

22 **Sec. 111.** 1. Except as otherwise provided in subsection 2, whether
23 a notification is sent within a reasonable time is a question of fact.

24 2. In a transaction other than a consumer transaction, a notification
25 of disposition sent after default and 10 days or more before the earliest
26 time of disposition set forth in the notification is sent within a reasonable
27 time before the disposition.

28 **Sec. 112.** Except in a consumer-goods transaction, the following
29 rules apply:

30 1. The contents of a notification of disposition are sufficient if the
31 notification:

32 (a) Describes the debtor and the secured party;

33 (b) Describes the collateral that is the subject of the intended
34 disposition;

35 (c) States the method of intended disposition;

36 (d) States that the debtor is entitled to an accounting of the unpaid
37 indebtedness and states the charge, if any, for an accounting; and

38 (e) States the time and place of a public sale or the time after which
39 any other disposition is to be made.

40 2. Whether the contents of a notification that lacks any of the
41 information specified in subsection 1 are nevertheless sufficient is a
42 question of fact.

1 3. The contents of a notification providing substantially the
2 information specified in subsection 1 are sufficient, even if the
3 notification includes:
4 (a) Information not specified by that subsection; or
5 (b) Minor errors that are not seriously misleading.
6 4. A particular phrasing of the notification is not required.
7 5. The following form of notification and the form appearing in
8 subsection 3 of section 113 of this act, when completed, each provides
9 sufficient information:

12 person to which the notification is

27 You are entitled to an accounting of the unpaid indebtedness secured by
28 the property that we intend to sell [or lease or license, as applicable] [for
29 a charge of \$___]. You may request an accounting by calling us at
30 [telephone number].

31 **Sec. 113.** In a consumer-goods transaction, the following rules
32 apply:

33 1. A notification of disposition must provide the following
34 information:

35 (a) The information specified in subsection 1 of section 112 of this
36 act;

37 (b) A description of any liability for a deficiency of the person to
38 which the notification is sent;

39 (c) A telephone number from which the amount that must be paid to
40 the secured party to redeem the collateral under section 122 of this act is
41 available; and
42
43

1 (d) A telephone number or mailing address from which additional
2 information concerning the disposition and the obligation secured is
3 available.

4 2. A particular phrasing of the notification is not required.

5 3. The following form of notification, when completed, provides
6 sufficient information:

9 NOTICE OF OUR PLAN TO SELL PROPERTY

10 [Name and address of any obligor who is also a debtor]

11 Subject: [Identification of Transaction]

13 We have your [describe collateral], because you broke promises in our

9 *4. A notification in the form of subsection 3 is sufficient, even if*
10 *additional information appears at the end of the form.*

11 *5. A notification in the form of subsection 3 is sufficient, even if it*
12 *includes errors in information not required by subsection 1, unless the*
13 *error is misleading with respect to rights arising under this article.*

14 *6. If a notification under this section is not in the form of subsection*
15 *3, law other than this article determines the effect of including*
16 *information not required by subsection 1.*

17 **Sec. 114. 1.** *A secured party shall apply or pay over for application*
18 *the cash proceeds of disposition in the following order to:*

19 *(a) The reasonable expenses of retaking, holding, preparing for*
20 *disposition, processing, and disposing, and, to the extent provided for by*
21 *agreement and not prohibited by law, reasonable attorney's fees and*
22 *legal expenses incurred by the secured party;*

23 *(b) The satisfaction of obligations secured by the security interest or*
24 *agricultural lien under which the disposition is made;*

25 *(c) The satisfaction of obligations secured by any subordinate security*
26 *interest in or other subordinate lien on the collateral if:*

27 *(1) The secured party receives from the holder of the subordinate*
28 *security interest or other lien an authenticated demand for proceeds*
29 *before distribution of the proceeds is completed; and*

30 *(2) In a case in which a consignor has an interest in the collateral,*
31 *the subordinate security interest or other lien is senior to the interest of*
32 *the consignor; and*

33 *(d) A secured party that is a consignor of the collateral if the secured*
34 *party receives from the consignor an authenticated demand for proceeds*
35 *before distribution of the proceeds is completed.*

36 *2. If requested by a secured party, a holder of a subordinate security*
37 *interest or other lien shall furnish reasonable proof of the interest or lien*
38 *within a reasonable time. Unless the holder does so, the secured party*
39 *need not comply with the holder's demand under paragraph (c) of*
40 *subsection 1.*

41 *3. A secured party need not apply or pay over for application*
42 *noncash proceeds of disposition under this section unless the failure to*
43 *do so would be commercially unreasonable. A secured party that applies*

1 *or pays over for application noncash proceeds shall do so in a*
2 *commercially reasonable manner.*

3 *4. If the security interest under which a disposition is made secures*
4 *payment or performance of an obligation, after making the payments*
5 *and applications required by subsection 1 and permitted by subsection 3:*

6 *(a) Unless paragraph (d) of subsection 1 requires the secured party to*
7 *apply or pay over cash proceeds to a consignor, the secured party shall*
8 *account to and pay a debtor for any surplus; and*

9 *(b) The obligor is liable for any deficiency.*

10 *5. If the underlying transaction is a sale of accounts, chattel paper,*
11 *payment intangibles, or promissory notes:*

12 *(a) The debtor is not entitled to any surplus; and*

13 *(b) The obligor is not liable for any deficiency.*

14 *6. The surplus or deficiency following a disposition is calculated*
15 *based on the amount of proceeds that would have been realized in a*
16 *disposition complying with this part to a transferee other than the*
17 *secured party, a person related to the secured party, or a secondary*
18 *obligor if:*

19 *(a) The transferee in the disposition is the secured party, a person*
20 *related to the secured party, or a secondary obligor; and*

21 *(b) The amount of proceeds of the disposition is significantly below*
22 *the range of proceeds that a complying disposition to a person other than*
23 *the secured party, a person related to the secured party, or a secondary*
24 *obligor would have brought.*

25 *7. A secured party that receives cash proceeds of a disposition in*
26 *good faith and without knowledge that the receipt violates the rights of*
27 *the holder of a security interest or other lien that is not subordinate to the*
28 *security interest or agricultural lien under which the disposition is made:*

29 *(a) Takes the cash proceeds free of the security interest or other lien;*

30 *(b) Is not obligated to apply the proceeds of the disposition to the*
31 *satisfaction of obligations secured by the security interest or other lien;*
32 *and*

33 *(c) Is not obligated to account to or pay the holder of the security*
34 *interest or other lien for any surplus.*

35 **Sec. 115. 1. In this section:**

36 *(a) “Explanation” means a writing that:*

37 *(1) States the amount of the surplus or deficiency;*

38 *(2) Provides an explanation in accordance with subsection 3 of how*
39 *the secured party calculated the surplus or deficiency;*

40 *(3) States, if applicable, that future debits, credits, charges,*
41 *including additional credit service charges or interest rebates, and*
42 *expenses may affect the amount of the surplus or deficiency; and*

1 (4) Provides a telephone number or mailing address from which
2 additional information concerning the transaction is available.

3 (b) “Request” means a record:

4 (1) Authenticated by a debtor or consumer obligor;

5 (2) Requesting that the recipient provide an explanation; and

6 (3) Sent after disposition of the collateral under section 109 of this
7 act.

8 2. In a consumer-goods transaction in which the debtor is entitled to
9 a surplus or a consumer obligor is liable for a deficiency under section
10 114 of this act, the secured party shall:

11 (a) Send an explanation to the debtor or consumer obligor, as
12 applicable, after the disposition and:

13 (1) Before or when the secured party accounts to the debtor and
14 pays any surplus or first makes written demand on the consumer obligor
15 after the disposition for payment of the deficiency; and

16 (2) Within 14 days after receipt of a request; or

17 (b) In the case of a consumer obligor who is liable for a deficiency,
18 within 14 days after receipt of a request, send to the consumer obligor a
19 record waiving the secured party’s right to a deficiency.

20 3. To comply with subparagraph (2) of paragraph (a) of subsection
21 1, a writing must provide the following information in the following
22 order:

23 (a) The aggregate amount of obligations secured by the security
24 interest under which the disposition was made, and, if the amount
25 reflects a rebate of unearned interest or credit service charge, an
26 indication of that fact, calculated as of a specified date:

27 (1) If the secured party takes or receives possession of the collateral
28 after default, not more than 35 days before the secured party takes or
29 receives possession; or

30 (2) If the secured party takes or receives possession of the collateral
31 before default or does not take possession of the collateral, not more than
32 35 days before the disposition;

33 (b) The amount of proceeds of the disposition;

34 (c) The aggregate amount of the obligations after deducting the
35 amount of proceeds;

36 (d) The amount, in the aggregate or by type, and types of expenses,
37 including expenses of retaking, holding, preparing for disposition,
38 processing, and disposing of the collateral, and attorney’s fees secured by
39 the collateral which are known to the secured party and relate to the
40 current disposition;

41 (e) The amount, in the aggregate or by type, and types of credits,
42 including rebates of interest or credit service charges, to which the

1 *obligor is known to be entitled and which are not reflected in the amount*
2 *in paragraph (a); and*

3 *(f) The amount of the surplus or deficiency.*

4 *4. A particular phrasing of the explanation is not required. An*
5 *explanation complying substantially with the requirements of paragraph*
6 *(a) of subsection 1 is sufficient, even if it includes minor errors that are*
7 *not seriously misleading.*

8 *5. A debtor or consumer obligor is entitled without charge to one*
9 *response to a request under this section during any 6-month period in*
10 *which the secured party did not send to the debtor or consumer obligor*
11 *an explanation pursuant to paragraph (a) of subsection 2. The secured*
12 *party may require payment of a charge not exceeding \$25 for each*
13 *additional response.*

14 **Sec. 116. 1. A secured party's disposition of collateral after**
15 **default:**

16 *(a) Transfers to a transferee for value all of the debtor's rights in the*
17 *collateral;*

18 *(b) Discharges the security interest under which the disposition is*
19 *made; and*

20 *(c) Discharges any subordinate security interest or other subordinate*
21 *lien.*

22 *2. A transferee that acts in good faith takes free of the rights and*
23 *interests described in subsection 1, even if the secured party fails to*
24 *comply with this article or the requirements of any judicial proceeding.*

25 *3. If a transferee does not take free of the rights and interests*
26 *described in subsection 1, he takes the collateral subject to:*

27 *(a) The debtor's rights in the collateral;*

28 *(b) The security interest or agricultural lien under which the*
29 *disposition is made; and*

30 *(c) Any other security interest or other lien.*

31 **Sec. 117. 1. A secondary obligor acquires the rights and becomes**
32 **obligated to perform the duties of the secured party after the secondary**
33 **obligor:**

34 *(a) Receives an assignment of a secured obligation from the secured*
35 *party;*

36 *(b) Receives a transfer of collateral from the secured party and agrees*
37 *to accept the rights and assume the duties of the secured party; or*

38 *(c) Is subrogated to the rights of a secured party with respect to*
39 *collateral.*

40 *2. An assignment, transfer, or subrogation described in subsection 1:*

41 *(a) Is not a disposition of collateral under section 109 of this act; and*

42 *(b) Relieves the secured party of further duties under this article.*

1 **Sec. 118. 1.** *In this section, “transfer statement” means a record*
2 *authenticated by a secured party stating:*

3 *(a) That the debtor has defaulted in connection with an obligation*
4 *secured by specified collateral;*

5 *(b) That the secured party has exercised its post-default remedies with*
6 *respect to the collateral;*

7 *(c) That, by reason of the exercise, a transferee has acquired the*
8 *rights of the debtor in the collateral; and*

9 *(d) The name and mailing address of the secured party, debtor, and*
10 *transferee.*

11 **2.** *A transfer statement entitles the transferee to the transfer of*
12 *record of all rights of the debtor in the collateral specified in the*
13 *statement in any official filing, recording, registration, or certificate-of-*
14 *title system covering the collateral. If a transfer statement is presented*
15 *with the applicable fee and request form to the official or office*
16 *responsible for maintaining the system, the official or office shall:*

17 *(a) Accept the transfer statement;*

18 *(b) Promptly amend its records to reflect the transfer; and*

19 *(c) If applicable, issue a new appropriate certificate of title in the*
20 *name of the transferee.*

21 **3.** *A transfer of the record or legal title to collateral to a secured*
22 *party under subsection 2 or otherwise is not of itself a disposition of*
23 *collateral under this article and does not of itself relieve the secured party*
24 *of its duties under this article.*

25 **Sec. 119. 1.** *Except as otherwise provided in subsection 7, a*
26 *secured party may accept collateral in full or partial satisfaction of the*
27 *obligation it secures only if:*

28 *(a) The debtor consents to the acceptance under subsection 3;*

29 *(b) The secured party does not receive, within the time set forth in*
30 *subsection 5, a notification of objection to the proposal authenticated by:*

31 *(1) A person to which the secured party was required to send a*
32 *proposal under section 120 of this act; or*

33 *(2) Any other person, other than the debtor, holding an interest in*
34 *the collateral subordinate to the security interest that is the subject of the*
35 *proposal;*

36 *(c) If the collateral is consumer goods, the collateral is not in the*
37 *possession of the debtor when the debtor consents to the acceptance; and*

38 *(d) Subsection 5 does not require the secured party to dispose of the*
39 *collateral.*

40 **2.** *A purported or apparent acceptance of collateral under this*
41 *section is ineffective unless:*

42 *(a) The secured party consents to the acceptance in an authenticated*
43 *record or sends a proposal to the debtor; and*

1 (b) *The conditions of subsection 1 are met.*

2 3. *For purposes of this section:*

3 (a) *A debtor consents to an acceptance of collateral in partial*
4 *satisfaction of the obligation it secures only if he agrees to the terms of*
5 *the acceptance in a record authenticated after default; and*

6 (b) *A debtor consents to an acceptance of collateral in full satisfaction*
7 *of the obligation it secures only if he agrees to the terms of the*
8 *acceptance in a record authenticated after default or the secured party:*

9 (1) *Sends to the debtor after default a proposal that is unconditional*
10 *or subject only to a condition that collateral not in the possession of the*
11 *secured party be preserved or maintained;*

12 (2) *In the proposal, proposes to accept collateral in full satisfaction*
13 *of the obligation it secures; and*

14 (3) *Does not receive a notification of objection authenticated by the*
15 *debtor within 20 days after the proposal is sent.*

16 4. *To be effective under paragraph (b) of subsection 1, a notification*
17 *of objection must be received by the secured party:*

18 (a) *In the case of a person to which the proposal was sent pursuant to*
19 *section 120 of this act, within 20 days after notification was sent to him;*
20 *and*

21 (b) *In other cases:*

22 (1) *Within 20 days after the last notification was sent pursuant to*
23 *section 120 of this act; or*

24 (2) *If a notification was not sent, before the debtor consents to the*
25 *acceptance under subsection 3.*

26 5. *A secured party that has taken possession of collateral shall*
27 *dispose of the collateral pursuant to section 109 of this act within the*
28 *time specified in subsection 6 if:*

29 (a) *Sixty percent of the cash price has been paid in the case of a*
30 *purchase-money security interest in consumer goods; or*

31 (b) *Sixty percent of the principal amount of the obligation secured has*
32 *been paid in the case of a non-purchase-money security interest in*
33 *consumer goods.*

34 6. *To comply with subsection 5, the secured party shall dispose of the*
35 *collateral:*

36 (a) *Within 90 days after taking possession; or*

37 (b) *Within any longer period to which the debtor and all secondary*
38 *obligors have agreed in an agreement to that effect entered into and*
39 *authenticated after default.*

40 7. *In a consumer transaction, a secured party may not accept*
41 *collateral in partial satisfaction of the obligation it secures.*

1 **Sec. 120.** 1. A secured party that desires to accept collateral in full
2 or partial satisfaction of the obligation it secures shall send its proposal
3 to:

4 (a) Any person from which the secured party has received, before the
5 debtor consented to the acceptance, an authenticated notification of a
6 claim of an interest in the collateral;

7 (b) Any other secured party or lienholder that, 10 days before the
8 debtor consented to the acceptance, held a security interest in or other
9 lien on the collateral perfected by the filing of a financing statement that:

10 (1) Identified the collateral;

11 (2) Was indexed under the debtor's name as of that date; and

12 (3) Was filed in the office or offices in which to file a financing
13 statement against the debtor covering the collateral as of that date; and
14 (c) Any other secured party that, 10 days before the debtor consented
15 to the acceptance, held a security interest in the collateral perfected by
16 compliance with a statute, regulation, or treaty described in subsection 1
17 of section 32 of this act.

18 2. A secured party that desires to accept collateral in partial
19 satisfaction of the obligation it secures shall send its proposal to any
20 secondary obligor in addition to the persons described in subsection 1.

21 **Sec. 121.** 1. A secured party's acceptance of collateral in full or
22 partial satisfaction of the obligation it secures:

23 (a) Discharges the obligation to the extent consented to by the debtor;

24 (b) Transfers to the secured party all of a debtor's rights in the
25 collateral;

26 (c) Discharges the security interest or agricultural lien that is the
27 subject of the debtor's consent and any subordinate security interest or
28 other subordinate lien; and

29 (d) Terminates any other subordinate interest.

30 2. A subordinate interest is discharged or terminated under
31 subsection 1 even if the secured party fails to comply with this article.

32 **Sec. 122.** 1. A debtor, any secondary obligor, or any other secured
33 party or lienholder may redeem collateral.

34 2. To redeem collateral, a person must tender:

13 12. “Creditor” includes a general creditor, a secured creditor, a lien
14 creditor and any representative of creditors, including an assignee for the
15 benefit of creditors, a trustee in bankruptcy, a receiver in equity and an
16 executor or administrator of an insolvent debtor’s or assignor’s estate.

17 13. “Defendant” includes a person in the position of defendant in a
18 cross-action or counterclaim.

19 14. “Delivery” with respect to instruments, documents of title, chattel
20 paper or securities means voluntary transfer of possession.

21 15. “Document of title” includes bill of lading, dock warrant, dock
22 receipt, warehouse receipt or order for the delivery of goods, and also any
23 other document which in the regular course of business or financing is
24 treated as adequately evidencing that the person in possession of it is
25 entitled to receive, hold and dispose of the document and the goods it
26 covers. To be a document of title a document must purport to be issued by
27 or addressed to a bailee and purport to cover goods in the bailee’s
28 possession which are either identified or are fungible portions of an
29 identified mass.

30 16. “Fault” means wrongful act, omission or breach.

31 17. “Fungible” with respect to goods or securities means goods or
32 securities of which any unit is, by nature or usage of trade, the equivalent of
33 any other like unit. Goods which are not fungible shall be deemed fungible
34 for the purposes of this chapter to the extent that under a particular
35 agreement or document unlike units are treated as equivalents.

36 18. “Genuine” means free of forgery or counterfeiting.

37 19. “Good faith” means honesty in fact in the conduct or transaction
38 concerned.

39 20. “Holder” with respect to a negotiable instrument means the person
40 in possession if the instrument is payable to bearer or, in the case of an
41 instrument payable to an identified person, if the identified person is in
42 possession. “Holder” with respect to a document of title means the person

1 in possession if the goods are deliverable to bearer or to the order of the
2 person in possession.

3 21. To “honor” is to pay or to accept and pay, or where a credit so
4 engages to purchase or discount a draft complying with the terms of the
5 credit.

6 22. “Insolvency proceedings” includes any assignment for the benefit
7 of creditors or other proceedings intended to liquidate or rehabilitate the
8 estate of the person involved.

9 23. A person is “insolvent” who either has ceased to pay his debts in
10 the ordinary course of business or cannot pay his debts as they become due
11 or is insolvent within the meaning of the federal bankruptcy law.

12 24. “Money” means a medium of exchange authorized or adopted by a
13 domestic or foreign government and includes a monetary unit of account
14 established by an intergovernmental organization or by agreement between
15 two or more nations.

16 25. A person has “notice” of a fact when:

17 (a) He has actual knowledge of it;

18 (b) He has received a notice or notification of it; or

19 (c) From all the facts and circumstances known to him at the time in
20 question he has reason to know that it exists.

21 A person “knows” or has “knowledge” of a fact when he has actual
22 knowledge of it. “Discover” or “learn” or a word or phrase of similar
23 import refers to knowledge rather than to reason to know. The time and
24 circumstances under which a notice or notification may cease to be
25 effective are not determined by this chapter.

26 26. A person “notifies” or “gives” a notice or notification to another by
27 taking such steps as may be reasonably required to inform the other in
28 ordinary course whether or not such other actually comes to know of it. A
29 person “receives” a notice or notification when:

30 (a) It comes to his attention; or

31 (b) It is delivered at the place of business through which the contract
32 was made or at any other place held out by him as the place for receipt of
33 such communications.

34 27. Notice, knowledge or a notice or notification received by an
35 organization is effective for a particular transaction from the time when it is
36 brought to the attention of the person conducting that transaction, and in
37 any event from the time when it would have been brought to his attention if
38 the organization had exercised due diligence. An organization exercises due
39 diligence if it maintains reasonable routines for communicating significant
40 information to the person conducting the transaction and there is reasonable
41 compliance with the routines. Due diligence does not require a person
42 acting for the organization to communicate information unless such
43 communication is part of his regular duties or unless he has reason to know

1 of the transaction and that the transaction would be materially affected by
2 the information.

3 28. “Organization” includes a corporation, government or
4 governmental subdivision or agency, business trust, estate, trust,
5 partnership or association, two or more persons having a joint or common
6 interest, or any other legal or commercial entity.

7 29. “Party,” as distinct from “third party,” means a person who has
8 engaged in a transaction or made an agreement within this chapter or
9 chapter 104A of NRS.

10 30. “Presumption” or “presumed” means that the trier of fact must find
11 the existence of the fact presumed unless and until evidence is introduced
12 which would support a finding of its nonexistence.

13 31. “Purchase” includes taking by sale, discount, negotiation,
14 mortgage, pledge, lien, **security interest**, issue or reissue, gift or any other
15 voluntary transaction creating an interest in property.

16 32. “Purchaser” means a person who takes by purchase.

17 33. “Remedy” means any remedial right to which an aggrieved party is
18 entitled with or without resort to a tribunal.

19 34. “Representative” includes an agent, an officer of a corporation or
20 association, and a trustee, executor or administrator of an estate, or any
21 other person empowered to act for another.

22 35. “Rights” includes remedies.

23 36. “Security interest” means an interest in personal property or
24 fixtures which secures payment or performance of an obligation. ~~[The~~
25 ~~retention or reservation of title by a seller of goods notwithstanding~~
26 ~~shipment or delivery to the buyer (NRS 104.2401) is limited in effect to a~~
27 ~~reservation of a “security interest.”]~~ The term also includes any interest of a
28 **consignor and a** buyer of accounts, ~~for~~ chattel paper ~~[which]~~, **a payment**
29 **intangible or a promissory note in a transaction that** is subject to ~~[article]~~
30 **Article 9**. The special property interest of a buyer of goods on identification
31 of such goods to a contract for sale under NRS 104.2401 is not a “security
32 interest,” but a buyer may also acquire a “security interest” by complying

26 44. “Unauthorized” signature means one made without actual, implied
27 or apparent authority and includes a forgery.

30 a person gives “value” for rights if he acquires them:

31 (a) In return for a binding commitment to extend credit or for the

16 encumbrancer or owner. If the lessee's right to remove terminates, the
17 priority of the interest of the lessor continues for a reasonable time.

43 physical injury, but not for any diminution in value of the real estate caused

1 by the absence of the goods removed or by any necessity of replacing them.
2 A person entitled to reimbursement may refuse permission to remove until
3 the party seeking removal gives adequate security for the performance of
4 this obligation.

18 **Sec. 173.** The legislative counsel shall reserve for reuse the numbers
19 of the sections repealed by section 172 of this act and, except as otherwise
20 provided in this section, in preparing the 1999 reprint of NRS, shall number
21 the sections of chapter 104 of NRS that are added by sections 2 to 135,
22 inclusive, of this act, and the internal references thereto, to correspond to
23 the numbers assigned to those sections of the Uniform Commercial Code
24 by the National Conference of Commissioners on Uniform State Laws. The
25 legislative counsel shall number the sections added by sections 128 to 134,
26 inclusive, of this act consecutively beginning with NRS 104.901. The
27 reserved numbers not so used are reserved for future use for similar
28 purposes.

29 **Sec. 174.** 1. This section and section 173 of this act become
30 effective upon passage and approval.

31 2. Sections 1 to 172, inclusive, of this act become effective on July 1,
32 2001.

33 3. A governmental agency affected by a provision of sections 1 to 172,
34 inclusive, of this act may test or put into effect a required change before
35 July 1, 2001, if the agency also allows action to be taken under the existing
36 law until that date.
