

SENATE RESOLUTION NO. 9—SENATORS RAGGIO AND TITUS

MAY 25, 1999

Read and Adopted

SUMMARY—Designates certain members of Senate as regular and alternate members of Legislative Commission. (BDR R-1774)

SENATE RESOLUTION—Designating certain members of the Senate as regular and alternate members of the Legislative Commission.

- 1 RESOLVED BY THE SENATE OF THE STATE OF NEVADA, That pursuant to
- 2 the provisions of NRS 218.660 and the Joint Rules of the Legislature,
- 3 Senators Ann O’Connell, Dean A. Rhoads, Jon C. Porter, Michael A.
- 4 Schneider, Valerie Wiener and Alice Costandina Titus are designated as the
- 5 regular Senate members of the Legislative Commission; and be it further
- 6 RESOLVED, That Senators William R. O’Donnell and Maurice E.
- 7 Washington are designated as the first and second alternate members,
- 8 respectively, for Senator Ann O’Connell; Senators Lawrence E. Jacobsen
- 9 and Mark Amodei are designated as the first and second alternate members,
- 10 respectively, for Senator Dean A. Rhoads; and Senators Mike McGinness
- 11 and Randolph J. Townsend are designated as the first and second alternate
- 12 members, respectively, for Senator Jon C. Porter; and be it further
- 13 RESOLVED, That Senators Terry Care and Maggie Carlton are
- 14 designated as the first and second alternate members, respectively, for
- 15 Senators Michael A. Schneider, Valerie Wiener and Alice Costandina
- 16 Titus; and be it further
- 17 RESOLVED, That the procedure for requesting an alternate member to
- 18 replace a regular member during his absence at a meeting, must be as
- 19 follows:
- 20 1. The Secretary of the Legislative Commission shall establish a record
- 21 of service of alternate members at meetings of the Legislative Commission,
- 22 and shall maintain a list of the alternate members for each individual
- 23 Senator or group of Senators. Each list must contain a numerical
- 24 designation in ascending order for each alternate member on the list. The

1 initial sequence in which the alternate members must be listed must
2 correspond to their designation as alternates in this resolution.

3 2. If a regular member of the Legislative Commission is unable to
4 attend a scheduled meeting of the commission, and notifies the Secretary of
5 the Legislative Commission, the Secretary shall request the alternate
6 member with the lowest numerical designation on the appropriate list to
7 replace the regular member at the meeting. If the alternate member does not
8 agree to serve, the Secretary shall make the same request of the alternate
9 member with the next higher numerical designation on the list, and so on
10 through the list until an alternate member agrees to replace the regular
11 member.

12 3. An alternate member who agrees to replace a regular member at a
13 meeting of the Legislative Commission loses the numerical designation he
14 had on the appropriate list at the time he was requested to serve. The
15 Secretary of the Legislative Commission shall, when the alternate member
16 agrees to replace the regular member, assign to that alternate member the
17 highest numerical designation on the appropriate list. At the same time, the
18 Secretary shall also reduce by one the numerical designation in the
19 appropriate list to those alternate members who have higher numerical
20 designations in the appropriate list than the alternate member who has
21 agreed to serve.

22 4. An alternate member who is requested to replace a regular member
23 at a meeting of the Legislative Commission, but who does not agree to
24 replace the regular member, does not lose the numerical designation he had
25 on the appropriate list at the time of the request.
