AN ACT relating to regional planning; authorizing a governing board for regional planning to enter certain cooperative and interlocal agreements; authorizing a governing board for regional planning and a regional planning commission jointly or separately to appoint subcommittees and advisory committees; authorizing a governing board for regional planning and a regional planning commission jointly or separately to appoint advisory committees to assist in the formulation and implementation of the comprehensive regional plan; authorizing a governing board for regional planning and a regional planning commission jointly or separately to appoint advisory committees for regional issues; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** NRS 278.0265 is hereby amended to read as follows:
2 278.0265 The governing board:
3 1. Shall adopt such regulations as are necessary to carry out its specific
4 powers and duties.
5 2. Shall prescribe an appropriate course of at least 12 hours of training
6 in land use planning for the members of the regional planning commission.
7 The course of training must include, without limitation, training relating to:
8 (a) State statutes and regulations and local ordinances, resolutions and
9 regulations concerning land use planning; and
10 (b) The provisions of chapter 241 of NRS.
11 3. May establish and collect reasonable fees for the provision of any
12 service that is authorized pursuant to the provisions of NRS 278.026 to
13 278.029, inclusive.



1 4. *May enter into an agreement pursuant to NRS 277.045 or 277.080*
2 *to 277.180, inclusive, for a purpose that is consistent with the provisions*
3 *of NRS 278.026 to 278.029, inclusive.*
4 **Sec. 2.** NRS 278.0268 is hereby amended to read as follows:
5 278.0268 1. *The governing board and the regional planning*
6 *commission may, jointly or separately, appoint subcommittees for any*
7 *purpose that is consistent with NRS 278.026 to 278.029, inclusive. A*
8 *subcommittee appointed pursuant to this subsection must be composed*
9 *only of:*
10 (a) *Members of the governing board or regional planning*
11 *commission, as appropriate, if the subcommittee is appointed separately;*
12 *or*
13 (b) *Members from both the governing board and the regional*
14 *planning commission, if the subcommittee is appointed jointly.*
15 2. To assist in the formulation *and the implementation* of the
16 *comprehensive regional* plan, the governing board *and the regional*
17 *planning commission* may , *jointly or separately*, appoint advisory
18 committees to advise and report to the *governing board*, regional planning
19 commission ~~H~~ , *director of regional planning or a combination of such*
20 *entities*. No more than three members of the governing board *or regional*
21 *planning commission* may serve on any advisory committee and they must
22 not constitute more than 20 percent of the membership of the committee.
23 3. *The governing board and the regional planning commission may,*
24 *jointly or separately, appoint advisory committees to examine issues that*
25 *affect the county in which the governing board and regional planning*
26 *commission are located. The governing board and regional planning*
27 *commission may appoint persons from outside the county in which the*
28 *governing board and regional planning commission are located and from*
29 *outside this state to serve on an advisory committee appointed pursuant*
30 *to this section. An advisory committee appointed pursuant to this*
31 *subsection may:*
32 (a) *Identify, examine and discuss regional issues that affect the*
33 *county in which the governing board and regional planning commission*
34 *are located, including, without limitation, issues relating to land use,*
35 *fiscal matters, air quality and infrastructure;*
36 (b) *Meet not more than once every calendar quarter at the call of the*
37 *director of regional planning; and*
38 (c) *Make recommendations to the governing board, regional planning*
39 *commission, or both, concerning regional issues.*
40 **Sec. 3.** This act becomes effective on July 1, 2001.
