SUMMARY—Authorizes Nevada silver haired legislative forum to operate independently of
aging services division of department of human resources. (BDR 38-534)

AN ACT relating to aging persons; authorizing the Nevada silver haired legislative forum to
operate independently of the aging services division of the department of human
resources; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 427A of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 ***1. All money received by the Nevada silver haired legislative forum***
4 ***must be deposited in a bank, credit union or other financial institution in***
5 ***this state and paid out on its order for its expenses.***

6 ***2. All expenses incurred by the Nevada silver haired legislative***
7 ***forum in carrying out the provisions of NRS 427A.320 to 427A.400,***
8 ***inclusive, must be paid from an account established pursuant to***
9 ***subsection 1.***

10 **Sec. 2.** NRS 427A.320 is hereby amended to read as follows:

11 427A.320 The ~~division shall establish the~~ Nevada silver haired
12 legislative forum ***is hereby created*** to identify and act upon issues of
13 importance to aging persons.

14 **Sec. 3.** NRS 427A.370 is hereby amended to read as follows:

15 427A.370 The Nevada silver haired legislative forum shall elect from
16 among its members, to serve a term of 1 year:

17 1. A president, who shall conduct meetings and oversee the formation
18 of committees as necessary to accomplish the purposes of the Nevada
19 silver haired legislative forum.



1 2. A vice president, who shall assist the president and conduct
2 meetings of the Nevada silver haired legislative forum if the president is
3 absent or otherwise unable to perform his duties.

4 3. A secretary, who shall:

5 (a) Prepare and keep a record of meetings, including, without limitation,
6 the date, time, place and purpose of every meeting; and

7 (b) At the first meeting every year of the Nevada silver haired
8 legislative forum, prepare a list of the dates of the meetings that are
9 scheduled for the year.

10 4. A treasurer, who shall ~~prepare and keep a list of the expenses of the~~
11 ~~Nevada silver haired legislative forum to be sent to the division for~~
12 ~~payment.] administer any account established pursuant to section 1 of~~
13 ~~this act.~~

14 **Sec. 4.** NRS 427A.390 is hereby amended to read as follows:

15 427A.390 The Nevada silver haired legislative forum may:

16 1. Submit a report containing topics for possible legislative action to
17 the governor before September 1 of each even-numbered year.

18 2. Accept gifts, grants and donations that must be deposited in ~~the~~
19 ~~state treasury for credit to the aging services division's gift account in the~~
20 ~~department of human resources' gift fund. A gift, grant or donation to the~~
21 ~~Nevada silver haired legislative forum may be expended only in carrying~~
22 ~~out the duties of the Nevada silver haired legislative forum.] an account~~
23 ~~established pursuant to section 1 of this act.~~

24 3. Adopt procedures to conduct meetings of the Nevada silver haired
25 legislative forum and committees thereof. ~~These] Those~~ procedures may
26 be changed upon approval of a majority vote of all members of the Nevada
27 silver haired legislative forum who are present and voting.

28 **Sec. 5.** NRS 427A.400 is hereby amended to read as follows:

29 427A.400 Within the limits of legislative appropriations, and any gifts,
30 grants and donations ~~+~~

31 ~~1. The division shall pay the expenses of the Nevada silver haired~~
32 ~~legislative forum.~~

33 ~~2. Each] , each~~ member of the Nevada silver haired legislative forum
34 is entitled to receive for attendance at a meeting of the Nevada silver haired
35 legislative forum or a committee thereof the per diem allowance and travel
36 expenses provided for state officers and employees generally.

37 **Sec. 6.** NRS 427A.410 is hereby repealed.

38 **Sec. 7.** On July 1, 2001, or as soon thereafter as practicable, the state
39 controller shall draw his warrant, payable to the Nevada silver haired
40 legislative forum, for the amount of money ~~in the aging services division's~~
41 ~~gift account in the department of human resources' gift fund~~ that was
42 credited to that account pursuant to NRS 427A.390.

43 **Sec. 8.** This act becomes effective on July 1, 2001.
