SUMMARY—Revises provisions governing metropolitan police departments. (BDR 22-47)

AN ACT relating to metropolitan police departments; revising provisions relating to withdrawal from or dissolution of a department; requiring the approval of the voters for withdrawal from or dissolution of a department; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     **Section 1.** Chapter 280 of NRS is hereby amended by adding thereto  
2     the provisions set forth as sections 2 to 5, inclusive, of this act.  
3     **Sec. 2. 1.** *If a participating political subdivision in a department*  
4     *that consists of three or more participating political subdivisions wishes*  
5     *to withdraw from the department, the participating political subdivision*  
6     *must submit the question of whether the political subdivision should*  
7     *withdraw from the department to the registered voters of the political*  
8     *subdivision at a general election held pursuant to NRS 293.12755. The*  
9     *participating political subdivision shall give notice of its intent to*  
10    *withdraw to the other participating political subdivisions at least 6*  
11    *months before that general election. If a majority of the voters approve*  
12    *the question, the effective date of the withdrawal is the commencement of*  
13    *the fiscal year immediately following the general election at which the*  
14    *question of withdrawal is approved. The ordinance that had been adopted*

1 *by the withdrawing political subdivision providing for the merger is void*  
2 *on the effective date of the withdrawal.*

3 *2. If a department consists of:*

4 *(a) Two participating political subdivisions and one of the*  
5 *participating political subdivisions determines that it wishes to withdraw;*  
6 *or*

7 *(b) Three or more participating political subdivisions and all or all*  
8 *except one of the participating political subdivisions determine that they*  
9 *wish to withdraw,*  
10 *the participating political subdivisions must each submit the question of*  
11 *whether the department should be dissolved to the registered voters*  
12 *within their jurisdiction at the next general election held pursuant to*  
13 *NRS 293.12755. If a majority of the total votes cast on the question are in*  
14 *favor of the dissolution of the department, the effective date of the*  
15 *dissolution is the commencement of the fiscal year immediately following*  
16 *the general election at which the question of dissolution is approved. The*  
17 *ordinances that had been adopted by the participating political*  
18 *subdivisions providing for the merger are void on the effective date of the*  
19 *dissolution.*

20 *Sec. 3. 1. Upon the withdrawal of a participating political*  
21 *subdivision from the department, the committee, in cooperation with the*  
22 *withdrawing political subdivision, shall determine the employees of the*  
23 *department that must be transferred to the law enforcement agency of the*  
24 *withdrawing political subdivision.*

25 *2. Such employees must hold positions of rank and grade*  
26 *comparable to their positions with the department before their transfer to*  
27 *the withdrawing political subdivision and are entitled to suffer no loss in*  
28 *pay, pension, fringe benefits or other job benefits by reason of the*  
29 *transfer.*

30 *3. Sick leave, longevity and vacation time accrued to such employees*  
31 *in the service of the department must be credited to them as employees of*  
32 *the law enforcement agency of the withdrawing political subdivision. All*  
33 *rights and accruals of such employees as members of the public*  
34 *employees' retirement system pursuant to the Public Employees'*  
35 *Retirement Act remain in force and must be automatically transferred*  
36 *from the department to the law enforcement agency of the withdrawing*  
37 *political subdivision.*

38 *4. The duties and responsibilities of such employees must not be*  
39 *diminished by reason of their transfer to the withdrawing political*  
40 *subdivision, but their area and division of assignment may be changed at*  
41 *the discretion of the chief law enforcement officer of the law*  
42 *enforcement agency of the withdrawing political subdivision.*

43 *Sec. 4. 1. Upon the dissolution of a department, employees of the*  
44 *department may, at the discretion of the employee, obtain employment*  
45 *with the political subdivision in the boundaries of which the employee*  
46 *had performed the majority of his duties for the department during the*  
47 *fiscal year immediately preceding dissolution.*

1     2. Such employees must hold positions of rank and grade  
2     comparable to their positions before dissolution and are entitled to suffer  
3     no loss in pay, pension, fringe benefits or other job benefits by reason of  
4     the dissolution.

5     3. Sick leave, longevity and vacation time accrued to such employees  
6     in the service of the department must be credited to them as employees of  
7     the law enforcement agencies of the political subdivisions participating  
8     in the department at the time of dissolution. All rights and accruals of  
9     such employees as members of the public employees' retirement system  
10    pursuant to the Public Employees' Retirement Act remain in force and  
11    must be automatically transferred from the department to such law  
12    enforcement agencies.

13    4. The duties and responsibilities of such employees must not be  
14    diminished by reason of the dissolution, but their area and division of  
15    assignment may be changed at the discretion of chief law enforcement  
16    officers of the law enforcement agencies of the political subdivisions to  
17    which the employees are transferred upon dissolution.

18    Sec. 5. 1. Any contract, franchise or other agreement into which a  
19    department enters after merger for goods or services is subject to  
20    rescission by either party if one or more of the participating political  
21    subdivisions withdraw from the department or the department is  
22    dissolved.

23    2. A valid claim against a department arising from law enforcement  
24    activity is not diminished or altered by reason of the dissolution of the  
25    department. The participating political subdivisions at the time of  
26    dissolution are liable for any claims resulting from any pending action or  
27    proceeding which involves any debt, demand, liability or obligation or  
28    which has been brought by or against the department after the merger,  
29    irrespective of the nature of such matter in litigation.

30    Sec. 6. NRS 280.110 is hereby amended to read as follows:

31    280.110 1. The board of county commissioners of any county and  
32    the governing body of any city or cities located in the county may merge  
33    their respective law enforcement agencies into one metropolitan police  
34    department. To do so, the board of county commissioners of the  
35    participating county and the governing body of each participating city must  
36    each adopt an ordinance providing for the merger. Except with respect to  
37    an ordinance providing for the reorganization of an existing department  
38    pursuant to the provisions of this chapter, any ordinance providing for a  
39    merger must be adopted and become effective on or before November 30  
40    in the year preceding the commencement of the fiscal year in which the  
41    merger is to occur.

42    2. ~~Any participating political subdivision may withdraw from the~~  
43    ~~metropolitan police department by repealing the ordinance providing for~~  
44    ~~the merger. The withdrawal must be effective at the beginning of a fiscal~~  
45    ~~year and notice must be given to all other participating political~~  
46    ~~subdivisions at least 6 months in advance of that date.~~

1 enforcement and the governing body of the city adopts an ordinance for the  
2 merger authorized by this section:

3 (a) The charter provision for appointment of a chief of police shall be  
4 deemed superseded as long as the ordinance providing for a merger of the  
5 police department of the participating city remains in effect.

6 (b) The duties of law enforcement vested in the law enforcement  
7 agencies designated in the merger, devolve upon the metropolitan police  
8 department, except the duty to construct, maintain or operate any county or  
9 city jail or detention facility.

10 ~~14-1~~ 3. Any nonparticipating city may, by adopting an ordinance  
11 providing for a merger, merge its law enforcement agency into an existing  
12 metropolitan police department with the unanimous consent of the  
13 committee and subject to such rules and regulations as the committee may  
14 adopt which are consistent with the provisions of this chapter.

15 **Sec. 7.** NRS 280.220 is hereby amended to read as follows:

16 280.220 1. Upon merger, the county auditor or county comptroller of  
17 a county which has a department shall:

18 ~~14-1~~ (a) Create in the county treasury one or more funds and accounts  
19 within those funds, pursuant to the provisions of NRS 354.470 to 354.626,  
20 inclusive, as the department may request, for the exclusive use of the  
21 department.

22 ~~12-1~~ (b) Receive all money from the county, participating cities and any  
23 other source on behalf of the department and deposit the money in the  
24 appropriate department fund.

25 ~~13-1~~ (c) Receive all money collected by the department for any purpose,  
26 except criminal and civil fines, and deposit the money in the appropriate  
27 department fund.

28 ~~14-1~~ (d) Issue warrants against a department fund in the manner  
29 provided in this chapter.

30 ~~15-1~~ (e) Credit any interest earned on money held in a department fund  
31 to any such fund designated by the department.

33 end of each fiscal year.

34 2. *Within 30 days after the effective date of the withdrawal of a*  
35 *participating political subdivision from the department, the county*  
36 *auditor or county comptroller shall issue a warrant to pay to the*  
37 *withdrawing political subdivision any money held in a department fund*  
38 *that is attributable to the withdrawing political subdivision based on the*  
39 *proportion that the total budgetary contribution of the withdrawing*  
40 *political subdivision to the department bears to the total budgetary*  
41 *contributions of all the participating political subdivisions to the*  
42 *department since the time of merger.*

43 3. *Within 30 days after the effective date of the dissolution of the*  
44 *department, the county auditor or county comptroller shall disburse any*  
45 *money held in a department fund to the participating political*  
46 *subdivisions at the time of dissolution based on the proportion that the*  
47 *total budgetary contribution of each participating political subdivision to*  
48 *the department bears to the total budgetary contributions of all the*

3 **Sec. 8.** NRS 280.262 is hereby amended to read as follows:

4 280.262 **1.** In each county in which a metropolitan police department  
5 is established, there is hereby created a taxing district consisting of:

6 ~~H-1~~ (a) The area within the boundaries of each incorporated city which  
7 participates in the department; and

8 ~~I-2-1~~ (b) The area of the county outside the boundaries of any  
9 incorporated city.

10 **2.** *The boundary of the taxing district must not be altered or*  
11 *abolished as a result of the withdrawal of a participating political*  
12 *subdivision from the department or the dissolution of the department in*  
13 *such a manner as to impair any outstanding bonds or other obligations*  
14 *that are payable from or secured by a pledge of a tax imposed in the*  
15 *taxing district until those bonds or other obligations have been*  
16 *discharged in full.*

17 **Sec. 9.** NRS 280.264 is hereby amended to read as follows:

18 280.264 **1.** The committee may, with the consent of the governing  
19 body of the county and each participating city, borrow money from time to  
20 time as general obligations to construct buildings or improve property used  
21 by the department, except a county or city jail or detention facility. For this  
22 purpose, the committee is a "governing body" within the meaning of NRS  
23 350.524.

24 **2.** If general obligations are issued pursuant to this section, the  
25 committee shall determine the amount required in each fiscal year to pay  
26 the interest and required installments of principal, and report this amount to  
27 the Nevada tax commission as the budgets of local governments are  
28 reported, for the levy of the requisite tax on all taxable property within the  
29 taxing district.

30 **3.** For the purposes of any debt limitation of a county or city,  
31 obligations issued pursuant to this section shall be deemed to be the  
32 respective general obligations of the county and each of the cities in the  
33 same proportion as the percentage of the department's expenses paid by the  
34 county and each of the cities pursuant to the formula in effect at the time  
35 the obligations are issued.

36 **4.** *If a participating political subdivision withdraws from the*  
37 *department, the withdrawing political subdivision becomes liable for the*  
38 *proportion of the indebtedness for the general obligations issued*  
39 *pursuant to this section that is attributable to the withdrawing political*  
40 *subdivision based on the percentage of the department's expenses paid by*  
41 *the withdrawing political subdivision pursuant to the formula in effect at*  
42 *the time the general obligations were issued.*

43 **5.** *Each participating political subdivision at the time of dissolution*  
44 *becomes liable for the proportion of the indebtedness for the general*  
45 *obligations issued pursuant to this section that is attributable to each*  
46 *participating political subdivision based on the percentage of the*  
47 *department's expenses paid by each participating political subdivision*  
48 *pursuant to the formula in effect at the time the general obligations were*  
49 *issued.*



1     **Sec. 10.** NRS 280.266 is hereby amended to read as follows:

2     280.266 1. Upon the adoption of a resolution pursuant to NRS  
3     350.087, the committee may issue a medium-term obligation to purchase  
4     capital equipment or enter into a lease-purchase agreement for capital  
5     equipment.

6     2. The committee is not required to comply with the provisions of  
7     NRS 350.089 if it issues a medium-term obligation for a lease-purchase  
8     agreement for capital equipment.

9     3. *If a participating political subdivision withdraws from the*  
10    *department, the withdrawing political subdivision becomes liable for the*  
11    *proportion of the indebtedness for the medium-term obligations issued*  
12    *pursuant to this section that is attributable to the withdrawing political*  
13    *subdivision based on the percentage of the department's expenses paid by*  
14    *the withdrawing political subdivision pursuant to the formula in effect at*  
15    *the time the medium-term obligations were issued.*

16    4. *Each participating political subdivision at the time of dissolution*  
17    *becomes liable for the proportion of the indebtedness for the medium-*  
18    *term obligations issued pursuant to this section that is attributable to*  
19    *each participating political subdivision based on the percentage of the*  
20    *department's expenses paid by each participating political subdivision*  
21    *pursuant to the formula in effect at the time the medium-term obligations*  
22    *were issued.*

23    **Sec. 11.** NRS 280.340 is hereby amended to read as follows:

24    280.340 1. Upon merger, the title to and possession of all personal  
25    property which is:

26    (a) Owned or held by, or in trust for, any of the participating political  
27    subdivisions, or by their officers or agencies in trust for public use; and

28    (b) Exclusively devoted at the time of merger to the purposes of law  
29    enforcement,  
30    shall be vested in and transferred to the department.

31    2. Property which is required to be transferred under the provisions of  
32    this section must be inventoried and appraised before the transfer in a  
33    manner which satisfies the accounting requirements of each participating  
34    political subdivision, in order that values may be determined as of the date  
35    of transfer.

36    3. The department shall hold title to all personal property it acquires  
37    after the time of merger.

38    4. To acquire personal property, the department may, upon the  
39    approval of the committee and by the unanimous vote of the members of  
40    the governing body of each participating political subdivision, issue  
41    negotiable notes in the amount of the purchase price thereof, which:

42    (a) Mature not later than 5 years from the date of issuance; and

43    (b) Bear interest at a rate not to exceed 12 percent per annum.

44    5. Each participating political subdivision shall provide in its annual  
45    budget for the payment of the principal and interest on the negotiable notes  
46    according to the funding apportionment plan established pursuant to NRS  
47    280.201 for the fiscal year in which the negotiable notes were issued.

48    6. If *the withdrawal of* a participating political subdivision ~~gives~~  
49    ~~notice of its intention to withdraw~~ from the department ~~it~~ *is approved*

21 *the department bears to the total contributions of personal property of all*  
22 *participating political subdivisions to the department since the effective*  
23 *date of the merger; and*  
24 (b) *The proportion that its total budgetary contribution to the*  
25 *department bears to the total budgetary contributions of all participating*  
26 *political subdivisions to the department since the effective date of the*

28 8. Upon *the effective date of the* withdrawal from the department, a  
29 *withdrawing* political subdivision becomes obligated for the payment of its  
30 share of the unpaid balance of any negotiable note issued by the  
31 department pursuant to subsection 4, determined in accordance with the  
32 funding apportionment plan established pursuant to NRS 280.201 for the  
33 fiscal year in which the negotiable note was issued. The department ~~1. or if~~

35 ~~date of the withdrawal the other political subdivision,1~~ becomes obligated  
36 for the payment of the remainder of the unpaid balance.  
37 9. *Upon the effective date of the dissolution of the department, each*

40 *negotiable note issued by the department pursuant to subsection 4 in the*  
41 *proportion that its total budgetary contribution to the department during*  
42 *the fiscal year or years in which the personal property was acquired*  
43 *bears to the total budgetary contributions of all participating political*

45 **Sec. 12.** NRS 280.350 is hereby amended to read as follows:

36 *political subdivision on the effective date of the dissolution.*

37 (b) *Real property that was acquired for the use and benefit of or in*  
38 *trust for the department after the effective date of the merger must*  
39 *immediately be inventoried and appraised. Each participating political*  
40 *subdivision at the time of dissolution is entitled to receive, on the effective*  
41 *date of the dissolution, its share of the value of each such parcel of real*  
42 *property and any improvements on that property, in cash or in kind, or*  
43 *both, in the proportion that its total budgetary contribution to the*  
44 *department during the fiscal year or years in which the parcel was*  
45 *acquired and improved bears to the total budgetary contributions of all*  
46 *participating political subdivisions to the department during that period.*
