SUMMARY—Revises various provisions regarding regulation of mortgage brokers,
mortgage agents and mortgage companies. (BDR 54-491)

AN ACT relating to financial institutions; creating the mortgage industry commission;
prescribing the powers and duties of the mortgage industry commission and its
executive director; transferring the responsibilities of regulating mortgage
brokers and mortgage agents from the commissioner of financial institutions to
the mortgage industry commission and its executive director; revising various
provisions relating to the regulation of mortgage brokers and mortgage agents;
revising provisions concerning certain powers of attorney; eliminating the
advisory council on mortgage investments and mortgage lending; and providing
other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 645B of NRS is hereby amended by adding thereto
2 the provisions set forth as sections 2 to 14.5, inclusive, of this act.
3 **Sec. 2.** *“Accredited investor” means an investor:*
4 1. *Who, on the date of an act or transaction, meets the criteria to be*
5 *an accredited investor pursuant to the provisions of Regulation D of the*
6 *Securities and Exchange Commission, 17 C.F.R. §§ 230.501 to 230.508,*
7 *inclusive; or*
8 2. *Whom, on the date of an act or transaction, a mortgage broker or*
9 *mortgage agent reasonably believes meets the criteria to be an accredited*
10 *investor pursuant to the provisions of Regulation D of the Securities and*
11 *Exchange Commission, 17 C.F.R. §§ 230.501 to 230.508, inclusive.*
12 **Sec. 3.** *“Executive director” means the executive director of the*
13 *commission.*
14 **Sec. 4.** *“Mortgage company” has the meaning ascribed to it in*
15 *NRS 645E.100.*

1 **Sec. 5.** *For the purposes of this chapter:*

2 1. *The southern district of Nevada consists of the counties of Clark,*
3 *Esmeralda, Lincoln and Nye; and*

4 2. *The northern district of Nevada consists of all other counties of*
5 *this state.*

6 **Sec. 6.** *1. The mortgage industry commission is hereby created.*

7 2. *The commission consists of five members appointed by the*
8 *governor. The governor shall appoint to the commission:*

9 (a) *Three members who are residents of the southern district of*
10 *Nevada; and*

11 (b) *Two members who are residents of the northern district of Nevada.*

12 3. *If, during his term, a member changes his residency to a location*
13 *outside of the district from which he was appointed, the member shall be*
14 *deemed to have resigned from his office, and the office shall be deemed*
15 *to be vacant.*

16 4. *A person may not be appointed to the commission unless the*
17 *person:*

18 (a) *Is a citizen of the United States;*

19 (b) *Has been a resident of this state for at least 5 years immediately*
20 *preceding the date of his appointment; and*

21 (c) *For at least 3 years immediately preceding the date of his*
22 *appointment:*

23 (1) *Has held a valid license issued by this state as a mortgage*
24 *broker or mortgage company or has been a general partner, director or*
25 *officer of such a mortgage broker or mortgage company; or*

26 (2) *Has been actively and legally engaged in this state in the*
27 *business of mortgage lending or in the activities of a mortgage agent.*

28 5. *Before entering upon the duties of his office, a member shall take:*

29 (a) *The constitutional oath of office; and*

30 (b) *An oath that he is legally qualified to serve as a member of the*
31 *commission.*

32 **Sec. 7.** *1. After the initial terms, the members of the commission*
33 *must be appointed to terms of 3 years. Upon the expiration of his term, a*
34 *member continues to serve on the commission until a qualified person*
35 *has been appointed as his successor.*

36 2. *Members of the commission may not be appointed to serve more*
37 *than two consecutive terms, excluding any appointment to:*

38 (a) *An initial term of less than 3 years; and*

39 (b) *An unexpired term that does not exceed 18 months.*

40 3. *A person who has been appointed to serve two consecutive terms*
41 *on the commission may be appointed to the commission if, on the date of*
42 *his most recent appointment, more than 3 years have elapsed since the*
43 *expiration of his last term.*

44 4. *Any vacancy in the membership of the commission must be filled*
45 *for the remainder of the unexpired term in the same manner as the*
46 *original appointment.*

47 **Sec. 8.** *1. The commission shall:*

48 (a) *Operate on the basis of a fiscal year beginning on July 1 and*
49 *ending on June 30.*



- 1 ***(b) At the first meeting of each fiscal year, select one member as***
2 ***chairman and one member as vice chairman. The chairmanship of the***
3 ***commission must alternate each fiscal year between a member who is a***
4 ***resident of the southern district of Nevada and a member who is a***
5 ***resident of the northern district of Nevada. The vice chairman may not***
6 ***be a resident of the same district as the chairman. If a vacancy occurs in***
7 ***the chairmanship or vice chairmanship, the vacancy must be filled for***
8 ***the remainder of the unexpired term by a member who is a resident of***
9 ***the same district as his predecessor. The vice chairman shall perform the***
10 ***duties of the chairman during any absence of the chairman.***
11 ***2. The commission:***
12 ***(a) Shall hold at least two meetings each year, one in the southern***
13 ***district of Nevada and one in the northern district of Nevada; and***
14 ***(b) May hold additional meetings each year at the call of the***
15 ***chairman or upon a written request submitted to the executive director by***
16 ***two members of the commission.***
17 ***3. The chairman shall designate the time and place for each meeting***
18 ***of the commission. Not later than 3 working days before each meeting,***
19 ***the executive director shall give each member of the commission written***
20 ***notice of the time, place and purpose of the meeting.***
21 ***4. Three members of the commission constitute a quorum. A***
22 ***majority of the members present during a quorum may take any action or***
23 ***make any decision as the commission.***
24 ***5. The commission shall:***
25 ***(a) Prepare and maintain a record of its transactions and***
26 ***proceedings; and***
27 ***(b) Adopt a seal of which each court of this state shall take judicial***
28 ***notice.***
29 ***6. While engaged in the business of the commission, each member of***
30 ***the commission is entitled to receive:***
31 ***(a) A salary of not more than \$80 per day, as fixed by the commission;***
32 ***and***
33 ***(b) A per diem allowance and travel expenses at a rate fixed by the***
34 ***commission. The rate must not exceed the rate provided for officers and***
35 ***employees of this state generally.***
36 ***Sec. 9. 1. The commission shall designate the location of the***
37 ***principal office of the commission. If the principal office of the***
38 ***commission is located in:***
39 ***(a) The southern district of Nevada, the commission shall establish at***
40 ***least one branch office in the northern district of Nevada.***
41 ***(b) The northern district of Nevada, the commission shall establish at***
42 ***least one branch office in the southern district of Nevada.***
43 ***2. Within the limits of legislative appropriation, the commission may***
44 ***establish such additional branch offices in this state as it considers***
45 ***necessary to carry out its functions and duties.***
46 ***3. The executive director shall conduct business primarily in the***
47 ***principal office of the commission.***

1 **Sec. 10.** *The commission may delegate to the executive director:*

2 *1. The authority of the commission to take any disciplinary action*
3 *and to impose any fines and penalties; and*

4 *2. Any other authority conferred on the commission by this chapter*
5 *and any other specific statute relating to the powers and duties of the*
6 *commission.*

7 **Sec. 11.** *1. The director of the department of business and industry*
8 *shall appoint an executive director who:*

9 *(a) Within the limits of legislative appropriation, is entitled to receive*
10 *such compensation as is fixed by the commission;*

11 *(b) Is in the unclassified service of the state; and*

12 *(c) Serves at the pleasure of the director of the department of business*
13 *and industry.*

14 *2. The executive director may not be:*

15 *(a) A member of the commission; or*

16 *(b) A licensed mortgage broker or mortgage company, a partner,*
17 *director or officer of a licensed mortgage broker or mortgage company*
18 *or, directly or indirectly, interested in, employed by or associated with a*
19 *licensed mortgage broker or mortgage company.*

20 *3. Except as otherwise provided in NRS 284.143, the executive*
21 *director shall devote his entire time and attention to the business of his*
22 *office and shall not pursue any other business or occupation or hold any*
23 *other office of profit.*

24 *4. The executive director:*

25 *(a) Is subject to the supervision of the director of the department of*
26 *business and industry;*

27 *(b) Is responsible for administering and carrying out the policies and*
28 *administrative functions of the commission;*

29 *(c) Shall direct and supervise all the technical and administrative*
30 *functions of the commission;*

31 *(d) Shall report to the commission all relevant and important matters*
32 *concerning the administration of the office of the commission;*

33 *(e) Shall perform the duties set forth in this chapter and the duties*
34 *delegated to the executive director by the commission pursuant to section*
35 *10 of this act; and*

36 *(f) Shall perform any lawful act that the executive director considers*
37 *necessary or desirable to carry out the purposes and provisions of this*
38 *chapter and any other specific statute relating to the powers and duties of*
39 *the commission.*

40 **Sec. 12.** *1. Within the limits of legislative appropriation, the*
41 *executive director may employ such persons as he deems necessary to*
42 *carry out the functions and duties of the commission.*

43 *2. A person employed by the executive director may not be:*

44 *(a) A member of the commission; or*

45 *(b) A licensed mortgage broker or mortgage company, a partner,*
46 *director or officer of a licensed mortgage broker or mortgage company*
47 *or, directly or indirectly, interested in, employed by or associated with a*
48 *licensed mortgage broker or mortgage company.*

1 3. *While engaged in the business of the commission, the executive*
2 *director and each person employed by the executive director is entitled to*
3 *receive a per diem allowance and travel expenses at a rate fixed by the*
4 *commission. The rate must not exceed the rate provided for officers and*
5 *employees of this state generally.*
6 **Sec. 13.** *The commission, the commissioner of financial institutions*
7 *and the division of financial institutions shall cooperate with, share*
8 *records and information with and assist each other to the extent*
9 *necessary to carry out the provisions of this chapter, chapter 645E of*
10 *NRS and any other specific statute relating to the powers and duties of*
11 *the commission, the commissioner of financial institutions and the*
12 *division of financial institutions.*
13 **Sec. 14.** 1. *The attorney general is the attorney for the commission*
14 *and the executive director.*
15 2. *The attorney general shall designate one or more of his deputies to*
16 *conduct actions, proceedings and hearings for the commission and the*
17 *executive director. Such deputies shall advise the commission and the*
18 *executive director on all matters relating to the commission.*
19 **Sec. 14.5.** *The commission shall adopt regulations that set forth the*
20 *procedures that a mortgage broker or mortgage agent must follow to*

6 NRS, unless the person is also licensed as a mortgage broker pursuant to
7 this chapter.

7 (a) The making of the loan would not be detrimental to the financial

28 this chapter or chapter 645E of NRS suspended or revoked within the 10
29 years immediately preceding the date of his application.
- 30 (5) Has not had a license that was issued in any other state, district or
31 territory of the United States or any foreign country suspended or revoked

4 645B.025 1. A mortgage broker shall post each license in a
5 conspicuous place in the office to which it pertains.

6 2. A mortgage broker may not transfer or assign a license to another
7 person, unless the ~~commissioner gives his~~ *commission gives its* written
8 approval.

9 **Sec. 27.** NRS 645B.035 is hereby amended to read as follows:

10 645B.035 1. A license entitles a licensee to engage only in ~~the~~ :

1. The advisory council on mortgage investments and mortgage

2. The advisory council consists of five members appointed by the
legislative commission from a list of persons provided by the
commissioner.

3. The members of the advisory council:

(a) Must be persons who have experience with, an interest in or a
knowledge of issues relating to mortgage investments or mortgage lending.

Such persons may include, without limitation, investors, public officers and employees, licensees and persons who have engaged in or been involved with any business, profession or occupation relating to mortgage investments or mortgage lending.

(b) Serve terms of 2 years and at the pleasure of the legislative commission.

(d) Serve without compensation and may not receive a per diem allowance or travel expenses.

4. Any vacancy in the membership of the advisory council must be filled for the remainder of the unexpired term in the same manner as the original appointment.

5. A member of the advisory council who is an officer or employee of this state or a political subdivision of this state must be relieved from his duties without loss of his regular compensation so that he may prepare for and attend meetings of the advisory council and perform any work necessary to carry out the duties of the advisory council in the most timely manner practicable. A state agency or political subdivision of this state shall not require an officer or employee who is a member of the advisory council to make up the time he is absent from work to carry out his duties as a member of the advisory council or use annual vacation or compensatory time for the absence.

6. Notwithstanding any other provision of law, a member of the advisory council:

(a) Is not disqualified from public employment or holding a public office because of his membership on the advisory council; and

(b) Does not forfeit his public office or public employment because of his membership on the advisory council.

645B.865 Chairman and vice chairman; meetings; quorum; subcommittees.

1. The members of the advisory council on mortgage investments and mortgage lending shall elect a chairman and a vice chairman from among their membership. The vice chairman shall perform the duties of the chairman during any absence of the chairman.

2. The advisory council may meet at least once each calendar quarter and at other times on the call of the chairman or a majority of its members.

3. The meetings of the advisory council may be held at any location designated by the chairman or a majority of its members.

4. A majority of the members of the advisory council constitutes a quorum for the transaction of all business.

5. The chairman may appoint subcommittees of the members of the advisory council to consider specific problems relating to mortgage investments or mortgage lending.

645B.870 Purpose. The purpose of the advisory council on mortgage investments and mortgage lending is to:

1. Consult with, advise and make recommendations to the commissioner in all matters relating to mortgage investments and mortgage lending.

2. Make recommendations to the legislature concerning the enactment of any legislation relating to mortgage investments and mortgage lending.

4. Conduct hearings, conferences and special studies on all matters relating to mortgage investments and mortgage lending.
5. Provide a forum for the consideration and discussion of all matters relating to mortgage investments and mortgage lending.
6. Gather and disseminate information relating to mortgage investments and mortgage lending.
7. Engage in other activities that are designed to promote, improve and protect the reliability and stability of mortgage investments and mortgage lending in this state.
