AN ACT relating to railroad trains; requiring the Nevada gaming commission to adopt regulations governing the licensing and operation of railroad gaming; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     **Section 1.** Chapter 463 of NRS is hereby amended by adding thereto a  
2     new section to read as follows:  
3     1. *A person may not operate railroad gaming without obtaining a*  
4     *restricted license for railroad gaming from the commission.*  
5     2. *Notwithstanding any other provision of law:*  
6     (a) *The commission may issue a restricted license to a person to*  
7     *operate railroad gaming in accordance with the regulations adopted*  
8     *pursuant to this section.*  
9     (b) *To operate railroad gaming, a person is not required to procure or*  
10    *maintain:*  
11    (1) *A gaming license or business license from any city, town or*  
12    *county, regardless of whether the historic railroad train stops in or*  
13    *traverses that city, town or county; or*  
14    (2) *A county license for each particular slot machine.*  
15    (c) *No city, town or county may collect any license fee or tax for the*  
16    *operation of railroad gaming.*  
17    3. *The commission shall adopt regulations governing the licensing*  
18    *and operation of railroad gaming.*  
19    4. *As used in this section:*  
20    (a) *“Historic railroad train” means a steam, electric or other motor*  
21    *locomotive of historic distinction, with or without railroad cars coupled*

1 *thereto, which travels upon stationary rails within this state and which is*  
2 *operated by a nonprofit organization. The term does not include a*  
3 *streetcar.*

4 *(b) “Railroad gaming” means the operation of slot machines on a*  
5 *historic railroad train.*

6 **Sec. 2.** NRS 463.0189 is hereby amended to read as follows:  
7 463.0189 “Restricted license” or “restricted operation” means a state  
8 gaming license for, or an operation consisting of, not more than 15 slot  
9 machines and no other game or gaming device ~~that~~:

10 *1. At* an establishment in which the operation of slot machines is  
11 incidental to the primary business of the establishment ~~that~~; *or*

12 *2. On a historic railroad train as defined in section 1 of this act.*

13 **Sec. 3.** This act becomes effective on July 1, 2001.
