SUMMARY—Requires state contractors' board to suspend certain privileges of license issued to contractor under certain circumstances. (BDR 54-1298)

AN ACT relating to contractors; requiring the suspension of a contractor's license by the state contractors' board if the licensee has failed to comply with a certain number of administrative citations; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 624 of NRS is hereby amended by adding thereto a
2 new section to read as follows:
3 1. *Except as otherwise provided in subsection 3, if the board issues a*
4 *written administrative citation pursuant to NRS 624.341 that includes an*
5 *order to correct a condition resulting from an act which constitutes a*
6 *cause for disciplinary action to a licensee who performs residential*
7 *construction and who the board believes has at least nine other*
8 *outstanding citations, the board shall:*
9 (a) *Conduct a hearing pursuant to NRS 624.291 to determine whether*
10 *the licensee has at least 10 outstanding citations; or*
11 (b) *Suspend the license of the licensee, in accordance with subsection*
12 *4 of NRS 624.291, for all purposes related to residential construction*
13 *except for the purpose of correcting the outstanding violations.*
14 2. *If the board issues, during a hearing, a written administrative*
15 *citation pursuant to NRS 624.341 that includes an order to correct a*
16 *condition resulting from an act which constitutes a cause for disciplinary*
17 *action to a licensee who performs residential construction, the board*
18 *shall determine at that hearing whether the licensee has at least 10*
19 *outstanding citations, including the citation issued at the hearing.*
20 3. *If the board determines at a hearing that the licensee has at least*
21 *10 outstanding citations pursuant to subsection 1 or 2, the board shall*
22 *suspend the license issued to the licensee for all purposes related to*



1 *residential construction except for the purpose of correcting the*
2 *outstanding violations.*

3 *4. If the board suspends a license pursuant to this section, the board*
4 *shall not reinstate the license until:*

5 *(a) At least 30 days after the date the license is suspended; and*

6 *(b) The board determines that the total number of outstanding*
7 *citations issued to the licensee is five or less.*

8 *5. Except as otherwise provided in this subsection, as used in this*
9 *section, "outstanding citation" means a written administrative citation*
10 *issued to a licensee pursuant to NRS 624.341 which includes an order to*
11 *take action to correct a condition resulting from an act that constitutes a*
12 *cause for disciplinary action and with which the licensee has not*
13 *complied to the satisfaction of the board. If a civil action is initiated*
14 *concerning an act for which a written administrative citation has been*
15 *issued by the board, the citation is not an outstanding citation.*
