AN ACT relating to state financial administration; restricting the ability of a state agency to enter into certain agreements to purchase real property; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 353 of NRS is hereby amended by adding thereto a
2 new section to read as follows:
3 1. *Before a state agency or person acting on the behalf of a state*
4 *agency may enter into a long-term agreement to purchase unimproved*
5 *real property, improved real property or improvements to real property,*
6 *the legislature must approve the long-term agreement.*
7 2. *This section does not affect any agreement, including, without*
8 *limitation, a long-term agreement, to purchase personal property.*
9 3. *As used in this section:*
10 (a) *“Long-term agreement” means an agreement to purchase*
11 *property, in the form of a lease or an agreement to pay in installments,*
12 *pursuant to which the State of Nevada or a state agency may pay the*
13 *purchase price of the property over a period that extends beyond the*
14 *biennium in which the agreement is executed, including, without*
15 *limitation:*
16 (1) *An agreement pursuant to which the State of Nevada or a state*
17 *agency may acquire the property that is the subject of the agreement at*
18 *the end of the term of the agreement or the end of the term of a renewal*
19 *of the agreement upon payment of no additional consideration or*
20 *nominal additional consideration; and*
21 (2) *An agreement that, for the purposes of federal income tax, is*
22 *treated as an agreement for conditional sale.*



- 1 ***(b) “State agency” means an agency, bureau, board, commission,***
- 2 ***department, division or any other unit of the government of this state that***
- 3 ***is required to submit information to the chief pursuant to subsection 1 or***
- 4 ***6 of NRS 353.210.***
- 5 **Sec. 2.** This act becomes effective upon passage and approval.
