AN ACT relating to rural health; creating in the state general fund the revolving loan account to provide assistance to certain rural health programs to make loans to rural health programs that require such assistance; establishing the Nevada office of rural health within the University of Nevada School of Medicine; making appropriations; and providing other matters properly relating thereto.

## THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

**Section 1.** Chapter 353 of NRS is hereby amended by adding thereto a new section to read as follows:

- 1. The revolving loan account to provide assistance to certain rural health programs is hereby created in the state general fund.
- 2. The money in the account must be used solely to make loans to rural health programs that require such assistance.
- 3. The account must be administered by the director of the department of human resources, who may apply for and accept any gift, donation, bequest, grant or other source of money for deposit in the account.
- 4. The interest and income earned on the money in the account, after deducting any applicable charges, must be credited to the account.
  - 5. The money in the account must remain in the account and does not revert to the state general fund at the end of any fiscal year.
- 6. The director of the department shall adopt regulations to carry out the provisions of this section. The regulations must include, without limitation:
- (a) The procedure by which a person may apply for a loan of money
   from the account to provide assistance to certain rural health programs;



- (b) The criteria that the department will consider in determining whether to award such a loan of money from the account; and
- (c) Procedures to distribute the money in the account in a fair and equitable manner.
- **Sec. 2.** NRS 232.355 is hereby amended to read as follows:

- 232.355 1. Except for gifts or grants specifically accounted for in another fund or account, all gifts or grants of money or other property which the divisions of the department of human resources are authorized to accept must be accounted for in the department of human resources' gift fund, hereby created as a trust fund. The fund is a continuing fund without reversion. The department may establish such accounts in the fund as are necessary to account properly for gifts received. All money received by the division must be deposited in the state treasury for credit to the fund. The money in the fund must be paid out on claims as other claims against the state are paid. Unless otherwise specifically provided by statute, claims against the fund must be approved by the director or his delegate.
- 2. Gifts of property other than money may be sold or exchanged when this is deemed by the head of the facility or agency responsible for the gift to be in the best interest of the facility or agency. The sale price must not be less than 90 percent of the value determined by a qualified appraiser appointed by the head of the facility or agency. All money received from the sale must be deposited in the state treasury to the credit of the appropriate gift account in the department of human resources' gift fund. The money may be spent only for the purposes of the facility or agency named in the title of the account. The property may not be sold or exchanged if to do so would violate the terms of the gift.
- **Sec. 3.** Chapter 396 of NRS is hereby amended by adding thereto a new section to read as follows:
- 1. The Nevada office of rural health is hereby established within the University of Nevada School of Medicine.
- 2. The Nevada office of rural health shall address the need for and recommend programs concerning the delivery of health care services to rural and frontier populations. The office shall administer or coordinate, or both, programs and services which affect the delivery of health care services in rural areas including, without limitation, programs and services in the following categories:
  - (a) Education and training;
  - (b) Needs of special populations;
  - (c) Delivery of health services; and
- (d) Financing of health care.
- **Sec. 4.** There is hereby appropriated from the state general fund to the revolving loan account to provide assistance to certain rural health programs the sum of \$500,000.
- **Sec. 5.** 1. There is hereby appropriated from the state general fund to the Nevada Rural Health Centers, Inc., for its Carlin, Nevada, clinic the sum of \$70,000.
- 47 2. Any remaining balance of the appropriation made by subsection 1 must not be committed for expenditure after June 30, 2003, and reverts to



- the state general fund as soon as all payments of money committed have been made.

  Sec. 6. This act becomes effective upon passage and approval.
