SUMMARY—Requires transfers of money from fund for school improvement to provide scholarships for students pursuing degrees in teaching. (BDR S-434)

AN ACT relating to education; requiring transfers of money from the fund for school improvement to provide scholarships for students pursuing degrees in teaching; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Section 11 of chapter 543, Statutes of Nevada 1999, at
2 page 2841, is hereby amended to read as follows:
3 Sec. 11. 1. *The* superintendent of public instruction shall
4 transfer from the fund for school improvement to the University and
5 Community College System of Nevada ~~the sum of \$130,680 to be~~
6 ~~used to provide not more than 45 scholarships at the University of~~
7 ~~Nevada, Las Vegas, and not more than 45 scholarships at the~~
8 ~~University of Nevada, Reno,]~~ *to provide certain scholarships:*
9 *For the fiscal year 1999-2000 \$130,680*
10 *For the fiscal year 2000-2001 \$130,680*
11 2. *The money transferred pursuant to subsection 1 must be used*
12 *each fiscal year to provide:*
13 *(a) Not more than 45 scholarships at the University of Nevada,*
14 *Las Vegas; and*
15 *(b) Not more than 45 scholarships at the University of Nevada,*
16 *Reno,*
17 for qualified students pursuing degrees in teaching.

1 3. *Any* balance of the ~~sum~~ *sums* authorized for expenditure by
2 subsection 1 *remaining at the end of the respective fiscal years* must
3 not be committed for expenditure after June 30 ~~1, 2001,~~ *of the*
4 *respective fiscal years* and reverts to the fund for school improvement
5 as soon as all payments of money committed have been made.

6 **Sec. 2.** 1. The superintendent of public instruction shall transfer
7 from the fund for school improvement to the University and Community
8 College System of Nevada to provide certain scholarships:

9 For the fiscal year 2001-2002..... \$230,680
10 For the fiscal year 2002-2003..... \$230,680

11 2. The money transferred pursuant to subsection 1 must be used each
12 fiscal year to provide:

13 (a) Not more than 45 scholarships at the University of Nevada, Las
14 Vegas;

15 (b) Not more than 45 scholarships at the University of Nevada, Reno;

16 (c) Not more than 45 scholarships at the Nevada State College,
17 Henderson; and

18 (d) Not more than 45 scholarships at the Great Basin College,
19 for qualified students pursuing degrees in teaching.

20 3. Any balance of the sums authorized for expenditure by subsection 1
21 remaining at the end of the respective fiscal years must not be committed
22 for expenditure after June 30 of the respective fiscal years and reverts to
23 the fund for school improvement as soon as all payments of money
24 committed have been made.

25 **Sec. 3.** 1. This section and section 1 of this act become effective
26 upon passage and approval.

27 2. Section 2 of this act becomes effective on July 1, 2001.
