SUMMARY—Imposes surcharge on payment of child support collected by district attorney to be used for programs for mentoring of children. (BDR 11-110)

AN ACT relating to children; imposing a surcharge on each payment of child support collected by a district attorney to be used for programs for the mentoring of children; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     **Section 1.** Chapter 125B of NRS is hereby amended by adding thereto  
2     a new section to read as follows:  
3     ***1. Each time a district attorney collects an installment of an***  
4     ***obligation to pay support for a child that arises from the judgment of a***  
5     ***court, a surcharge of \$1 must be added to the amount of the installment***  
6     ***and collected by the district attorney.***  
7     ***2. A district attorney shall remit the money collected from the***  
8     ***surcharge imposed pursuant to this section to the county treasurer on or***  
9     ***before the fifth day of each month for the preceding month, to be***  
10    ***deposited in a special fund in the county treasury to be designated as the***  
11    ***fund for programs for the mentoring of children. The money in the fund***  
12    ***does not revert to the general fund of the county at any time, and any***  
13    ***interest earned on the money in the fund, after deducting any applicable***  
14    ***charges, must be credited to the fund.***  
15    ***3. Each board of county commissioners shall adopt guidelines and***  
16    ***procedures setting forth the manner in which the money collected***  
17    ***pursuant to this section is to be distributed to a nonprofit organization***  
18    ***that offers a program for the mentoring of children.***  
19    ***4. The money in the fund must be distributed, in accordance with the***  
20    ***guidelines and procedures adopted by the board of county commissioners***

3 **Sec. 2.** NRS 125B.002 is hereby amended to read as follows:  
4 125B.002 As used in NRS 125B.002 to 125B.180, inclusive, *and*  
5 *section 1 of this act*, unless the context otherwise requires, the words and  
6 terms defined in NRS 125B.004 and 125B.008 have the meanings ascribed  
7 to them in those sections.  
8 **Sec. 3.** The amendatory provisions of this act apply to an installment  
9 of an obligation to pay support for a child that is collected on or after  
10 July 1, 2001.  
11 **Sec. 4.** This act becomes effective on July 1, 2001.
