AN ACT relating to vehicles; providing for the issuance under certain circumstances of a permit authorizing the operation or movement of certain heavier vehicles used to provide public mass transportation; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** NRS 484.7485 is hereby amended to read as follows:
2 484.7485 1. ~~1A~~ *Except as otherwise provided in subsection 2, a*
3 vehicle that is used by a regional transportation commission or its
4 contractor to provide public mass transportation may be operated or moved
5 upon a public highway, other than a highway within the designated
6 interstate system, if the maximum weight does not exceed, on a single axle
7 with:
8 (a) Single tires, 20,000 pounds; or
9 (b) Dual tires, 25,000 pounds.
10 2. *A vehicle with a maximum weight on a single axle with single tires*
11 *of more than 20,000 pounds but not more than 29,000 pounds that is*
12 *used by a regional transportation commission or its contractor to provide*
13 *public mass transportation as part of a demonstration project may be*
14 *operated or moved upon a public highway, other than a highway within*
15 *the designated interstate system, if the tires are not less than 20 inches in*
16 *width and the department of transportation, after conducting an*
17 *evaluation of the vehicle;*

1 *(a) Determines that such operation or movement of the vehicle is in*
2 *the best interest of the department; and*

3 *(b) In its discretion, issues a permit authorizing such operation or*
4 *movement of the vehicle.*

5 3. As used in this section:

6 (a) “Contractor” means any person or governmental entity that has
7 entered into a contract with a regional transportation commission to
8 provide services related to the provision of public mass transportation, but
9 only during the period in which the contract remains legally effective.

10 (b) “Regional transportation commission” means any regional
11 transportation commission created and organized in accordance with
12 chapter 373 of NRS, and which provides or sponsors public mass
13 transportation services.
