- 1 WHEREAS, The staff of the Nevada Legislature and the Administrative,
- 2 Audit, Fiscal Analysis, Legal and Research Divisions of the Legislative
- 3 Counsel Bureau provide services to the Legislature which are vital to an
- 4 efficient and productive session of the Nevada Legislature; and
- 5 WHEREAS, The additional employees hired specifically for the
- 6 legislative session also provide essential services with dedication,
- 7 competence and enthusiasm throughout the long days of the session; and
- 8 WHEREAS, Extraordinary demands are routinely placed on legislative
- 9 employees as a result of the time constraints imposed by the 120-day
- 10 limitation on the length of the legislative session, and the entire legislative
- 11 staff has demonstrated their extraordinary talents, patience, flexibility and
- 12 tireless work ethic to meet these required deadlines; and

11 2. Employee of the Legislature and Legislative Counsel Bureau hired
12 temporarily for the legislative session who:

13 (a) Is employed by the Legislature or Legislative Counsel Bureau on the
14 last day of this session; and

15 (b) If requested to do so by the employee's supervisor, remains in that
16 employment after the last day of this session until all tasks assigned to the
17 employee during the session are completed.
