SUMMARY—Makes various changes to provisions governing program for millennium scholarships. (BDR 34-433)

AN ACT relating to the program for millennium scholarships; expanding the program to provide for the disbursement of scholarships to students of certain additional colleges and universities in this state; revising the eligibility requirements for certain pupils who did not graduate from high school at the time regularly scheduled for their graduation; increasing the amount of scholarships for upper division courses at community colleges; eliminating the requirement that the scholarship be repaid if a student drops out of school or fails to maintain a certain grade-point average; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 396 of NRS is hereby amended by adding thereto a
2 new section to read as follows:
3 *“Eligible institution” means:*
4 1. *A university, state college or community college within the system;*
5 or
6 2. *Any other nonsectarian college or university that:*
7 (a) *Was originally established in, and is organized under the laws of,*
8 *this state;*
9 (b) *Is exempt from taxation pursuant to 26 U.S.C. § 501(c)(3); and*
10 (c) *Is accredited by a regional accrediting agency recognized by the*
11 *United States Department of Education.*



1 **Sec. 2.** NRS 396.911 is hereby amended to read as follows:

2 396.911 1. The legislature hereby declares that its priorities in
3 expending the proceeds to the State of Nevada from settlement agreements
4 with and civil actions against manufacturers of tobacco products are:

5 (a) To increase the number of Nevada students who attend and graduate
6 from Nevada institutions of higher education; and

7 (b) To assist Nevada residents in obtaining and maintaining good
8 health.

9 2. To further these priorities, the legislature hereby declares that it is in
10 the best interest of the residents of the State of Nevada that all money
11 received by the State of Nevada pursuant to any settlement entered into by
12 the State of Nevada and a manufacturer of tobacco products and all money
13 recovered by the State of Nevada from a judgment in a civil action against
14 a manufacturer of tobacco products be dedicated solely toward the
15 achievement of the following goals:

16 (a) Increasing the number of residents of the State of Nevada who enroll
17 in and attend a university , college or community college ~~of the University~~
18 ~~and Community College System~~ *in the State* of Nevada;

19 (b) Reducing and preventing the use of tobacco products, alcohol and
20 illegal drugs, especially by children;

21 (c) Expanding the availability of health insurance and health care for
22 children and adults in this state, especially for children and for adults with
23 disabilities;

24 (d) Assisting senior citizens who have modest incomes in purchasing
25 prescription drugs and assisting those senior citizens in meeting their needs
26 related to health care, home care, respite care and their ability to live
27 independent of institutional care; and

28 (e) Promoting the general health of all residents of the State of Nevada.

29 **Sec. 3.** NRS 396.914 is hereby amended to read as follows:

30 396.914 As used in NRS 396.914 to 396.938, inclusive, *and section 1*
31 *of this act*, unless the context otherwise requires, the words and terms
32 defined in NRS 396.918 and 396.922 *and section 1 of this act* have the
33 meanings ascribed to them in those sections.

34 **Sec. 4.** NRS 396.930 is hereby amended to read as follows:

35 396.930 1. Except as otherwise provided in subsections 2 and 3, a
36 student may apply to the board of regents for a millennium scholarship if
37 he:

38 (a) Has been a resident of this state for at least 2 years before he applies
39 for the scholarship;

40 (b) ~~Graduated~~ *Except as otherwise provided in paragraph (c),*
41 *graduated* from a public or private high school in this state:

42 (1) After May 1, 2000; and

43 (2) Not more than 8 years before he applies for the scholarship;

44 (c) *Does not satisfy the requirements of paragraph (b) and:*

45 (1) *Was enrolled as a pupil in a public or private high school in this*
46 *state with a class of pupils who were regularly scheduled to graduate*
47 *after May 1, 2000;*

48 (2) *Received his high school diploma within 5 years after he was*
49 *regularly scheduled to graduate; and*

1 (3) *Applies for the scholarship not more than 8 years after he was*
2 *regularly scheduled to graduate from high school;*
3 (d) Maintained at least a 3.0 grade-point average on a 4.0 grading scale
4 in high school in the core curriculum, as determined by the board of
5 regents pursuant to subsection 2; and
6 ~~(d)~~ (e) Is enrolled in at least ~~12 semester credit hours in a university~~
7 ~~or at least 6~~ :
8 (1) *Six* semester credit hours in a community college ~~1~~ *within the*
9 *system; or*
10 (2) *Twelve semester credit hours in another eligible institution.*
11 2. The board of regents shall:
12 (a) Define the core curriculum that a student must complete in high
13 school to be eligible for a millennium scholarship.
14 (b) Develop a plan to ensure that needy students and students from
15 families that otherwise could not afford to send their children to college
16 receive millennium scholarships.
17 3. ~~For~~ *Except as otherwise provided in paragraph (c) of subsection*
18 *1, for* students who did not graduate from a public or private high school in
19 this state and who have been residents of this state for at least 2 years, the
20 board of regents shall establish:
21 (a) The minimum score on a standardized test that such students must
22 receive; or
23 (b) Other criteria that students must meet,
24 to be eligible for millennium scholarships.
25 4. In awarding scholarships, the board of regents shall enhance its
26 outreach to students who:
27 (a) Are pursuing a career in education or health care;
28 (b) Come from families who lack sufficient financial resources to pay
29 for the costs of sending their children to ~~a university or community~~
30 ~~college;~~ *an eligible institution;* or
31 (c) Substantially participated in an anti-smoking, anti-drug or anti-
32 alcohol program during high school.
33 **Sec. 5.** NRS 396.934 is hereby amended to read as follows:
34 396.934 1. Within the limits of money available in the trust fund, a
35 student who is eligible for a millennium scholarship is entitled to receive:
36 (a) If he is enrolled in a community college ~~1~~ *within the system*, \$40
37 per credit for *each lower division course and \$60 per credit for each*
38 *upper division course in* which the student is enrolled, or the amount of
39 money that is necessary for the student to pay the costs of attending the
40 community college that are not otherwise satisfied by other grants or
41 scholarships, whichever is less. *The board of regents shall provide for the*
42 *designation of upper and lower division courses for the purposes of this*
43 *paragraph.*
44 (b) *If he is enrolled in a state college within the system, \$60 per credit*
45 *for which the student is enrolled, or the amount of money that is*
46 *necessary for the student to pay the costs of attending the state college*
47 *that are not otherwise satisfied by other grants or scholarships,*
48 *whichever is less.*



1 (c) If he is enrolled in ~~{a-university,}~~ *another eligible institution*, \$80
2 per credit for which the student is enrolled, or the amount of money that is
3 necessary for the student to pay the costs of attending the university that
4 are not otherwise satisfied by other grants or scholarships, whichever is
5 less.

6 No student may be awarded a scholarship for a total amount in excess of
7 \$10,000.

8 2. A student who receives a millennium scholarship shall:

9 (a) Make satisfactory academic progress toward a recognized degree or
10 certificate, as determined by the board of regents pursuant to subsection
11 ~~{6,}~~ *5*; and

12 (b) Maintain at least a 2.0 grade-point average on a 4.0 grading scale.

13 3. A millennium scholarship must be used only:

14 (a) For the payment of registration fees and laboratory fees and
15 expenses;

16 (b) To purchase required textbooks and course materials; and

17 (c) For other costs related to the attendance of the student at the
18 ~~{university or community college.~~

19 ~~— 4. Except as otherwise provided in this subsection, if a student drops
20 out of school or fails to maintain at least a 2.0 grade point average in any
21 semester, the student shall repay the millennium scholarship before the
22 student is eligible to receive an additional millennium scholarship or
23 otherwise receive money pursuant to NRS 396.914 to 396.934, inclusive.
24 The board of regents shall establish criteria for a waiver from the
25 repayment required by this subsection, including, without limitation,
26 service in the military and conditions of hardship such as a medical necessity.~~

28 4. The board of regents shall certify a list of eligible students to the
29 state treasurer. The state treasurer shall disburse a millennium scholarship
30 for each semester on behalf of an eligible student directly to the
31 ~~{community college or university}~~ *eligible institution* in which the student
32 is enrolled, upon certification from the ~~{community college or university}~~
33 *eligible institution* of the number of credits for which the student is
34 enrolled, which must meet or exceed the minimum number of credits
35 required for eligibility and certification that the student is in good standing
36 and making satisfactory academic progress toward a recognized degree or
37 certificate, as determined by the board of regents pursuant to subsection
38 ~~{6,}~~ *5*. The scholarship must be administered by the ~~{community college or
39 university}~~ *eligible institution* as other similar scholarships are
40 administered and may be used only for the expenditures authorized
41 pursuant to subsection 3.

43 whether a student is making satisfactory academic progress toward a
44 recognized degree or certificate for purposes of subsection ~~{5,}~~ *4*.

26 2753, is hereby amended to read as follows:

27 Sec. 10. On or before February 1, 2003, the board of regents of
28 the University of Nevada shall submit a report to the director of the
29 legislative counsel bureau for transmittal to the 72nd session of the
30 Nevada legislature that includes:

31 1. An examination of the projected enrollment of students in ~~the~~
32 ~~University and Community College System of~~ Nevada who will be
33 eligible for millennium scholarships;

34 2. An actuarial study to determine the approximate costs of
35 continuing the millennium scholarship program; and

36 3. A report setting forth any enhanced outreach efforts carried out
37 pursuant to subsection 4 of section 7 of this act.

38 **Sec. 8.** This act becomes effective on July 1, 2001.
