SUMMARY—Makes various changes concerning tax imposed on revenues from rental of transient lodging. (BDR 32-125)

AN ACT relating to taxation; consolidating provisions governing the administration, imposition and collection of taxes on revenues from the rental of transient lodging into a single chapter; authorizing a local government responsible for the collection of a tax on transient lodging to audit and investigate an operator of a facility for transient lodging; authorizing a local government to require an operator to maintain certain records; establishing requirements for the issuance of a notice of determination of a deficiency in the payment of taxes on transient lodging; providing for the taxation of the lodging portion of a package program offered by an operator; providing certain exemptions from the tax on revenues from the rental of transient lodging; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Title 32 of NRS is hereby amended by adding thereto a
2 new chapter to consist of the provisions set forth as sections 2 to 49,
3 inclusive, of this act.
4 **Sec. 2.** *As used in this chapter, the words and terms defined in*
5 *sections 3 to 8, inclusive, of this act have the meanings ascribed to them*
6 *in those sections.*
7 **Sec. 3.** *“Department” means the department of taxation.*
8 **Sec. 4.** *“Gross receipts” includes the total amount of the rental price*
9 *for transient lodging, which includes, without limitation, actual rent*
10 *payments, any deposits for transient lodging which are forfeited by a*
11 *transient guest and received by the operator and all revenue and fees*



1 associated with the rental, as determined by the local government which
2 imposes a tax on transient lodging. The term does not include the
3 amount of the tax on transient lodging imposed pursuant to this chapter,
4 regardless of whether such amount is recouped through charges to the
5 transient guests.

6 **Sec. 5.** "Local government" means a county or incorporated city in
7 this state.

8 **Sec. 6.** "Operator" means a person who provides transient lodging,
9 whether or not in the capacity of owner, lessee, sub-lessee, mortgagee,
10 licensee or any other capacity other than an employee of an operator. If
11 a person uses a managing agency other than an employee to provide
12 transient lodging, both the person who uses the agency and the agency
13 are operators.

14 **Sec. 7.** "Transient guest" means a person who pays rent for the
15 right to use and possess a room or space in transient lodging pursuant to
16 a lease, concession, permit, right of access, license, contract or
17 agreement.

18 **Sec. 8.** "Transient lodging" includes, without limitation, a facility or
19 portion of a facility which is occupied, intended for occupancy or
20 designed for occupancy for the purpose of sleeping, dwelling or lodging
21 by transient guests, which includes, without limitation, a hotel, motel, bed
22 and breakfast, lodging house, time-share unit, vacation home, apartment
23 house, recreational vehicle park, campground, guest ranch and all other
24 similar facilities.

25 **Sec. 9.** The Nevada tax commission shall, by regulation not
26 inconsistent with the provisions of this chapter, provide for the collection
27 and enforcement of the taxes distributed pursuant to paragraph (a) of
28 subsection 1 of section 20 of this act, paragraph (a) of subsection 2 of
29 section 20 of this act, paragraph (a) of subsection 1 of section 31 of this
30 act and paragraph (a) of subsection 2 of section 31 of this act.

31 **Sec. 10.** In connection with any tax on transient lodging assigned or
32 appropriated by a local government for use in connection with NRS
33 244A.597 to 244A.655, inclusive, the county fair and recreation board of
34 any county, on behalf of the county, in addition to powers elsewhere
35 conferred, may:

36 1. Collect the proceeds of such tax from time to time, receive, control,
37 invest and order the expenditure of all money pertaining thereto and
38 prescribe a procedure therefor, including, without limitation:

39 (a) Enforcing the collection of any delinquent taxes and providing
40 penalties in connection therewith, including, without limitation, the
41 suspension of the business license issued by a local government to a
42 facility that provides transient lodging and the closure of a facility that
43 provides transient lodging for failure to pay the tax on transient lodging;
44 and

45 (b) Creating an office and hiring personnel therefor.

46 2. Defray the reasonable costs of collecting and otherwise
47 administering taxes on transient lodging not exceeding 10 percent of the
48 gross revenues so collected, excluding from this limitation and from
49 those gross revenues any costs of collecting any delinquent taxes borne



1 *by any delinquent taxpayer. The incorporated cities collectively and any*
2 *county may enter into an agreement with the county fair and recreation*
3 *board for the payment of collection fees which may be more or less than*
4 *10 percent of the gross revenues collected by a particular city or the*
5 *county, except that the total payment of collection fees to all the cities*
6 *and the county must not exceed 10 percent of the combined gross*
7 *revenues so collected.*

8 *3. Defray further with the proceeds of the taxes on transient lodging*
9 *the costs of the county fair and recreation board and of officers, agents*
10 *and employees hired thereby, and of incidentals incurred thereby, of*
11 *operating and maintaining recreational facilities under the jurisdiction*
12 *of the board, including, without limiting the generality of the foregoing,*
13 *the payment of reasonable promotional expenses pertaining thereto,*
14 *payment of reasonable expenses pertaining to the promotion of tourism*
15 *and gaming generally, both individually and through grants to the*
16 *chambers of commerce of the incorporated cities of the county or other*
17 *nonprofit groups or associations, and of improving, extending and*
18 *bettering any recreational facilities authorized by NRS 244A.597 to*
19 *244A.655, inclusive, including, without limitation, making annual grants*
20 *to the state, the county and incorporated cities in the county for capital*
21 *improvements for recreational facilities, and of constructing, purchasing*
22 *or otherwise acquiring any such recreational facilities.*

23 *4. Redeem any general obligation bonds or revenue bonds of the*
24 *county issued pursuant to NRS 244A.597 to 244A.655, inclusive,*
25 *principal, interest and any prior redemption premium, regardless of*
26 *whether such taxes are pledged as additional security for their payment.*

27 *5. Make contracts from time to time concerning taxes on transient*
28 *lodging, notwithstanding that any such contract may limit the exercise of*
29 *powers pertaining thereto, including the right of a local government from*
30 *time to time to increase, decrease or otherwise modify the tax, but no*
31 *such change may be made which prejudicially affects any pledge of tax*
32 *proceeds as additional security for the payment of bonds issued pursuant*
33 *to NRS 244A.597 to 244A.655, inclusive, and each other political*
34 *subdivision assigning or appropriating such taxes pertaining thereto*
35 *must consent to any such modification.*

36 *6. Make rules and regulations concerning taxes on transient lodging*
37 *and provide penalties for the failure to comply therewith.*

38 **Sec. 11.** *All taxes on transient lodging collected by any operator is*
39 *public money from the moment of the collection of the taxes and must be*
40 *held in trust by the operator collecting such taxes for the use and benefit*
41 *of the local government levying such taxes or for the use of the county*
42 *fair and recreation board where the revenues have been assigned or*
43 *appropriated to the county fair and recreation board.*

44 **Sec. 12.** *A local government responsible for the collection of a tax*
45 *imposed pursuant to this chapter or an agent of such local government*
46 *that has been authorized by the local government to collect a tax imposed*
47 *pursuant to this chapter, may:*

48 *1. Pursuant to generally accepted standards for auditing, examine*
49 *and audit the books, papers, records and equipment of any operator and*



1 of any person who is liable for a tax imposed pursuant to this chapter;
2 and

3 2. Investigate the transient lodging business of an operator to:

4 (a) Verify that the amount of taxes collected pursuant to this chapter
5 by the operator and reported in the tax return of the operator is correct;
6 or

7 (b) If the operator has not filed a tax return for taxes collected
8 pursuant to this chapter, determine the amount of tax that the operator
9 owes pursuant to this chapter.

10 **Sec. 13.** 1. A local government responsible for the collection of
11 taxes on transient lodging may require an operator to maintain certain
12 records relating to the rental of transient lodging and provide the records
13 to the local government upon request.

14 2. If a local government requires an operator to maintain certain
15 records pursuant to subsection 1, the operator shall maintain the records
16 for at least 4 years after the date of payment of the taxes on transient
17 lodging to the local government or the filing of the tax return which
18 includes the taxes on transient lodging with the local government,
19 whichever is later, unless the local government authorizes in writing the
20 earlier destruction of the records.

21 3. If a person fails to file a tax return or fails to obtain and maintain
22 any license required by the applicable local governments for operation of
23 a facility for transient lodging, he shall maintain all records, receipts,
24 invoices and any other information relating to the collection of a tax on
25 transient lodging for at least 8 years after those records, receipts, invoices
26 and other information are created, unless the local government
27 authorizes in writing the earlier destruction of the documents.

28 4. Except for a report filed pursuant to section 17 of this act, all
29 information concerning:

30 (a) Taxes on transient lodging levied pursuant to this chapter; and

31 (b) The business affairs or operation of any operator obtained as a
32 result of the payment of taxes on transient lodging or as the result of any
33 audit or examination of the books, records, papers and equipment of the
34 operator pursuant to section 12 of this act,
35 is confidential and must not be disclosed by any member, officer or
36 employee of the local government imposing the tax unless the disclosure
37 is authorized by the affirmative vote of a majority of the members of the
38 governing body of the local government. Continuing disclosure may be
39 authorized pursuant to an agreement with the department for the
40 exchange of information concerning taxpayers.

41 **Sec. 14.** Unless the local government provides otherwise by
42 ordinance or resolution, the taxes imposed pursuant to this chapter and
43 the forms for filing tax returns are due to the local government
44 responsible for collecting the taxes on or before the fifteenth day of the
45 month immediately following the month in which the operator collects
46 the taxes.

47 **Sec. 15.** 1. A local government that is required to impose a tax on
48 transient lodging pursuant to this chapter must enact or retain such
49 ordinances as are necessary to impose or collect the tax.

1 2. *Ordinances of a local government that relate to the imposition of a*
2 *tax on transient lodging pursuant to this chapter may include, without*
3 *limitation:*

4 (a) *The rate of tax on transient lodging, which must be in accordance*
5 *with the rates established pursuant to this chapter;*

6 (b) *Methods of reporting taxes on transient lodging to the local*
7 *government;*

8 (c) *A requirement that each operator display, in a conspicuous place,*
9 *a sign that provides notice to transient guests that a tax on transient*
10 *lodging is being imposed;*

11 (d) *Provisions for penalties, interest and reinstatement fees for*
12 *delinquent payment of a tax on transient lodging;*

13 (e) *Procedures for resolving disputes relating to the overpayment or*
14 *underpayment of a tax on transient lodging;*

15 (f) *Provisions for an exemption from payment of tax on transient*
16 *lodging for use or occupancy of the same room or space by the same*
17 *person for a certain number of consecutive days;*

18 (g) *Provisions for assessing a tax on transient lodging on rooms*
19 *provided to a transient guest free of charge;*

20 (h) *Documents required to support a claim for exemption from a tax*
21 *on transient lodging;*

22 (i) *Provisions for the calculation of a tax on transient lodging as part*
23 *of a promotional package;*

24 (j) *Provisions for a discount for prompt payment of a tax on transient*
25 *lodging;*

26 (k) *Licensing requirements for operators; and*

27 (l) *Procedures for revoking a license of an operator for failing to*
28 *remit to the local government revenues from a tax on transient lodging in*
29 *accordance with applicable requirements for remitting such revenues.*

30 3. *A local government that is required to impose a tax on transient*
31 *lodging pursuant to this chapter shall, by ordinance:*

32 (a) *Define the term “transient” for the purposes of sections 7 and 8 of*
33 *this act; and*

34 (b) *Define the terms “dwelling” and “lodging” for the purposes of*
35 *section 8 and subsection 2 of section 49 of this act.*

36 **Sec. 16.** 1. *A local government shall not enforce an ordinance that*
37 *imposes a new or additional tax on transient lodging or makes changes*
38 *relating to the imposition or collection of a tax on transient lodging, until*
39 *at least the first day of the second calendar month after the date the local*
40 *government adopts the ordinance that imposes the tax or makes the*
41 *changes. If a local government requires an operator to be licensed,*
42 *within 30 days after adopting an ordinance that imposes a new or*
43 *additional tax on transient lodging or makes changes relating to the*
44 *imposition or collection of a tax on transient lodging, the local*
45 *government shall mail written notice of the change to all operators that*
46 *are licensed as such by the local government.*

47 2. *Not more than 10 days after the effective date of any legislation*
48 *that changes provisions relating to the collection of a tax on transient*

1 *lodging, the department shall notify all entities responsible for collecting*
2 *the tax of the change.*

3 *3. The requirements for notification set forth in this section are in*
4 *addition to the requirements for notification set forth in chapter 237 of*
5 *NRS.*

6 **Sec. 17.** *On or before September 15 of each year, the governing body*
7 *of each local government shall submit a report to the department in a*
8 *form prescribed by the committee on local government finance that*
9 *states:*

10 *1. The rate of all taxes on transient lodging imposed within the*
11 *boundaries of the local government in the preceding fiscal year;*

12 *2. The total amount of revenue collected from all taxes on transient*
13 *lodging imposed within the boundaries of the local government in the*
14 *preceding fiscal year; and*

15 *3. The manner in which the revenue was used by the local*
16 *government in the previous fiscal year.*

17 **Sec. 18.** *1. Except as otherwise provided in this section, a notice of*
18 *determination of a deficiency in the payment of taxes on transient*
19 *lodging issued by a local government must be personally served or mailed*
20 *within 4 years after the fifteenth day of the first calendar month*
21 *following the period for which the amount is proposed to be determined*
22 *or within 3 years after the return is filed, whichever period expires later.*

23 *2. A notice of determination issued for failure to make a return or a*
24 *claim for an additional amount must be personally served or mailed*
25 *within 8 years after the last day of the calendar month following the*
26 *period for which the amount is proposed to be determined.*

27 *3. This section does not apply if an operator has committed fraud or*
28 *intentional evasion of the provisions of this chapter or any ordinance,*
29 *resolution or regulation adopted pursuant thereto.*

30 **Sec. 19.** *1. The board of county commissioners:*

31 *(a) In a county whose population is 400,000 or more, shall impose, by*
32 *ordinance, a tax at a rate of 2 percent; and*

33 *(b) In a county whose population is less than 400,000, shall impose,*
34 *by ordinance, a tax at the rate of 1 percent,*
35 *of the gross receipts from the rental of transient lodging in that county*
36 *upon all persons in the business of providing lodging. This tax must be*
37 *imposed by the board of county commissioners in each county, regardless*
38 *of the existence or nonexistence of any other license fee or tax imposed*
39 *on the revenues from the rental of transient lodging. The ordinance*
40 *imposing the tax must include a schedule for the payment of the tax.*

41 *2. A tax required pursuant to subsection 1 must be collected and*
42 *administered in accordance with ordinances adopted pursuant to section*
43 *15 of this act.*

44 *3. The tax imposed pursuant to subsection 1 may be collected from*
45 *the transient guests and may be shown as an addition to the charge for*
46 *the rental of transient lodging. The person providing the transient*
47 *lodging is liable to the county for the tax whether or not it is actually*
48 *collected from the transient guest.*

1 **Sec. 20.** *The proceeds of the tax imposed pursuant to section 19 of*
2 *this act and any applicable penalty or interest must be distributed as*
3 *follows:*

4 1. *In a county whose population is 400,000 or more:*

5 (a) *Three-eighths of the first 1 percent of the proceeds must be paid to*
6 *the department for deposit with the state treasurer for credit to the fund*
7 *for the promotion of tourism.*

8 (b) *The remaining proceeds must be transmitted to the county*
9 *treasurer for deposit in the county school district's fund for capital*
10 *projects established pursuant to NRS 387.328, to be held and expended in*
11 *the same manner as other money deposited in that fund.*

12 2. *In a county whose population is less than 400,000:*

13 (a) *Three-eighths must be paid to the department for deposit with the*
14 *state treasurer for credit to the fund for the promotion of tourism.*

15 (b) *Five-eighths must be deposited with the county fair and recreation*
16 *board created pursuant to NRS 244A.597 to 244A.655, inclusive, or, if no*
17 *such board is created, with the board of county commissioners, to be*
18 *used to advertise the resources of that county related to tourism,*
19 *including available accommodations, transportation, entertainment,*
20 *natural resources and climate, and to promote special events related*
21 *thereto.*

22 **Sec. 21.** *The proceeds of the tax imposed pursuant to section 19 of*
23 *this act must not be used:*

24 1. *As additional security for the payment of, or to redeem, any*
25 *general obligation bonds issued pursuant to NRS 244A.597 to 244A.655,*
26 *inclusive.*

27 2. *To defray the costs of collecting or administering the tax incurred*
28 *by the county fair and recreation board.*

29 3. *To operate and maintain recreational facilities under the*
30 *jurisdiction of the county fair and recreation board.*

31 4. *To improve and expand recreational facilities authorized by NRS*
32 *244A.597 to 244A.655, inclusive.*

33 5. *To construct, purchase or acquire recreational facilities described*
34 *in subsections 3 and 4.*

35 **Sec. 22.** 1. *Except as otherwise provided in subsection 2 of section*
36 *28 of this act, in addition to all other taxes imposed on the revenue from*
37 *the rental of transient lodging, a board of county commissioners may, by*
38 *ordinance, but not as in a case of emergency, impose a tax at the rate of*
39 *1 percent of the gross receipts from the rental of transient lodging*
40 *pursuant to either paragraph (a) or (b) as follows:*

41 (a) *After receiving the approval of a majority of the registered voters*
42 *of the county voting on the question at a special, primary or general*
43 *election, the board of county commissioners may impose the tax*
44 *throughout the county, including its incorporated cities, upon all persons*
45 *in the business of providing transient lodging. The question may be*
46 *combined with a question submitted pursuant to NRS 278.710, 371.045*
47 *or 377A.020, or any combination thereof.*

48 (b) *After receiving the approval of a majority of the registered voters*
49 *who reside within the boundaries of a transportation district created*

1 pursuant to NRS 244A.252 voting on the question at a special, primary
2 or general district election, the board of county commissioners may
3 impose the tax within the boundaries of the transportation district upon
4 all persons in the business of providing transient lodging. The question
5 may be combined with a question submitted pursuant to NRS 278.710.

6 2. A special election may be held only if the board of county
7 commissioners determines, by a unanimous vote, that an emergency
8 exists. The determination made by the board of county commissioners is
9 conclusive unless it is shown that the board acted with fraud or a gross
10 abuse of discretion. An action to challenge the determination made by
11 the board must be commenced within 15 days after the board's
12 determination is final. As used in this subsection, "emergency" means
13 any unexpected occurrence or combination of occurrences which
14 requires immediate action by the board of county commissioners to
15 prevent or mitigate a substantial financial loss to the county or to enable
16 the board to provide an essential service to the residents of the county.

17 3. The ordinance imposing the tax must include all the matters
18 required by section 19 of this act for the mandatory tax, must be
19 administered in the same manner, and imposes the same liabilities,
20 except:

21 (a) Collection of the tax imposed pursuant to this section must not
22 commence earlier than the first day of the second calendar month after
23 adoption of the ordinance imposing the tax; and

24 (b) The governmental entity collecting the tax shall transfer all
25 collections to the county and may not retain any part of the tax as a
26 collection or administrative fee.

27 **Sec. 23.** In a county in which a tax has been imposed pursuant to
28 paragraph (a) of subsection 1 of section 22 of this act:

29 1. The proceeds of the tax and any applicable penalty or interest
30 must be:

31 (a) Remitted to the appropriate city if collected in the incorporated
32 area of any city and not within any transportation district created by the
33 county, or if collected in any transportation district created by a city; or

34 (b) Retained by the county if collected elsewhere, and used as provided
35 in this section.

36 2. Except as otherwise provided in subsection 3, if the county has
37 created one or more transportation districts, it shall use any part of the
38 money retained which is collected within the boundaries of a
39 transportation district to pay the cost of:

40 (a) Projects related to the construction and maintenance of sidewalks,
41 streets, avenues, boulevards, highways, bridges and other public rights of
42 way used primarily for vehicular or fixed guideway traffic, including,
43 without limitation, overpass projects, street projects and underpass
44 projects, as defined in NRS 244A.037, 244A.053 and 244A.055,
45 respectively, within the boundaries of the district or within 1 mile outside
46 those boundaries if the governing body finds that such projects outside
47 the boundaries of the district will facilitate transportation within the
48 district;

1 (b) Payment of principal and interest on notes, bonds or other
2 obligations issued by the county to fund projects described in paragraph
3 (a); or

4 (c) Any combination of those uses.

5 3. In addition to those uses set forth in subsection 2, if a county has
6 created one or more transportation districts and all or any portion of
7 those districts is located in an area that is governed by an interstate
8 compact entered into by this state and a state that borders this state, the
9 county may use any part of the money retained which is collected within
10 the boundaries of a transportation district to pay the cost of establishing,
11 operating and maintaining a public transit system, including any
12 improvement thereto, within the boundaries of the district, or outside
13 those boundaries if the governing body finds that such a system outside
14 the boundaries of the district will facilitate transportation within the
15 district, or both.

16 4. If the county has entered into an agreement pursuant to NRS
17 277.080 to 277.170, inclusive, which contemplates later payment by the
18 other party of a portion of the cost of a project which may be funded
19 pursuant to subsection 2, the county may pay from retained proceeds the
20 principal and interest on notes, bonds or other obligations issued in
21 anticipation of that payment.

22 5. Any part of the money retained which is collected in the
23 unincorporated area of the county and not within any transportation
24 district created by the county or a city must be used for the same
25 purposes within the unincorporated area of the county or within 1 mile
26 outside that area if the board of county commissioners finds that such
27 projects outside that area will facilitate transportation within that area.

28 6. As used in this section:

29 (a) "Improvement" has the meaning ascribed to it in NRS 244A.033.

30 (b) "Public transit system" means a system designed to facilitate the
31 transportation of members of the general public, including:

32 (1) The use of motor buses, rails or any other means of conveyance,
33 operated by whatever type of power; and

34 (2) An offstreet parking project or an overpass project as defined in
35 NRS 244A.035 and 244A.037, respectively.

36 **Sec. 24.** In a transportation district in which a tax has been imposed
37 pursuant to paragraph (b) of subsection 1 of section 22 of this act, the
38 proceeds of the tax and any applicable penalty or interest must be
39 retained by the county and used to pay the cost of:

40 1. Projects related to the construction and maintenance of sidewalks,
41 streets, avenues, boulevards, highways and other public rights of way
42 used primarily for vehicular traffic, including, without limitation,
43 overpass projects, street projects and underpass projects, as defined in
44 NRS 244A.037, 244A.053 and 244A.055, respectively, within the
45 boundaries of the district or within such a distance outside those
46 boundaries as is stated in the ordinance imposing the tax, if the
47 governing body finds that such projects outside the boundaries of the
48 district will facilitate transportation within the district;

1 2. *Payment of principal and interest on notes, bonds or other*
2 *obligations issued by the county to fund projects described in subsection*
3 *1; or*

4 3. *Any combination of those uses.*

5 **Sec. 25.** *A board of county commissioners which, after March 25,*
6 *1991, imposes a tax pursuant to NRS 278.710, 365.203, 371.045, 373.030*
7 *or 377A.020, or section 22 of this act shall, by January 1, 2001, and every*
8 *10 years thereafter:*

9 1. *Prepare a comprehensive report which includes:*

10 (a) *A statement of the proposed uses during the following 10 years of*
11 *the revenues to be collected from each tax imposed; and*

12 (b) *A projection of the principal amount of any general or special*
13 *obligation bonds or other securities proposed to be issued during the*
14 *following 10 years to fund projects described in paragraph (a) of*
15 *subsection 2 of section 23 of this act;*

16 2. *Hold a public hearing to consider and solicit comments on the*
17 *report; and*

18 3. *Provide a copy of the report to the next regular session of the*
19 *legislature.*

20 **Sec. 26.** 1. *Any tax on transient lodging:*

21 (a) *Which is levied by a county whose population is 100,000 or more;*

45 The Reno-Sparks Convention and Visitors Authority:

46 (a) Shall remit all proceeds of the tax imposed on or before
47 June 30, 1992, and any penalty and interest attributable thereto, to the
48 City of Reno 30 days after receipt; and

(b) May not retain any part of the tax, interest or penalties as collection or administrative fee.

4. The proceeds of the tax imposed pursuant to subsection 2:

(a) From July 1, 1991, through June 30, 1992, and any penalties and interest attributable thereto must be used to pay the costs of operation or debt service, or both, of the National Automobile Museum; and

(b) After June 30, 1992, and any penalties and interest attributable thereto must be used to pay the cost of the construction and operation of a multi-purpose bowling facility, including parking and space for other functions ancillary to such a facility.

5. If the Reno-Sparks Convention and Visitors Authority does not approve the construction of the bowling facility on or before June 30, 1992, the collection of the tax must be suspended until such action is taken or June 30, 1993, whichever is earlier. If the collection of the tax is suspended on June 30, 1993, the board of county commissioners shall repeal the ordinance imposing the tax and shall not impose any further taxes pursuant to this section.

6. The county, acting by and through the Reno-Sparks Convention and Visitors Authority, may pledge any money received from the proceeds of the tax imposed pursuant to this section with revenue derived from the project that is described in paragraph (b) of subsection 4, including any existing or future extensions or enlargements thereof, for the payment of general or special obligations issued for the project. A pledge pursuant to this subsection may include the tax authorized by this section and other taxes imposed on the rental of transient lodging that are available for pledge by the Reno-Sparks Convention and Visitors Authority. Any money pledged by the county pursuant to this subsection may be treated as pledged revenues of the project for the purposes of subsection 3 of NRS 350.020.

Sec. 60. Section 24 of Chapter 506, Statutes of Nevada 1997, as last amended by chapter 28, Statutes of Nevada 1999, at page 64, is hereby amended to read as follows:

Sec. 24. 1. The board of county commissioners of Washoe County may by ordinance, but not as in a case of emergency, impose a tax upon the retailers at the rate of not more than one-eighth of 1 percent of the gross receipts of any retailer from the sale of all tangible personal property sold at retail, or stored, used or otherwise consumed in the county if:

(a) The city of Reno imposes a tax on the rental of transient lodging pursuant to ~~NRS 268.7845~~ *section 35 of this act* in the maximum amount allowed by that section; and

1 2. An ordinance enacted pursuant to subsection 1 may not
2 become effective before a question concerning the imposition of the
3 tax is approved by a two-thirds majority of the members of the board

5 3. An ordinance enacted pursuant to subsection 1 must specify the
6 date on which the tax must first be imposed which must occur on the
7 first day of the first month of the next calendar quarter that is at least
8 60 days after the date on which a two-thirds majority of the board of

All decisions, and any deliberations leading to those decisions, that are made by any body, including, without limitation, the Reno/Sparks Convention and Visitors Authority, the Truckee Meadows Tourism Facility and Revitalization Steering Committee and the Sparks Tourism and Marketing Committee, concerning the expenditure, commitment or other use of money derived from the proceeds of the tax imposed pursuant to this section must be made at a public meeting that complies with the provisions of chapter 241 of NRS, whether or not the body is determined to be a public body to which that chapter is applicable.

4. As used in this section, "gross receipts from the rental of transient lodging" does not include the tax imposed or collected from paying guests pursuant to this section.

Nothing in this act repeals or otherwise affects the operation of existing local acts, including the Carson City Tax on Transient Lodging, the Douglas County Lodgers Tax Law, the Washoe County Taxes on Transient Lodging and the Tahoe-Douglas Visitor's Authority Act.
