AN ACT relating to the department of prisons; requiring the director to establish a system for offender management in each institution and facility of the department; requiring the director to develop and implement a program of facility training for correctional staff in each institution and facility of the department.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 209 of NRS is hereby amended by adding thereto
2 the provisions set forth as sections 1.3 and 1.7 of this act.
3 **Sec. 1.3.** *The director shall establish, with the approval of the board,*
4 *a system for offender management, to be implemented in each institution*
5 *and facility of the department, which consists of structured living*
6 *programs for offenders and the management of units by the staff, with*
7 *levels of custody, security and privileges and opportunities for offenders*
8 *based upon the assessed needs of the offenders as determined by their*
9 *initial and ongoing classification and evaluation.*
10 **Sec. 1.7.** *The director shall develop and implement, in each*
11 *institution and facility of the department, a program of facility training*
12 *for the correctional staff.*
13 **Sec. 2.** NRS 209.051 is hereby amended to read as follows:
14 209.051 “Department” means the department of ~~prisons.~~ *corrections.*
15 **Sec. 3.** NRS 209.061 is hereby amended to read as follows:
16 209.061 “Director” means the director of the department . ~~of prisons.~~
17 **Sec. 4.** NRS 209.101 is hereby amended to read as follows:
18 209.101 1. The department of ~~prisons.~~ *corrections* is hereby
19 created.
20 2. The head of the department is the board of state prison
21 commissioners.



1 3. The governor is the president of the board. The secretary of state is
2 the secretary of the board.
3 4. Any two members of the board constitute a quorum for the
4 transaction of business.
5 5. The secretary shall keep full and correct records of all the
6 transactions and proceedings of the board.
7 **Sec. 5.** NRS 209.136 is hereby amended to read as follows:
8 209.136 The director of the department ~~{of prisons}~~ shall notify the
9 senate standing committee on finance and the assembly standing
10 committee on ways and means during a regular or special session of the
11 legislature and the interim finance committee when the legislature is not in
12 session of any:
13 1. Negotiations entered into by the department to resolve any potential
14 or existing litigation which could have a fiscal effect that exceeds the
15 amount budgeted for that purpose by the legislature; and
16 2. Plans regarding the location of any prison facility or institution.
17 **Sec. 6.** NRS 209.151 is hereby amended to read as follows:
18 209.151 1. The director shall appoint an assistant director for
19 industrial programs who:
20 (a) Is responsible to the director for the administration of all industrial,
21 vocational and agricultural programs for the employment of offenders,
22 except conservation camps and centers for the purpose of making
23 restitution; and
24 (b) Shall enforce all policies and regulations of the department relating
25 to industrial, vocational and agricultural programs.
26 2. *The director shall appoint an assistant director for offender*
27 *management who:*
28 *(a) Is responsible to the director for the administration of all*
29 *programs concerning the education, training, rehabilitation, treatment*
30 *and development of skills of offenders and all programs concerning*
31 *services for victims and families of offenders; and*
32 *(b) Shall enforce all policies and regulations of the department*
33 *relating to the programs described in paragraph (a).*
34 3. In addition to the assistant ~~{director}~~ *directors* appointed pursuant to
35 ~~{subsection 1,}~~ *subsections 1 and 2*, the director shall appoint such other
36 assistant directors as are necessary.
37 ~~{3-}~~ 4. The assistant directors are in the classified service of the state
38 except for purposes of retention.
39 ~~{4-}~~ 5. During any absence of the director, he shall designate an
40 assistant director or a warden to act as director of the department without
41 increase in salary.
42 ~~{5-}~~ 6. The assistant directors shall carry out such administrative
43 duties as may be assigned to them by the director and shall not engage in
44 any other gainful employment or occupation.
45 **Sec. 7.** NRS 209.153 is hereby amended to read as follows:
46 209.153 The assistant director for industrial programs appointed
47 pursuant to subsection 1 of NRS 209.151 ~~{is}~~ *and the assistant director for*
48 *offender management appointed pursuant to subsection 2 of NRS*
49 *209.151 are* entitled to receive the same retirement benefits as police



1 officers and firemen employed by public employers. For this purpose, the
2 provisions of chapter 286 of NRS governing the retirement benefits of
3 police officers and firemen apply to the assistant director ~~for industrial~~
4 ~~programs and the assistant director for offender management.~~

5 **Sec. 8.** NRS 209.183 is hereby amended to read as follows:

6 209.183 In addition to his regular salary, each person employed by the
7 department of ~~prisons~~ *corrections* or the division of forestry of the state
8 department of conservation and natural resources at the Southern Nevada
9 Correctional Center, the Southern Desert Correctional Center, the Indian
10 Springs Conservation Camp, the correctional institution identified as the
11 Men's Prison No. 7 in chapter 656, Statutes of Nevada 1995, and chapter
12 478, Statutes of Nevada 1997, or the Jean Conservation Camp is entitled to
13 receive, as compensation for travel expenses, not more than \$7.50 for each
14 day he reports to work if his residence is more than 25 miles from the
15 respective facility. The total cost for compensation for travel expenses
16 authorized by this section must not exceed the amount specially
17 appropriated for this purpose.

18 **Sec. 9.** NRS 209.189 is hereby amended to read as follows:

19 209.189 1. The fund for prison industries is hereby created as an
20 enterprise fund to receive all revenues derived from programs for
21 vocational training and employment of offenders and the operation of the
22 prison farm and to receive all revenues raised by the department from
23 private employers for the leasing of space, facilities or equipment within
24 the institutions or facilities of the department. ~~for prisons.~~

25 2. Money in the fund must be maintained in separate budgetary
26 accounts, including at least one account for industrial programs and one for
27 the prison farm.

28 3. Subject to the approval of the state board of examiners, the director
29 may expend money deposited in this fund for the promotion and
30 development of these programs and the prison farm. The director shall
31 expend money deposited in this fund to pay the premiums required for
32 coverage of offenders under the modified program of industrial insurance
33 adopted pursuant to NRS 616B.028.

34 4. The interest and income earned on the money in the fund, after
35 deducting any applicable charges, must be credited to the fund.

36 5. If money owed to the department for the leasing of space, facilities
37 or equipment within the institutions or facilities of the department or for
38 the purchase of goods or services, which must be deposited into the fund
39 for prison industries pursuant to subsection 1, is not paid on or before the
40 date due, the department shall charge and collect, in addition to the money
41 due, interest on the money due at the rate of 1.5 percent per month or
42 fraction thereof from the date on which the money became due until the
43 date of payment.

44 **Sec. 10.** NRS 209.248 is hereby amended to read as follows:

45 209.248 1. The department ~~of prisons~~ shall establish in any insured
46 bank, credit union or savings and loan association doing business in this
47 state an account for disbursements to offenders. The balance in the account
48 must not exceed \$600,000. Money in the account may be expended only
49 for the payment of transactions involving offenders' trust funds.

1 2. Payments made from the account for disbursements to offenders
2 must be promptly reimbursed from money in the appropriate fund on
3 deposit with the state treasurer.

4 **Sec. 11.** NRS 209.274 is hereby amended to read as follows:

5 209.274 1. Except as otherwise provided in this section, when an
6 offender is required or requested to appear before a court in this state, the
7 department ~~of prisons~~ shall transport the offender to and from court on
8 the day scheduled for his appearance.

9 2. If notice is not provided within the time set forth in NRS 50.215, the
10 department shall transport the offender to court on the date scheduled for
11 his appearance if it is possible to transport the offender in the usual manner
12 for the transportation of offenders by the department. If it is not possible
13 for the department to transport the offender in the usual manner:

14 (a) The department shall make the offender available on the date
15 scheduled for his appearance to provide testimony by telephone or by
16 video, if so requested by the court.

17 (b) The department shall provide for special transportation of the
18 offender to and from the court, if the court so orders. If the court orders
19 special transportation, it shall order the county in which the court is located
20 to reimburse the department for any cost incurred for the special
21 transportation.

22 (c) The court may order the county sheriff to transport the offender to
23 and from the court at the expense of the county.

24 **Sec. 12.** NRS 209.382 is hereby amended to read as follows:

25 209.382 1. The state health officer shall periodically examine and
26 shall report to the board semiannually upon the following operations of the
27 department : ~~of prisons~~

28 (a) The medical and dental services and places where they are provided,
29 based upon the standards for medical facilities as provided in chapter 449
30 of NRS.

31 (b) The nutritional adequacy of the diet of incarcerated offenders taking
32 into account the religious or medical dietary needs of an offender and the
33 adjustment of dietary allowances for age, sex and level of activity.

34 (c) The sanitation, healthfulness, cleanliness and safety of its various
35 institutions and facilities.

36 2. The board shall take appropriate action to remedy any deficiencies
37 reported ~~under~~ *pursuant to* subsection 1.

38 **Sec. 13.** NRS 209.429 is hereby amended to read as follows:

39 209.429 1. Except as otherwise provided in subsection 6, the director
40 shall assign an offender to the custody of the division of parole and
41 probation of the department of motor vehicles and public safety to serve a
42 term of residential confinement, pursuant to NRS 213.380, for not longer
43 than the remainder of the maximum term of his sentence if:

44 (a) The offender has:

45 (1) Established a position of employment in the community;

46 (2) Enrolled in a program for education or rehabilitation; or

47 (3) Demonstrated an ability to pay for all or part of the costs of his
48 confinement and to meet any existing obligation for restitution to any
49 victim of his crime;

1 (b) The offender has successfully completed the initial period of
2 treatment required under the program of treatment established pursuant to
3 NRS 209.425; and

4 (c) The director believes that the offender will be able to:

5 (1) Comply with the terms and conditions required under residential
6 confinement; and

7 (2) Complete successfully the remainder of the program of treatment
8 while under residential confinement.

9 If an offender assigned to the program of treatment pursuant to NRS
10 209.427, completes the initial phase of the program and thereafter refuses
11 to enter the remainder of the program of treatment pursuant to this section,
12 the offender forfeits all or part of the credits earned by him to reduce his
13 sentence pursuant to this chapter before this refusal, as determined by the
14 director. The director may provide for a forfeiture of credits pursuant to
15 this paragraph only after proof of the offense and notice to the offender,
16 and may restore credits forfeited for such reasons as he considers proper.
17 The decision of the director regarding such a forfeiture is final.

18 2. Before a person may be assigned to serve a term of residential
19 confinement pursuant to this section, he must submit to the division of
20 parole and probation a signed document stating that:

21 (a) He will comply with the terms or conditions of his residential
22 confinement; and

23 (b) If he fails to comply with the terms or conditions of his residential
24 confinement and is taken into custody outside of this state, he waives all
25 his rights relating to extradition proceedings.

26 3. If an offender assigned to the custody of the division of parole and
27 probation pursuant to this section escapes or violates any of the terms or
28 conditions of his residential confinement:

29 (a) The division of parole and probation may, pursuant to the procedure
30 set forth in NRS 213.410, return the offender to the custody of the
31 department. ~~to prisons.~~

32 (b) The offender forfeits all or part of the credits earned by him to
33 reduce his sentence pursuant to this chapter before the escape or violation,
34 as determined by the director. The director may provide for a forfeiture of
35 credits pursuant to this paragraph only after proof of the offense and notice
36 to the offender, and may restore credits forfeited for such reasons as he
37 considers proper. The decision of the director regarding forfeiture of
38 credits is final.

39 4. The assignment of an offender to the custody of the division of
40 parole and probation pursuant to this section shall be deemed:

41 (a) A continuation of his imprisonment and not a release on parole; and

42 (b) For the purposes of NRS 209.341, an assignment to a facility of the
43 department, ~~to prisons.~~
44 except that the offender is not entitled to obtain any benefits or to
45 participate in any programs provided to offenders in the custody of the
46 department. ~~to prisons.~~

47 5. A person does not have a right to be assigned to the custody of the
48 division of parole and probation pursuant to this section, or to remain in
49 that custody after such an assignment, and it is not intended that the



1 provisions of this section or of NRS 213.371 to 213.410, inclusive, create
2 any right or interest in liberty or property or establish a basis for any cause
3 of action against the state, its political subdivisions, agencies, boards,
4 commissions, departments, officers or employees.

5 6. The director shall not assign an offender who is serving a sentence
6 for committing a battery which constitutes domestic violence pursuant to
7 NRS 33.018 to the custody of the division of parole and probation to serve
8 a term of residential confinement unless the director makes a finding that
9 the offender is not likely to pose a threat to the victim of the battery.

10 **Sec. 14.** NRS 209.481 is hereby amended to read as follows:
11 209.481 1. The director shall not assign any prisoner to an institution
12 or facility of minimum security if the prisoner:
13 (a) Except as otherwise provided in NRS 484.3792 and 484.3795, is not
14 eligible for parole or release from prison within a reasonable period;
15 (b) Has recently committed a serious infraction of the rules of an
16 institution or facility of the department ; ~~of prisons;~~
17 (c) Has not performed the duties assigned to him in a faithful and
18 orderly manner;
19 (d) Has been convicted of a sexual offense;
20 (e) Has committed an act of serious violence during the previous year;
21 or
22 (f) Has attempted to escape or has escaped from an institution of the
23 department. ~~of prisons;~~
24 2. The director shall, by regulation, establish procedures for classifying
25 and selecting qualified prisoners.

26 **Sec. 15.** NRS 209.4813 is hereby amended to read as follows:
27 209.4813 1. The advisory board on industrial programs is hereby
28 created.
29 2. The advisory board consists of the director of the department , ~~of~~
30 ~~prisons;~~ the chief of the purchasing division of the department of
31 administration and eight members appointed by the interim finance
32 committee as follows:
33 (a) Two members of the senate.
34 (b) Two members of the assembly.
35 (c) Two persons who represent manufacturing in this state.
36 (d) One person who represents business in this state.
37 (e) One person who represents organized labor in this state.
38 3. The members of the advisory board shall select a chairman from
39 among their membership.
40 4. Each member of the advisory board appointed by the interim
41 finance committee must be appointed to a term of 2 years and may be
42 reappointed.
43 5. Except during a regular or special session of the legislature, each
44 legislator who is a member of the advisory board is entitled to receive the
45 compensation provided for a majority of the members of the legislature
46 during the first 60 days of the preceding regular session for each day or
47 portion of a day during which he attends a meeting of the advisory board or
48 is otherwise engaged in the work of the advisory board. Each
49 nonlegislative member appointed by the interim finance committee is

1 entitled to receive compensation for his service on the advisory board in
2 the same amount and manner as the legislative members whether or not the
3 legislature is in session. Each nonlegislative member of the advisory board
4 is entitled to receive the per diem allowance and travel expenses provided
5 for state officers and employees generally. Each legislator who is a
6 member of the advisory board is entitled to receive the per diem allowance
7 provided for state officers and employees generally and the travel expenses
8 provided pursuant to NRS 218.2207. All compensation, allowances and
9 travel expenses must be paid from the fund for prison industries.

10 **Sec. 16.** NRS 209.521 is hereby amended to read as follows:

11 209.521 1. If a victim of an offender provides his current address to
12 the director and makes a written request for notification of the offender's
13 release or escape, the director shall notify the victim if the offender:

14 (a) Will be released into the community for the purpose of employment,
15 training or education, or for any other purpose for which release is
16 authorized; or

17 (b) Has escaped from the custody of the department . ~~{of prisons.}~~

18 2. An offender must not be temporarily released into the community
19 for any purpose unless notification of the release has been given to every
20 victim of the offender who has requested notification and has provided his
21 current address.

22 3. The director may not be held responsible for any injury proximately
23 caused by his failure to give any notice required pursuant to subsection 1 or
24 2 if no address was provided to the director or the address provided is
25 inaccurate or not current.

26 4. All personal information, including, but not limited to, a current or
27 former address, which pertains to a victim and which is received by the
28 director pursuant to this section is confidential.

29 5. As used in this section, "victim" has the meaning ascribed to it in
30 NRS 213.005.

31 **Sec. 17.** NRS 211.040 is hereby amended to read as follows:

32 211.040 1. Payment of expenses and the method of transporting a
33 prisoner from a county jail to an institution or facility of the department of
34 ~~{prisons}~~ **corrections** must be as provided in chapter 209 of NRS. When a
35 prisoner is transferred from the county jail to such an institution or facility,
36 the sheriff shall provide the director of the department of ~~{prisons}~~
37 **corrections** with a written report pertaining to the medical, psychiatric,
38 behavioral or criminal aspects of the prisoner's history. This report may be
39 based upon observations of the prisoner while confined in the county jail
40 and must note in particular any medication or medical treatment
41 administered in the jail, including the type, dosage and frequency of
42 administration.

43 2. Except as provided in subsection 1, the sheriff, personally or by his
44 deputy, or by one or more of his jailers, shall transfer all prisoners within
45 his county to whatever place of imprisonment the sentence of the court
46 may require, at as early a date after the sentence as practicable. For that
47 purpose the board of county commissioners shall pay all necessary costs,
48 charges and expenses of the prisoner or prisoners, and of the officer or

1 officers having charge thereof, to which must be added mileage for each
2 officer, at the rate of 20 cents per mile, one way only.

3 3. The provisions of subsection 2 apply in cases where prisoners are
4 taken from county jails to be tried in any courts in other counties.

5 **Sec. 18.** NRS 212.030 is hereby amended to read as follows:

6 212.030 1. When any prisoner escapes from an institution or facility
7 of the department of ~~prisons~~ **corrections**, the director of the department
8 may issue a warrant for the recapture of the escaped prisoner. The warrant
9 is effective in any county in this state, and may command the sheriff of any
10 county in this state, or any constable thereof, or any police officer of any
11 city in this state, to arrest the prisoner and return him to the director.

12 2. When any prisoner escapes from a jail, branch county jail or other
13 local detention facility, the sheriff, chief of police or other officer
14 responsible for the operation of the facility may issue a warrant for the
15 recapture of the escaped prisoner. The warrant is effective in any county in
16 this state, and may command the sheriff of any county in this state, or any
17 constable thereof, or any police officer of any city in this state, to arrest the
18 prisoner and return him to the officer who issued the warrant.

19 **Sec. 19.** NRS 212.040 is hereby amended to read as follows:

20 212.040 1. If an escape is not the result of carelessness,
21 incompetency or other official delinquency of the director or other officers
22 of the department of ~~prisons~~ **corrections**, all expenses of enforcing the
23 provisions of NRS 212.030 or appertaining to the recapture and return of
24 escaped convicts are a charge against the state, and must be paid out of the
25 reserve for statutory contingency account upon approval by the state board
26 of examiners.

27 2. Except as otherwise provided in NRS 211.060, all expenses of
28 enforcing the provisions of NRS 212.030 or appertaining to the recapture
29 and return of escaped convicts are a charge against the county, city or other
30 local government responsible for the operation of that facility.

31 **Sec. 20.** NRS 212.150 is hereby amended to read as follows:

32 212.150 1. A person shall not visit, or in any manner communicate
33 with, any prisoner convicted of or charged with any felony, imprisoned in
34 the county jail, other than the officer having such prisoner in charge, his
35 attorney, or the district attorney, unless the person has a written permission
36 so to do, signed by the district attorney, or has the consent of the director of
37 the department of ~~prisons~~ **corrections** or the constable or sheriff having
38 such prisoner in charge.

39 2. Any person violating, aiding in, conniving at, or participating in the
40 violation of this section is guilty of a gross misdemeanor.

41 **Sec. 21.** NRS 212.160 is hereby amended to read as follows:

42 212.160 1. A person, who is not authorized by law, who knowingly
43 furnishes, attempts to furnish, or aids or assists in furnishing or attempting
44 to furnish to a prisoner confined in an institution of the department of
45 ~~prisons~~ **corrections**, or any other place where prisoners are authorized to
46 be or are assigned by the director of the department, any deadly weapon,
47 explosive, a facsimile of a firearm or an explosive, any controlled
48 substance or intoxicating liquor, shall be punished:



1 (a) Where a deadly weapon, controlled substance, explosive or a
2 facsimile of a firearm or explosive is involved, for a category B felony by
3 imprisonment in the state prison for a minimum term of not less than 1 year
4 and a maximum term of not more than 6 years, and may be further
5 punished by a fine of not more than \$5,000.

6 (b) Where an intoxicant is involved, for a gross misdemeanor.
7 2. Knowingly leaving or causing to be left any deadly weapon,
8 explosive, facsimile of a firearm or explosive, controlled substance or
9 intoxicating liquor where it may be obtained by any prisoner constitutes,
10 within the meaning of this section, the furnishing of the article to the
11 prisoner.

12 3. A prisoner confined in an institution of the department of ~~prisons,~~
13 **corrections**, or any other place where prisoners are authorized to be or are
14 assigned by the director of the department, who possesses a controlled
15 substance without lawful authorization is guilty of a category D felony and
16 shall be punished as provided in NRS 193.130.

17 **Sec. 22.** NRS 212.180 is hereby amended to read as follows:

18 212.180 It is unlawful for any person, unless he was licensed to sell
19 alcoholic beverages at that address before July 1, 1983, to sell by wholesale
20 or retail any alcoholic beverage within one-half mile of any institution
21 under the jurisdiction of the department of ~~prisons,~~ **corrections** which is
22 designed to house 125 or more offenders within a secure perimeter, and no
23 license may be granted authorizing the sale of any alcoholic beverage
24 within one-half mile of such an institution.

25 **Sec. 23.** NRS 213.020 is hereby amended to read as follows:

26 213.020 1. Any person intending to apply to have a fine or forfeiture
27 remitted, or a punishment commuted, or a pardon granted, or someone in
28 his behalf, shall make out a notice and four copies in writing of the
29 application, specifying therein:

- 30 (a) The court in which the judgment was rendered;
31 (b) The amount of the fine or forfeiture, or kind or character of
32 punishment;
33 (c) The name of the person in whose favor the application is to be made;
34 (d) The particular grounds upon which the application will be based;
35 and
36 (e) The time when it will be presented.

37 2. Two of the copies must be served upon the district attorney and one
38 upon the district judge of the county wherein the conviction was had. The
39 fourth copy must be served upon the director of the department of ~~prisons,~~
40 **corrections** and the original must be filed with the clerk of the board. In
41 cases of fines and forfeitures a similar notice must also be served on the
42 chairman of the board of county commissioners of the county wherein the
43 conviction was had.

44 3. The notice must be served, as provided in this section, at least 30
45 days before the presentation of the application, unless a member of the
46 board, for good cause, prescribes a shorter time.

47 **Sec. 24.** NRS 213.100 is hereby amended to read as follows:

48 213.100 Whenever clemency is granted by the board, there shall be
49 served upon the director of the department of ~~prisons,~~ **corrections** or other

1 officer having the person in custody, an order to discharge him therefrom
2 upon a day to be named in the order, upon the conditions, limitations or
3 restrictions named therein.

4 **Sec. 25.** NRS 213.1088 is hereby amended to read as follows:

5 213.1088 1. The department of motor vehicles and public safety in
6 conjunction with the department of ~~prisons~~ **corrections** shall establish a
7 program of orientation that:

8 (a) Each member of the board shall attend upon appointment to a first
9 term; and

10 (b) Each person named by the board to the list of persons eligible to
11 serve as a case hearing representative pursuant to NRS 213.135 shall attend
12 upon being named to the list. A person named to the list may not serve as a
13 case hearing representative until the person completes the program of
14 orientation.

15 2. The program of orientation must include a minimum of 40 hours of
16 training. The information presented during the program of orientation must
17 include, but is not limited to:

18 (a) A historical perspective of parole, including the objectives of and
19 reasons for using parole within the criminal justice system;

20 (b) The role and function of the board within the criminal justice
21 system;

22 (c) The responsibilities of members of the board and case hearing
23 representatives;

24 (d) The goals and objectives of the board;

25 (e) The programs administered by the board;

26 (f) The policies and procedures of the board; and

27 (g) The laws and regulations governing parole, including the standards
28 for granting, denying, revoking and continuing parole.

29 3. The chairman of the board shall develop a written plan for the
30 continuing education of members of the board and case hearing
31 representatives. The plan must require that:
