AN ACT relating to school districts; authorizing the department of education to waive certain eligibility requirements for grants of money previously appropriated for the purchase of library books and extending the reversion date of the appropriation; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Section 4 of chapter 544, Statutes of Nevada 1999, at page
2 2842, is hereby amended to read as follows:
3 Sec. 4. 1. There is hereby appropriated from the state general
4 fund to the Department of Education for distribution to school
5 districts to purchase library books:
6 For the fiscal year 1999-2000..... \$374,000
7 For the fiscal year 2000-2001..... \$374,000
8 2. ~~{Except as otherwise provided in subsection 7, the}~~ *The* board
9 of trustees of a school district may submit an application to the
10 Department of Education for a grant of money from the appropriation
11 made by subsection 1 on a form provided by the Department of
12 Education. Such an application must include a description of the:
13 (a) Amount of money expended by the school district, excluding
14 gifts and grants, in the immediately preceding year for the purchase of
15 library books for use in the media centers of school libraries within
16 the school district; and
17 (b) Financial needs of the school district to maintain an adequate
18 supply of library books in the media centers of school libraries within
19 the school district.
20 3. Upon receipt of such an application, the Department of
21 Education shall review the application to determine whether it is
22 complete. Except as otherwise provided in subsection 7, the

1 Department of Education shall approve an application if it is
2 complete.

3 4. The Department of Education shall apportion the money
4 available for each fiscal year among the school districts whose
5 applications have been approved. Each school district is entitled to
6 receive, within the limits of money available, an amount equal to not
7 more than 50 percent of the money that the school district expended,
8 excluding gifts and grants, on the purchase of library books for use in
9 the media centers of school libraries in the immediately preceding
10 year.

11 5. The board of trustees of a school district that receives a grant of
12 money pursuant to subsection 4 shall use the money to purchase
13 library books for use in the media centers of school libraries.

14 6. The board of trustees of a school district that receives a grant of
15 money pursuant to subsection 4 shall not use the money to:

16 (a) Supplant or cause to be reduced any other source of funding for
17 the media centers of school libraries within the school district.

18 (b) Settle or arbitrate disputes or negotiate settlements between an
19 organization that represents licensed employees of the school district
20 and the school district.

21 (c) Adjust the schedules of salaries and benefits of the employees
22 of the school district.

23 7. ~~HH~~ *Except as otherwise provided in subsection 8, if* the board
24 of trustees of a school district receives a grant of money pursuant to
25 subsection 4 for the fiscal year 1999-2000 and the board of trustees
26 does not expend at least the amount of money, excluding gifts and
27 grants, that the board of trustees expended in the immediately
28 preceding year on the purchase of library books for media centers of
29 school libraries, the board of trustees is not eligible to ~~apply for~~
30 *receive* a grant of money for the fiscal year 2000-2001. If the
31 Department of Education receives an application from a school
32 district and, upon review of the information contained in the
33 application described in paragraph (a) of subsection 2, the Department
34 determines that the board of trustees did not expend at least the
35 amount of money that the board of trustees expended in the
36 immediately preceding year on the purchase of library books for
37 media centers of school libraries, the Department shall deny the
38 application ~~H~~, *unless a waiver is granted pursuant to subsection 8.*

39 8. *The Department of Education may waive the requirement*
40 *provided in subsection 7 for good cause shown.*

41 9. As used in this section, "media center of a school library"
42 means a centralized collection of educational resources located in a
43 school library that is designed to:

44 (a) Integrate the curriculum of a school;

45 (b) Teach pupils skills in methods to acquire information; and

46 (c) Ensure that teachers and pupils use the resources of information
47 offered in a school library.

48 ~~9-10~~ 10. Any remaining balance of the appropriation made by
49 subsection 1 for:



1 (a) The fiscal year 1999-2000 must be transferred and added to the
2 money appropriated for the fiscal year 2000-2001.

3 (b) The fiscal year 2000-2001, including any money added thereto
4 pursuant to paragraph (a), must not be committed for expenditure after
5 June 30, ~~2001~~, **2002**, and reverts to the state general fund as soon as
6 all payments of money committed have been made.

7 **Sec. 2.** This act becomes effective upon passage and approval.
