AN ACT relating to cancer; creating the task force on prostate cancer; prescribing its powers and duties; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 457 of NRS is hereby amended by adding thereto
2 the provisions set forth as sections 2 to 6, inclusive, of this act.
3 **Sec. 2.** *As used in sections 2 to 6, inclusive, of this act, "task force"*
4 *means the task force on prostate cancer created pursuant to section 3 of*
5 *this act.*
6 **Sec. 3.** *1. The task force on prostate cancer, consisting of 11*
7 *members, is hereby created. The task force consists of:*
8 *(a) The following ex officio members:*
9 *(1) The chief executive officer of Family to Family: Americans for*
10 *Prostate Cancer Awareness and Support;*
11 *(2) The Nevada director of Us Too International, Inc.; and*
12 *(3) The executive officer of the public employees' benefit program;*
13 *and*
14 *(b) The following members appointed by the governor:*
15 *(1) Two members who are physicians licensed pursuant to chapter*
16 *630 of NRS;*
17 *(2) One member who is an officer or employee of the University and*
18 *Community College System of Nevada;*
19 *(3) One member who is an employee of the bureau of disease*
20 *control and intervention of the health division;*
21 *(4) One member who has had prostate cancer;*



1 (5) *One member who is related to a person who has had prostate*
2 *cancer; and*

3 (6) *Two members who are representatives of business.*

4 2. *If Family to Family: Americans for Prostrate Cancer Awareness*
5 *and Support or Us Too International, Inc., ceases to exist, the highest*
6 *officer or person in charge of any successor organization shall serve as*
7 *the ex officio member required by subparagraph (1) or (2) of paragraph*
8 *(a) of subsection 1 or, if there is no successor organization, the governor*
9 *shall appoint a person to serve pursuant to the applicable subparagraph.*

10 3. *Vacancies of members appointed to the task force must be filled in*
11 *the same manner as original appointments.*

12 4. *The task force shall annually submit a report concerning its*
13 *activities and any recommendations for legislation to the director of the*
14 *legislative counsel bureau for transmittal to the legislature.*

15 **Sec. 4.** 1. *The member of the task force described in subparagraph*
16 *(1) of paragraph (a) of subsection 1 of section 3 of this act shall serve as*
17 *chairman during even-numbered years and the member described in*
18 *subparagraph (2) of paragraph (a) of subsection 1 of section 3 of this act*
19 *shall serve as chairman during the odd-numbered years.*

20 2. *The members of the task force shall meet at least four times each*
21 *year and at the call of the chairman. The task force shall prescribe*
22 *regulations for its management and government.*

23 3. *Six members of the task force constitute a quorum, and a quorum*
24 *may exercise all the powers conferred on the task force.*

25 4. *After the initial terms, the term of each appointed member of the*
26 *task force is 4 years. The governor shall not appoint a member to serve*
27 *more than two terms.*

28 5. *The members of the task force serve without compensation and*
29 *are not entitled to receive a per diem allowance or travel expenses.*

30 6. *The members of the task force who are state employees must be*
31 *relieved from their duties without loss of their regular compensation to*
32 *perform their duties relating to the task force in the most timely manner*
33 *practicable. The state employees may not be required to make up the time*
34 *they are absent from work to fulfill their obligations as members of the*
35 *task force or take annual leave or compensatory time for the absence.*

36 **Sec. 5.** *The task force may:*

37 1. *Compile research and information concerning prostate cancer.*

38 2. *Identify and evaluate the methods used by the state and local*
39 *governments to increase the awareness of the general public concerning*
40 *the risk, treatment and prevention of prostate cancer.*

41 3. *Identify and evaluate methods to improve communication among*
42 *institutions and other entities in this state that are involved in the*
43 *research and treatment of prostate cancer.*

44 4. *Identify and evaluate methods to increase funding for institutions*
45 *and other entities in this state that are involved in cancer research.*

46 5. *Identify and evaluate methods to increase the number of men in*
47 *this state who are regularly tested for the presence of prostate cancer.*

48 6. *Identify and evaluate methods to increase the awareness and*
49 *education of the general public concerning prostate cancer.*



1 7. *Apply for any available grants and accept any gifts, grants or*
2 *donations to assist the task force in carrying out its duties pursuant to*
3 *this section.*

4 **Sec. 6.** *The director of the department of human resources shall*
5 *provide the personnel, facilities, equipment and supplies required by the*
6 *task force to carry out the provisions of sections 2 to 6, inclusive, of this*
7 *act.*

8 **Sec. 7.** As soon as practicable after July 1, 2001, the governor shall
9 appoint to the task force on prostate cancer created by section 3 of this act:

- 10 1. Four members whose terms expire on June 30, 2004.
11 2. Four members whose terms expire on June 30, 2005.

12 **Sec. 8.** This act becomes effective on July 1, 2001.
