AN ACT relating to counties; detaching certain territory from Clark County and attaching that territory to Nye County; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 243.293 is hereby amended to read as follows:

12 line through sections 3, 10, 15, 22, 27 and 34 to the south quarter corner of
13 section 34, T. 17 S., R. 54 E. and the north quarter corner of section 3, T.

16 *54 E. to the range line between Ranges 54 and 55 E., M.D.B. & M.;*
17 *thence southerly along that range line to the intersection of the state line*
18 *between Nevada and California.*
