SUMMARY—Requires occupational licensing boards to submit quarterly summaries of disciplinary actions and biennial reports of activities to director of legislative counsel bureau. (BDR 54-451)

AN ACT relating to occupational licensing boards; requiring each occupational licensing board to submit a quarterly summary of disciplinary actions and a biennial report of its activities to the director of the legislative counsel bureau; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Title 54 of NRS is hereby amended by adding thereto a
2 new chapter to consist of the provisions set forth as sections 2, 3 and 4 of
3 this act.
4 **Sec. 2.** *As used in this chapter, unless the context otherwise*
5 *requires, “occupational licensing board” includes, without limitation:*
6 1. *The state board of architecture, interior design and residential*
7 *design.*
8 2. *The board of landscape architecture.*
9 3. *The state contractors’ board.*
10 4. *The state board of professional engineers and land surveyors.*
11 5. *The board of registered environmental health specialists.*
12 6. *The Nevada state board of accountancy.*
13 7. *The board of medical examiners.*
14 8. *The board of homeopathic medical examiners.*
15 9. *The board of dental examiners of Nevada.*
16 10. *The state board of nursing.*
17 11. *The state board of osteopathic medicine.*
18 12. *The chiropractic physicians’ board of Nevada.*
19 13. *The state board of Oriental medicine.*
20 14. *The state board of podiatry.*
21 15. *The Nevada state board of optometry.*



- 1 16. *The board of dispensing opticians.*
- 2 17. *The board of hearing aid specialists.*
- 3 18. *The board of examiners for audiology and speech pathology.*
- 4 19. *The Nevada state board of veterinary medical examiners.*

- 24 **Sec. 3.** 1. *Each occupational licensing board shall, on or before*
25 *the 20th day of January, April, July and October, submit to the director*
26 *of the legislative counsel bureau a summary of each disciplinary action*
27 *taken during the immediately preceding calendar quarter against the*
28 *holder of a license, certificate, registration or permit issued by the*
29 *occupational licensing board.*
- 30 2. *The director of the legislative counsel bureau shall:*
- 31 (a) *Provide any information he receives pursuant to subsection 1 to a*
32 *member of the public upon request;*
- 33 (b) *Cause a notice of the availability of such information to be posted*
34 *on the public website of the Nevada legislature on the Internet; and*
- 35 (c) *Transmit a compilation of the information he receives pursuant to*
36 *subsection 1 to the legislative commission quarterly, unless otherwise*
37 *directed by the commission.*
- 38 **Sec. 4.** 1. *Each occupational licensing board shall, on or before*
39 *November 1 of each even-numbered year, submit a report of its activities*
40 *to the director of the legislative counsel bureau.*
- 41 2. *The report must include, without limitation:*
- 42 (a) *The number of licenses, certificates, registrations and permits,*
43 *respectively, issued by the occupational licensing board during the*
44 *immediately preceding 2 fiscal years;*
- 45 (b) *A summary of the budget of the occupational licensing board*
46 *during the immediately preceding 2 fiscal years that is related to the*
47 *duties of the occupational licensing board pursuant to this Title,*
48 *including, without limitation, a description of all income and*
49 *expenditures related to such duties;*

1 (c) *A summary of each disciplinary action taken during the*
2 *immediately preceding 2 fiscal years against the holder of a license,*
3 *certificate, registration or permit issued by the occupational licensing*
4 *board; and*

5 (d) *Any other information that is requested by the director of the*
6 *legislative counsel bureau or which the occupational licensing board*
7 *determines would be helpful to the legislature in evaluating whether the*
8 *continued existence of the occupational licensing board is necessary.*

9 3. *The director of the legislative counsel bureau shall compile all the*
10 *reports he receives and distribute copies of the compilation to the senate*
11 *standing committee on commerce and labor and the assembly standing*
12 *committee on commerce and labor, which each shall review the*
13 *compilation to determine whether the continued existence of each*
14 *occupational licensing board is necessary.*
