AN ACT relating to industrial insurance; defining the term “construction project” for the purpose of a consolidated insurance program; limiting the type of construction project that may be insured through a consolidated insurance program; prohibiting a consolidated insurance program from covering more than one construction project; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 616B of NRS is hereby amended by adding thereto
2 the provisions set forth as sections 2 to 5, inclusive, of this act:
3 **Sec. 2.** *As used in NRS 616B.710 to 616B.737, inclusive, and*
4 *sections 2 to 5, inclusive, of this act, unless the context otherwise*
5 *requires, the words and terms defined in sections 3, 4 and 5 of this act*
6 *have the meanings ascribed to them in those sections.*
7 **Sec. 3.** *“Construction project” means a project to construct or do*
8 *construction work on a fixed work or structure.*
9 **Sec. 4.** *“Fixed work” includes irrigation, drainage, water supply,*
10 *water power, flood control, harbors, railroads, highways, tunnels,*
11 *airports and airways, sewers and sewage disposal systems, bridges,*
12 *inland waterways, pipelines for transmission of petroleum and other*
13 *liquid or gaseous substances, refineries, chemical plants and industrial*
14 *plants requiring a specialized engineering knowledge and skill, power*
15 *plants, piers and foundations.*
16 **Sec. 5.** *“Structure” means a building or other structure designed for*
17 *the support, shelter and enclosure of persons, animals, chattels or*
18 *movable property of any kind, the construction of which requires the use*
19 *of more than two unrelated building trades or crafts.*

1 **Sec. 6.** NRS 616B.710 is hereby amended to read as follows:

2 616B.710 1. A private company, public entity or utility may:

3 (a) Establish and administer a consolidated insurance program to
4 provide industrial insurance coverage for employees of contractors and
5 subcontractors who are engaged in a construction project of which the
6 private company, public entity or utility is the owner or principal
7 contractor, if the ~~estimated~~ :

8 (1) *Estimated* total cost of the construction project is equal to or
9 greater than the threshold amount established by the commissioner
10 pursuant to subsection 3; *and*

11 (2) *Diameter of the site for the construction project is not more than*
12 *1 mile;* and

13 (b) As a condition precedent to the award of a contract to perform work
14 on the construction project, require that contractors and subcontractors who
15 will be engaged in the construction of the project participate in the
16 consolidated insurance program.

17 2. If a private company, public entity or utility:

18 (a) Establishes and administers a consolidated insurance program; and

19 (b) Pursuant to the contract for the construction of the project, owes a
20 periodic payment to a contractor or subcontractor whose employees are
21 covered under the consolidated insurance program,
22 the private company, public entity or utility shall not withhold such a
23 periodic payment on the basis that the contractor or subcontractor has not
24 signed an employer's report of industrial injury or occupational disease as
25 required pursuant to NRS 616C.045.

26 3. The commissioner shall establish the threshold amount that the
27 estimated total cost of a construction project must be equal to or greater
28 than before a consolidated insurance program may be established and
29 administered for that project pursuant to this section. The base amount for
30 the threshold must initially be \$150,000,000 and thereafter must be an
31 amount equal to \$150,000,000 as adjusted by the commissioner on June 30
32 of each year to reflect the present value of that amount with respect to the
33 construction cost index.

34 4. As used in this section:

35 (a) "Construction cost index" means the construction cost index
36 published by the Engineering News-Record as a measure of inflation.

37 (b) "Estimated total cost" means the estimated cost to complete all parts
38 of a construction project, including, without limitation, the cost of:

39 (1) Designing the *construction* project;

40 (2) ~~Acquiring the real property on which the project will be~~
41 ~~constructed;~~ *Constructing or doing the required construction work on*
42 *the fixed work or structure;*

43 (3) Connecting the *construction* project to utilities; *and*

44 (4) Excavating and carrying out underground improvements for the
45 *construction* project. ~~}; and~~

46 ~~(5) Acquiring equipment and furnishings for the project.}~~

47 The term does not include the cost of any fees or charges associated with
48 acquiring the money necessary to complete the *construction* project ~~};~~ ,
49 *the cost of acquiring any real property on which the construction project*

1 *will be located or the cost of acquiring equipment or furnishings, that are*
2 *not necessary for the completion of the construction work, for the fixed*
3 *work or structure.*

4 **Sec. 7.** NRS 616B.720 is hereby amended to read as follows:

5 616B.720 A contract for the provision of industrial insurance that is
6 authorized pursuant to NRS 616B.712 must include, without limitation:

7 1. Provisions that require compliance with each of the requirements
8 relating to safety and the administration of claims for industrial insurance
9 at the site of the construction project that are set forth in NRS 616B.725
10 and 616B.727;

11 2. The names and qualifications of the persons appointed to oversee
12 issues of safety and the administration of claims for industrial insurance at
13 the site of the construction project pursuant to NRS 616B.725 and
14 616B.727;

15 3. The terms and conditions pursuant to which the contract provides
16 industrial insurance coverage. The terms and conditions must include,
17 without limitation:

18 (a) A definition of the site of the construction project that:

19 (1) *Includes an area with a diameter of not more than 1 mile;*

20 (2) Delineates clearly the area within which coverage is provided;
21 and

22 ~~[(2)]~~ (3) *Is reasonably contiguous to the actual physical site of the*
23 ~~construction project;~~ *fixed work or structure being constructed or the*
24 *portion of the fixed work or structure upon which construction work is*
25 *being performed;* and

26 (b) A description of the scope and details of the construction project and
27 the duration of industrial insurance coverage that is provided for the
28 project;

29 4. A list in which the owner, principal contractor, construction
30 manager, contractors and subcontractors of the construction project are set
31 forth as named insureds; and

32 5. A provision setting forth the penalties to which the owner, principal
33 contractor, construction manager, contractors and subcontractors of the
34 construction project may be subject if such persons or entities fail to
35 comply with the provisions relating to safety and the administration of
36 claims for industrial insurance that are required pursuant to NRS 616B.725
37 and 616B.727.

38 **Sec. 8.** Section 27 of chapter 582, Statutes of Nevada 1999, at page
39 3152, is hereby amended to read as follows:

40 Sec. 27. 1. This section and section 26.5 of this act become
41 effective upon passage and approval.

42 2. Sections 1 to 10, inclusive, and 12 to 26, inclusive, of this act
43 become effective on October 1, 1999.

44 ~~3. Section 10 of this act expires by limitation on September 30,~~

46 ~~4. Section 11 of this act becomes effective on October 1, 2001.~~

47 **Sec. 9.** Section 11 of chapter 582, Statutes of Nevada 1999, at page
48 3142, is hereby repealed.
