SUMMARY—Makes various changes concerning computers, technology, Internet and crimes against children. (BDR 15-442)

AN ACT relating to crimes; requiring Internet service providers to maintain certain information; authorizing certain persons to apply to the court for an order to obtain such information; establishing a penalty for committing the crime of stalking with the use of the Internet or electronic mail; prohibiting the use or attempted use of a computer, network or system to lure children and providing that such an offense constitutes a sexual offense for the purpose of certain statutes pertaining to sex offenders; making various changes concerning the sale of tobacco products or alcoholic beverages to minors through the use of the Internet; increasing the penalty for certain unlawful uses of encryption; making various changes concerning the crime of annoying or molesting a minor; requiring that certain conditions of probation and parole be imposed upon certain offenders; providing penalties; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 193 of NRS is hereby amended by adding thereto a
2 new section to read as follows:
3 ***1. Each provider of Internet service shall create and maintain:***
4 ***(a) For at least 180 days after it is created:***
5 ***(1) A record of each person who enters or leaves its system,***
6 ***including, without limitation, the IP address of the person or any other***
7 ***information that identifies the person; and***
8 ***(2) A record of each customer of the service who logs on to the***
9 ***service, including, without limitation, information that identifies the***
10 ***customer; and***
11 ***(b) For at least 1 year after it is created, a record of each customer of***
12 ***the service that includes, without limitation, his name, address, telephone***

1 *number, the method he uses to pay for the service, the dates and times*
2 *that he has logged on to the service and the number of minutes that he*
3 *was logged on to the service.*

4 *2. A provider of Internet service who violates the provisions of*
5 *subsection 1 is guilty of a misdemeanor and shall be punished by a fine*
6 *of not less than \$50 or more than \$500 for each violation.*

7 *3. In investigating criminal activity that involves or may involve the*
8 *use of a computer, the attorney general, a district attorney, the sheriff of*
9 *any county in this state, the head of any organized police department of*
10 *any municipality in this state, the head of any department of this state*
11 *engaged in the enforcement of any criminal law of this state and any*
12 *sheriff or chief of police of a municipality may, if there is reasonable*
13 *cause to believe that a crime has been committed through the use of the*
14 *services of the provider of Internet service, apply to the court for an order*
15 *compelling the provider of Internet service to provide any information*
16 *relevant to the alleged crime that the provider is required to create and*
17 *maintain pursuant to subsection 1.*

18 *4. As used in this section:*

19 *(a) "Computer" has the meaning ascribed to it in NRS 205.4735.*

20 *(b) "Provider of Internet service" has the meaning ascribed to it in*
21 *NRS 205.4758.*

22 **Sec. 2.** NRS 200.571 is hereby amended to read as follows:

23 200.571 1. A person is guilty of harassment if:

24 (a) Without lawful authority, the person knowingly threatens:

25 (1) To cause bodily injury in the future to the person threatened or to
26 any other person;

27 (2) To cause physical damage to the property of another person;

28 (3) To subject the person threatened or any other person to physical
29 confinement or restraint; or

30 (4) To do any act which is intended to substantially harm the person
31 threatened or any other person with respect to his physical or mental health
32 or safety; and

33 (b) The person by words or conduct places the person receiving the
34 threat in reasonable fear that the threat will be carried out.

35 2. Except where the provisions of subsection 2 *or 3* of NRS 200.575
36 are applicable, a person who is guilty of harassment:

37 (a) For the first offense, is guilty of a misdemeanor.

38 (b) For the second or any subsequent offense, is guilty of a gross
39 misdemeanor.

40 3. The penalties provided in this section do not preclude the victim
41 from seeking any other legal remedy available.

42 **Sec. 3.** NRS 200.575 is hereby amended to read as follows:

43 200.575 1. A person who, without lawful authority, willfully or
44 maliciously engages in a course of conduct that would cause a reasonable
45 person to feel terrorized, frightened, intimidated or harassed, and that
46 actually causes the victim to feel terrorized, frightened, intimidated or
47 harassed, commits the crime of stalking. Except where the provisions of
48 subsection 2 *or 3* are applicable, a person who commits the crime of
49 stalking:

2 (b) For any subsequent offense, is guilty of a gross misdemeanor.
3 2. A person who:
4 (a) Commits the crime of stalking and in conjunction therewith
5 threatens the person with the intent to cause him to be placed in reasonable
6 fear of death or substantial bodily harm;
7 (b) Commits the crime of stalking on his spouse while a proceeding for
8 the dissolution of their marriage is pending for which he has actual or legal
9 notice or within 6 months after entry of the final decree of dissolution; or
10 (c) Commits the crime of stalking on a person with whom he has a child
11 in common while a proceeding for the custody of that child is pending for
12 which he has actual or legal notice,
13 commits the crime of aggravated stalking.

16 *communication to publish, display or distribute information in a manner*

19 4. A person who commits the crime of aggravated stalking shall be
20 punished:
21 (a) If he commits the crime set forth in paragraph (a) of subsection 2,
22 for a category B felony by imprisonment in the state prison for a minimum
23 term of not less than 2 years and a maximum term of not more than 15
24 years, and may be further punished by a fine of not more than \$5,000.
25 (b) If he commits the crime set forth in paragraph (b) or (c) of
26 subsection 2:
27 (1) For the first offense, for a gross misdemeanor.
28 (2) For the second and any subsequent offense, for a category B
29 felony by imprisonment in the state prison for a minimum term of not less
30 than 2 years and a maximum term of not more than 15 years, and may be
31 further punished by a fine of not more than \$5,000.
32 ~~14-1~~ 5. Except as otherwise provided in subsection 2 of NRS 200.571,
33 a criminal penalty provided for in this section may be imposed in addition

4 (c) *“Network” has the meaning ascribed to it in NRS 205.4745.*

5 (d) *“Provider of Internet service” has the meaning ascribed to it in*
6 *NRS 205.4758.*

7 (e) *“Without lawful authority” includes acts which are initiated or*
8 *continued without the victim’s consent. The term does not include acts*
9 *which are otherwise protected or authorized by constitutional or statutory*
10 *law, regulation or order of a court of competent jurisdiction, including, but*
11 *not limited to:*

12 (1) *Picketing which occurs during a strike, work stoppage or any*
13 *other labor dispute.*

14 (2) *The activities of a reporter, photographer, cameraman or other*
15 *person while gathering information for communication to the public if that*
16 *person is employed or engaged by or has contracted with a newspaper,*
17 *periodical, press association or radio or television station and is acting*
18 *solely within that professional capacity.*

19 (3) *The activities of a person that are carried out in the normal course*
20 *of his lawful employment.*

21 (4) *Any activities carried out in the exercise of the constitutionally*
22 *protected rights of freedom of speech and assembly.*

23 **Sec. 4.** Chapter 201 of NRS is hereby amended by adding thereto a
24 new section to read as follows:

25 1. *Except as otherwise provided in subsection 2, a person shall not*
26 *use a computer, system or network to knowingly contact or communicate*
27 *with or attempt to contact or communicate with a child less than 16 years*
28 *of age with the intent to persuade, lure or transport the child away from*
29 *his home or from any location known to his parent or guardian or other*
30 *person legally responsible for the child to a place other than where the*
31 *child is located, for any purpose:*

32 (a) *Without the express consent of the parent or guardian or other*
33 *person legally responsible for the child; and*

34 (b) *With the intent to avoid the consent of the parent or guardian or*
35 *other person legally responsible for the child.*

36 2. *The provisions of this section do not apply if the contact or*
37 *communication is made or attempted with the intent to prevent imminent*
38 *bodily, emotional or psychological harm to the child.*

39 3. *A person who violates or attempts to violate the provisions of this*
40 *section:*

41 (a) *With the intent to engage in sexual conduct with the child or to*
42 *cause the child to engage in sexual conduct, is guilty of a category B*
43 *felony and shall be punished by imprisonment in the state prison for a*
44 *minimum term of not less than 1 year and a maximum term of not more*
45 *than 10 years and may be further punished by a fine of not more than*
46 *\$10,000;*

47 (b) *By providing the child with obscene material or requesting the*
48 *child to provide the person with obscene material, is guilty of a category*
49 *C felony and shall be punished as provided in NRS 193.130; or*

2 misdemeanor.

3 4. As used in this section:

4 (a) "Computer" has the meaning ascribed to it in NRS 205.4735.

5 (b) "Material" means anything that is capable of being used or
6 adapted to arouse interest, whether through the medium of reading,
7 observation, sound or in any other manner.

8 (c) "Network" has the meaning ascribed to it in NRS 205.4745.

9 (d) "Obscene" has the meaning ascribed to it in NRS 201.235.

10 (e) "Sexual conduct" has the meaning ascribed to it in NRS 201.520.

11 (f) "System" has the meaning ascribed to it in NRS 205.476.

12 Sec. 5. Chapter 202 of NRS is hereby amended by adding thereto a
13 new section to read as follows:

14 1. It is unlawful for a person to knowingly sell or distribute
15 cigarettes, cigarette paper, tobacco of any description or products made
16 from tobacco to a child under the age of 18 years through the use of the
17 Internet.

18 2. A person who violates the provisions of subsection 1 shall be
19 punished by a fine of not more than \$500 and a civil penalty of not more
20 than \$500. Any money recovered pursuant to this section as a civil
21 penalty must be deposited in the same manner as money is deposited
22 pursuant to subsection 6 of NRS 202.2493.

23 3. Every person who sells or distributes cigarettes, cigarette paper,
24 tobacco of any description or products made from tobacco through the
25 use of the Internet shall adopt a policy to prevent a child under the age of
26 18 years from obtaining cigarettes, cigarette paper, tobacco of any
27 description or products made from tobacco from the person through the
28 use of the Internet. The policy must include, without limitation, a method
29 for ensuring that the person who delivers such items obtains the
30 signature of a person who is over the age of 21 years when delivering the
31 items, that the packaging or wrapping of the items when they are shipped
32 is clearly marked with the word "cigarettes" or the words "tobacco
33 products," and that the person complies with the provisions of 15 U.S.C.
34 § 376. A person who fails to adopt a policy pursuant to this subsection is
35 guilty of a misdemeanor and shall be punished by a fine of not more than
36 \$500.

37 Sec. 6. NRS 202.055 is hereby amended to read as follows:

38 202.055 1. Every person who knowingly:

39 (a) Sells, gives or otherwise furnishes an alcoholic beverage to any
40 person under 21 years of age;

41 (b) Leaves or deposits any alcoholic beverage in any place with the
42 intent that it will be procured by any person under 21 years of age; or

43 (c) Furnishes, gives, or causes to be given any money or thing of value
44 to any person under 21 years of age with the knowledge that the money or
45 thing of value is to be used by the person under 21 years of age to purchase
46 or procure any alcoholic beverage,
47 is guilty of a misdemeanor.

48 2. Paragraph (a) of subsection 1 does not apply to a parent, guardian or
49 physician of the person under 21 years of age.



1 3. Every person who sells, gives or otherwise furnishes alcoholic
2 beverages through the use of the Internet shall adopt a policy to prevent
3 a person under 21 years of age from obtaining an alcoholic beverage
4 from the person through the use of the Internet. The policy must include,
5 without limitation, a method for ensuring that the person who delivers
6 the alcoholic beverages obtains the signature of a person who is over the
7 age of 21 years when delivering the beverages and that the packaging or
8 wrapping of the alcoholic beverages when they are shipped is clearly
9 marked with words that describe the alcoholic beverages. A person who
10 fails to adopt a policy pursuant to this subsection is guilty of a
11 misdemeanor and shall be punished by a fine of not more than \$500.

12 Sec. 7. NRS 202.2485 is hereby amended to read as follows:

13 202.2485 As used in NRS 202.2485 to 202.2497, inclusive ~~H~~ , and
14 section 5 of this act:

15 1. "Distribute" includes furnishing, giving away or providing products
16 made from tobacco or samples thereof at no cost to promote the product,
17 whether or not in combination with a sale.

18 2. "Health authority" means the district health officer in a district, or
19 his designee, or, if none, the state health officer, or his designee.

20 Sec. 8. NRS 202.249 is hereby amended to read as follows:

21 202.249 1. It is the public policy of the State of Nevada and the
22 purpose of NRS 202.2491, 202.24915 and 202.2492 to place restrictions on
23 the smoking of tobacco in public places to protect human health and safety.

24 2. The quality of air is declared to be affected with the public interest
25 and NRS 202.2491, 202.24915 and 202.2492 are enacted in the exercise of
26 the police power of this state to protect the health, peace, safety and
27 general welfare of its people.

28 3. Health authorities, police officers of cities or towns, sheriffs and
29 their deputies and other peace officers of this state shall, within their
30 respective jurisdictions, enforce the provisions of NRS 202.2491,
31 202.24915 and 202.2492. Police officers of cities or towns, sheriffs and
32 their deputies and other peace officers of this state shall, within their
33 respective jurisdictions, enforce the provisions of NRS 202.2493 and
34 202.2494 ~~H~~ and section 5 of this act.

35 4. An agency, board, commission or political subdivision of this state,

43 encryption, directly or indirectly, to:

44 (a) Commit, facilitate, further or promote any criminal offense;
45 (b) Aid, assist or encourage another person to commit any criminal
46 offense;

47 (c) Conceal the commission of any criminal offense;

48 (d) Conceal or protect the identity of a person who has committed any
49 criminal offense; or

(e) Delay, hinder or obstruct the administration of the law.

2. A person who violates any provision of this section:

(a) Is guilty of a gross misdemeanor ~~and~~, *unless the encryption was used or attempted to be used to commit a crime for which a greater penalty is provided by specific statute. If the encryption was used or attempted to be used to commit a crime for which a greater penalty is provided by specific statute, the person shall be punished as prescribed by statute for that crime.*

(b) Commits a criminal offense that is separate and distinct from any other criminal offense and may be prosecuted and convicted pursuant to this section whether or not the person or any other person is or has been prosecuted or convicted for any other criminal offense arising out of the same facts as the violation of this section.

Sec. 10. NRS 207.260 is hereby amended to read as follows:

207.260 ~~A~~

1. Unless a greater penalty is provided by specific statute, a person who annoys or molests or attempts to annoy or molest a minor, including, without limitation, soliciting a minor to engage in unlawful sexual conduct, is guilty of:

(a) For the first offense, a misdemeanor.

(b) For the second and each subsequent offense, he is guilty of a category B felony and shall be punished by imprisonment in the state prison for a minimum term of not less than 1 year and a maximum term of not more than 6 years, and may be further punished by a fine of not more than \$5,000.

2. For the purposes of this section, "soliciting" includes, without limitation, contacting a person directly, through the use of a telephone, in writing, through the use of a computer or through an advertisement.

3. As used in this section:

(a) "Computer" has the meaning ascribed to it in NRS 205.4735.

(b) "Sexual conduct" has the meaning ascribed to it in NRS 200.700.

Sec. 11. NRS 176.0931 is hereby amended to read as follows:

176.0931 1. If a defendant is convicted of a sexual offense, the court shall include in sentencing, in addition to any other penalties provided by law, a special sentence of lifetime supervision.

2. The special sentence of lifetime supervision commences after any period of probation or any term of imprisonment and any period of release on parole.

3. A person sentenced to lifetime supervision may petition the district court in whose jurisdiction he resides for release from lifetime supervision. The court shall grant a petition for release from a special sentence of lifetime supervision if:

(a) The person has not been convicted of an offense that poses a threat to the safety or well-being of others for an interval of at least 15 consecutive years after his last conviction or release from incarceration, whichever occurs later; and

(b) The person is not likely to pose a threat to the safety of others if released from lifetime supervision.

33 (g) Any combination of the crimes listed in paragraphs (a) to ~~(e)~~ (f),
34 inclusive.
